## Who was this veteran?

Famous people I have met. A Veteran came to a meeting I was attending some years ago. I listened to this veteran's story. He was being escorted around by other veterans helping him tell his story. According to his report, he was the last person alive that raised the flag on Iwo Jima and he felt obligated to tell the true story. He started: It was a day of a lot of dying. His fellow soldiers were falling all around him. After and during the battle a small group of soldiers put up the flag to show the ships and other soldiers that they had taken that part of the island. A high ranking military officer was watching with a pair of binoculars from a ship that was just off shore. He was struck by the sight of the flag raising. So after the battle he decided it would make a great photo op to send back home to USA. So he contacted his photographer to meet him on shore. The original men were no longer

there that raised the flag so he asked some soldiers that were there to pose for the picture. He had acquired a much larger flag for the photo op. They took the picture which you see today but without the original soldiers in it. According to this veteran some of the original men were fighting on the other side of the island while the picture was being taken. This veteran telling the story said he would be able to rest better after he told the story for his comrades who had all passed away. I was touch by his story. I recently went to the internet and acquired some information so I will inject into the story here. Because of this story, history was changed. You will also see that the Marine Corps investigated and corrected the original story.

Off the internet:

There were six Flag Raisers on the famous Iwo Jima photo, four in the front line and two in back. The front four are (left

to right) Ira Hayes, Franklin Sousley, Harold Schultz and Harlon Block. The back two are Michael Strank (behind Sousley) and Rene Gagnon (behind Schultz). Strank, Block and Sousley would die shortly afterwards. Bradley, Hayes and Gagnon became national heroes within weeks.

2016 update: The Marine Corps investigated and determined that Harold Henry Schultz was among the 6 in the famous photograph of the 2nd flag raising instead of John Bradley.

Medicare For All?

President Donald Trump says he has a better plan than any other – We'll see!

In the meantime, 'two-out-of-three' Republicans don't care if their fellow Americans have Health Care or not. They think that 'Medicare-For-All' is a non-starter.

They seem overlook the fact that, in America, almost no-one goes without. The uninsured can go to the emergency room and demand immediate attention or do without.

This, of course, is encouraged by the Medical Industry which rakes in \$10,000, \$20,000, \$30,000 PER DAY for each Walk-In!

One survey reported that almost half of the respondents said that they are "financially burdened" by medical bills. Any employers health plan can cost about \$20,000 dollars a year, with ruinous co payments and deductibles.

miniscule 4% think that no improvements are needed at all.

Most of the Democrat Presidential candidates say that 'A Single-Payer, Medicare for All' system is the only way to go.

Their proposed Health Care System would provide Health Care for everyone. Unfortunately, the Democrats also want to 'outlaw' private health insurance. But Doctors and Hospitals would stay private.

This idea dates back to President Franklin Delano Roosevelt who gets credit for Social Security, but his attempts to include a 'National Health Service' were defeated by doctors and the drug industry.

# A Simple Examination Could Save Your Life

A trip to the dermatologist has traditionally involved treatment for a specific skin problem like a rash, acne or a wart. Increasingly however patients are seeking care for a much more serious problem: skin cancer, which will affect one in five Americans in their lifetime.

This alarming increase in skin cancer incidence is leading board-certified dermatologists to take a proactive approach – urging patients to get full body examinations to identify potential skin cancers anywhere on the body, including areas where patients might not think skin cancer could occur.

The exam is simple, quick, and painless – but priceless for the early detection it offers.

More than 3 million people will be diagnosed with skin cancer this year, including nearly 200,000 Americans diagnosed with the deadliest form of skin cancer, melanoma.

A common misconception is that melanoma only occurs on skin that has had extensive sun exposure. As many as three out of ten melanomas arise in completely sun-protected parts of the body. An annual Total-Body Skin Cancer Exam ensures that even these 'hidden' melanomas do not go undetected.

While detection is critical for problems created in the past, protection is the important theme of what to do to maintain your health in the future.

To protect your skin and your health, Advanced Dermatology recommends:

Moles or growths that change, itch or bleed could be early warning signs of melanoma. Get them checked as soon as possible by a –board-certified dermatologist.

### PRACTICE PRECAUTION - PREVENT A DROWNING TRAGEDY

Florida loses more children under age five to drowning than any other state.

Annually in Florida, enough children to fill three to four preschool classrooms drown and do not live to see their fifth birthday.

It only takes a minute. You look away, you may not hear the splash and your child is nowhere in sight. Drowning – the harsh reality of losing a child in as little as 20 seconds.

Sadly, there are approximately 3500 fatal unintentional (non-boating) drowning deaths a year in the United States. The Lady Lake Police Department is committed to educating parents and caregivers about taking precautions to help end these preventable tragedies.

Living in Central Florida, we are surrounded by water. Although children may know how to swim, if left unsupervised, they can drown in less than two inches of water. When participating in outdoor water activities, I encourage you to follow these safety-conscious behaviors:

- NEVER leave children unsupervised in or around a body of water - even for a moment.
- Children can drown in as little as two

inches of water in less than one minute.

- Install a self-closing gate or child safety fence around the pool.
- Alarm every door leading to water to alert you if a child has gone outside.
- Teach children water and swimming skills as soon as they can crawl.
- During pool parties or family fun gatherings, designate an adult to watch the children.
- Remove any toys that may attract children to the pool area.
- Install a pool cover to securely cover the water area.
- Install a poolside, cordless phone.
- Keep lifesaving equipment - a pole, life preserver and rope - in the pool area.
- Children with long hair should clip it back or wear a cap in the pool.
- Avoid keeping water in buckets or other large containers when toddlers are home.
- Don't rely on flotation devices to protect your children in the water.

### Drowning Prevention Checklist

- CONSTANT adult supervision by an adult who knows how to swim
- Childproof locks on all doors leading to water
- Gate or fence surrounding water
- Gate or fence is self-closing with a lock
- Pool cover is in use

- Alarms for doors and windows leading to pool are activated
- Child has completed swim lessons
- Above-ground pool stairs removed when pool not in use
- Lifesaving equipment in pool area
- Pool chemicals and supplies are locked in a secure area
- Child is watched in bathtub at all times
- Parent and/or caregiver know CPR

While you are out enjoying a fun day in the water this summer, please remember to be responsible and practice safety. Make a commitment to safeguard our children from becoming victims of this entirely preventable tragedy.

## Robocalls

Robocalls are a growing problem nationwide. Not only are they annoying, the calls are often part of a scam designed to trick consumers into parting with their hard-earned cash. My office is working diligently with our federal partners to stop these illegal calls, and this week, we joined the Federal Trade Commission in an effort to block one billion robocalls nationwide as part of Operation Call it Quits.

The robocall crackdown involved more than 90 actions across the country. As part of the crackdown, our office took action against three illegal operations targeting Floridians. Many of the victims of these illegal robocalls were seniors who had registered their phone numbers on the Do Not Call registry.

The calls purported to offer free products, but when consumers signed up they were billed monthly charges. Some offered credit card interest-rate-reduction services guaranteeing that consumers would save thousands if they would pay an upfront fee.

Working with the FTC, we shut down these scams, securing money judgments valued in the millions of dollars against the

defendants and in one of the cases, provided an average of a \$1,000 each in consumer refunds. [This nationwide effort](#) is just the latest action our office has taken to stop illegal robocalls.

Earlier this year, I urged Congress to [enact the TRACED Act](#) to reduce the number of illegal robocalls and fight spoofing—the practice of using technology to disguise a caller's phone number. Last month, our office advocated for the Federal Communications Commission to [enforce rules against caller ID spoofing](#).

There were more than 48 billion robocalls in 2018. Robocalls remain the number one source of consumer complaints received by the FTC and FCC, resulting in millions in consumer losses every year. It will take a massive collaborative effort to stop illegal robocalls, but we must continue to work together toward this end—for a stronger, safer Florida.

## Scam Stopper Workshop

TALLAHASSEE, Fla.—Attorney General Ashley Moody today presented Seniors vs. Crime volunteer Bryan Lifsey the 2018-2019 Advocate of the Year Award for working to protect seniors from scams. Lifsey is one of five Seniors vs. Crime volunteer sleuths nominated for the award. These Super Senior Sleuths are taking extraordinary steps to assist consumers through Attorney General Moody's Seniors

Lifsey is one of five volunteers recognized today as a Super Senior Sleuth. Attorney General Moody presented each of these remarkable volunteers an award, and all were nominees for 2018-2019 Advocate of the Year Award. The additional Super Senior

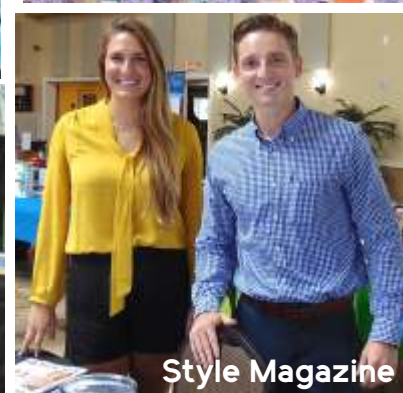

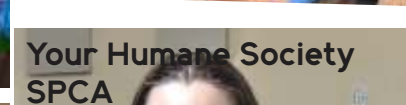

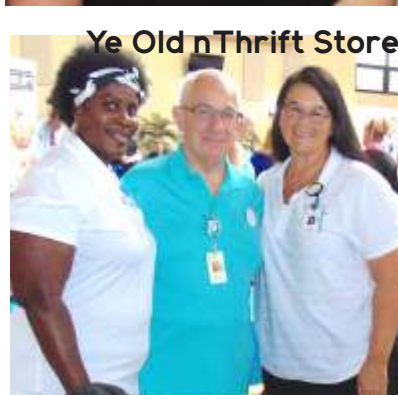

## Bills to Support Florida's Veterans

**Tampa, Fla.** – Today, Governor Ron DeSantis signed CS/CS/HB 501: Alternative Treatment Options for Veterans and CS/CS/HB 427: Honor and Remember Flag, at the University of South Florida's Office of Veteran Success.

“Here in Florida, we take great pride in being the most veteran-friendly state in the nation and I am proud to sign these two bills today to support our veterans,” said **Governor DeSantis**. “With more than 1.5 million veterans living in Florida, this community makes up an important part of our state's identity. While we may never be able to fully repay these men and women for their sacrifices, we will continue to do everything we can to support them and their families.”

“I'm proud of Governor DeSantis, our

Cabinet and legislature for supporting FDVA and the 1.5 million veterans of our state,” said **Danny Burgess, Executive Director of the Florida Department of Veterans' Affairs**. “Together, we will work to ensure Florida continues to lead the charge as the most veteran-friendly state in the nation.”

CS/CS/HB 501, sponsored by Representative Mel Ponder and Senator Tom Wright, creates a \$200,000 pilot program focused on treating post-traumatic stress and traumatic brain injuries in veterans using alternative therapies. It expands available therapies for eligible veterans to include accelerated resolution therapy, equine therapy, music therapy, service animal training therapy and hyperbaric oxygen therapy at registered facilities.

“I would like to thank Governor DeSantis for signing this good piece of legislation today,” said **Representative Mel Ponder**. “Too many veterans are returning home with wounds from conflict, after laying their lives on the line for our freedom, to insufficient care. We need to do better to honor and thank the sacrifices these heroes have made for us and this legislation is a step in the right direction.”

“I'm so proud Governor DeSantis signed the alternative treatments bill today,” said **Senator Tom Wright**. “This bill will allow us to provide the treatments our veterans need to cure PTSD/TBI. These men and women have served us proudly and with honor and now it's our time to serve them.”

It allows the flag to be flown on Veterans Day, Gold Star Mother's Day and a day on which a member of the United States Armed Forces who is a resident of Florida loses his or her life.

“It was my honor, as a retired Air Force officer and member of the Legislature, to ask the State of Florida to display this flag to honor the men and women who gave their lives defending our country and recognize the sacrifices of Gold Star families,” said **Representative Tommy Gregory**.

“It was an honor to be a part of this piece of legislation that recognizes and remembers our fellow Floridians, Gold Star Families, and Fallen Heroes who gave their lives so we can live ours,” said **Senator Joe Gruters**.

Governor DeSantis was joined at the bill signing by FDVA Executive Director Danny Burgess, Bryan Anderson of non-profit Veterans Alternative, Gold Star father Kris Hager, Senators Tom Wright and Kelli Stargel, Representatives Tommy Gregory, Jamie Grant, Jennifer Webb and Fentrice Driskell, and Representative-elect Randy Maggard.

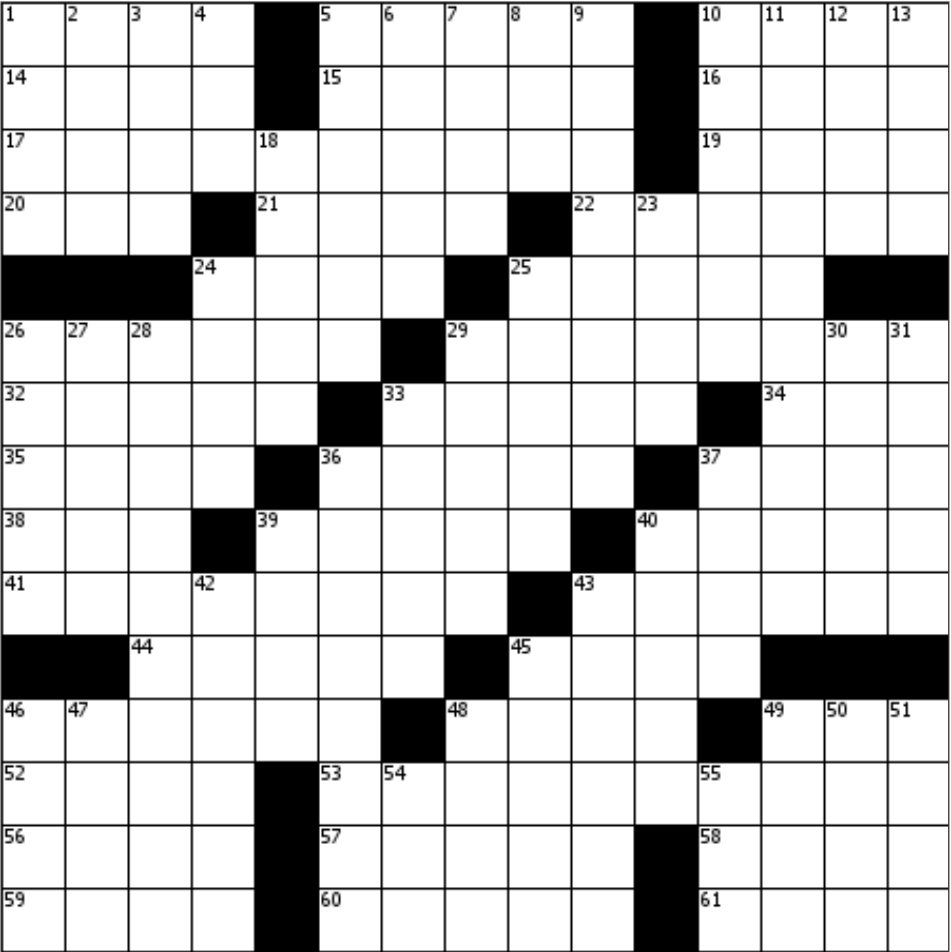

## Unsafe Airbags On U.S. Roads

### More Than 17 Million Unsafe Airbags Remain In Vehicles On U.S. Roads

(NAPSI)—Today, in the U.S., more than 17 million recalled Takata airbags remain in vehicles on the road. A defective part inside the airbag can explode when the airbag deploys, potentially shooting sharp metal fragments at the driver and passengers. The National Highway Traffic Safety Administration (NHTSA) has confirmed that 16 people in the U.S. have been killed, and hundreds of others alleged to have been injured, by this defect.

Affected vehicles include those made by BMW, Chrysler, Daimler, Ferrari, Ford, General Motors, Honda, Infiniti, Jaguar, Land Rover, Lexus, Mazda, McLaren, Mercedes-Benz, Mitsubishi, Nissan, Scion, Subaru, Tesla, Toyota and Volkswagen.

Vehicle manufacturers are sending official recall notices to affected consumers. Consumers also get notifications through postcards, e-mail, social media and other forms of communication urging them to contact their dealers immediately to schedule an appointment for a free recall repair.

Even if they haven't received a communication, all vehicle owners should check if their vehicle is affected by the Takata airbag recall by visiting [www.SafeAirbags.com](http://www.SafeAirbags.com) or [www.NHTSA.gov/Recalls](http://www.NHTSA.gov/Recalls) and entering their vehicle identification number (VIN).

Dealerships around the country have replacement parts available, and the free recall repair should take an average of one to several hours depending on vehicle make and model.

"Unfortunately, many consumers are not taking immediate action, either because they have ignored the repeated safety recall notices or do not understand the severity of the situation," said Patrick Juneau, who is leading a nationwide outreach program by [SafeAirbags.com](http://SafeAirbags.com).

"It is vitally important for consumers to pay attention to any notifications they receive and to schedule an appointment to have their airbags repaired for FREE. This literally could be a matter of life and death."

The call to action is simple.

If consumers receive a Takata airbag recall notice, letter, postcard or e-mail, they should immediately schedule a free recall repair at a local dealership.

Consumers uncertain whether their vehicles are part of the Takata airbag recall should visit [www.SafeAirbags.com](http://www.SafeAirbags.com). They will be prompted to enter the vehicle identification number (VIN), upload a photo of the license plate, or manually enter the plate number. The website will immediately indicate if the vehicle is currently under recall for defective Takata airbags.

A free smartphone app, Airbag Recall, can also be downloaded, enabling consumers to take a picture of their license plate to immediately determine if a vehicle is under recall.

It takes just a few minutes to determine if a vehicle has a recalled airbag and just a few hours to have an airbag repaired. Take the time to protect yourself, your family and your friends.

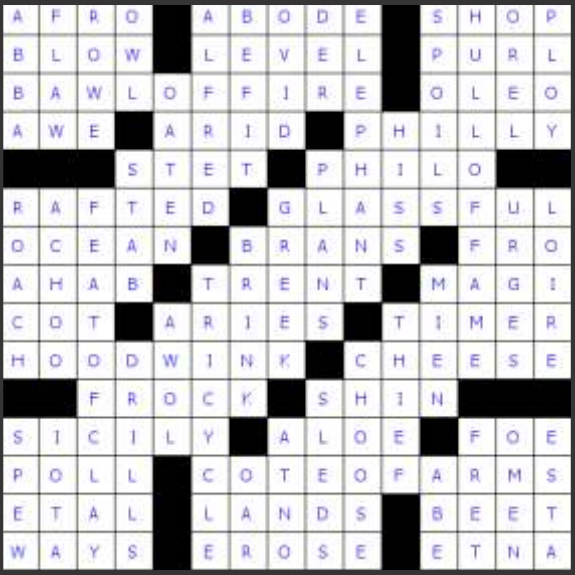
