Back in 2010, Signet Research, Inc. released data on readers' platform preferences when consuming content in media brand issues. ## AS I SEE IT

### IMPEACH THE PRESIDENT?

Apparently, a Washington intelligence officer reported that President Trump talked to the leader of Ukraine about the business dealings of Former Democrat Vice President, Joe Biden and his son Hunter Biden.

Because of its conflicts with Russia, the Ukraine receives millions of American Tax-Dollars in aid.

Its interesting that VP Joe Biden is rumored to have stopped a corruption prosecution against a company that hired his son Hunter Biden.

By his own admission, VP Joe Biden made at least a dozen visits to Kyiv, Ukraine when he was in the White House.

Questions are being asked about his role

in the dismissal of the country's prosecutor general, Viktor Shokin back in 2016.

And his threat that he would withhold a \$1 billion loan guarantee if Prosecutor Shokin was not removed.

Some investigators claimed that VP Biden improperly intervened to protect his son, Hunter Biden.

Hunter Biden is a lawyer who pursued "business opportunities" which 'intersected' with his father's contacts.

It is reported that a company called Burisma Holdings has paid Hunter Biden about \$850,000

to join its Board of Directors. Though whether he actually did any work for them is unclear.

Interestingly Hunter was not paid directly; One of his business partners,

Devon Archer, who was also on the Board, set up a company in the USA to indirectly route the money stateside to Biden.

Apparently, the U.S, under VP Biden, asked Ukrainian prosecutors to assist the U.K. authorities with their investigation of corruption in the Ukraine, and warned of "negative consequences" if that didn't happen involving about \$23 million.

In a September 2015 speech, the U.S. ambassador to Ukraine faulted the prosecutors office for "subverting" a U.K. Corruption probe.

But VP Biden admitted that he told Ukrainian officials directly, "If this prosecutor is not fired, you're not getting the money,"

Shortly thereafter Prosecutor Shokin was ousted, and the loan guarantee came through.

Even the International Monetary Fund was faulting The Ukraine for not investigating government corruption.

Since then VP Joe Biden has said that he's never spoken with his son Hunter about his foreign business dealings.

But Hunter told the New Yorker that they did. "Dad said, 'I hope you know what you are doing,' and I said, 'I do.'"

Apparently that was true because "all legal proceedings and pending criminal allegations" against that company were terminated.

Prosecutor Shokin said that he had been actively pursuing an investigation into the company (Burisma) and that he was fired because of it.

This is what President Trump believes still justifies an investigation.

The media misrepresents the reason that Rudy Giuliani, the president's personal lawyer, is pressing Ukrainian officials for an explanation.

Fact is that, if VP Joe Biden improperly intervened in The Ukraine on behalf of his son Hunter, it would be a U.S. offense, not a Ukrainian one.

The new prosecutor general in The Ukraine has said that he is planning to provide information to U.S. law enforcement officials about payments made to Hunter Biden so that US authorities can verify that appropriate taxes were paid on that income.

But, so far, there has been no 'Stateside' investigation to find out if there was any wrongdoing related to those payments. And, if the Democrats have their way, there never will be. 'til next time. . . .

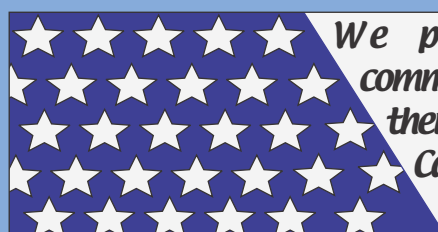

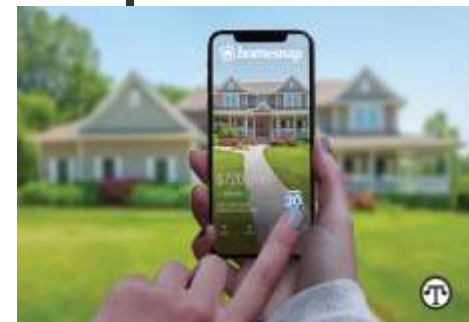

## Community Civility



**National League For Nursing Calls For Greater Civility Among Our National Community**

(NAPSI)—As the world reacts with shock and horror at mass shootings in the U.S., it is important that we as nurses and nurse educators reaffirm our core values and dedicate ourselves to the essential role we play in creating and sustaining a culture of civility, wherever we work and interact with others.

As representatives of the National League for Nursing, we believe we speak for our members in calling for an end to name-calling and an emphasis on thoughtful dialogue and courageous conversation.

As well, we believe it is essential to address issues related to gun ownership in the United States. This past February, the National League for Nursing joined with 166 national, state, and local medical, public health, and research organizations in asking Congress to provide funding for the Centers for Disease Control and Prevention to conduct public health research into firearm morbidity and mortality prevention. We emphasized that the use of firearms is a public health issue and must be addressed as such, noting that with rigorous research, it is possible to "accurately quantify and describe the facets of an issue and identify opportunities for reducing its related morbidity and mortality."

As we consider the National League for Nursing's core values, let us reflect especially on the value of diversity and inclusiveness, which encompasses respect for all persons and celebrates the richness of every individual, irrespective of race, ethnicity, gender, sexual orientation, socio-economic status, age, physical abilities, and religious and political beliefs or other ideologies. An appreciation for the value of diversity is essential for achieving an inclusive and civil society. We all have a role to play in helping to make that happen.

**Witch-ing you a spook-tacular Halloween! Let's make it a safe one.**

Halloween is fast approaching, and while children anticipate the annual celebration of fun and fantasy, it's a good time for the rest of us to think about safety. As part of our ongoing commitment to protect children, all of us at the Lady Lake Police Department will be passing along Halloween safety advice.

Children should be instructed not to eat any treats until they're back at home and mom or dad has inspected them. Parents should make sure that candy wrappers are sealed. Fruit or homemade items should be thoroughly examined. **If in doubt, throw it out.**

When little ghosts and goblins take to the streets, the biggest threat they face is motor vehicle traffic – something for parents and drivers to keep in mind.

For motorists, extreme caution is the rule for Halloween night. Expect children to run across the street, coming out of nowhere, oblivious to traffic. Children should be accompanied by adults when trick-or-treating. A responsible grown-up will be the person with a flashlight, leading the way when there's a need to cross the street. It's always best to stay close to home and to visit

neighbors and friends that you know. Make sure children only approach homes that are well lit. Treats should be handed out at the door so that youngsters don't have to enter the homes of strangers.

Surprisingly, simply falling down is also a leading cause of accidental injury on Halloween, the result of children tripping on their own costumes. Make sure their costume fits well and check that the child can see through any mask that he or she might be wearing.

Older children and teenagers need to be reminded that Halloween trick-or-treating is okay but vandalism will not be tolerated. Any deliberate act that damages property or causes harm to another person is a crime and police officers will treat it as such. Remind teens to never wear a mask in public, especially when visiting a store or similar establishment. It is actually against the law and it could lead to tragic consequences if a fun-loving young person were mistaken for a robbery suspect.

In addition to protecting children this Halloween, it is also important to protect property as well. Battery powered lights are always a safer alternative to candles inside pumpkins. If you decide to use candles, never leave them unattended, and make sure children are never left unsupervised around them.

I urge all parents to keep these few, common sense safety tips in mind this season. Let's all make sure our children stay safe this Halloween.

**School Board Fails Children**

The Marion County School Board votes four to one to keep three novels containing pornographic content in our high schools.

In a hearing before the School Board of Marion County, held August 19, four school board members; two former teachers, a pastor and the director of "Marion County Child's Alliance", voted to remove the three books from middle schools but to keep them in high schools. Only one school board member had the moral fortitude to want the books remove from all schools. The titles are; "The Bluest Eye", "Beloved" and "Dreaming in Cuban".

These books and others in use in our schools contain very graphic sexual content including; sexual conduct, sexual excitement, sexual battery, sexual bestiality and incest.

The School Board and the Superintendent have refused to address the issue of pornographic content in our schools even though it has been brought to their attention for years. After many failed attempts to quietly get the Board and the Superintendent to remove this type of content from our public schools, to protect children and to follow the law, members of "It's Your Tea Party Florida" formally objected to nine novels found in school libraries. Under Board Policy 4.3, a committee was formed to review the books. After reviewing the books, the committee recommended keeping all the books in middle and high school libraries. 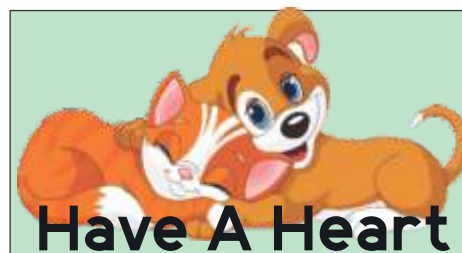

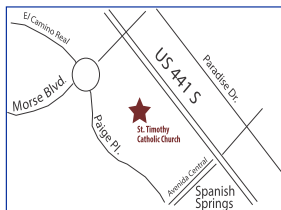

**Marriage is a tradition that exists on every continent and in nearly every country. Having a partner not only means creating a family unit, it means sharing things like a home and other property. Understanding how your future retirement might affect your spouse is important. When you're planning for your retirement, here are a few things to remember:**

Your spouse's benefit amount could be up to 50 percent of your spouse's full retirement age amount, if you are full retirement age when you take it. If you qualify for a benefit from your own work history and a spouse's record, we always pay your own benefit

first. You cannot receive spouse's benefits unless your spouse is receiving his or her retirement benefits (except for divorced spouses). If you took your reduced retirement first while waiting for your spouse to reach retirement age, when you add spouse's benefits later, your own retirement portion remains reduced, which causes the total retirement and spouses benefit together to total less than 50 percent of the worker's amount. You can find out more about this at [www.socialsecurity.gov/OACT/quickcalc/spouse.html](http://www.socialsecurity.gov/OACT/quickcalc/spouse.html).

**On the other hand, if your spouse's retirement benefit is higher than your retirement benefit, and he or she chooses to take reduced benefits and dies first, your survivor benefit will be reduced, but may be higher than what your spouse received.**

If the deceased worker started receiving reduced retirement benefits before their full retirement age, a special rule called the retirement insurance benefit limit may apply to the surviving spouse. The retirement insurance benefit limit is the maximum survivor benefit you may receive. Generally, the limit is the **higher of**:

The reduced monthly retirement benefit to which the deceased spouse would have been entitled if they had lived, or

82.5 percent of the unreduced deceased spouse's monthly benefit if they had started receiving benefits at their full retirement age (rather than choosing to receive a reduced retirement benefit early).

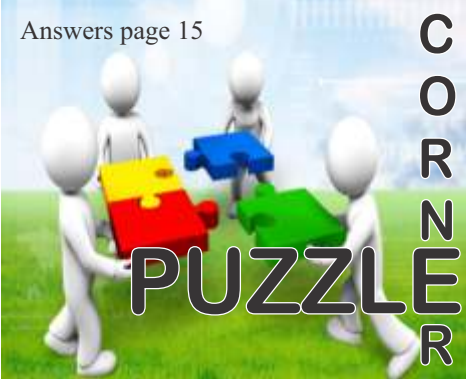

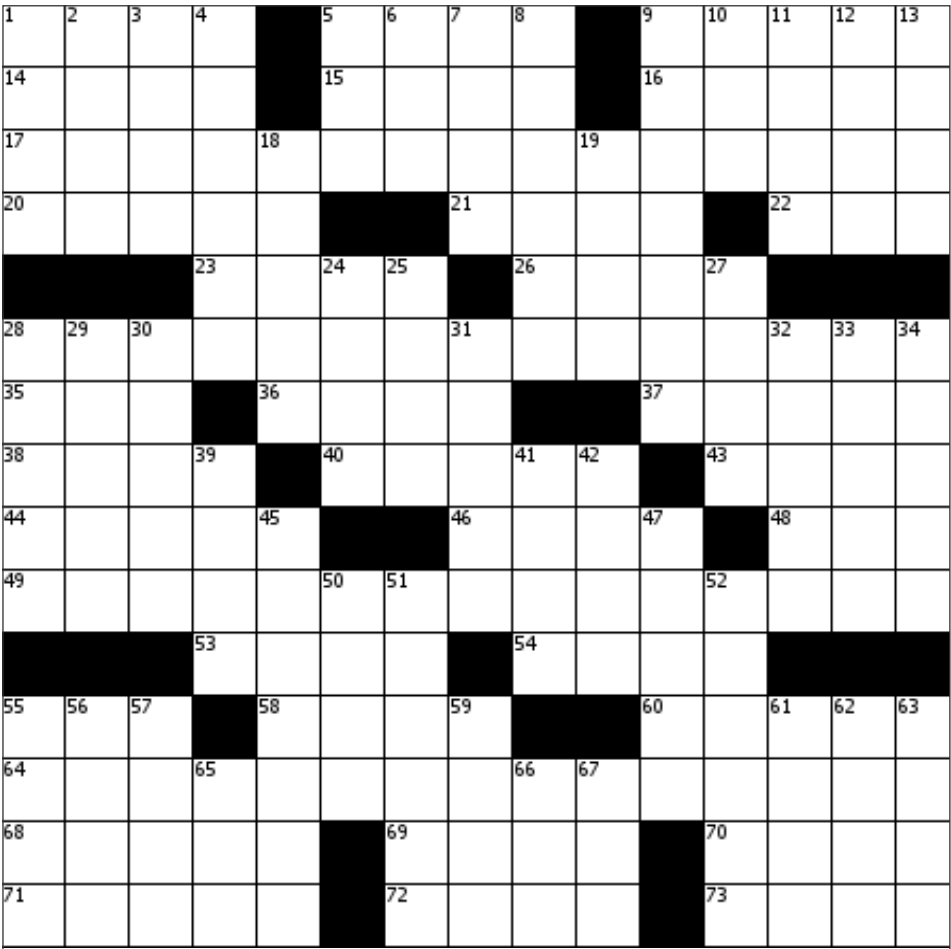

# Prostate Cancer Diagnosis



## Removing The Mystery From A Prostate Cancer Diagnosis

(NAPSI)—According to the American Cancer Society, about one in nine American men will be diagnosed with prostate cancer. A leading cause of cancer in men, more than 173,000 new diagnoses are expected in the U.S. this year. Fortunately, this disease can be treated successfully, especially if caught early.

### Some Answers

**Testing:** Since the 1980s, prostate cancer was being diagnosed with a simple blood test, the PSA. It checks the level of prostate-specific antigen in your blood.

In the past, there was controversy about whether having a prostate cancer screening done was beneficial or if it produced more harmful effects due to complications from over-testing. PSA testing was the best thing available for a long time.

New tools now exist that provide much more information, giving predictability about the aggressiveness of the cancer and data to help urologists safely manage their patients' disease. With this information, urologists have higher numbers of appropriate candidates on active surveillance regimens. Using tests such as the Gleason grade score, overall patient health and risk factors—age, race, ethnicity, family history and exposure to Agent Orange—urologists can determine with confidence how aggressive the cancer is and which patients will do well on active surveillance. They will also know which therapy options will be the optimal for the patient.

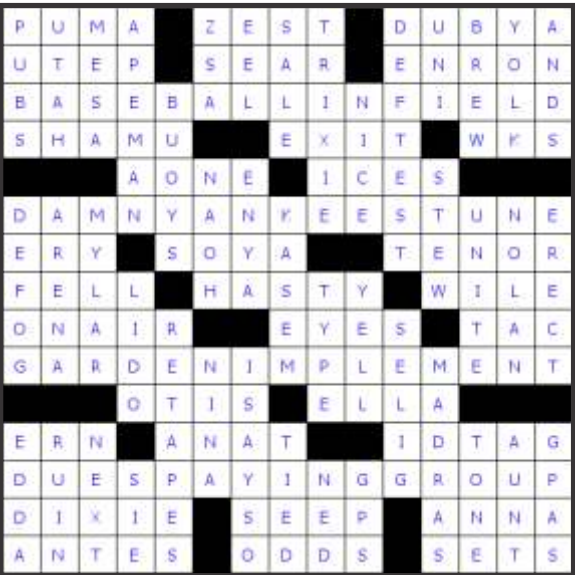
