We have bantering pictures of Animals, Birds, Flowers nonprofessional photography. Here is some information from the web about the Purple Passionflower.

Alternate Names Wild passion flower,

maypop, apricot vine, old field apricot, Holy-Trinity flower, molly-pop, passion vine, pop- apple, granadilla, maycock, maracoc, maracock, white sarsaparilla.

Uses One of the uses of the purple passionflower is ornamental in nature. This is because of their showy blooms and their

climbing ability over fences, arbors, or up walls. Native American Indians used the poultice root for boils, cuts, earaches and inflammation. Dried leaves boiled with water also aids in insomnia.

Wildlife Purple passionflower attracts butterflies. Young tendrils inch lavender flowers are short-stalked from leaf axils. The petals and sepals subtend a fringe of wavy or crimped, hair-like segments. The pistil and stamens are also showy. Three-lobed, deciduous leaves are dark-green above and whitish below. The plants bloom from June to September. The pulpy fruit or "maypop" develops in two to three months after flowering and may be harvested from July to October. It will be yellowish in color and it is about the size of a large oval hen's egg.

Establishment The purple passionflower requires direct sunlight for at least half of the day and prefers fertile, well-drained soil although it will grow in heavier clay soils. Plants may be propagated from seed or by cuttings. Seeds should be collected in the fall after the fruit has begun to shrivel. Mature seeds are brown in color with no traces of white. Wash the gelatinous covering from the seeds if they are to be stored for any length of time. It is best to plant the seed directly into an outdoor seedbed. Cuttings should be taken in the early spring. Remove the lower leaves from a 15 to 20 cm cutting before placing it in the rooting medium. Removing the suckers that develop around the established plants provides materials for propagating by division. With a shovel, separate and remove the suckers and roots. Transplant the divisions and water them immediately.

OCALA, Fla.-The Department of Health

in Marion County is reporting 331 cumulative cases of COVID-19 as of this afternoon. The most recent individuals confirmed to have the virus are:

- 22-year-old male from Belleview
- 22-year-old female from Ocala
- 30-year-old male from Ocala

- 33-year-old male from Ocala
- 53-year-old male from Belleview
- 60-year-old female from Ocala

So far, 19,488 COVID-19 tests have been given in Marion County. Of those, 19,149 were negative. Individuals who tested positive for the virus have ranged in age from 6 months to 97 years old. Eight Marion County residents have died after becoming ill with COVID-19. Marion's overall positive test rate is 1.7%; Florida's positive test rate is 5.6%. Readers ask a lot of questions, but, often, I don't have (informed) answers!

Q-Was the 'Declaration of Independence' signed by citizens of the United States of America?

AISI-The eight 'signers' were all Englishmen who were born in the 'colonies'?

Q Who wrote the Declaration of Independence?

AISI-Apparently many of the most meaningful lines in the Declaration of Independence were written by George Mason from Virginia. One example is “all men are born equally free and independent.”

AISI-. Thomas Jefferson's expansion reads "We hold these truths to be self-evident, that all men are created equal."

AISI-Of course, neither one of them really meant "all men".

Also, Mason included "Natural Rights” as “Enjoyment of Life and Liberty, with the means of acquiring and possessing Property, and pursuing and obtaining Happiness and Safety.”

Jefferson whittled it down to a man's inalienable rights as "Life, Liberty, and the Pursuit of Happiness."

Q-Did the American Revolution start on 4th of July?

AISI-That was over a year earlier; back in April 1775.

Q-Was July 4 the day that they declared independence from England?

AISI-Back in June, Thomas Jefferson had written a first draft of the Declaration of

Independence. It was on July 4th 1776 that the 'Continental Congress' approved the Declaration of Independence.

AISI-The English 'Redcoats' were already on their way to New York Harbor.

Q-When did they tell England that they were done with them?

AISI-That didn't happen until about four months later, in November 1776.

Q-Can you get to see the original document they signed?

AISI- Not the 'original' signed document. Only copies signed in August 1776 survived. (Now displayed at the National Archives in Washington, D.C.)

Q-Was the Fourth of July always a national holiday?

AISI-Not for about 15 or 20 years; perhaps because there was a War of Independence going on.

AISI-Interestingly, in the context of what we see on TV these days, back in 1817, John Adams was already observing that America was uninterested in its own past.

AISI-Decades later, printed copies of the Declaration were widely circulated, all showing the date as July 4, 1776.

AISI-Also Thomas Jefferson, John Adams and James Monroe, died on July 4. But President Calvin Coolidge, was born on July 4 in 1872.

AISI-Finally, in 1870, Congress set July 4 as a national holiday (along with Christmas).

Q-Who else worked on the DoI?

AISI- There are a lot, but it was John Locke's idea to state that governments derive “their just Powers from the consent of the people.”

AISI-the word “forgive” appears 121 times in the bible.

-"And said to them, he that is without sin; let him first cast a stone".

-Regardless of whether people have harmed you, or if they deserve your forgiveness, your forgiveness does not mean forgetting, nor does it mean condoning or excusing their offenses against you.

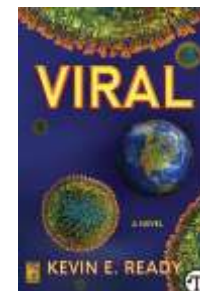

"Viral" by Kevin E. Ready

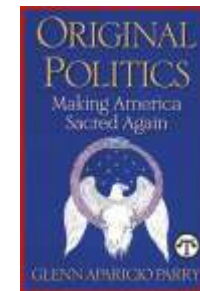

Tips To Help Home/Business



Get Ready: 10 Tips To Help Home And Business Owners Prepare Ahead Of Storms, Hurricanes And Floods

(NAPSI)—The preparations you make now, ahead of storms, floods or hurricanes, can help you recover faster and stay safe during cleanup. The Outdoor Power

Equipment Institute (OPEI), an international trade association representing manufacturers and suppliers of power equipment, small engines and battery power, utility and personal transport vehicles, and golf cars, reminds home and business owners to get ready before a storm strikes and make preparations now.

“Weather can be unpredictable, so it's important to always keep your equipment in working order, to have the right fuel on hand and to know where your safety gear is. This is doubly true during storm season, as the weather can change quickly,” said Kris Kiser, president and CEO of OPEI. “You also want to know how to use your equipment safely and use caution when cleaning up.”

These tips can help homeowners and businesses plan ahead for storm cleanup:

Take stock of your outdoor power equipment. Make sure it's in good working order. If needed, take the equipment to an

authorized service center for maintenance or repair. If you need to buy a new piece of equipment, get it before the storm and learn how to use it.

Find your safety gear. Avoid the scramble for sturdy shoes, safety goggles, hard hats, reflective clothing and work gloves, which should be stored in an accessible area with your equipment.

Review the owner's manuals. Read product manuals to ensure you know how to operate your equipment safely.

Have the right fuel on hand. Fuel stations may be closed after a storm. Store your fuel in an approved container. Use the type of fuel recommended by the equipment manufacturer. It's illegal to use any fuel with more than 10% ethanol in outdoor power equipment (for more information on proper fueling visit www.LookBeforeYouPump.com).

Charge batteries. Collect the batteries for

your outdoor power equipment and fully charge them ahead of the storm.

Use safety precautions. Be aware of fundamental dangers that can occur. For instance, chainsaw kickback may happen when the moving chain at the tip of the guide bar touches an object or when the wood closes in and pinches the saw chain in the cut. Always stand with your weight on both feet, and adjust your stance so you're angled away from the blade. Hold the chainsaw with both hands. Never over-reach or cut anything above your shoulder height. Have a planned retreat path if something falls.

Ensure portable generators have plenty of ventilation. Generators should never be used in an enclosed area or inside a home or garage, even if the windows or doors are open. Place the generator outside and away from windows, doors and vents that could allow carbon monoxide inside. Keep the generator dry. Do not use it in rainy or wet conditions. Before refueling, turn the generator off and let it cool down.

Drive Utility Type Vehicles (UTVs) with caution. Keep the vehicle stable and drive slowly. Do not turn the vehicle mid-slope or while on a hill.

Be aware of others. Keep bystanders, children and animals out of your work area. Don't let other people near outdoor power equipment when starting or using it.

Pay attention to your health. Storm cleanup can be taxing on the body and the spirit. Don't operate power equipment when you're fatigued. Drink plenty of water and take regular breaks.

Keep this advice in mind and you may be better prepared to weather any storm.

PRACTICE PRECAUTION - PREVENT A DROWNING TRAGEDY

It only takes a minute. You look away, you may not hear the splash and your child is nowhere in sight.

Drowning – the harsh reality of losing a child in less than one minute. Drowning is swift and silent.

According to the National Drowning Prevention Alliance (NDPA), there are approximately 4000 drowning deaths a year in the United States. The Lady Lake Police Department is committed to educating parents and caregivers about taking precautions to help end these preventable tragedies.

Florida loses more children under age five to drowning than any other state. Annually in Florida, enough children to fill three to four preschool classrooms drown and do not live to see their fifth birthday (Floridahealth.gov.)

Living in Central Florida, we are surrounded by water. Although children may know how to swim, if left unsupervised, they can drown in less than two inches of water. When participating in outdoor water activities, I encourage you to follow these safety-conscious behaviors:

- Never leave children unsupervised in or around a body of water - even for a moment. Children can drown in as little

as two inches of water in less than one minute. Remember, a life-guard on duty at a pool, beach, or lake is not an alternative for you watching your children. It's still your responsibility.

- Install at least a 4 foot gate around the pool that is self-latching and self-locking.
- Install a pool cover to securely cover the water area.
- Alarm every door leading to water to alert you if a child has gone outside.
- Teach children water and swimming skills at a young age.
- Children and inexperience swimmers should wear a U.S. Coastguard approved life jacket.
- During pool parties or family fun gatherings, designate an adult to watch the children. These are known as "water watchers." Rotate adults if needed.
- Remove any toys that may attract children to the pool area.
- Keep a phone with you so that you never have to "run" to answer a call.
- Keep lifesaving equipment - a pole, life preserver and rope - in the pool area.
- Children with long hair should clip it back or wear a cap in the pool.
- Avoid keeping water in buckets or other large containers when toddlers are home.
- Don't rely on flotation devices to protect your children in the water.
- Be observant of water current indicator/warning flags at beaches. The current can change or be dangerously stronger than expected even if you are an

experienced swimmer. Children will be at a higher risk of drowning in these conditions.

Drowning Prevention Checklist

- Constant adult supervision by an adult who knows how to swim
- Childproof locks on all doors leading to water
- Gate or fence surrounding water that is self-latching, self-locking
- Pool cover in use
- Alarms for doors and windows leading to pool are activated
- Child has completed swim lessons
- Above-ground pool stairs removed when pool not in use
- Lifesaving equipment in pool area
- Pool chemicals and supplies are locked in a secure area
- Child is watched in bathtub at all times
- Parent and / or caregiver knows CPR

While you are out enjoying a fun day in the water this summer, please remember to be responsible and practice safety. Make a commitment to safeguard our children from becoming victims of this entirely preventable tragedy.

Story of Max Mallory

Every Young Man Should Know About This Type Of Cancer Prevention

(NAPSI)—Young men and those who care about them should consider the story of Max Mallory. At 22 he graduated from college and started his dream job in the video game industry. He landed the job before graduation at the company where he had interned for almost a year. Set up in his own apartment, he started to live his life on his own and navigate the nuances of that first professional job.

Life was fine until mid-October, when Max experienced what seemed like stomach troubles and minor back pain. After two visits to urgent care centers where doctors prescribed antibiotics, he came home to stay with his dad and visit a urologist. He never made it to that medical appointment. Doubled over with sudden pain the next afternoon, he called 911. Late that evening in the emergency room, he heard the worrisome diagnosis: late-stage testicular cancer.

His cancer journey lasted only seven hard-fought months. He had an aggressive testicular cancer, choriocarcinoma. He passed away three days after he received the first round of stem cells.

He couldn't have prevented his testicular cancer with self-exams, since he "was born with" one testicle that was healthy.

Be Aware of the Other Cause

Mallory was born with one undescended testicle, known in medical terms as

cryptorchidism and identified as the most common genital problem pediatricians encounter (Medscape). He had exploratory surgery at age one. He and his parents were told he was born with one testicle, that the undescended testicle they were looking for wasn't there. Over the years, no one questioned this situation—though he regularly saw pediatricians.

His cancer did not appear as a lump or tumor on his testicle. The malignant mass rested in his lower abdomen. The acute back pain became the catalyst for action. Unknown to him, his “missing” testicle existed after all and developed into the cancerous tissue. By the time he made it to the E.D., it had already spread to other parts of his body.

What Can Be Done?

For boys and men with two testicles, self-exam is key. Some schools, coaches and informed doctors have told these young men how to go about it. There are many sources online for the information; for example, the Mayo Clinic is a good place to check.

For those who have had an undescended testicle, it's important to find out what was done about it. If it was surgically put in place (usually done in infancy), there is still a slightly higher risk of testicular cancer. Your doctor should know about this.

More Info

The Max Mallory Foundation was founded in 2017 and provides awareness of testicular cancer not identified “with a

lump” and self-exam. It also assists young adults with cancer, an underserved group and works in association with other testicular cancer organizations. The Foundation is a 501c(3) organization. Mallory's full story is on the website, <https://maxmalloryfoundation.com>.

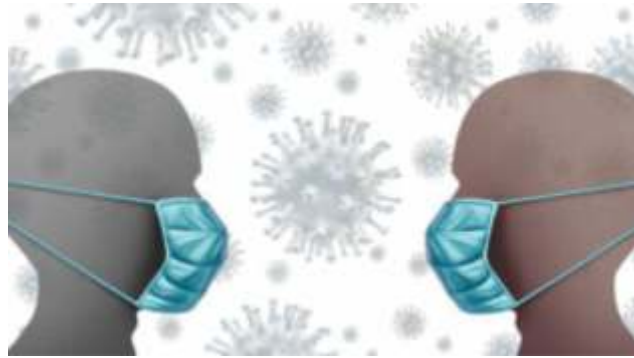

Attorney General Moody Asks Floridians to Immediately Report Child Porn Zoombombing to Law Enforcement
TALLAHASSEE, Fla. — Attorney General Ashley Moody is working with Florida

sheriffs, police chiefs and university police to stop child porn Zoombombing. Zoombombing occurs when hackers hijack internet video conferences, like those offered by the fast-growing platform Zoom. These hackers often present inappropriate, offensive material or otherwise disrupt video conferences. Recent reports indicate that hackers are crashing online meetings with child pornography. After learning of this criminal activity, Attorney General Moody began working with local law enforcement to thwart the offensive conduct and ensure local, state and federal law enforcement are coordinated in their efforts.

Attorney General Ashley Moody said, "It's heartbreaking that anyone would exploit children in this manner, but child pornography is pervasive online. It's disgusting and illegal. When hackers hijack meetings and force participants to view these disturbing images, we must ensure we

have an immediate, aggressive and coordinated law enforcement response. That is why I am working with our great law enforcement agencies to track down Zoombombers and hold them accountable for the victimization of our children."

Anyone experiencing Zoombombing with illegal images, or receiving child pornography by other means, should immediately report the crime to local law enforcement. To report child abuse, Floridians can also call the state child abuse hotline at 1(800)962-2873.

Earlier this year, Attorney General Moody issued a Consumer Alert to inform Floridians about steps they can take to prevent online meetings being hijacked. To increase privacy and guard against Zoombombing:

- Create separate passwords for each virtual meeting;
- Establish a Zoom waiting room for meeting participants;
- Lock down the meeting once everyone invited to attend has joined; and
- Do not publicly post meeting links on social media or any other public forum.

Zoom also offers privacy settings to provide hosts an additional layer of protection. To enable these extra security features, hosts should click on the settings menu, scroll to Screen Sharing, find Who Can Share? then click on Host Only. Finally, the user should save the changes.

After saving the new preferences, subsequent meetings should enable these enhanced privacy features by default. For more virtual meeting security tips, go to <https://zoom.us/security>.

Attorney General Moody Warns of Work-from-Home Employment Scams Targeting College Students

TALLAHASSEE, Fla.—Attorney General Ashley Moody today issued a Consumer Alert warning students at Florida colleges and universities of an emerging work-from-home employment scam. Scammers are targeting students via emails that appear to be sent from a college or university advertising fictitious work-from-home employment opportunities. The scammers obtain personal information from the student while posing as a university representative. Savvy scammers convince students to cash counterfeit checks and send them the money.

Attorney General Ashley Moody said, "During the COVID-19 crisis and resulting economic downturn, Floridians are looking for work, and it is unconscionable that scammers are exploiting these times of uncertainty to prey on our college students. Students who fall victim to this scam could face serious repercussions to their financial stability and credit record. I am urging all students currently enrolled at Florida colleges and universities to take extra precaution when receiving online job

offers."

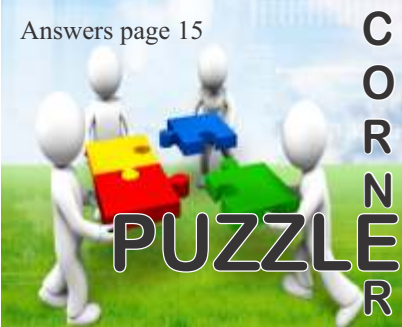
The emerging scheme involves scammers sending online job advertisements offering college students an administrative position, tricking the student into believing the email is from a college or university representative by using an email address ending in '.edu'. As part of the scheme, the student receives counterfeit checks in the mail, or via email, and is instructed to deposit the checks into a personal checking account. The scammers then direct the student to withdraw the money and make a payment necessary for the job. Often, after the student sends the money, the checks are confirmed to be fraudulent by the bank.

According to Attorney General Moody's Consumer Protection Division, students falling victim to the scam experience bank accounts being closed due to fraudulent activity and a report filed by the bank with a credit bureau or law enforcement agency. Additionally, the student would be responsible for reimbursing the bank for the total amount of the counterfeit checks, often times resulting in an adverse effect on the student's credit record.

To avoid these types of employment scams:

- Research the company before accepting any job offer. Does the company have a professional website and legitimate contact information? Search for what others are saying about experiences with the company;
- If the solicitor is communicating via email, locate contact information for the

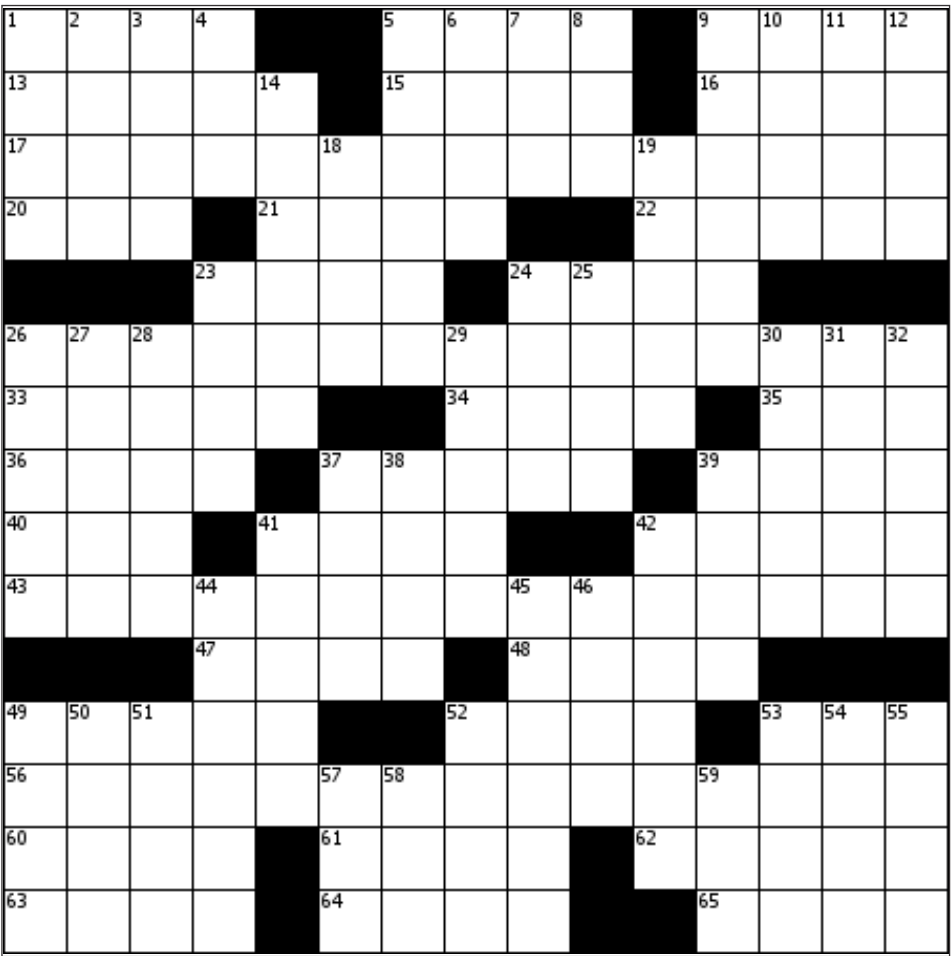
Affairs has expanded current programs and launched several new initiatives, combined with proactive information sharing, to help reduce social isolation and loneliness among people as they remain safer at home.”

sender through the school's website and confirm whether the job offer is real;

- Look for red flags, such as typos and grammatical errors. Offers of employment or pay without an interview are another sign of an employment scam; and
- Never send funds in the form of cash, checks, gift cards or wire transfers to secure a job or as part of an assigned duty by a new employer.

Since the pandemic hit Florida, Attorney General Ashley Moody has issued more than a dozen Consumer Alerts to help Floridians avoid COVID-19 related scams.

Anyone who believes they are the victim of hacking or a COVID-19 related scam should contact the Florida Attorney General's Office at 1(866) 9NO-SCAM or MyFloridaLegal.com.

Attorney General Moody Takes Action to Stop COVID-19 Grant Scam Targeting Seniors

TALLAHASSEE, Fla.—Attorney General Ashley Moody is issuing a Consumer Alert to warn Floridians about a new scam targeting seniors with offers of fake COVID-19 grants. The Florida Attorney General's Office is receiving reports from seniors offered thousands of dollars in federal grant money to stay isolated at home to prevent the spread of COVID-19. Scammers are contacting seniors via Facebook Messenger, email and text message to offer these sham grants and request upfront payment as insurance for the

expedited delivery of grant money.

Attorney General Ashley Moody said, "This scam appears to involve an international criminal organization utilizing a multifaceted communications plan to deceive seniors. These criminals are hacking Facebook accounts to send messages to targets from a friend's profile—creating the illusion that the grant program is being promoted by an acquaintance. Once contact is made, the criminals request personal information, bank account numbers and insurance payments purportedly to help ensure the safe delivery of thousands of dollars in federal grant money, and of course, the money is never sent."

"Sadly, we have uncovered evidence that some are falling for this scam. Please know that the federal government is not contacting seniors and offering them grant money to stay home and stop the spread of COVID-19. We are actively working with law enforcement to investigate and stop this scam. You can help us by reporting suspicious messages to our office."

The scheme involved a mock website, since shut down, purporting to be hosted by the U.S. Department of Treasury. The site included videos of seniors endorsing the sham grant program. As part of its active and ongoing investigation, Attorney General Moody's Office worked with law enforcement partners to have the sham website removed; yet there are concerns that scammers will simply move the site to a new location online. The recently disabled website address is <https://usafederalgrantclaim.wixsite.com/g>

rantinfo. Anyone who provided information and payments after visiting the site should contact the Florida Attorney General's Office.

To avoid this new COVID-19 federal grant scam

- Know that the federal government is not contacting seniors and offering them grants to stay at home and stop the spread of COVID-19;

• Remember, requests for upfront payments of any kind, including through gift cards, money orders, wire transfers, bitcoin or insurance fees in exchange for a grant, loan or government benefit are red flags of a scam;

- Be wary of any COVID-19 related offers received via Facebook, even if the offer

appears to come from a familiar account. Hackers can hijack social media accounts and send the account holders' friends or followers deceiving messages;

- Never click on links sent in unsolicited messages. These links could contain malware or connect the target to a website set up to obtain personal or financial information for nefarious purposes; and

• Watch out for websites or messages containing typos, grammatical mistakes or awkward word choices. Many sham websites are created by foreign scam artists struggling with the English language. Typos and grammatical mistakes in messages purporting to be from the government are red flags that a message is from an imposter.

Need for Donor Registry

Need for Donor Registry Prompts Nobel Nomination

(NewsUSA) – When Dr. Bart Fisher's son, Ivan, was diagnosed with a rare blood disorder in 1983 at eight-years-old, the only cure was a bone marrow transplant. However, at that time, there was only a small bone marrow registry in England, with 50,000 names and, in the U.S., no registry at all to find a match. Since Ivan's death, Dr. Fisher has made it his mission to establish large marrow registries around the world that would provide the gift of life to those in need of marrow transplantation.

Underscoring the need for a donor registry is the fact that every nine minutes an American dies from a blood cancer such as leukemia, lymphoma, or myeloma. In 2018 alone, there were 174,250 new blood cancer cases. "I tried to take a personal disaster and turn it into a mechanism that could save the lives of others needing a marrow match," says Dr. Fisher, a Washington D.C. lawyer, and PhD. Now, due in large part to Dr. Fisher's efforts, the National Marrow Donor Program and other marrow registries match voluntary marrow donors with patients in need of a bone marrow transplant, as well as those who have marrow failure. Since the formation of the program in 1986, more than 80,000 transplants have taken place as a result of matches found by marrow registries and over 6,200 transplants a year are performed. According to Dr. Robert K. Stuart, Ivan's doctor, the registry was needed long before it became a reality. "The skeptics said we need to develop the technology before we would be ready for a registry. But

what people don't realize is that creating the registry is what drove the technology development. We would not be where we are if we had waited to create the registry later," he says. In addition to his work to create an international registry, Dr. Fisher co-founded the Give Life Foundation, which seeks to expand the base of voluntary organ donors for the worldwide registries. In turn, the



Foundation has launched the Swab for Life campaign, a program that promotes registries through pharmacies, dentists' offices, and doctors' offices. For his tireless efforts, the Aplastic Anemia and MDS International Foundation (AAMDS) has nominated Dr. Fisher, its founder and a member of its Board of Directors, for a 2019 Nobel Prize in two categories: peace and

medicine. "The Nobel Prize nomination recognizes the significant contributions of Dr. Fisher to the establishment and growth of marrow registries around the world, and we are pleased and honored to support his efforts to advance this life-saving cure for aplastic anemia, leukemia, and other blood cancers," says Neil Horikoshi, executive director and CEO of the Aplastic Anemia and MDS International Foundation. "I am honored to receive this nomination on behalf of my son, knowing that the work I have done has helped thousands of people in need. 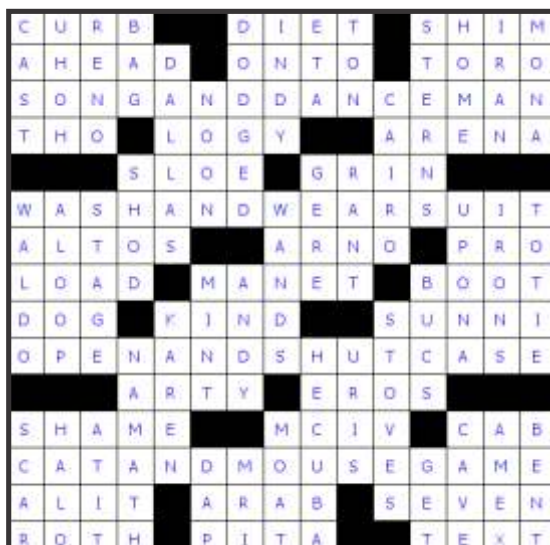
