The Bond Conundrum

When you think of investing in bonds, you tend to think "safe", "reliable" and "boring". Bonds are the asset class that lets you sleep at night and provides a good balance to stocks in a portfolio, particularly during turbulent periods. Yet, over the past decade, most bond sectors have outpaced the S&P 500 Index return with lower volatility and a healthy income stream. After the credit crisis of 2008-2009, the Federal Reserve embarked on a massive stimulus program which lowered interest rates to historic levels.

This action further accelerated the appeal of bonds and helped to produce above average returns. While looking in the rear view mirror is easy, it is deciphering what's ahead that can be difficult. Some investors are now starting to ask whether the heyday for bonds is over and if now is a good time to be investing or holding bonds in their portfolio.

There is also a growing sentiment among some market prognosticators that the Federal Reserve's policy of keeping interest rates at historically low levels has inflated Treasury bond prices to a point of creating a "bubble" that will eventually burst and hurt all types of bond securities. The Fed has kept interest rates low in order to stimulate borrowing in the midst of the economic malaise. Even with worries about the United State's ability to deal with its deficit problems, the U.S. bond market has continued to be the safe haven for many investors. Now, investors are becoming concerned that once the Fed's stimulus is reduced or removed from the economy, interest rates could rise to a more "normal" level. If this occurs, bond prices could fall precipitously as a result (bond

AS I SEE IT

It's not ALL good news, but the ongoing USA recovery, since the Presidential election last year has continued into 2013.

Here's a few news items:-

- Construction of new homes has climbed almost 12% - the best since 1992.

- Caterpillar Inc. (CAT), says, “The United States, is increasingly optimistic. We expect the U.S. housing industry to help the economy in 2013.”

- Property values in 20 U.S. Cities have increased 5.5 percent, the biggest gain since August 2006.

- The strengthening world economy will

bolster American exports, which means more jobs for Americans.

- Economic growth in China increased last year for the first time in two years, raising demand for U.S. goods.

- The World Bank says that developing nations are projected to expand 5.5 percent in 2013, more than last year, while Europe stabilizes.

- Even giant General Electric Co. (GE)'s fourth-quarter profit exceeded analysts' estimates.

- Richard Moody, chief economist at Regions Bank said, “I think we're really on the

verge of a self-sustaining recovery,”

- Several economists have said that they expect average monthly job gains of 171,000, with the pace quickening later this year. Unemployment will fall by year's end.

- After gaining an average 157,000 jobs a month, the economy will add 184,000 a month by the end of the year.

- Congress and the White House averted a worse fate by agreeing in January to keep income taxes stable for households earning less than \$450,000 a year.

- Economists expect the effects of the federal cuts to fade by the fourth quarter, with growth picking up to about 2.7%. Housing markets are rebounding and the Stock Market is rising which boosts consumer wealth

- The European financial crisis is easing, and Corporate America is cash-rich.

- Allen Sinai of Decision Economics, was quoted as saying, “The most positive development is that households have worked off much of the debt that hampered their spending in recent years”.

- Employment grew again in January.

- November job creation rose from the originally reported 161,000 to a whopping 247,000, while December was pushed upward to 196,000 from 155,000.

- “The gains we've received on the January jobs report are the start of positive readings for the foreseeable future,” said Todd Schoenberger, managing partner at Land-Colt Capital.

- Retail led the way in January with 33,000 new jobs; construction rose 28,000, and health care added 23,000 jobs.

- One pundit observed “Unfortunately, the Republican Congress appears once again poised to make matters worse, with automatic budget cuts that will inflict harm on the economy—and on America's working families.”

- There are many signs that the American jobs picture is clearing up, despite the fears of what Washington might do.

- For the first time in nearly two years, the average duration of unemployment made a significant move to the lowest since January 2011.

- Another key point, wages rose 4 cents an hour to \$23.78, representing a 2.1 percent gain over the past year.

- Many recent economic reports, show an economy on the mend.

- Interest Rates? - The Federal Reserve is tied directly to the jobless rate. The U.S. central bank has said it will not alter its zero interest rate policy until the jobless rate falls to 6.5 percent and inflation eclipses 2.5 percent.

- The recovery is not limited to the USA. Europe's main indexes are rising in a reaction to the positive trends of the Nikkei Index in Japan and there have been rises in Australia and Korea as well.

- Even our local, Republican influenced newspaper has reported that GOOGLE shares have zoomed past \$800/share for the first time ever.

- And that Home-builder confidence has been at a 6-year high.

- As I See It, the right-wing media will

LION OR LAMB?

March “comes in like a lion, out like a lamb” from old weather folklore of the 17th century, or as astrologers note, the constellation Leo (the Lion) is on the

eastern horizon at sunset at the beginning of the month and by the end of the month Aries (the Ram) is on the western horizon. In recent years it seems as though it is the other

way around. Whatever the case, it is a transition time from winter to spring. With that I would like to transition from last month’s article on having a heart to this month starting a series on having a mind, as the heart does influence the mind. We can reverse the devastating predicted future prospects that are in store for us according to statistics, but only if we take care of our mind now. To do this we need to start with the brain, and understanding the fundamentals of memory.

Shakespeare was quoted as calling the memory “the warder of the brain”, being in charge of keeping watch over your personal account of being. If your memory

fails, your own record of self is endangered. This can be a frightening prospect. Memory loss can range from the simplest age-related impairment to several types of dementia. Dementia cases worldwide are expected to triple by 2050. As of 2010 there were 35.6 million people with dementia, with 115.4 million cases expected by 2050, and with \$604 billion currently estimated as the annual cost of care. Alzheimer’s disease, the most common form of dementia, affects 5.4 million people and is the 6th leading cause of death in the US. Although Alzheimer’s disease is irreversible, recent research has indicated there are improved treatment protocols on the horizon. Memory impairment associated with other conditions, such as depression, thyroid problems, sleep apnea, insufficient insulin levels, lack of exercise, overuse of prescription and over the counter medications, etc. may be correctable.

All memories are the result of signals that pass through an estimated 100 billion nerve cells called neurons. “Normal aging” causes some of the neurons to shrink, while others can be disabled by free radicals, high blood pressure or elevated LDL cholesterol levels, etc. Memory is stored throughout the brain, but certain areas, such as the cerebral cortex

and cerebellum, store most of this information, and a structure called the hippocampus (Greek for “seahorse”) evaluates incoming data from your five senses and determines whether to store or discard this information. We know this because of new, sophisticated brain imaging procedures that allow us to watch specific areas of the brain “turn on and off” as a person performs various types of mental activity. People with brain injuries have also helped researchers identify different aspects of memory and a neurological test known as an event-related potential, a form of an EEG, has shown promise in assisting in evaluating the brain’s electrical activity.

Now what does this mean for you? Although medical science has made advances in the diagnosis and treatment of these memory problems, you must be your own health advocate and take a proactive stance in doing what you can for yourself. We will discuss aspects of the book “When Doctors Don’t Listen” in this regard and the role chiropractic plays in assisting you to be a lion, not a lamb!

“The Truth About Elections”.

Facts are stubborn things and are still true contrary to how many articles you see stating otherwise. Over the past several months, there has been much debate

over 2011 House Bill 1355 regarding the elections process. Due to several contradictions in reporting and public opinion, a few more facts need to be restated.

1. As sponsor of HB1355, I never had a conversation with anyone about voter suppression. The election law update was always about preventing mishap and mischief, protecting voters from having their vote stolen and simplifying the process. That's a fact!

2. Most supervisors did not use, and many did not need, all of the early voting sites approved. That's a fact!

3. Provisional Ballots are real ballots and do count if determined to be an eligible voter. They do not count if the voter was determined to be ineligible. They are a very polite way to deal with people who show up to vote but are not showing on the precinct roll and their eligibility can be determined. Without them, ineligible votes would be

counted or eligible voters might be turned away. That's a fact!

4. Early voting was not diminished by one hour. The number of days was compacted from 14 to 8 for efficiency sake! That's a fact!

5. Sunday before Election Day voting was provided in only 10 of 67 counties before HB1355. Recent testimony by numerous supervisors before the new elections and ethics committee verified that a majority of them use Sunday and Monday to set up the Tuesday General Election format. That's a fact!

6. Of the 67 counties, 62 performed on time and 5 under performed. It is not a state-wide problem. Marion County Supervisor's staff was done and looking for the door at 10pm. That's a fact!

7. The access to pick up an Absentee Ballot, complete it, and give it back to the clerk at the supervisor's office really gives thirty days of early voting. An absentee ballot is an early vote. That's a fact!

8. The length of the ballot is a function of how much public policy the voters are allowed to express themselves regarding. All voters get a sample ballot, so they can prepare their response. That's a fact! (If you think this ballot was long, just think how long your ballot would be if Hometown Democracy had passed!)

At the end of the day, it comes down to

logistics. We can vote the whole state in four hours if enough voting stations are provided at the polling sites and if precincts designated are not over-populated.

In spite of these facts, let me make clear my confidence in Chairman Boyd and Chairman Latvala, the leaders of the respective Committees over election legislation,

to reach reasonable changes in our election law to facilitate success. We want it to be easy for eligible voters to vote and hard for ineligible voters to cheat. I will be ready to support any changes that will accommodate that end without compromising the integrity of the result. That is always the objective in a Democratic Republic.

prices move inversely to interest rates). Before you convince yourself either way about the future of bonds in your portfolio, let's take a deep breath, think rationally and review the role bonds play in a portfolio: The first is for Diversification. Bonds tend to be less volatile than stocks and can therefore stabilize the value of your portfolio during times when the stock market struggles. Having a combination of both types of investments over the long term can often provide comparable returns with less risk than a portfolio devoted to only one type of investment. Second is for Stability. Price fluctuations in bonds tend to be much lower as compared to stocks. Since a large part of bond returns comes from interest payments, the value of bonds tend to stay relatively stable. Next, bonds provide Consistent Income. Unlike stock dividends, coupon payments are consistently distributed at regular intervals. Individuals seeking this consistent income might find bonds a better alternative than the dividend payments some stocks offer. Finally, an investor could save on Taxes. Payments from some bonds are exempt from federal taxes. For individuals in high tax brackets, these investments are often an excellent vehicle for their portfolio. Over

the past few years, bonds have benefitted from an accommodative Federal Reserve along with risk-averse stock investors. The low yielding alternatives such as CDs and money markets have further added to the allure of bonds. As the economy continues to strengthen, it is likely that the level of interest rates will revert back to a more normalized level. That would put the yield on the 10 Year U.S. Treasury bond at around 3.5 to 4.0 percent, as compared to around 1.9 percent today. If this transpires over years, it would crimp bond returns and not be catastrophic, since the income provided by bonds should also rise. If yields rise over a shorter period of time, bond returns would be hit harder. No one has a crystal ball and the market seldom proceeds down a rational or expected path. In our best assessment, based on the current monetary and economic environment, and after many years of above average returns in bonds, we expect yields to steadily rise over several years.

We do not expect a sudden and violent rise in bond yields. Under our modest rise scenario, total returns in bonds would roughly equal the underlying coupon rate on the bond. While not great, it is far from catastrophic and should be looked at as an opportunity to invest in higher yielding bonds

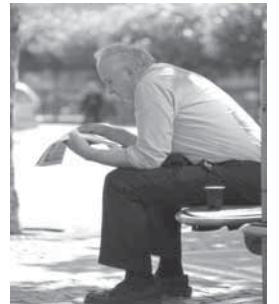
at some point in the future. For most investors, it is prudent to review your bond holdings to ensure there is proper diversification and determine whether changes are in order. However, remember why you hold bonds in the first place and the many positive attributes they provide to your overall portfolio. for those courses in Marion County. We also have volunteers doing the same job in Lake and Sumter Counties. We offer Driver Safety Courses in all three counties as well as nationwide on a regular basis. As a volunteer program we do not have the funds to pay for advertising but, most of the local media post our monthly schedules for the benefit of the seniors in the area and it appears your publication is focused on the age group most likely to take our courses.

Our courses are held at host locations who provide the room and visual display equipment and we provide the instructors, workbooks, CDs and certificates for successful completion. Florida Statutes mandate that auto insurance companies offer a discount for successful completion of a State approved course (discounts vary by company). The courses are 6 hours in length and are scheduled by agreement between the instructor and host. The courses cover the changes in, not only the roads and driving conditions that change, the changes in our vehicles but, also the changes we all encounter as we get older. They also cover changes in the laws and include many safety suggestions. The cost of the courses is \$12 for AARP members and \$14 for non-members. This cost is

nearly always less than the annual discount for the participants auto insurance and the discount is for three years.

Attached please find a copy of the news release we posted in local media for February. I would like to be able to post a similar course listing in your monthly issue. If this is agreeable to you please let me know and I'll make sure the news release is sent to you in plenty of time for your March issue.

FLORIDA WORKING TO KEEP TRADE GROWING

Rule Changes to Streamline Truck Permitting and Gain Parity with Other States on Load Limits

TALLAHASSEE - Governor Scott announced that in order to capitalize on the expansion of the Panama Canal and to strengthen Florida's position as a leader in international trade, the Florida Department of Transportation (FDOT) implemented administrative rule changes to reduce the regulatory burden on trucks, while protecting the integrity of Florida's infrastructure and preserving our commitment to safe mobility on our roadways.

The implemented administrative rule changes will:

- Streamline the permitting process for applicants
- Provide the same level of service to both trip and blanket permit applicants by eliminating the requirement for trip permit applicants to submit a height survey letter prior to obtaining a permit for vehicles up to 18 feet in height
- Increase the number of days for which a trip permit is valid from 5 days to 7 days
- Increase the maximum gross vehicle weight allowed for sealed containerized cargo units from 95,000 pounds to 100,000 pounds, and
- Reduce the number and/or type of escorts required when traveling on a limited access facility.

These changes advance Governor Scott's


vision to make Florida the trade gateway for America. A properly permitted sealed truck container can now haul the same weight levels as other surrounding states thereby allowing Florida's farmers and manufacturers to ship and receive goods through Florida ports that previously went through other states, therefore more jobs for Florida families.


Governor Rick Scott said, "In the last three years, we've invested \$421 million in Florida's ports to make our state a hub for global commerce and job creation. In addition to our investments, we've eliminated 2,300 onerous regulations that hamper businesses growth - and created an environment where businesses can grow jobs for Florida families. By streamlining operations we'll better position Florida to capitalize on the increased trade opportunities that the expansion of the Panama Canal will bring to our communities."

FDOT Secretary Ananth Prasad said, "By implementing these rule changes, we are not only enabling freight to flow better but ensuring that Florida remains competitive. A level playing field leads to more business opportunities and good jobs for Florida families."

Roy Schleicher, JAXPORT Interim CEO said, "This move sends the message to our private sector partners that this state is good for their business and we will work to remove unnecessary obstacles so they can grow along with us. Clearly, JAXPORT

will benefit as we compete head-to-head with ports in other states for cargo; cargo which will bring jobs and dollars to North Florida.”

The Department's Office of Freight, Logistics and Passenger Operations and Office of Maintenance are focused on freight and trucking issues and are constantly working with the motor carrier industry and other stakeholders on ways to streamline processes without compromising public safety.

Louisa Lee, Regional Sales Manager for Norton Lilly International (agents for SeaFreight Line) said, “The State of Florida increasing their over the road weight limits

to match those of surrounding states allows Florida ports and carriers like SeaFreight Line to compete on a level playing field with regards to cargo weights with other South Atlantic and Gulf ports such as Savannah, Charleston and Mobile.”

Mary Lou Rajchel, President and CEO of the Florida Trucking Association said, “Florida's ports and freight distribution systems are vital components of the state's current and future economy. The Florida Trucking Association supports the Governor and the Florida Department of Transportation in their efforts to make Florida's freight logistics system more competitive with our surrounding states. As an essential industry

that is the sole means of supply for more than 80% of the state's communities, Florida's trucking industry appreciates the critical role trucking plays in this equation. To that end, we look forward to the increased opportunities for collaboration and enterprise that will result from this increase in weight limits for containerized freight.”

Gov. Rick Scott said Wednesday he wants to earmark roughly \$4.5 million in the state budget to fight human trafficking and help victims recover in a safe place after they're rescued.

The bulk of the money would create 30 rape crisis centers statewide and help improve law enforcement response to crimes of rape and sexual abuse. Another \$1.5 million will also provide victims of sex trafficking with a safe place to rehabilitate instead of charging them with prostitution or hold-

ing them in juvenile detention facilities. The “safe houses” around the state will help victims heal in a therapeutic environment, officials said.

During a press conference in Miami with Scott on Wednesday, juvenile justice and child welfare officials also announced they are expanding a pilot program that helps identify sex trafficking victims.

Department of Juvenile Justice Secretary Wansley Walters said Florida is the first state in the nation to attempt to identify victims immediately upon arrest.

TALLAHASSEE— Governor Scott announced the number of available online job openings in Florida increased by 27,979 in January 2013. That is a 12 percent increase over the year, for a total of 255,749 openings (seasonally adjusted).

Governor Rick Scott said, “With more than 255,000 job openings available in our state, it's clear the decisions we're making are helping employers feel more confident about the future of their businesses. My Florida Families First Budget lives within our means while continuing our progress of job creation by providing a quality education for every Floridian, ensuring we have a talented workforce available for current and future employers and improving the state's business climate to facilitate job creation. Ensuring that every Floridian who wants a job, gets a job remains my number one priority.”

Florida's labor demand, measured by online advertised vacancies, bottomed out in April 2009 at 151,251 ads and has increased by 104,498 openings (+69.1 percent) since then.

According to the Help Wanted OnLine data series from The Conference Board, online job demand was strongest in the large metro cities, led by Miami, Orlando, Tampa, and Jacksonville. Among the cities with the most online ads, the highest percentage gain over the year in online ads was in Miami (+26.3 percent).

Major occupational groups with the most online ads in January were healthcare practitioners and technical occupations; sales and related occupations; office and administrative support occupations; and computer and mathematical occupations.

The Florida Department of Economic Opportunity combines the state's economic, workforce and community development efforts. This new approach helps expedite economic development projects to fuel job creation in competitive communities. port state and local law enforcement in the areas of high tech crime and Electronic Surveillance Support Teams. The Governor also highlighted the Department of Juvenile Justice's "Victim Identification Pilot Project," – a program that's the first-of-its-kind in the nation that identifies trafficking victims and coordinates support services.

Governor Scott said, "As a father of two daughters and a grandfather, I take the health and safety of Florida's families seriously. We've made progress in making our communities safer and FDLE recently reported that Florida is at a 41 year crime low. The Department of Corrections also announced the state's recidivism rate has decreased from nearly 34 percent to nearly 27 percent

over five years.

"While these figures demonstrate that we are improving in our efforts to protect Florida families, the reality is that even one violent crime is devastating. We are committed to making our communities even safer."

Human trafficking is a form of modern day slavery that affects more than 27 million people worldwide, including an estimated two million children who are trafficked for child labor and sexual exploitation. In the United States, the Polaris Project advocacy group estimates approximately 100,000 kids are currently trapped in the commercial sex trade of human trafficking.

To better protect children, Governor Scott signed the Safe Harbor Act and HB 7049 to help fight human trafficking by increasing

the prosecution of criminals who exploit children and also provide better services to the victims who are rescued from this heinous crime.

Last year, the Department of Juvenile Justice took steps to support children by creating the "Victim Identification Pilot Project" to identify victims of sex trafficking and coordinate with the Department of Children and Families to get children in a supportive environment where they feel safe. The program is the first-of-its-kind in the nation and was implemented in Broward County and later in Miami-Dade County. DJJ Secretary Walters has announced the pilot's further expansion to Orange County this year.

Governor Scott continued, "To support these kids, I'm proud to announce today that my Florida Families First Budget invests an additional \$1.5 million to provide trafficked youth a safe home, so they can begin to heal from the trauma they experienced. Our budget also invests nearly half-a-million dollars on top of current funding to support state and local law enforcement in the areas of high tech crime and Electronic Surveillance Support Teams."

First Lady Ann Scott said, "As a mother and grandmother, a topic like human trafficking is heartbreaking. I am proud that so many good-hearted people are committing themselves to helping victims of this horrific crime. Last year I visited the Kristi House in Miami and was amazed at the wonderful work that they do with children who have been victims of abuse. We cannot let that heartbreak silence our voices, and I'm proud

of my husband's commitment to helping the victims of trafficking."

Department of Juvenile Justice Secretary Wansley Walters said, "Through his Florida Families First Budget, Governor Scott's clearly illustrated his commitment to ensuring Florida's at-risk youth and their families have every opportunity to succeed. I am truly honored to be part of Gov. Scott's team as Florida leads the nation in anti-human trafficking efforts and invests in the futures of Florida's families."

DCF Secretary David Wilkins said, "This budget will help improve the lives of Florida's families by increasing funding to services for those in need and providing better access to help for victims of sexual violence, human trafficking, homelessness and more. Through the Governor's recommendations, our agency will build on the transformation we've begun to focus on assisting Florida's most vulnerable children, adults and families."

Miami-Dade State Attorney Katherine Fernandez Rundle said, "I am so glad that Governor Scott, and Secretaries Wilkins and Walters will join me to keep public attention focused on the ugly and horrific crime that is Human Trafficking. Florida, being one of America's great trendsetting states, is now moving to building the infrastructure that recognizes the particular needs of its victims. The victims of Human Trafficking, so often our own children, will benefit from the things we do today and in the future."

"Sex trafficking of a child is the most

severe form of child sexual abuse, where children seek love from the only family they know – their pimps,” said Trudy Novicki, Executive Director of Kristi House. “The proposed budget and the increased attention from Gov. Scott and his administration will help us prevent this crime and help the victims.”

T. Willard Fair, President and CEO, Urban League of Greater Miami said, “Proactive and vigilant prevention programs are the key to keeping youth out of the juvenile justice system. Such programs save millions of taxpayer dollars and the lives of our troubled youth. Governor Scott and Secretary Walters recognize that in their approach to juvenile justice.”

Stacy Gromatski, President and CEO, Florida Network of Youth and Family Services said, “If our goal is to prevent and divert troubled youth from entering the juvenile justice then Governor Scott and Secretary Walters are on the right track. In Miami, the budget invests more than \$618,000 to expand the PACE Center for Girls to Miami-Dade County, which will provide educational services designed with girls’ specific needs in mind. With the investment, PACE will work with its private partners to grow services to young women in Miami community who need a strong support network.

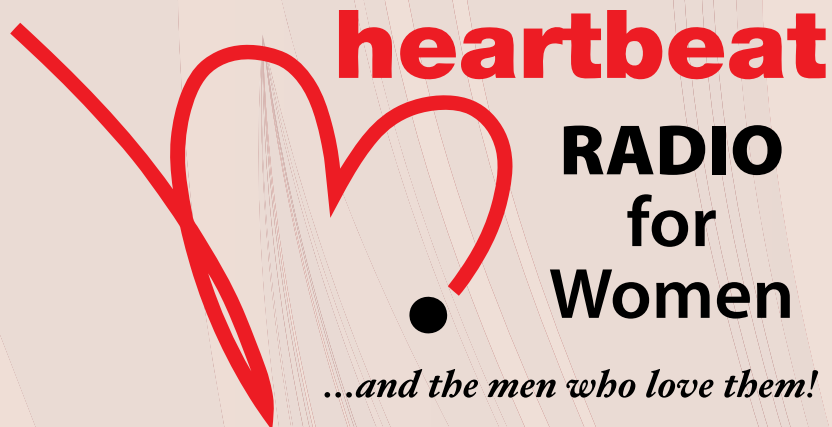
