He said he should not have sat through the interview; that he had compromised all they have tried to do in letting the Town Manager how to do her job without interference. Anyway the Council agreed to put the vote of the Town Charter review which has not been done in 40 years on the meeting agenda. Commissioner Hannon has been bringing the Town Charter discussion up for a long time. It is on record that several of the Commissioners have said that they have read the Town Charter. First the Town Charter is out dated; second I have been looking on the internet for a legal description for a Township and there are actual boundaries but it takes a legal mind to understand them. As I understand it, a Village and a Township are similar. That is why there are community Development Districts in the Villages. According to the state statues, if area or village is under a certain number of residents they don't have to come under certain state

It was suggested just Lady Lake Residents. The review board would need to have an attorney. During the discussion the Mayor said if the board makes suggestions on changing something, what are you going to do? I would guess the Town Commissioners would vote to yah or nay it, but stop hiding behind something that has not been reviewed in 40 years. You could be doing something wrong that has changed years ago making the town liable for a stiff fine. Get it reviewed, ask for a legal ruling on how you are doing things and make sure you are doing your job right by today's

standards and not the good old days when life was a lot harder but more real!

The next meeting was held and a vote to review the Town Charter was made. The vote was three to two. The Commissioners started discussing who would review the Town Charter; many views come into play, but they finally decided to have seven on the committee: at least one from each district and at least two business owners. Friends, This past week I had the pleasure of attending a private early showing, thanks to my good friend Senator Kelli Stargel, of the new major motion picture "Unplanned". The movie tells the true story of Abby Johnson and

This powerful film exposes viewers to the truth of what happens in the abortion industry, and the emotional, physical and mental damage that can trap women (and men) in a prison of pain and guilt. The story also offer its viewers, whether they've been touched by abortion or not, a story of love, forgiveness and a hope for our future. Since the passing of Roe v. Wade in 1973, it has been estimated that there have been over 60



million legal abortions in the United States. Even just one is heart wrenching enough for me, but to think that we have extinguished the lives of millions of our own offspring is devastating.

This year, in New York and Virginia, we have seen the far left liberals, under the guise of being "progressive", take some of the most extreme positions on abortion law that is nothing short of infanticide. However, I am optimistic that these radical proposals are beginning to further open the eyes of the American people to the true agenda of these "progressives", and the consequences that they will have on our society. In Florida, we have a Governor who is staunchly pro-life and our court system is ripe for new

legislation to combat the liberal agenda. Here in the Florida Legislature, there are three big pro-life proposals that I want to highlight for you.

SB 792, also known as the "Heartbeat Bill", is the legislation that your Senator has filed for this year. Along with a companion bill in the House, filed by Rep. Hill, this legislation would prohibit the termination of a pregnancy once a fetal heartbeat can be detected. SB 792 also requires a physician to perform an examination for, and inform a woman seeking to obtain an abortion of the presence of a fetal heartbeat. I think that this legislation is one that the left fears the most, because it is so real, simple, and convincing. In the history of humankind, the heartbeat has always been the clear signal that life is present. It is a signal that connects us so well to our own human emotion and conscience, because it can be physically seen, felt and heard.

SB 1774, known as the "Parental Consent for Abortion Act", filed by Senator Stargel, prohibits a physician from performing an abortion on a minor unless the physician has been presented with consent from the minor's parent or guardian. Your Senator as also co-sponsored this bill.

SB 558, the "Florida Pain-Capable Unborn Child Protection Act" filed by Senator Joe Gruters, prohibits a physician from performing the abortion of an unborn child that is deemed capable of feeling of pain. In the bill, an unborn child is defined as being pain capable at 20 weeks post-fertilization.

I am excited about the opportunity that we have to protect innocent life, and each of these pieces of legislation has the potential to make a big difference in our fight against abortion. It is an honor to be your Senator, thank you for allowing me to be "the man in the ring" and for sending me to Tallahassee to protect innocent life.

## Earthquake in Florida

It is said by seismic activity specialist the quakes could be related to natural or human activity but did not confirm or deny that they were connected to oil drilling in the area.

Local meteorologist provided earthquake coverage said they had been in contact with USGS geophysicists, and that it is next to impossible that oil drilling or fracking directly caused the earthquakes.

"Our area lies along a normally inactive fault line known as the Bahama Fracture Zone. Earthquakes generally don't happen along this fault. Seeing minor activity like this is not uncommon. It happened about 30 years ago. We are told they are part of normal seismic activity."

Sandy Ebersole, who heads the division of the Geological Survey of Alabama that



documents and studies earthquakes, said it's not uncommon to have multiple small-scale earthquakes back-to-back.

"We do have episodes of this kind of seismic activity clusters once in a while," Ebersole said in the article. "That's normal seismic activity for our area."

End the Fed and end corruption

What exactly is the Federal Reserve and why is the United States in perpetual debt with itself?

The Fed, simply the United States' central bank, was created in 1913 by the Federal Reserve Act under President Woodrow Wilson. This bill was conveniently presented when most of Congress had already left for Christmas break, leaving just a handful of Senators to vote. Not surprising it was unanimously passed. Congress was duped by the very people they were trying to disallow, and today America is \$22 trillion in debt to the successors of these bankers, or in short, the Fed.

America's debt grew exponentially after 2009 when the economy collapsed and the Fed bailed out big banks across the country, essentially preserving their own family fortunes. someone else.

**3. Learn:** Experts think that ongoing education and learning new things may help keep you mentally sharp simply by getting you in the habit of staying mentally active. Take a class from a senior center or community college, make it a habit to visit the library and pick up a new book each week. "Challenging your brain with mental exercise is believed to activate processes that help maintain individual brain cells and stimulate communication among them,"

according to Harvard Medical School.

**4. Finances:** A study published by The Journals of Gerontology found that "financial strain was a strong and robust predictor of worsening mental health" among older adults, including anxiety and depression symptoms. fraud and protect older Floridians from scams. They are also now playing an important role on [Florida's new Senior Protection Team](#).

The team is comprised of leading members from our Office of Statewide Prosecution, Consumer Protection Division and Medicaid Fraud Control Unit. Seniors v. Crime and the Florida Department of Law Enforcement are actively assisting the team with investigations and outreach efforts.

The goal is to bring attorneys and investigators specialized in fighting civil, criminal and health care fraud together to develop strategies to protect Floridians 60 and older.

## Use Online Reviews



### How To Use Online Reviews To Invest In The Best Technology For Your Office

Anyone who's in charge of purchasing

technology for a small business knows there's a bit of alchemy in the procurement process: You apply instinct. You ask your colleagues for advice. You research what the critics in the magazines say. Increasingly, you're also reading the online reviews on specialized sites.

Reading online reviews is a logical extension of how people once bought goods—through word of mouth. Technology, however, is even better, because it provides access to many more experienced.

Online reviews give depth and breadth. They explain the pros and cons of any product or experience. At their best, they're incredible tools, perhaps the best thing to have happened for consumers in decades. At their worst, they're a scam.

Consider this: A London journalist once created numerous fake reviews on a restaurant site and made his humble garden shed an opening-night restaurant hit.

As the manager of reviews for Capterra—a free site for software buyers to read objective and insightful reviews—I've learned how to navigate the world of online

reviews. Here are four top tips:

**Check to see if the site monitors its review:** Confirm the site has an FAQ page with transparent policy statements. Does it clearly state how the site makes money? Check to see if there's a way to report fake reviews. Make sure the site screens and reads all reviews before they go live. If it doesn't monitor reviews—or offer a way to report the fakes—the site isn't there to help you.

It's essential to report fake reviews because the reviews community depends on honest participation. When users share reviews, they help you to learn from their discoveries. Fake reviews tear at the fundamental trust everyone in the community must have in each other when they read and share online reviews.

**Look for verified reviewers:** Reviewers should be verified as being real people and actual customers. You'll also need to know if they're buying products for large enterprises or small businesses like yours. Knowing who's writing the reviews matters. As an example, think about when you're in the market for a new car, and you get a recommendation from a neighbor on the best vehicle to buy. Isn't it important to know if that neighbor prefers a plush, magisterial ride—or a sports car with tight handling for the side roads?

Verified reviewers should also be actual customers of the products they write about. No one likes a rubbernecker standing at the sidelines, making unqualified assessments. When users have either bought or demoed the product, however, they have something

to say. They know the product's pros and cons. They're often passionate about the product and want to share their experiences with you.

**Read the negative reviews but read them fairly:** Make sure to understand what's truly behind a negative review—it could be that one person's lemon is your lemonade on a hot day. For example, a honeymooner might not like a hotel that you, with kids, would consider a perfect vacation destination.

Negative reviews are most useful when you can find specific patterns: If most of the reviews say the company has an excellent product but substandard customer service, then take that into account before you decide to buy or move on.

**Also, look for a vendor response:** If the vendor hasn't responded to the negative reviews, then that's useful to know. When

the business responds to the reviews—if, for example, it says it's working to improve customer service consider that a point in its favor.

Remember that negative reviews are also a snapshot in time. Take into account recency and don't fault a vendor for something that occurred two years ago, especially if the vendor has responded to the negative review.

Be open to discovering new product: At Capterra, it's common for a user to come to the site looking for a marquee-name software product. But after some research, that user may then decide upon software from a smaller, less well-known provider. Often, it's because the product is better priced and better suited to the user's business. And usually, it's because others in the reviews community thought it was a better product.

Those software vendors that have a smaller footprint in the marketplace may have more utility and suitability for you. Be

open to the unexpected when you read reviews.

Finding the best reviews in a sea of bad ones is no small challenge, but online reviews offer you a chance to avoid the mistakes of others and gain from the wisdom inherent in online reviews. Use these tips to learn from reviewers who have honestly shared their positive and negative experiences. Use reviews to discover new products and services that can take your business to a new level.

## Plant-Based Nutrition

(NAPSI)—As people continue to look for ways to live healthier lifestyles, the plant-based diet continues to gain momentum. A plant-based diet describes a way of eating in which there is an emphasis on plant foods in the form of colorful fruits and vegetables, legumes and whole grains.

Benefits of eating more plant foods are numerous. Plant foods are nutrient dense, which means that they provide an abundance of nutrients relative to their calorie cost. ### How Much Protein Is Right For You?

Protein is important for maintaining lean body mass. Susan Bowerman, Registered Dietitian and Senior Director of Worldwide Nutrition Education and Training at Herbalife Nutrition says the Institute of Medicine recommends you eat 10 to 35 percent of your total daily calories from protein.

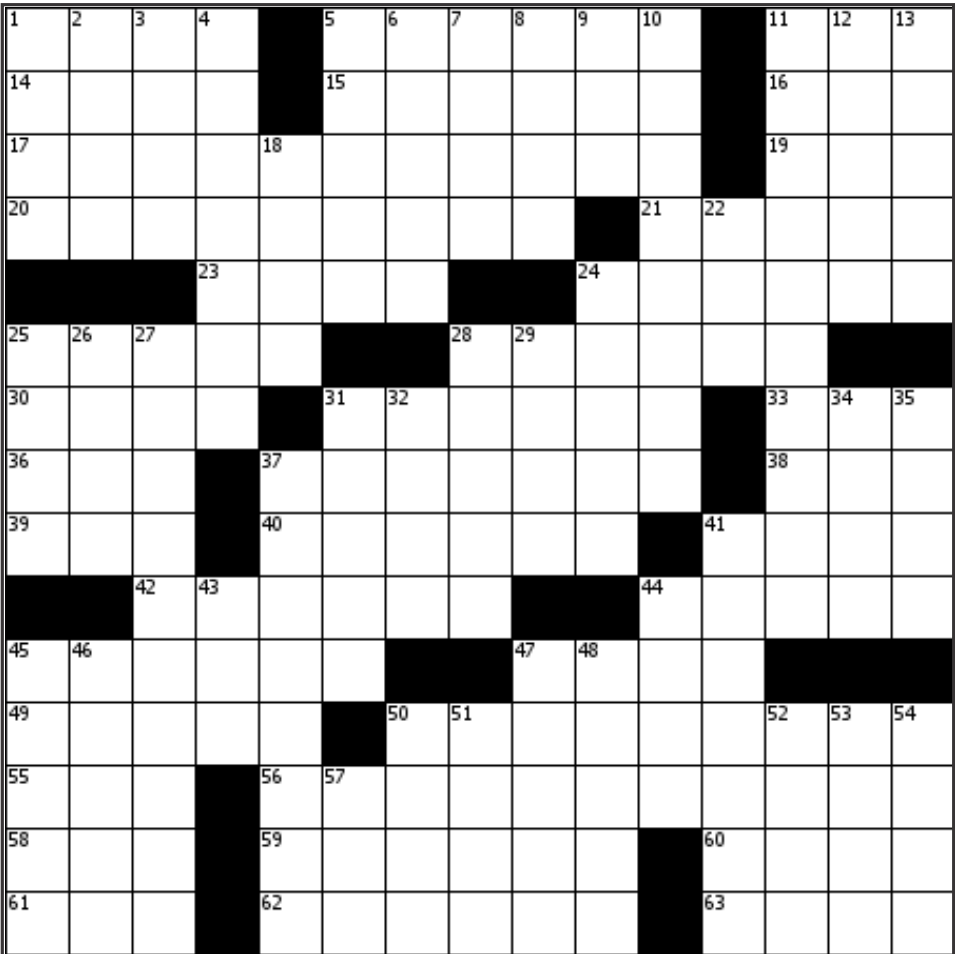

# Major Changes Headed To A Product Label Near You



## Major Changes Headed To A Product Label Near You

(NAPSI)—If you're like 90 percent of shoppers, you consult the Nutrition Facts panel on food packages before you buy. To make it easier to make informed food choices, the U.S. Food and Drug Administration (FDA) has developed a new Nutrition Facts label. Here are the seven major new features:

### 1. Increased print size for "Calories."

Calorie counts will be easier to see.

### 2. Inclusion of "Added Sugars."

The FDA currently defines *added sugars* as "sugars that are either added during the processing of foods, or are packaged as such, and include sugars (free, mono- and disaccharides), sugars from syrups and honey, and sugars from concentrated fruit or

vegetable juices that are in excess of what would be expected from the same volume of 100 percent fruit or vegetable juice of the same type." Sugar alcohols, or polyols, provide sweetness but aren't counted as "added sugars" because they're not sugar. These low-digestible carbohydrates can replace sugar as a lower-calorie alternative. Common polyols include erythritol, maltitol, sorbitol, mannitol, xylitol, lactitol, isomalt and hydrogenated starch hydrolysates.

### 3. Changing "Sugars" to "Total Sugars."

Sugar can be present in healthy foods. This change can help consumers understand the amount of sugar the product contains from any source.

### 4. Removal of "Calories from Total

Fat."

Research shows the *type* of fat (for example, polyunsaturated) is more important than the total calories from fat. Labels still include "Total Fat," "Saturated Fat" and "Trans Fat."

### 5. Increased print size for "Serving Size" and "Servings per Package/Container."

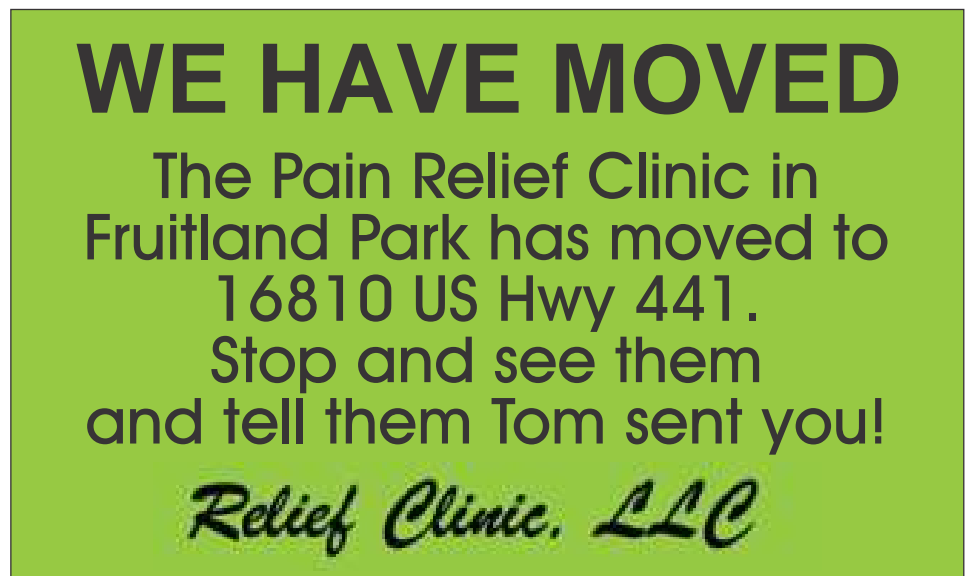
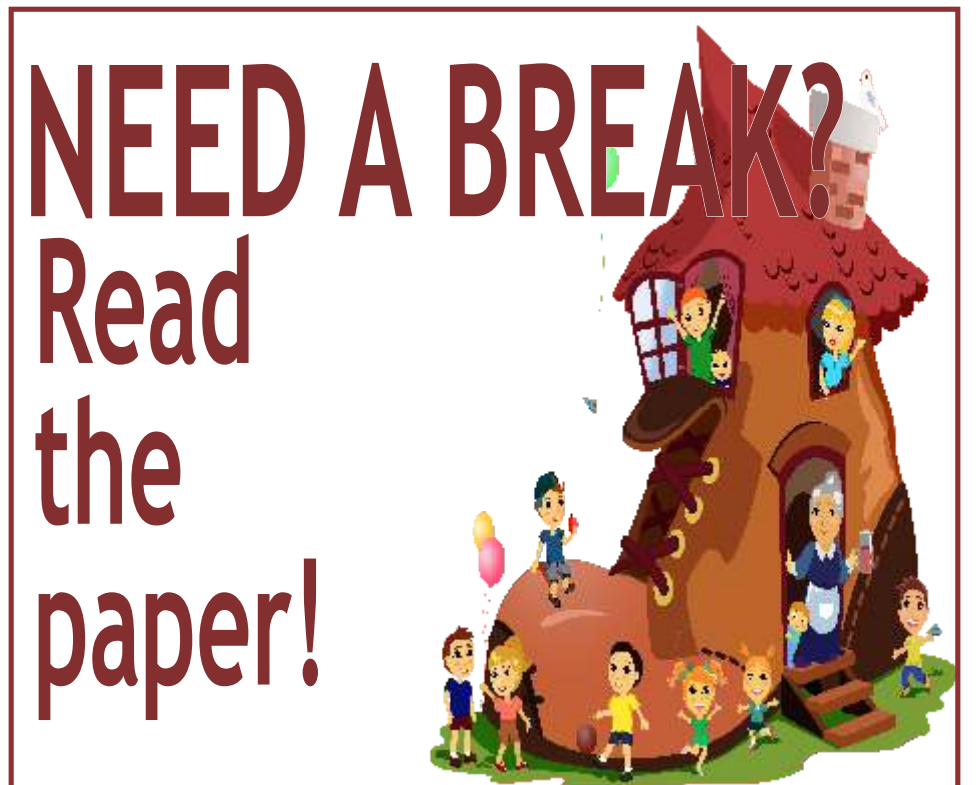
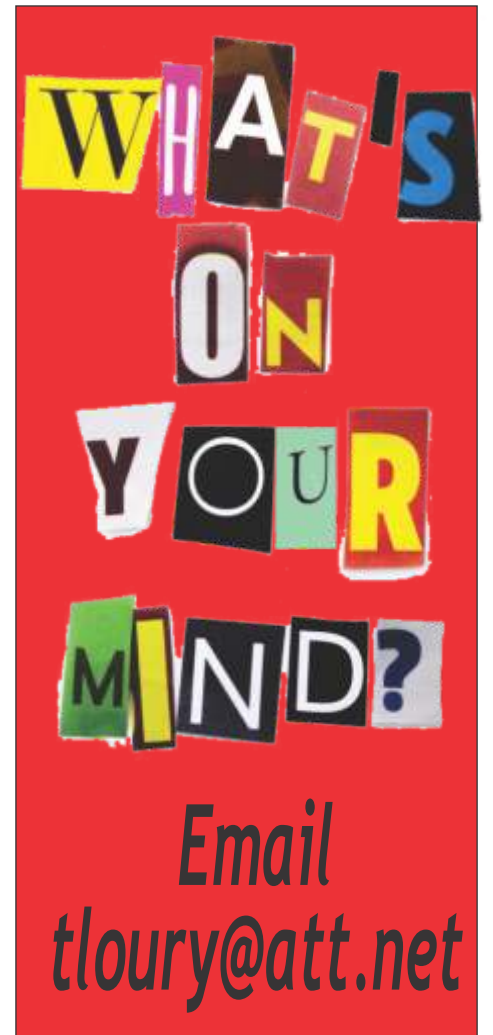
Portion control remains a problem for many. Increased visibility of recommended serving sizes can help people make better, more accurate decisions.

### 6. The amounts of vitamin D and potassium are now required, instead of vitamins A and C.

Based on research from the Institute of Medicine, the new labels will include this information to increase visibility of vitamin D and potassium requirements. Though voluntary, similar information for vitamins A and C may still be included.

### 7. Revision of "Percent Daily Value"

The new language will specifically state: "The % Daily Value tells you how much a nutrient in a serving of food contributes to a daily diet. 2,000 calories a day is used for general nutrition advice." Experts at the Calorie Control Council, a nonprofit association that seeks to provide objective, science-based communications about low-calorie foods and beverages, suggest that this revision may help clarify the meaning of "Daily Value".

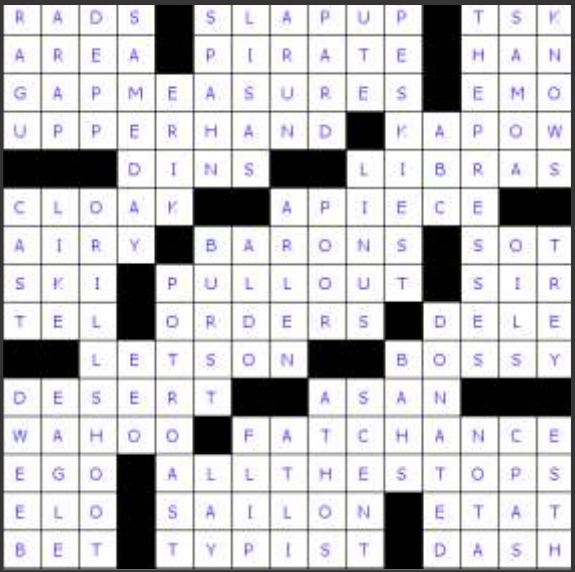
