As I learn and grow to become a part of these beautiful communities, I hope to be able to share with you my passion to serve not only as a great Chiropractor here in Ocala and in The Villages, but also a referring physician to help guide you towards the care you need and most

certainly deserve.

To begin developing my relationship with the beautiful people here, I find it would be fitting for me to share with you how and why I became to be so passionate about serving as a Chiropractic physician.

This passion has been developing for me since the age of 10 years old when I was involved in a severe motor vehicle accident in which the door of the car I was in was struck by a semi truck going 60 plus miles per hour. This resulted in a concussion, broken nose, and complete laceration of my upper lip and chin as well as some significant neck pain to follow. The pain soon wore off however even after healing from the superficial wounds, I was still unable to look all the way to the right due to the trauma to my neck causing a subluxation and or a restriction preventing me from that movement.

My mother, the wonderful loving nurse she is, insisted that I see a Chiropractor. I had been with her a few times before to watch as she was adjusted. The sounds I heard from her spine had more or less convinced me there was NO WAY I would let someone ever do that to me. However, I noted that she always talked about how much better she felt when she left. It's funny how a mother has a way of directing your care, especially being a nurse. Therefore I decided "Okay if mom says its safe, I'll give it a try". Still apprehensive and extremely nervous to say the least, I laid down to allow this Chiropractic physician an opportunity to fix my neck and restore full range of motion. The adjustment to my surprise was over before I knew it, and I was immediately able to move my neck further to the right. At 10

Just a couple months later, we returned home. I quickly discovered as I began to return to civilian life that I wasn't the soldier or man that I was before I left for Iraq. Not only the way I looked at life and the meaning it now had to me, but I began to have severe migraines with vomiting, sensitivity to light, hot flashes, loss of balance, and a pain that caused me to curl up with a bed pan or next to the toilet in a dark room. These migraines lasted anywhere from 4-72 hours as a complete shutdown, drastically changing my ability to not only be a productive member of society but just be myself and live life. I had seen several neurologist, had several scans of my brain and inner ear, even had surgery where they took a graft of skin

Social Security Benefits Increase in 2020

Each year, we announce the annual cost-of-living adjustment (COLA). By law, federal benefits increase when the cost of living rises, as measured by the Department of Labor's Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). Usually, there is an increase in the benefit amount people will receive each month, starting the following January.

Nearly 69 million Americans will see a 1.6 percent increase in their Social Security benefits and SSI payments in 2020.

Other changes that will happen in January

Florida State Senate

Friends,
This column comes to you from our desk in the Florida Capitol. That is right, our desk, not mine. This seat, this desk, belong to the people of Senate District 12 and it is very humbling for me to be here on your behalf today. It is never taken for granted the responsibility and trust that you have given to me to represent over 500,000 people in

our great State. We get to work on some big issues, that will affect all of you, and it is very important for you to be engaged and informed in our legislative process.

One piece of legislation that you should all be very aware of is one that was touched on briefly in my last column. In fact, this is probably the most important bill that will be filed all year in the Florida Legislature. SB 404, filed by Senator Kelli Stargel and co-sponsored by your State

Senator, is a bill that would require parental consent for minors seeking to obtain an abortion procedure. Current state law only require parental notification. Critics from the left have labeled this an anti-abortion bill that would infringe on women's privacy rights. Nothing could be further from the truth. This bill is quite simple. Parents must be involved in any medical decisions that their children undergo. In schools, your child is not allowed to take a Tylenol without your permission. At the movie theatre, your child is not allowed to see an R-rated movie about abortion (see movie: Unplanned) without your permission. Yet some people believe that these same children should be allowed to undergo a medical procedure,

without any input from the people who are held responsible for their safety. That is just not right.

My friends, this is not about pro-life versus pro-choice. My stance on those issues is well documented and I am very proud to be called a defender of life, but we need to put all of that aside for minute and recognize what we are trying to do here. This is about empowering families to be able to take care of each other. When a child is faced with that kind of situation, a father and/or a mother's involvement, no matter what decision is made, is so critical to that child's future and we must let parents take care of their children. Since there will be cases of minors who do not have family involvement, then this bill provides a way for them to petition a court, at no cost, and have their records remain completely confidential with no public access.

As this is being written, the bill was heard in the Health Policy Committee in the Florida Senate, and fifteen amendments were filed. All of them were given a fair hearing. We anticipate that this bill will pass that first stop and be heard in at least two more committees before it reaches the floor.

HOLIDAY SAFETY REMINDERS FROM THE LADY LAKE POLICE DEPARTMENT

As the holiday season approaches, residents in our community will be gathering with family and friends to celebrate. Whether you are traveling out of town or hosting holiday festivities at home, the Lady Lake Police Department wants you to be safe. Here is a security checklist to help protect your home and family.

Before you leave town it is important to make sure your home appears occupied. Place timers on your lights and set them to turn on and off at different times. Lock your garage door and disconnect the automatic opener. Most importantly, tell a trusted neighbor that you are going to be away and ask them to dial 911 immediately if they see anyone on your property.

Here are some additional home security tips to keep in mind:

- Be sure the locks on all doors and windows are still functioning properly and always use them. If not, replace them. The cost to do so will be less than the damage and theft from a burglary.
- Stop newspaper and mail deliveries while you are away from your home.
- Never hide a spare key outside.
- Give that spare key to a trusted neighbor

and provide them with an emergency telephone number where they can reach you.

- Have someone mow your lawn if you'll be away more than a couple of weeks.
- Turn down your telephone ringer so no one outside can hear repeated rings, and never leave a message on your telephone answering machine stating you are out of town.
- Leave your window blinds as you normally would if you were home.
- Invite your neighbor to park their car in your driveway or have a friend move yours if you left it at home.
- Try to avoid posting holiday travel plans on social networking sites, if possible. Even if you are not planning to travel, the holidays are also a time when the criminal element are looking to cash in at your expense. Here are some tips from the Lady Lake Police Department to help keep your home, your car, your possessions, and your family safe.

Keeping Your Home Safe

We all want our homes to reflect the joy of the season, but avoid displaying gifts where they can be seen from a window or doorway.

- Arrange to have packages delivered to a neighbor if you're not home to receive them. Packages left on porches or doorsteps are "easy picking" for thieves. It also draws unwanted attention to your home.
- Consider simple outside decorations. Elaborate decorations are sometimes stolen right off the lawn.

- Be sure not to obscure the view from your windows. You need a clear view of your property.
- Always lock your home's doors and windows, even if you're only gone for a few minutes.

- Dispose of gift packaging discreetly. Often criminals will spot something you've discarded and can target you for their next burglary or theft.

Remain Alert While Shopping

- Always lock your car and close the windows, even if you're only gone a few moments. When possible, lock all merchandise or packages in the trunk of your car. Load your packages before departing and not at the next destination.
- Shop with at least one other person. Have your car or house key in your hand as you approach the door.
- Stay alert to your surroundings and the

people around you. Look inside your car and around it as you approach.

- Be mindful of your purses and wallets. Be sure that your purse is secured as you travel to and from the store and don't leave it in a shopping cart unattended. Keep wallets in a side pant pocket or an inside pocket of a coat, if possible.
- Avoid carrying large quantities of cash.
- Plan your trips to the stores. Instead of one big shopping trip, try several small ones. This will cut down on the amount of money you carry, the packages you will be overloaded with, and it will make your shopping less stressful.
- Park in well-lighted areas that will be well-lighted when you return.

2020 reflect the increase in the national average wage index. For example, the maximum amount of earnings subject to Social Security payroll tax will increase to \$137,700 from \$132,900. The earnings limit for workers who are younger than "full" retirement age (age 66 for people born in 1943 through 1954) will increase to \$18,240. (We deduct \$1 from benefits for each \$2 earned over \$18,240.)

The earnings limit for people turning 66 in 2020 will increase to \$48,600. (We deduct \$1 from benefits for each \$3 earned over \$48,600 until the month the worker turns age 66.)

In December 2019, we will post Social Security COLA notices online for retirement, survivors, and disability beneficiaries who have a *my Social Security* account. You will be able to view and save future COLA notices via the Message Center inside *my Social Security*.

You can log in to or sign up for a *my Social Security* account today at www.socialsecurity.gov/myaccount to get more information about your new benefit amount. You can choose to receive an electronic notification by email, text, or both ways under "Message Center Preferences." Our notification will let you know that a new message is waiting for you. We will not send any personal information in the notification. The Message Center also allows you to go paperless by opting out of receiving agency notices by mail that you can get online, including annual cost-of-living adjustments and the income-related monthly adjustment amount increases. The Message Center is a secure portal where you can conveniently receive sensitive communications that we don't send through email or text.

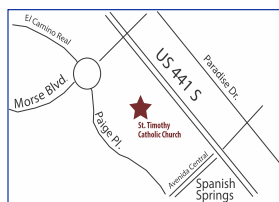

This week is National Utility Scam Awareness Week. Utility scammers prey on unsuspecting consumers' emotions and scare them into giving up personal and financial information.

I don't want any Floridian to feel helpless against these fraudsters, so I issued tips directly to consumers this week through social media to arm them with information needed to not fall for these scams.

There are three main ways that utility scammers try to exploit consumers. First, they call threatening disconnection of utility services unless payment is made immediately using prepaid cards. Second, they claim that a utility bill was overpaid, and bank account information is needed to facilitate a refund. Finally, they could come to the door impersonating a utility worker to gain entry into your home.

While this is not an exhaustive list of all the methods these fraudsters use, the following tips will help you discern if you are speaking with a legitimate utility company or a scammer.

Remember, utility representatives will never call to demand payment over the phone or request prepaid debit cards for bill payment. If you receive a call that you believe is from a utility company and want to confirm the validity, hang up and then call the company directly to see if it is a legitimate request.

It is also a good rule of thumb to never give out or confirm personal information to anyone initiating contact, whether by phone, in-person or email, claiming to be a utility representative. Additionally, never let someone you do not personally know into your home.

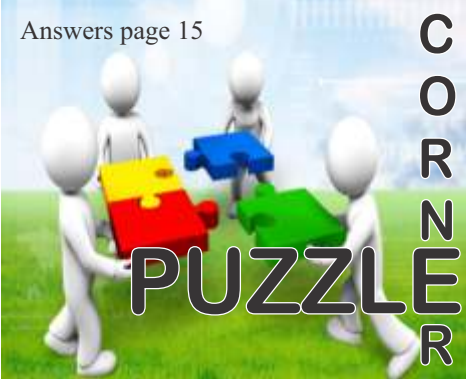

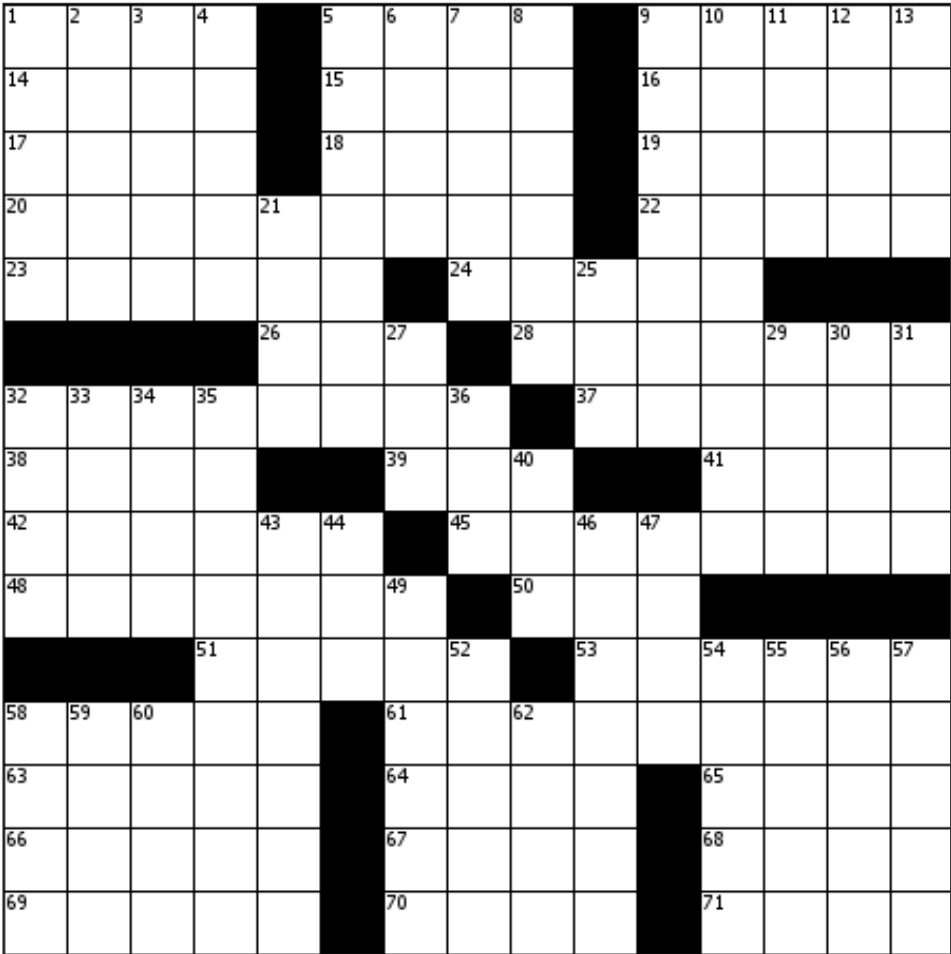

Connecting Veterans And Volunteers



Connecting Veterans And Volunteers Nationwide

(NAPSI)—If you would like to help a veteran, if you are a veteran who needs extra help, or know of one in your community, here's good news. There's a new, nationwide resource that makes it easy to match civic-minded individuals with those who need a little assistance. The database, called VolunteerforVeterans.org, was created by DAV (Disabled American Veterans), a nonprofit charity that helps veterans get their benefits and services.

Here's how it works. Veterans, as well as their caregivers, can use the site to seek assistance by entering the type of help they need, from basic tasks such as yardwork, help with errands or other services. Neighbors or friends who know of a veteran in need of help can step in to coordinate requests on their behalf. On the flip side, volunteers who are interested in giving their time can use the site to look for and respond to requests for help.

Using the site is easy, and at no cost to

veterans or volunteers. Go to www.VolunteerforVeterans.org, click on the "sign up" icon and indicate whether you are a veteran or caregiver who needs help, a friend or neighbor making a request on someone's behalf, or a volunteer willing to give support. Choose your state and the screen will populate with requests.

There is no minimum time requirement for volunteering, and groups, such as the Girl Scouts and Boy Scouts, can participate. Volunteer opportunities are updated daily, so individuals and groups are encouraged to check back often.

Ways to help. Opportunities to volunteer vary from activities that require special skills to basic assistance around the house, such as fixing and serving a meal, home maintenance, laundry, cleaning, grocery shopping, paperwork, carpentry, automotive repair and more.

Become a volunteer driver. One important and growing need, particularly for the aging veteran population, is transportation to medical appointments. At one time, the federal government provided assistance for veterans to help them access the care they earned. Unfortunately, that program was stopped in 1987. Since then, DAV has stepped in to coordinate no-cost rides through volunteer drivers to get ill and injured veterans to their scheduled care at VA medical facilities.

Drivers are provided training and use

DAV-donated vehicles for transporting veterans. Volunteers may select the days that best fit their schedule.

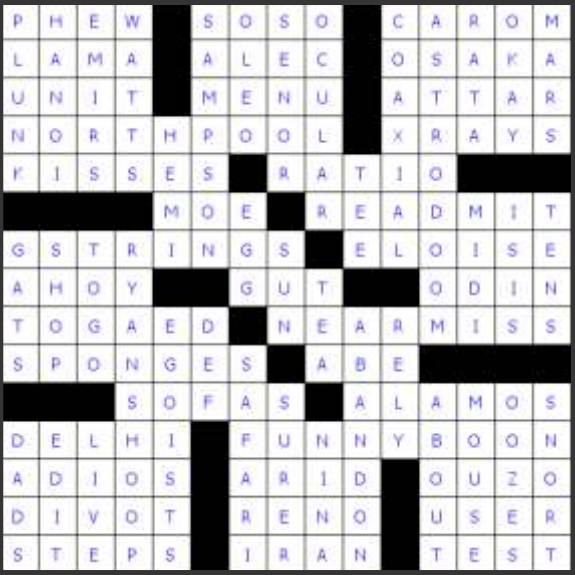




