## William Harvey Carney

The first African American to receive the Medal of Honor in the Civil War. Despite the fact that he had been shot many times he would not let the American Flag touch the ground. A true American, what would he say if he was still alive?

### Biography

William Harvey Carney was born as a slave in Norfolk, Virginia, on February 29, 1840. How he made his way to freedom is not certain. According to most accounts, he escaped through the Underground Railroad, and joined his father in Massachusetts. Other members of their family were freed by purchase or by the death of their master.

### Civil War

Carney joined the 54th Massachusetts

Volunteer Infantry in March 1863 as a sergeant. He took part in the July 18, 1863, assault on Fort Wagner in Charleston, South Carolina. His actions there ultimately earned him the Medal of Honor. When the color guard was killed, Carney retrieved the U.S. flag and marched forward with it, despite serious wounds. When the Union troops were forced to retreat under fire, he struggled back across the battlefield, eventually returning to his own lines and turning over the colors to another survivor of the 54th, saying, "Boys, I only did my duty; the old flag never touched the ground!" He received an honorable discharge due to disability from his wounds in June 1864.

Another election season is almost here and your involvement is critical. It seems that we say that every election year and it is just as true today as it ever was. In just a few short weeks, millions of Americans will be preparing to cast their vote in a party preference primary. Much of the attention and focus is on the Presidential

race in November, but August is when we will choose who represents our party in the local and state races. These smaller races are so important and will probably have the bigger effect on your day-to-day life. Research these local candidates. Call them and speak with them, most of them are very accessible and ready to speak with reasoned, sensible people in the community. It is ok to disagree with them on some issues, as long as they do not violate your core principles but please do not skip voting because you do not agree on one-hundred percent of everything.

Not voting in August or November is not an option. If you are in the vulnerable population and do not want to risk exposing yourself or others to COVID, then order your vote-by-mail ballot and let your vote be counted. If going to polls is an option for you, then by all means, let that be your first choice. Early voting is great option as well. Usually done one week prior to that Tuesday, early voting lets you choose which day in your schedule is best you while still getting to watch your ballot go in to the tabulating machine to make sure that it is counted. The lines are usually shorter and there will be 5-6 different locations to choose from, as opposed to just one if you voted on Election Day. Your Supervisor of Elections will have those locations posted on their website, or you can call for the information.

Do your research, pay attention to the local races, vote-by-mail, early vote, or show up at your precinct at Election Day and let us continue to make Florida the best place to live, work and raise a family.

**1 1/2 tsp baking powder**

**1/2 tsp baking soda**

**1/2 tsp salt**

**2 c blueberries**

Preheat oven to 375° F. Coat muffin tins with nonstick spray.

In large bowl, whisk eggs, yogurt, butter and vanilla. In medium bowl, combine flours, sweetpotatoes, sugar, baking powder, baking soda and salt. Mix flour mixture into egg mixture. Gently stir in blueberries.

Divide batter between 24 regular or 10 jumbo muffin cups. Bake until golden brown and set, about 25 minutes for regular muffins or 30 for jumbo.

## Work At Home



**Work At Home In Comfort And Safety**  
(NAPSI)—According to Darrell Smith, executive director of the International Window Film Association, window film makes a lot of sense for homeowners eager to save money on their energy bills.

“Solar-control films can block as much as 80 percent of the solar heat coming through glass into a building, decrease the heat load on the air-conditioning system and reduce energy costs,” Smith says.

With more people working and studying from home, window film allows in abundant natural sunlight while blocking 99 percent of the sun's harmful UV rays to better protect the skin (from possible cancer) and eyes (from cataract development), while reducing the fading of floors and furnishings. Smith estimates that 40 to 60 percent of color fading is caused by UV exposure. Windows may also be upgraded for safety, as window film helps to hold glass pieces together if the window is impacted and broken.

For even a 3,000 square foot home, window film may be installed in a day or less with minimal disruption. Window film installers clean the glass before installation,

The state of Florida has the second highest total number of heat related deaths of children being left unattended in a vehicle. More than half of vehicular heatstroke cases from 1998 to 2019 were because an

adult forgot about a child, according to NoHeatstroke.org. Additionally, every year pets suffer and die when their guardians make the mistake of leaving them unattended in a parked vehicle to “run in for just a minute” at the local store. The Lady

Lake Police Department is committed to informing and educating parents and pet owners on the dangers of leaving children and pets unattended in a vehicle and taking precautions to help prevent these tragic situations.

Leaving a child or a pet in a hot car even for a short period of time can be dangerous, even if parked in a shade or with the windows cracked. A vehicle's glass transparency allows for the sun's rays to heat up the inside essentially creating a vacuum of heat. Within minutes a car that was just being cooled can experience a spike in temperature. On a sunny day, when outside temperatures are 80 degrees outside, the inside temperature of a vehicle can rise to 99 degrees in 10 minutes and soar up to 114

degrees in 30 minutes. At 90 degrees outside, the inside temperature of a vehicle can rise to 109 degrees in 10 minutes and soar up to 124 degrees in 30 minutes.

A child's body temperature can rise up to five times faster than an adult's. When a core body temperature of 107 degrees Fahrenheit is reached, internal organs begin to shut down leading to death.

**Dogs and cats can't sweat like humans, so they pant to lower their body temperature. If they're inside a car, recycling very hot air, panting gives no relief, and heat stroke can happen quickly.**

**I encourage you to take these safety precautions to help avoid these preventable tragedies:**

- Make it routine to open the back door of your car every time you park.
- Set an alarm on your cell phone or

computer calendar as a reminder to drop your child off at child care. Make the alarm sound different from other alert tones.

- Keep a stuffed animal in the child's car seat. Place it on the front passenger seat as a reminder when the child is in the back seat.
- Ask your babysitter or child care provider to call you if your child hasn't arrived as scheduled.
- If you are driving a child, put something you need in the back seat so you will need to open the back door. Items may include a cellphone, handbag, employee badges, or any other item you would need at your destination.

**What to do if you find a pet confined to a vehicle:**

- Take the vehicle's make, model, color and license plate number and notify your local Animal Control or Police Department.
- Once removed from the vehicle, provide water to drink and if possible, immerse in cool water for up to two minutes to gradually lower the body temperature.
- Watch for signs and symptoms of heatstroke such as restlessness, thick saliva, heavy panting, glazed eyes, dark tongue, rapid heartbeat, difficulty breathing, dizziness, seizure and lack of coordination. If a dog shows any of these symptoms remove it from the heat and transport to a veterinarian immediately.

Practice safety awareness and follow these precautions this summer season with your children and your pets to prevent a vehicle heat-related tragedy from happening to your family. Stay safe out there!

and tips:

Before your appointment, your dental office may call you to ask about your current health and travel records.

You may also be asked to limit the number of people you bring to the appointment. That could mean leaving your children at home or allowing older children go to the office alone while a parent waits outside.

At your appointment: Be sure to wear a mask, even if it's not required and especially if your dentist's office is in an area where one is required. When you get to the dental office, you may be asked to wait outside until they're ready for you. This will reduce the number of people in the office and reduce the amount of time you're exposed to other people. When you enter the office, be prepared to have your temperature taken or other health test. Inside the office, things people tend to touch in the waiting room—such as toys or magazines—may no longer be there. Hand sanitizer, masks, and gloves may be made available to you.

Once you're in the dental chair, you may notice some things look different from the last time you were there. The dentist may have covered the computer's keyboard with a disposable cover so it can be easily cleaned between patients, for example. Your dentist may also be using different protective equipment than you've seen at previous appointments, including different masks, face shields, gowns, gloves, and goggles.

After your appointment, the dental team members will thoroughly clean the area with disinfectant. If you start feeling symptoms of COVID-19 within 14 days of your appointment, contact the dental office. You may have already been carrying the virus at

the time of your appointment, so anyone who came into contact with you during that time could be at risk for getting sick, too.

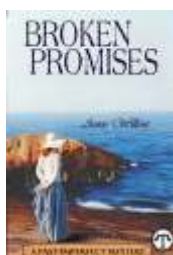

Town of White Springs – (\$400,000) to help fund construction, engineering and inspection services to improve sewer system transmission capabilities and correct issues that caused overflows during Hurricane Irma to the Town of White Spring's more than 40-year-old core sewer system.

## Governor Ron DeSantis Announces Next Steps to Strengthen Florida's Electric Vehicle Infrastructure

**Orlando, Fla.** – Today, Governor Ron DeSantis announced \$8.6 million in funding to strengthen Florida's electric vehicle infrastructure. This investment marks another step in the state's efforts to provide accessible electric vehicle infrastructure while also protecting air quality and expanding the state's charging stations by 50 percent along most traveled corridors.

“This long-term investment in electric vehicle charging infrastructure is a win for our state on multiple levels,” said **Governor DeSantis**. “Not only will these charging stations promote reduced emissions and better air quality, they will also improve mobility and safety for the ever-increasing number of Floridians that drive electric cars. I look forward to building on this investment and continuing our work to improve Florida's environment and transportation infrastructure.”

“Florida strives to lead the nation in air quality and is proud to be the most populous state in the nation to have met all of EPA's

National Ambient Air Quality Standards,” said **Department of Environmental Protection (DEP) Secretary Noah Valenstein**. “Through collaboration with sister agencies and the private sector, we are able to implement projects like these, that will protect air quality and provide access to charging stations in our state as electric vehicle usage continues to increase.”

“Under Governor DeSantis' leadership, Florida is advancing emerging transportation alternatives to build an infrastructure that will prepare us for decades to come,” said **Florida Department of Transportation (FDOT) Secretary Kevin J. Thibault, P.E.** “The addition of these electric vehicle charging stations will not only keep pace with the dramatic increase in the use of these vehicles, but also help to reduce emissions and improve mobility across Florida's transportation system.”

“The installation of these charging stations will greatly extend the range for electric vehicle travelers throughout our state,” said **Senator Debbie Mayfield**. “Under the great leadership of Governor DeSantis, we are continuing to improve our transportation infrastructure while also improving air quality as we lead Florida into a new era of technological innovation.”

“In March of this year Florida became the largest state in America to meet all National Ambient Air Quality Standards, and the addition of these electric vehicle charging stations encourages more EV commerce across our highways, producing less vehicle emissions,” said **State Representative Mike LaRosa, Chairman of the House Commerce Committee**. “I commend Governor DeSantis for providing Floridians and visitors to our state alike the ability to charge their environmentally friendly vehicles at our turnpike facilities and for continuing to deliver the cleanest air in Florida history.”

“As the first member of the legislature to drive a fully electric vehicle, I know not only the positive effect these cars can have on the environment, but the importance of having a solid infrastructure to leverage their growth,” said **Representative Randy Fine**. “I am excited about today's announcement for the commitment we continue to show to improving Florida's environment.”

Under the Volkswagen Settlement, Florida was allotted \$166 million to improve air quality. Florida's Beneficiary Mitigation Plan, which was finalized last October, outlines how the State intends to spend the full award under this settlement. This Plan focuses on Diesel Emission Reduction Act (DERA) projects, the construction of new electric vehicle charging stations and the procurement of electric buses for select school districts and transit agencies.

DEP has reviewed the applications received for the electric vehicle charging stations and has selected the projects to receive the awarded funding. With this funding, 74 additional DC fast chargers will be installed statewide. Combined with the chargers FDOT is installing along the Florida Turnpike, a total of 104 DC fast chargers will be installed along over 1,200 miles of highway, covering the most traveled corridors in the state. Each of the 34 locations will have at minimum 2 chargers each. This represents an approximately 50 percent statewide increase in publicly available DC charging stations.

## Capital City Health Care Provider Arrest for \$50,000 in Medicaid Fraud

TALLAHASSEE, Fla. — Attorney General Ashley Moody's Medicaid Fraud Control Unit, with the assistance of the Leon County

Sheriff's Office, today arrested a Medicaid provider on charges related to \$50,000 in fraud. The arrest follows an MFCU investigation that revealed Rodney Burt, 57, billed the Florida Medicaid Program for services not rendered from May 2016 through November 2019.

Attorney General Ashley Moody said, “Participation in Florida's Medicaid Program is increasing during this health crisis, and we will do everything in our power to protect taxpayer funds from fraud. That is why my Medicaid Fraud Control Unit attorneys and investigators aggressively chase down leads and uncover abuses in this taxpayer funded health care program to ensure those who would aim to rip off taxpayers are stopped and brought to justice.”

Additionally, the investigation uncovered that Burt, owner of No Place Like Home, a Home and Community Based Service Provider, assigned inaccurate billing codes

to claims submitted to the Florida Medicaid Program in order to increase reimbursements—a fraudulent billing practice known as upcoding.

Burt is charged with one count of Medicaid provider fraud \$50,000 or more, a first-degree felony. If convicted, Burt faces up to 30 years in prison and more than \$300,000 in fines and restitution.

The Attorney General's MFCU will prosecute the case through an agreement with the State Attorney's Office in the Second Judicial Circuit.

## Attorney General Moody and FTC Distribute More Than \$16 Million in Refunds for Victims of Bogus Debt Relief Operation

TALLAHASSEE, Fla.—Attorney General Ashley Moody and the Federal Trade Commission announced more than \$16 million is now being distributed to victims of a debt relief scam. The scam targeted thousands of consumers facing financial difficulty in Florida and across the nation. The millions in restitution culminates from a joint lawsuit brought by Attorney General Moody's Consumer Protection Division and the FTC against a group of defendants known as [Helping America](#)

[Group](#) for allegedly convincing victims to pay hundreds or thousands of dollars a month by falsely promising to pay, settle or obtain dismissal of debts and improve payors' credit scores. Instead, victims discovered debts unpaid, accounts in default and credit scores severely damaged—some were sued by creditors, and others were forced into bankruptcy.

Attorney General Ashley Moody said, “It infuriates me that anyone would take advantage of people trying to pay off their debts and improve their financial situations. Thankfully, our office, working together with the FTC, has now recovered millions to be returned to the victims of this appalling scam.”

More than 27,000 refund checks will be sent to victims of the scam. Additional money is expected to be collected in this case, and a second round of checks will be planned once additional money is secured.

Recipients should deposit or cash their checks within 90 days. The FTC never requires people to pay money or provide account information to cash a refund check. If recipients have questions about the refunds, they should contact the FTC's refund administrator, JND Legal Administration, at 1(833)928-2567. Refund data can also be viewed on the FTC's [interactive dashboards for refund data](#).

## Millions Available in Tech Support Scam Restitution as August Deadline Approaches

TALLAHASSEE, Fla.—Attorney General Ashley Moody today issued a Consumer Alert to urge victims of several tech support scams to claim millions of dollars made available for restitution. The multimillion dollar claims process currently underway is the result of action taken by the Florida Attorney General's Office to shut down several companies operating tech support scams. The deadline to file a claim is August 30. Thousands are eligible, but so far, only hundreds have successfully filed claims.

Attorney General Ashley Moody said, “Our Consumer Protection Division has worked hard to secure restitution for victims of tech support scams and they continue to diligently reach out to eligible consumers. We need your help to make sure victims know restitution is still available. If you or someone you know was the victim of a tech support scam, please file a claim before the August 30 deadline.”

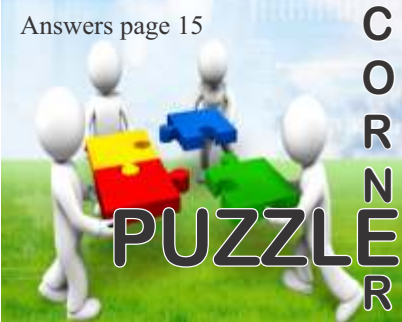

support scam investigation by the Florida Attorney General's Office into the following companies; Complete Fix, Compusafe, JSA Sales, GoReadyCalls Marketing, My Direct Customer Care, My Direct Tech, PC Tech Pros, Project Net 123, Protectnet Solutions, Safenet Solutions, Secure IT Digital Solutions, Telcom Experts, US Software Experts, US Software Pros, Webguard 123 and Wizard Tech Solutions. Another company, Banc of America Merchant Services, provided payment processing for the accused companies. Through an agreement with Banc of America Merchant Services, a claims process is now in place with \$7,200,000 available for victims.

The investigation revealed that more than 100,000 people nationwide fell victim to the tech support scams perpetrated by these companies. Last year, and again last month, claim notices went out to thousands of potential eligible consumers with information about how to obtain restitution. So far, approximately \$197,000 of the fund has been distributed.

Eligible victims are encouraged to submit claim forms as soon as possible. The deadline to file a claim and any supporting documentation is August 30.

Since 2014, the Florida Attorney General's Office has successfully shut down 13 tech support scams—representing the most tech support scam cases filed by any

single state agency in the country. Attorney General Moody filed the most recent case against [American PC Corporation](#).

Tech support scams typically involve fake pop-up messages or imposter phone calls claiming that a consumer's computer is infected with malware that poses an imminent risk to the device. Fraudsters will request virtual access to a victim's computer to supposedly fix the nonexistent problem. These scammers often target seniors.

To avoid tech support scams, consumers should never:

- Click on any links or call phone numbers provided on pop-up ads or emails;
- Send money, credit card numbers or any financial information to someone they do not know;
- Give anyone control of personal computers or electronic devices;
- Forget that Microsoft and most major computer companies do not display pop-up warnings and ask consumers to call toll-free numbers about viruses or security problems; or
- Go online without up-to-date security software.

veterans in accessing the benefits earned through their service to finding meaningful employment and supporting their families. DAV has continued to evolve and provide new care as veterans' needs have changed. However, one tradition remains a constant: DAV's services are provided to veterans and their families at no cost or obligation to them.

DAV's benefits advocates are located nationwide to assist veterans with accessing the health care, financial, disability and educational benefits they've earned. For those needing guidance on the transition to civilian life, DAV advocates provide benefits counseling at nearly 100 military installations throughout the country. They also assist veterans with filing initial claims for their VA benefits, as well as providing everyday support.

DAV is also committed to ensuring our nation's warriors have the tools, resources and opportunities they need to competitively enter the job market and secure meaningful employment. DAV helps facilitate more than 144 career fairs annually, including virtual and live events to connect veterans with employers who are committed to hiring them. presented by grid applications such as peak-shifting and Transmission and Distribution (T&D) capital deferral.

Energy storage systems provide many ways to manage the power supply for a more resilient energy infrastructure, and bring cost savings to utilities and consumers. 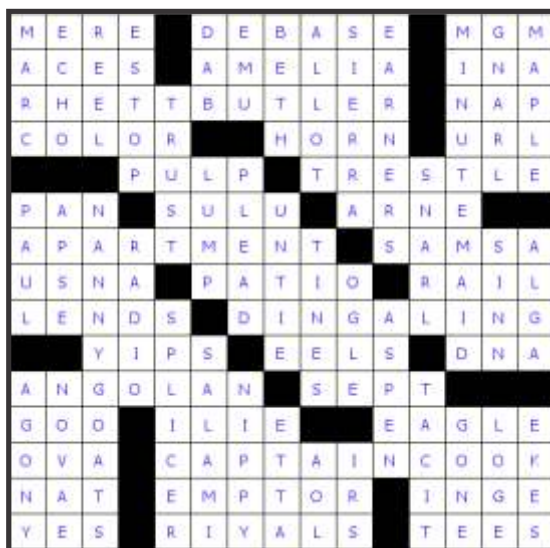
