Dr. Paul Banerjee is the Medical Director for Polk County Fire Rescue, Polk County Sheriff's Office SWAT team, Dr. Banerjee is board certified in Emergency Medicine and is an Associate Professor in Emergency Medicine at the University of Central Florida School of Medicine, Mercer

University School of Medicine and the University of South Florida School of Medicine. Dr. Banerjee was an EMS 10, 2017 Innovator of the year and the State of Florida Medical Director of the year in 2012. Dr Banerjee is also a member of the Metropolitan Collaboration of EMS Medical Directors.....

What do you think of all those certifications? Dr. Paul Banerjee recently gave a talk on COVID-19. During his talk he gave facts about how long the virus could live on different surfaces. Plastics, stainless steel, cardboard box etc. Then he gave statistics about the outbreak itself and the fact that the virus is very similar to other viruses that we have had around for years. Yes it's bad but there are many good things being tested right now that is showing promise. He said he would not take a vaccine until it has been used for a year. Your chance of catching the COVID-19 is .24 of one percent. That means we have a 99.76 chance of not getting it. One of the questions ask is the COVID-19 numbers inflated. He said he had not seen signs of that. My estimation is if you are a Doctor and you get \$10,000 for every patient of yours that is dialogist with COVID-19, what would you do? I'm only asking???

## AS I SEE IT

Apparently, many residents of 'The Villages' in Florida are concerned about their community moving away from building single-family homes and going full-on commercial and multi-family instead.

Seems that increasingly apartments, medical facilities, assisted living homes, shops, stores and businesses are the new focus.

The original 'Orange Blossom Gardens' started out as gated, Mobile Home Subdivision within the Town Of Lady Lake, back in the 70's.

But they soon changed, first to 'hybrids'; Mobile Home Construction installed on a concrete slab, and then to larger conventional homes.

The main selling approach was to promise 'Free Golf For Life' with access to numerous other 'amenities', clubhouses, Town Squares, softball, tennis and much more, all for a nominal monthly fee.

At the time, 'officials' from the Town Of Lady Lake freely admitted that they were approving

tax-free bonds to the now-renamed "Villages".

'High Finance' is way beyond my understanding, but it seems that the Founder, Harold Schwartz and his son Gary Morse's team, would borrow the Bond Money to be used for land purchases, and construction improvements, water, sewer, streets, golf courses etc; Then that

'infrastructure' and those amenities would be sold to another company they owned/controlled, thereby making a multi-million dollar cash profit, without risking a dime of their own money.

then a 'CDD' (Community Development District), would repay the bonds out of the mandatory Amenity Fees which they collected from Resident/Homeowners.

Some residents claim that system is still in place today.

That has worked well for years, but now residents say that 'management' is closing down or even demolishing pools, recreation facilities, clubhouses and converting, what was expected to be conventional residential areas to multi-family, rentals, retirement centers and the like.

One person said that examples include the recent construction of densely-sited apartments at Brownwood. Then the demolition of Hacienda Hills CC with plans for a large high-rise building, and

apartments to replace the former Katie Belles club.

As I See It, there seems to be a complete misunderstanding by Buyers/Home-Owners/Residents in The Villages.

Over the years dozens or, perhaps hundreds of 'Villagers' have claimed that their monthly 'Amenity Fee' entitles them to free golf, pools, clubhouse access, activities, tennis, softball, entertainment in the Town Squares and numerous other 'freebies'.

Of course, typical buyers accept what

they are told without question.

You'd expect that residents of a community like The Villages', which includes so many educated, retired, professionals would take time to 'read-before-you-sign'!

Unfortunately, I am neither educated nor retired, but, I can read!

I'm hoping that someone, who is better informed than I am, will enlighten us as to exactly which 'amenities' management is legally obligated to provide to homeowners!

This issue came up when a 'visitor' asked why so much 'premium real estate', (for example, on both sides of CR 466 and 466a), were 'wasted' by being used for non-profit golf courses.

Furthermore, she suggested that the prominent golf courses, on prime commercial real estate, are simply a temporary use as 'window-dressing' to promote sales.

But, ultimately to be developed similar to US Hwy 27/441 from Lady Lake north to Summerfield.

She claimed that, in fact, residents of The

Villages, have no 'legal' entitlement to 'amenities'!

That residents have an obligation to pay, but the developer has no 'legal obligation' to provide anything in return for the fees they receive!

### 2020 Hurricane Season Is In Full Swing—Eight Ways To Prepare Now

(NAPSI)—Hurricane season officially runs through November, and while no one can predict what lies ahead, there are things you can do to prepare. Here, T-Mobile offers eight ways to stay connected.

1. Make a disaster kit: Include things such as batteries, snacks, water, a first aid kit, a flashlight and device chargers.

2. Update your family, friends and emergency services contact numbers. Make sure they're saved and backed up in your devices AND written down someplace accessible.

3. Subscribe to official text alerts and connect with official social networks to learn about new developments before, during and after a disaster.

4. Keep your mobile devices fully charged. Have charging cables handy and consider picking up a car or portable charging device.

5. Protect your technology with waterproof re-sealable plastic bags.

6. Download emergency-assistance apps from the Red Cross and FEMA.

7. Make sure your phone supports Wireless Emergency Alerts and that you have enabled notifications on your device. Visit [t-mobile.com/wea](https://t-mobile.com/wea) for details on how to set up alerts on T-Mobile and Sprint devices.

8. Set up Wi-Fi Calling on your phone if you have a phone that supports it. For Apple phones, go to Settings > Phone > Wi-Fi Calling; for Android phones, go to Settings > More Connection Settings > Wi-Fi Calling.

### Managing Service Interruptions

Even with the measures T-Mobile and other wireless operators take to prepare their networks against disasters, there is still the potential for power outages and other communication service interruptions.

If your mobile service is interrupted or spotty immediately following a hurricane, try the following:

If you have home broadband and power but no mobile service, try Wi-Fi calling, which lets T-Mobile and Sprint customers with capable devices text and make and receive voice calls via any capable Wi-Fi connection. IMPORTANT: If you have to call 911 using Wi-Fi, be sure to give your address to the operator.

**Walking To School**

If your child walks to school, make sure there are sidewalks along the way. If you are not able to walk with your child, remember there is safety in numbers so have your child walk with siblings or other neighborhood children. Being hit by a car is by far the greatest threat to any child walking to school. Make sure your kids stay on the sidewalk and only cross at crosswalks. Remember to remind your children to never, ever stop to talk to strangers on the way to and from school and, most importantly, never to get into any vehicle with a stranger. These could potentially be life threatening situations.

**Bicycle Safety**

Children peddling to school on bicycles must wear bike helmets – it's the law. Helmets are the single most effective devices for cyclists, greatly reducing the risk of death or critical injury. Your children should ride their bicycles on the right side of

the road and obey stop signs and traffic signals.

**Bus Ride**

Children who ride the bus should never misbehave. And remember, no bullying. It's important for children to remain seated at all times, keeping their hands and feet inside the vehicle and never throw anything inside or outside of the bus. When exiting the bus, children should always cross in front of the bus – never from behind.

Drivers need to remember that Florida law prohibits passing, in either direction, a school bus that is stopped with its flashing lights activated on a two-way street or highway. If the highway is divided by a raised barrier or an unpaved median at least five feet wide, an example is US Hwy 27, you do not have to stop if you are moving in the opposite direction of the bus. Anyone caught passing a stopped school bus or speeding in a school zone can expect to get a costly fine – the Lady Lake Police Department simply will not tolerate violations that could harm a child. Please reference Florida State Statute 316.172.

Drivers must also remember to slow down in school zones. Driving slowly and carefully through school zones greatly reduces the risk of a tragic accident.

**Bullying**

Bullying among children is aggressive behavior that is intentional and involves an imbalance of power or strength. A child who is being bullied has a hard time defending him or herself. Usually, bullying is repeated

over time. Bullying can take many forms such as physical, verbal, emotional and cyber-bullying. Signs that your child might be bullied are: torn clothes; loss of appetite; mood changes; and/or a reluctance to go to school. It's important that your child knows they can talk to you if they are being bullied. Whenever you know that someone is the victim of a bully, you should speak up and report it right away.

Many schools in Lake County have a school resource officer or deputy. If your child is experiencing trouble with others or feels they are being bullied, please contact the school's administrative office and ask to speak to the officer or deputy.

Please ensure your child follows all guidelines set by the school in regards to social distancing, wearing a mask and remember to wash their hands prior to

eating. By keeping safety in mind, we can work together to make the 2020-2021 school year safe and successful.

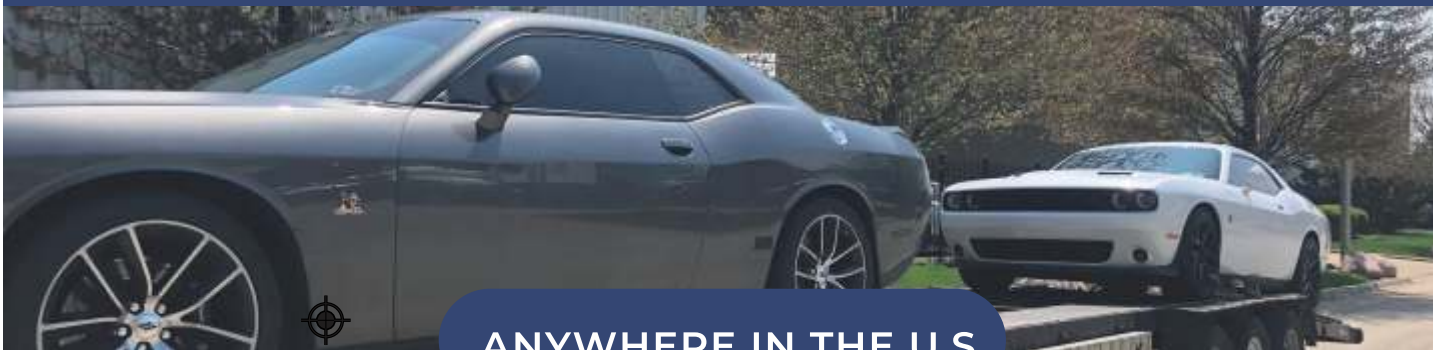

## The Story of Carl Letney

**“A Hero in World War II”**

Carl was the youngest of twelve (12) children in his family. When Carl was eight years old the family still had a total of seven children, Carl being the youngest. The family moved to Waterloo, Iowa. Carl became an excellent athlete in both football and baseball in school. Carl Letney called Buck left his high school in his senior year to join the Army. He was trained to be an Assault Ranger and was sent to the Battle of the Rapido River where he fought for two days trying to cross the Rapido River (north of Naples, Italy) and reach the winter line. Buck Letney lost his life on the second day of fighting on the Rapido River. No gains had been made in the capture of the Rapido or Gari Rivers and they became one of the big defeats suffered by the US Army in World War II. The AMVETS Post 31 was dedicated to Carl's memory and it is in Evansdale Iowa a small suburb of Waterloo where his statue and monument stands. Carls brother Jerry lives in the Villages.

## Support Cell Defense



### Coenzyme May Support Cell Defense

(NAPSI)—As scientists are learning more about COVID-19 and how it affects the body, they are also looking for ways to support the innate immune response to infection. While more research is needed, preclinical studies lay a foundation of science to inform future human studies.

A recently published preclinical study focused on levels of a coenzyme called nicotinamide adenine dinucleotide (NAD+) in cells and animal tissue infected with coronavirus, specifically SARS-CoV-2 and lung tissue from a COVID-19 cadaver. The results revealed that NAD+ may play a key role in cellular defense mechanisms.

The researchers observed how SARS-CoV-2 impacted cellular NAD+ levels and how the virus triggered the infected cells to seek out a cellular nutrient called nicotinamide riboside (NR) in an attempt to replenish the NAD+ levels that had dropped due to infection.

In a separate set of experiments, the researchers provided NR to coronavirus infected mouse cells and showed that viral replication was significantly reduced compared to a control.

The researchers concluded that coronaviruses disturb the NAD+ system, and increasing cellular NAD+ pools with NR may aid cells' defense during infection.

### What does it mean?

These scientists, from the University of Iowa, University of Kansas, and Oregon

The expansion comes as Governor Ron DeSantis [declares a state of emergency](#) for Tropical Storm Laura in the following counties: Bay, Broward, Calhoun, Charlotte, Citrus, Collier, DeSoto, Dixie, Escambia, Franklin, Glades, Gulf, Hardee, Hendry, Hernando, Hillsborough, Jackson, Jefferson, Lee, Levy, Manatee, Miami-Dade, Monroe, Okeechobee, Palm Beach, Pasco, Pinellas, Santa Rosa, Sarasota, Taylor, Wakulla, Walton and Washington. Florida's price gouging laws for this event only apply within the area of the declared state of emergency and only for commodities and services essential to preparing for or recovering from the storm event.

The price gouging laws remain in effect statewide under the emergency declaration in response to the COVID-19 pandemic in March for [commodities that relate specifically to the health crisis](#). Other storm-related state of emergencies continue as a result of Hurricane Michael for 14 counties and Hurricane Isaias for 19 counties on the east coast of Florida.

Attorney General Ashley Moody said, “Floridians should prepare now, with enough food, water and other essential items needed in case this storm strikes their

community. With the declared state of emergency, I am expanding my Price Gouging Hotline to receive reports of extreme price increases on the essential items Floridians need to be prepared. If you see potential price gouging, please report it immediately so we can ensure Floridians are able to prepare without the added stress of excessive prices.”

During a storm-related declared state of emergency, state law prohibits excessive increases in the price of essential commodities, such as food, water, hotel rooms, ice, gasoline, lumber and equipment, needed as a direct result of the event. Anyone who suspects price gouging should report it to the Florida Attorney General's Office by using the NO SCAM app, visiting [MyFloridaLegal.com](#) or by calling 1 (866) 9NO-SCAM. The Attorney General's NO SCAM app can be downloaded for free through Apple and Android stores by searching NO SCAM.

Violators of the price gouging statute are subject to civil penalties of \$1,000 per violation and up to a total of \$25,000 for multiple violations committed in a single 24-hour period. In addition to the civil penalties for price gouging, state law criminalizes the sale of goods and services to the public without possession of a business tax receipt.

### Attorney General Moody Hosts Symposium with Federal and State Agencies Regarding COVID-19 Schemes Targeting Medicaid

TALLAHASSEE, Fla.—Attorney General Ashley Moody today hosted a COVID-19 related Medicaid fraud symposium with federal and state agencies. Representatives from all three of Florida's U.S. Attorney Offices, the U.S. Department of Justice, the U.S. Health and Human Services Inspector General's Office and the Florida Agency for Health Care Administration participated in the virtual event. The discussion focused on the recent increase in Medicaid enrollment nationwide and fraud related to the COVID-19 pandemic. The group also discussed ways state and federal agencies can partner to protect taxpayer money and stop fraud and identity theft amid the current health crisis.

Attorney General Ashley Moody said, “My Medicaid Fraud Control Unit has been working throughout this pandemic to identify, investigate and stop fraudsters exploiting this important taxpayer-funded health care program. As a result of this health crisis and the resulting economic downturn, Florida is experiencing an increase in Medicaid enrollment. The goal of today's symposium was to bolster our individual and collective efforts to stay ahead of fraud trends related to the increased enrollment and COVID-19, and strengthen partnerships vital to upholding the integrity of the Medicaid program in Florida.”

U.S. Attorney for the Middle District of Florida Maria Chapa Lopez said, “Federal and state healthcare programs, such as Medicaid, are designed to assist people with limited income and resources during their time of greatest need. Criminals that target these programs or their beneficiaries during this national health crisis, or at any other time, can expect that we will join with our federal, state, and local partners to investigate and prosecute them to the fullest extent of the law. Today's symposium represents that commitment.”

Special Agent in Charge Omar Pérez Aybar of HHS OIG said, “Our oversight agency is dedicated to protecting beneficiaries of Medicaid and other federal health care programs, as well as safeguarding the financial integrity of those programs. With our law enforcement partners, we are aggressively targeting COVID-19 fraud schemes, bringing fraudsters to justice and warning the public about these scams. Today's symposium demonstrates the law enforcement community's commitment to efficiently and effectively shut down fraud, waste, and abuse during this unprecedented public health crisis.”

Attorney General Moody's MFCU works regularly with the state and federal agencies that participated in today's symposium to identify, investigate and prosecute Medicaid fraud cases. During the event, the participants discussed the increase in Medicaid enrollment and the opportunity the increase could create for criminals to exploit the government program to steal taxpayer money. The group also discussed ways to detect and prevent identity theft related to Medicaid and the pandemic, as well as fraud schemes designed to steal stimulus payments.

Earlier this year, Attorney General Moody issued a Consumer Alert warning Floridians about long-term care facilities seizing the stimulus payments of residents in the Medicaid program. To view the alert, visit [MyFloridaLegal.com](#).

Additionally, health care providers must remember to not seek payment from Medicaid recipients for co-payments, co-insurance, deductibles, or other cost-sharing during the declared state of emergency. On March 16, Florida Medicaid waived co-payment requirements for all services. Florida Medicaid also indicated it will pay for medically necessary services provided to Medicaid recipients diagnosed with COVID-19, regardless of whether the provider is located in-state or out-of-state.

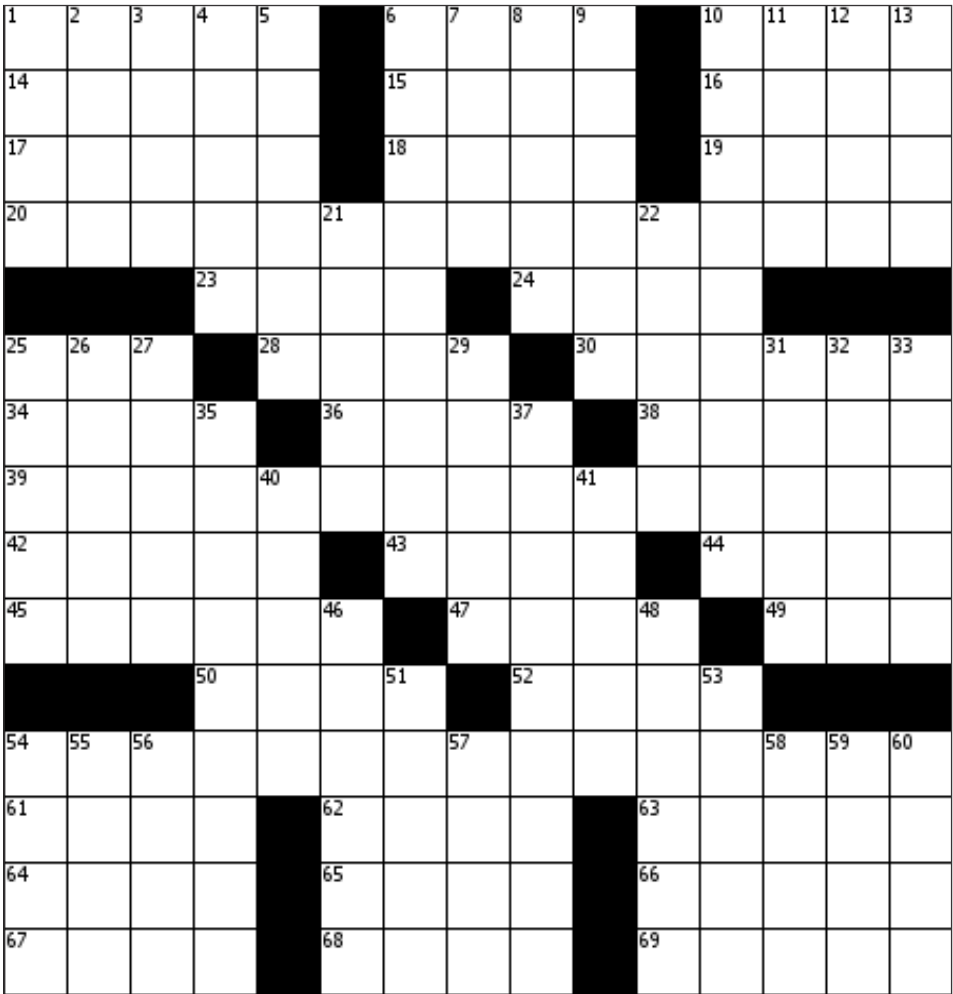

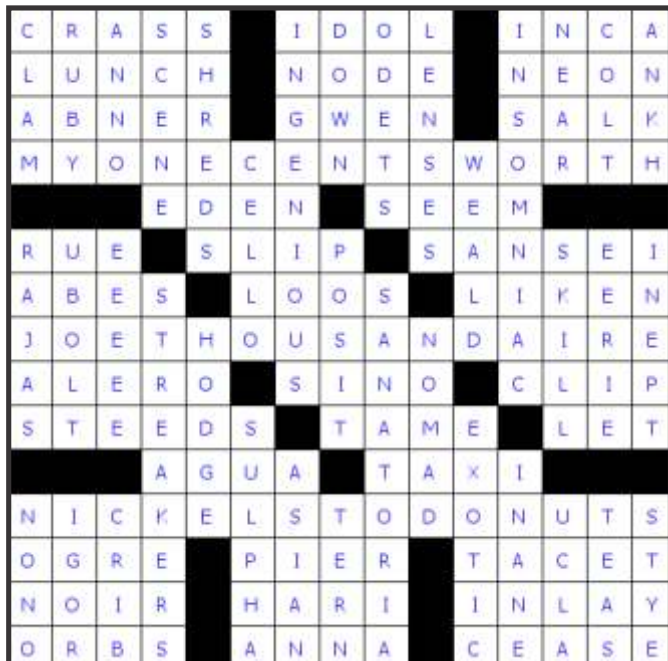
