## How Supreme Court Justices are selected?

The President nominates someone for a vacancy on the Court and the Senate votes to confirm the nominee, which requires a simple majority. In this way, both the Executive and Legislative Branches of the federal government have a voice in the composition of the Supreme Court.

**Are there qualifications to be a Justice?** Do you have to be a lawyer or attend law school to be a Supreme Court Justice?

The Constitution does not specify qualifications for Justices such as age, education, profession, or native-born citizenship. A Justice does not have to be a lawyer or a law school graduate, but all Justices have been trained in the law. Many of the 18th and 19th century Justices studied law under a mentor because there were few law schools in the country.

The last Justice to be appointed who did not attend any law school was James F. Byrnes (1941-1942). He did not graduate from high school and taught himself law, passing the bar at the age of 23.

Robert H. Jackson (1941-1954). While Jackson did not attend an undergraduate college, he did study law at Albany Law School in New York. At the time of his graduation, Jackson was only twenty years old and one of the requirements for a law degree was that students must be twenty-one years old. Thus rather than a law degree, Jackson was awarded with a "diploma of graduation." Twenty-nine years later, Albany Law School belatedly presented Jackson with a law degree noting his original graduating class of 1912.

**How is the Chief Justice selected?** Does the most senior Associate Justice become

Chief Justice? Like the Associate Justices, the Chief Justice is appointed by the President and confirmed by the Senate. There is no requirement that the Chief Justice serve as an Associate Justice, but 5 of the 17 Chief Justices have served on the Court as Associate Justices prior to becoming Chief Justice.

Three were members of the Court when they were elevated to Chief Justice:

- Edward Douglas White (Associate Justice 1894-1910, Chief Justice 1910-1921)
- Harlan Fiske Stone (Associate Justice 1925-1941, Chief Justice 1941-1946)
- William H. Rehnquist (Associate Justice 1972-1986, Chief Justice 1986-2005)

Two had a break in service between their periods of service:

- John Rutledge (Associate Justice 1789-1791, Chief Justice 1795)
- Charles Evans Hughes (Associate Justice 1910-1916, Chief Justice 1930-1941)

**How long is the term of a Supreme Court Justice?**

The Constitution states that Justices "shall hold their Offices during good Behavior."

This means that the Justices hold office as long as they choose and can only be removed from office by impeachment

**Has a Justice ever been impeached?**

The only Justice to be impeached was Associate Justice Samuel Chase in 1805.

The House of Representatives passed Articles of Impeachment against him; however, he was acquitted by the Senate.



## Family Caregivers Of Veterans



### Family Caregivers Of Veterans Eligible For Free Professional Help

(NAPSI)—The Elizabeth Dole Foundation and U.S. Department of Veterans Affairs have launched an emergency respite care fund for the family caregivers of wounded, ill, and injured veterans. The program, Respite Relief for Military and Veteran Caregivers, will provide non-medical, no-cost, professional home care to veteran caregivers who are struggling during the COVID-19 pandemic. CareLinx, a nationwide professional home care network, helped launch the fund with a donation of \$1 million worth of services. Wounded Warrior Project then contributed an additional \$1 million to expand the program. The Foundation expects to provide 75,000 hours of care to more than 3,000 veteran caregivers.

"The lack of affordable, convenient, professional respite care has always taken a significant toll on the emotional and physical well-being of veteran caregivers," said Steve Schwab, CEO of the Elizabeth Dole Foundation. "Now, due to the increased health risks and limitations created by the pandemic, we are seeing a spike in the need for short-term relief."

Even as states re-open, some of the most critically wounded or ill veterans and their caregivers will have a long journey back to the pre-pandemic world. These veterans often have vulnerable immune systems that require their caregivers to take every precaution against exposure. By asking family and friends to keep their distance, they are losing a vital source of daily support.

"We are grateful to CareLinx and Wounded Warrior Project for helping us respond to this urgent need," Schwab continued. "We hope other organizations also step up, so we can ensure every veteran caregiver suffering during COVID-19 receives the help they need."

The program is rolling out in select

### First Lady Casey DeSantis and Department of Children and Families Announce Nearly \$5 Million Emergency Grant for Crisis Counseling Program

On October 19, 2020, in News Releases, by Staff

Tallahassee, Fla. – Recently, the Department of Children and Families (DCF) received a nearly \$5 million emergency grant to implement a Crisis Counseling Program to help Floridians respond to the behavioral health impacts of the COVID-19 pandemic. The grant, awarded by the United States Department of Health and Human Services' Substance Abuse and Mental Health Services Administration (SAMHSA), will provide crisis counseling services through Florida's network of 2-1-1 crisis helplines, assisting individuals in need of mental or behavioral health counseling and referrals.

"Governor DeSantis and I are grateful for the opportunity to increase access to critical behavioral health services," said **First Lady Casey DeSantis**. "Through this program, one-on-one counseling will be readily available to those in crisis, ensuring they have the resources and support they need to address their own specific needs, recover fully, and begin to move forward with purpose."

Under the Federal Crisis Counseling Program Service Grant, DCF was awarded \$4,994,530 to be utilized over the next nine months. This funding will expand the existing capacity of crisis counselors within twelve 2-1-1 providers, while promoting the availability of behavioral health services among vulnerable populations, including children and their caregivers, first responders and healthcare workers, and those grieving a loss. 2-1-1 providers will routinely connect individuals to resources, while conducting telephone counseling services and screening callers for indications of more long-term behavioral health needs.

"With recent increases in calls to 2-1-1 statewide, the need for behavioral health services is overwhelmingly apparent," said **DCF Secretary Chad Poppell**. "Thanks to support from Governor DeSantis, First Lady DeSantis, and our federal partners, Florida's children and families will have access to counseling and referral services they need to cope during this period of transition and recovery."

As stated under Chapter 408.918, Florida Statutes, Florida's 2-1-1 network is authorized to serve as the single point of coordination for information and referral for health and human services. Florida's Crisis Counseling Program provides counseling services in all 67 counties, including the Miccosukee tribe, through 2-1-1 providers.



Here's a nutritious recipe using frozen strawberries in waffles:


**Strawberry Oat Waffles**

- Cooking spray
- Optional Toppings: maple syrup, fresh California strawberries



**Attorney General Moody Advances Fight to End the National Opioid Epidemic Even as COVID-19 Pandemic Rages**

TALLAHASSEE, Fla.—The COVID-19 pandemic has changed daily routines around the world, but it hasn't lessened Attorney General Ashley Moody's resolve to end the deadly opioid crisis plaguing Florida. Even as the novel coronavirus spreads, Attorney General Moody continues efforts to curb the national opioid crisis claiming lives in Florida—issuing statewide recommendations to address the opioid crisis, creating new partnerships to help Floridians struggling with substance abuse and crafting criminal justice training to assist prosecutors in shutting down the sham sober home industry.

Attorney General Ashley Moody said, "Our nation and our state face many challenges, but be assured that nothing will dampen my resolve to put an end to the national opioid crisis that continues to claim lives in our great state. Even before the COVID-19 pandemic struck Florida, we were working hard to stop opioid misuse and save lives, and as we continue to work together to stop the spread of COVID-19, please know that our fight against the deadly opioid crisis has not abated.

"There are signs that the pandemic may be contributing to an increase in opioid deaths, and that is even more reason why we cannot waiver in our fight to stop drug abuse—and why I will continue to work every day, on the local, state and national level, to end this deadly crisis affecting Florida families."

Attorney General Moody began working to stop the crisis even before taking office in 2019. Recent efforts, amid the COVID-19 pandemic, include:

As Chair of the Statewide Task Force on Opioid Abuse, Attorney General Moody and members of the team completed and issued the Task Force's report of findings and recommendations;

Continuing to enhance and update the Attorney General's statewide resource **DoseOfRealityFL.com** with information to help Floridians struggling with addiction;

Securing a new partnership with 211 to help better connect Floridians with local substance abuse treatment and counseling services; and

Creating and distributing a new virtual training tool to assist prosecutors in shutting down the sham sober home industry.

Prior to the COVID-19 pandemic, Attorney General Moody's efforts included:

Assembling a statewide **working group of experts** to identify strategies and best practices for addressing the opioid crisis;

Issuing a strategic report for combating the national opioid crisis impacting the lives of Florida families;

**Personally appearing in court and advocating for expediency** in the state's opioid litigation to hold responsible the nation's largest opioid distributors, manufacturers and pharmacies;

Securing a **successful ruling** denying the defendants' motions to dismiss the state's opioid litigation; and

Pushing back against the loosening of opioid prescribing guidelines by requesting that the U.S. Department of Health and Human Services **reverse a recommendation that medical providers rely on personal judgment** instead of consulting evidence-based recommendations, including opioid prescription duration and dosage.

**Provisional data** from the Centers for

Disease Control and Prevention include 70,980 fatal overdoses in 2019, with about 1,000 more deaths to likely be added, marking a 4.8% increase from the year before. The data indicates the U.S. last year likely eclipsed the prior record high of 70,237 overdose deaths set in 2017—and that the pandemic could exacerbate the opioid crisis.

In August, Attorney General Moody sponsored a cabinet resolution declaring Aug. 31, International Overdose Awareness Day.

TALLAHASSEE, Fla.—Attorney General Ashley Moody, along with 27 other state attorneys general, obtained a judgment against Tennessee-based Community Health Systems, Inc., and its subsidiary, CHSPSC LLC. This judgment resolves an investigation of a data breach that impacted approximately 6.1 million patients, including more than 430,000 from the state of Florida.

At the time of the data breach, CHS owned, leased or operated 206 affiliated hospitals, including 37 located in Florida. Information exposed in the breach included the addresses, birthdates, names, phone numbers and Social Security numbers of patients. The judgment, agreed to by CHS, requires a \$5 million payment to the states and provides that CHS agrees to implement and maintain a comprehensive information security program reasonably designed to safeguard personal information and protected health information that will include specific information security requirements.

Attorney General Ashley Moody said, "Health care patients are routinely asked to reveal personal information in the course of treatment. The added stress surrounding a data breach exposing personal information can be overwhelming. I'm glad we were able to provide relief to the more than 430,000 Floridians impacted by the negligent actions of this health care company."

Specific information security measures contained in the agreed judgment include

requirements to:

- Develop a written incident response plan;
- Incorporate security awareness and privacy training for all personnel who have access to protected health information;
- Limit unnecessary or inappropriate access to protected health information; and
- Implement specific policies and procedures regarding business associates, including use of business associate agreements and audits of business associates.

In addition to Florida, represented by Consumer Protection Division assistant attorney general Patrice Malloy, the multistate group includes Alaska, Arkansas, Connecticut, Illinois, Indiana, Iowa, Kentucky, Louisiana, Massachusetts, Michigan, Mississippi, Missouri, Nebraska, Nevada, New Jersey, North Carolina, Ohio, Oregon, Pennsylvania, Rhode Island, South Carolina, Tennessee, Texas, Utah, Vermont, Washington and West Virginia.

The proposed judgment is pending judicial approval.

## Ed's Story

### Ed's Story—Everyone With ALS Counts

(NAPSI)—Amyotrophic lateral sclerosis (ALS) is a fatal neurological disease that attacks the nerve cells. It first gained national attention as Lou Gehrig's disease,

named after the famous baseball player who was diagnosed with ALS in 1939. To date, the cause of ALS is unknown, and there is still no known cure. The disease strikes quickly, usually leading to death within 2–5 years of diagnosis. But every person with ALS has an individual story, and understanding these stories will help researchers ultimately piece together clues about the disease.

Ed Tessaro was diagnosed with ALS in 2009. As he learned to cope with this diagnosis, he reflects, "I've never considered myself a victim of the disease, because I believe in my heart all of us have a wheelchair. In my case, it's quite literal, but with everything that goes on in my life, I realize that every family has had a crisis." One of the things that helps him and others with ALS is reaching out for community support and resources. "The ongoing struggle is to encourage newly diagnosed people to come in and talk about their condition. I want to help people learn about the National ALS Registry, clinical trials, and other resources that can provide support and hope."

The National ALS Registry helps gather information from those who are living with this disease. Researchers from all around the world can access the Registry data to help

scientists learn more about what causes this disease. Everyone's story is different, and everyone's piece of the puzzle is essential. The Registry has found that more than 16,000 people with ALS live in the United States. It is important to include as many people as possible living with the disease to get the most accurate information. When patients join, it helps give researchers more information. This could lead to a better understanding of the causes of ALS, because learning more about the disease is one step further in the battle to defeat it.


