## Supreme Court Rules

### Supreme Court Rules Warrant-less Home Gun Confiscation

In 2015, Edward Caniglia and his wife had an argument at their home Rhode Island. During the argument, Caniglia retrieved an unloaded gun from their bedroom. Mrs. Caniglia left. , Mrs. Caniglia called the police the next day to request a wellness check on her husband. At the home, the sergeant determined that Caniglia was in imminent danger to himself and to others. The police requested that Caniglia go to a hospital for psychiatric evaluation. Caniglia agreed based on a promise from police that they would not confiscate his guns. The sergeant seized firearms and ammunition from the home. Some time later, Caniglia attempted to get his firearms back from the police department on several occasions. His requests were denied. Caniglia filed suit in district court against the police department and city officials, alleging violations to the U.S. Constitution and to state law. The firearms were returned to Caniglia. The district court granted the defendants' motion for summary judgment. On appeal, the U.S. Court of appeal for the 1st Circuit affirmed the district court's ruling.

## AS I SEE IT

### GUN LAW!

**Constitution of United States of America 1789 (rev. 1992) Amendment II.**

*"A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed".*

Is it clear?

Maybe! Maybe not!

The first part includes 'Well Regulated' and 'free State' – doesn't that suggest that the original intent was that each State (I. E. the 'government') should legislate it's own amateur, 'Militia' to fight against any Federal infringement of States Rights?

Is the second part of the same sentence an 'explanation' not an 'expansion'?

Was it intended to clarify/confirm that the Federal government can't prohibit (infringe on) the right of those people (the members of the militias) to own weapons (to keep and bear arms)?

Was the intent that each State should have its own, armed military and that the Federal Government can't stop them? And, it is a fact that all 50 states prohibit private paramilitary groups.

That interpretation would mean that Amendment II in no way permits private individuals to have a gun!

But AS I SEE IT 'prohibition' doesn't work – never has and never will (in the USA).

Now the State of Texas has 'outlawed' Gun Control, voiding licensing and training.

\*Except for 'under 21's' who will have to break the law and carry a gun, or 'Stand Your Ground' and pray!

Apparently, of the 15 million adults in Texas, only about one million have a handgun permit.

A Senator said that people with a criminal history are not included, but he wasn't asked when and how he would figure out who those people are.

Surprisingly, nearly 60 percent of Texas voters say that a gun permit should be mandatory, and the Law Enforcement community has pointed out that this law would put the lives of police officers, first responders and the general public at even greater risk."

"People who had never held a gun in their lives would be legally authorized to carry those guns almost everywhere," But supporters of the legislation say that the rising violent crime rate in major cities is due to Democrats failure to address the underlying problems in society.

Perhaps they are right!

The laws pertaining to the acquisition of firearms in Switzerland are among the most liberal in the world.

Switzerland allows semi-automatic, and fully automatic firearms (permit required), even by visitors with or without permanent residence.

Apparently their off-duty soldiers, all adult males, take their weapons home. Presumably hung up over the fireplace!

The unasked question is "Why is there so little gun violence? They don't have to buy a gun or steal one because there's a semi-automatic in every house!

## Undercover Drug Operation

### LAKE SHERIFF'S UNDERCOVER DRUG OPERATION LANDS 22 IN JAIL

The Lake County Sheriff's Office initiated Operation Basic Training during recent months, which was a joint investigation into a drug-trafficking organization operating throughout Central Florida. The Lake County Sheriff's Office, Drug Enforcement Administration (DEA), and the Clermont, Leesburg, and Eustis Police Departments all worked together to investigate narcotics-related crimes committed by mid- to high-level dealers associated with the organization. The Special Investigations Bureau concluded Operation Basic Training on April 28, 2021 with the execution of two residential search warrants within the city limits of Leesburg and thirteen arrest warrants for individuals charged in connection with their involvement with dangerous drugs.

Detectives executed search warrants for one storage unit, one passenger car, and four residences. The long-term investigation resulted in the seizure of approximately \$13,000 in U.S. currency and trafficking amounts of cocaine, crack cocaine, and methamphetamine. Detectives also seized several pounds of marijuana, cocaine-laced marijuana, and a small quantity of Oxycodone. The street value of the seized narcotics is estimated to be more than \$50,000 dollars. Ten assorted firearms were recovered during the search warrants, four of which were reported stolen from other jurisdictions throughout Central Florida.

Twenty-two individuals were charged with a variety of drug-related crimes throughout the investigation. These charges range from trafficking in cocaine and trafficking in methamphetamine to sale of

heroin/fentanyl within a thousand feet of a church. Many of the arrestees were charged with multiple felony drug offenses.

This operation was a concerted effort to target and combat the heroin and opioid epidemic, as overdoses throughout the state and beyond continue to rise.

"This is a fight we have to fight together, and we will keep fighting to put these dealers out of work here in our county," said Lake County Sheriff Peyton Grinnell. "We are thankful for the strong partnerships we have here with our fellow law enforcement agencies, as well as our citizens, and will continue working together with them to keep Lake County safe."

Leesburg Police Chief Rob Hicks added, "The Leesburg Police Department is very pleased with the outcome of this investigation, and the ongoing investigative efforts by all involved agencies. Cooperative investigations, such as this, enhance the quality of life for our citizens and improve the overall safety of our children and communities alike."

## Drug Bust In Tavares

### TWO MEN ARRESTED IN DRUG BUST IN TAVARES

On May 13, 2021, the Lake County Sheriff's Office's Special Investigations Bureau, with the assistance of the sheriff's SWAT team, executed a search warrant at 31726 Tropical Shores Drive in Tavares. The residence was believed to be a known location where narcotics were commonly used and sold.

Three adults and four juveniles were located in the residence at the time the search warrant was served.

A search of the residence yielded 29 grams of Fentanyl, 8 grams of heroin, one High Point .45 cal. semi auto pistol, 72

Dear Friends,  
The 2021 Legislative Session (and the ensuing Special Session on Gaming) has concluded. It feels good to be back in Senate District 12 with my family and friends.

Thanks to Senate President Wilton Simpson, House Speaker Chris Sprowls and Governor Ron DeSantis, we accomplished much and we are very proud of the strong position that

Florida is in for the future. For the next two or three columns, we will highlight some of the work we did as a body, on behalf of the citizens of Florida. This month, we will report on the budget.

A quick note: In the last two columns, we have highlighted extensively our elections integrity bill and we are excited to report that the bill was approved by the legislature and signed by the Governor.

The legislature approved a \$101.5 billion

balanced budget that leaves \$6 billion in state reserves, while making key investments in infrastructure, child welfare, and increasing the state employee minimum wage. The budget also included bonuses to our hardworking state and local first responders, teachers, and childcare providers, and nearly \$1 billion will be provided to reimburse health care employees and emergency responders for childcare expenses incurred during the pandemic.

The Legislature further increases an already unprecedented level of per student funding for K-12 education, and increases our allocation to again raise teacher salaries. Totally spending for education in Florida is

nearly \$40 billion and is the second most significant portion of state spending, right next to healthcare. Do not let anyone tell you that Florida does not invest in education!

Health and Human Services represents \$45 billion of state funding. This year we ensured that our Medicaid program remains fully funded, as well as the KidCare Program, which provides high quality health insurance for 229,000 children in Florida.

Significant investments are made to expedite water quality improvements and environmental restoration projects, as well as replenish the funds available for state highways projects, which declined last year as people spent more time at home due to the pandemic. Total funding for environmental and agriculture projects comes in at around \$4.4 billion. This includes immediate spending of \$111 million to fund project grants and planning for threats from flooding and sea level rise.

The best part about all of this? These responsible and strategic investments are made without needing a state income tax and without taxing businesses to death like they have done in New York and California. Our budget is half the size of New York, and we have more people than they do. Yet, by keeping taxes low and allowing people more freedom, we can ensure Florida continues on its path towards a full economic recovery, and positions our state to address any potential challenges and opportunities that lie ahead.

### Hurricane Preparedness

Hurricane Season is upon us in Florida. The 2021 Atlantic hurricane season runs June 1 through November 30, 2021. The NOAA forecasters predict a 60%

chance of an above-normal season. The time to prepare for the hurricane season is when you have time and are not under pressure. The Lady Lake Police Department would like to encourage all residents to begin preparations for this anticipated busy hurricane season now, before the season gets into full swing. Some things to consider during your preparations should include,

- Formulate an evacuation plan and an alternate plan
- Keep a first aid kit and check that it is stocked
- Plan on at least one gallon of drinking water per person, per day (at least 3-5



days)

- Stock supplies of non-perishable food items like peanut butter, cereal, granola bars and dried fruit for at least 3-5 days
- Have at least a 7 day supply of medications
- Flashlight
- Extra Batteries and portable chargers
- Personal hygiene items
- Waterproof container with cash and important documents
- Make sure that cats and dogs are wearing collars and identification tags that are up to date
- Put your cellphone number on your pet's tag (or a relative/friend's number in case you need to evacuate)
- check in advance to find out about pet-friendly shelters and special needs shelters if required

Additionally, help your neighbors. Many people, especially senior citizens, rely on the assistance of neighbors before and after a hurricane. Help your neighbors collect supplies they will need before the storm or assist them with securing their residences. Assist them with evacuation if needed or ordered to do so. Check on them after the storm when it is clear and safe.

With proper preparations and planning ahead you may remain safe in an emergency.

## Alzheimer's Disease



### New Hope for People with Alzheimer's Disease

(NAPSI)—There could be promising news for the more than six million Americans living with Alzheimer's disease and the people who care for them.

#### The Problem

Although nearly one in every three people will eventually be afflicted and it's the third leading cause of death of older adults in the U.S. (surpassed only by heart disease and cancer in non-pandemic years), there may be effective treatments on the horizon.

#### An Answer?

One contender is about to start a Phase I clinical trial. It's a novel drug known as NVG-291 and it's designed to repair damaged nerves. Originally developed by NervGen Pharma Corp. (TSX-V: NGEN) (OTCQX: NGENF) to treat spinal cord injury, it soon became apparent that the drug may be healing nerve damage at a biologically fundamental level. That suggests it can also help people who have multiple sclerosis and Alzheimer's disease.

#### Why It May Work

According to NervGen President & CEO Paul Brennan, NVG-291 is a truly unique and logical approach to treating Alzheimer's disease patients. "What differentiates NVG-291 from other drugs in development is that it leverages multiple

mechanisms for repairing nerve damage," he explains, "while most others focus on a single approach. Alzheimer's disease is a complex condition and likely caused by multiple factors. We believe that a systems approach to treating the disease is an important distinction."

NVG-291 is designed to achieve this by liberating the body's own repair mechanisms to accelerate nerve repair. When nerve damage occurs, either as a result of an injury or disease, molecules called chondroitin sulfate proteoglycan, or CSPG, accumulate and inhibit the body's ability to repair itself. NervGen's technology is designed to counteract this inhibition and result in the initiation of multiple repair mechanisms, including nerve regeneration and remyelination - the repair of the protective coating of the nerves. It should also improve plasticity, which is where surviving nerves take on additional function.

There are two additional mechanisms that are seen to be very important in treating Alzheimer's disease. Data in animal studies show that inflammation in the immune cells of the brain is reduced and autophagy, a cellular cleaning mechanism necessary for healthy neurons, is promoted. Researchers believe the same nerve-rejuvenating biotechnology can be adapted to remedy this mind-desecrating disease.

Currently approved Alzheimer's disease drugs merely address symptoms, whereas NVG-291 should act at a more fundamental level to let normal repair mechanisms kick in to create a favorable environment for nerves to grow and form entirely new nerve connections, according to Brennan.

The ability to bring to bear numerous mechanisms of repair, including two that are increasingly viewed as critical to addressing Alzheimer's disease, represents an unprecedented medical breakthrough.

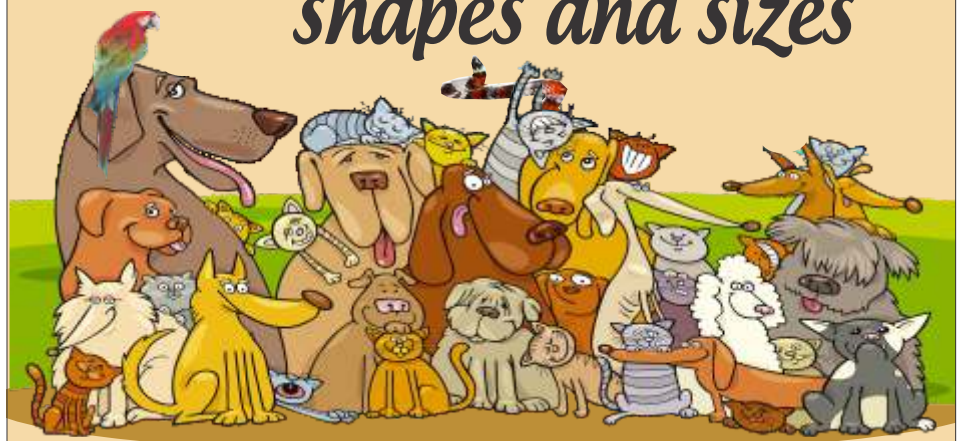

### **Governor Ron DeSantis Announces More Than \$765 Million in Record Funding for Teachers**

**TALLAHASSEE, Fla.** — Today, Governor Ron DeSantis was joined by teachers, school

principals, and superintendents in Baker County, Sarasota County and Okaloosa County to announce a total of \$765 million in funding to support Florida's teachers. *Florida Leads on Election Integrity and Transparency*

**West Palm Beach, Fla.** — Today, Governor Ron DeSantis signed into law Senate Bill 90, Florida's new election integrity bill, strengthening voter identification, prohibiting the mass mailing of ballots, banning ballot harvesting and prohibiting private money from administering elections in our state.

"Florida took action this legislative session to increase transparency and strengthen the security of our elections," said **Governor Ron DeSantis**. "Floridians can rest assured that our state will remain a leader in ballot integrity. Elections should be free and fair, and these changes will ensure this continues to be the case in the Sunshine State. I'd like to thank our legislative leaders on this issue — Senate President Wilton Simpson, House Speaker Chris Sprowls, Senator Dennis Baxley, and Representative Blaise Ingoglia."

"Florida leads the nation in election reforms because the Florida Legislature and Governor have taken a proactive approach to review and address any election issues," said **Senate President Wilton Simpson**. "Safeguarding and maintaining the integrity of our elections is important to all of us. We all lose when people have no confidence in the integrity of an election. That's what we want to avoid. We don't want to backslide. Florida was a model for the nation in November, and that is something we can all take pride in. With this legislation, we are codifying provisions of the Governor's executive order that were largely credited as a reason Florida's 2020 general election went so smoothly, and why results were available much quicker in Florida than in many other states. I appreciate the Governor's leadership on this important issue."

"Floridians have more options to cast their ballot than ever before. With that variety must come assurance of security, accountability, and transparency," said **House Speaker Chris Sprowls**. "The bill Governor DeSantis signed today will protect our election procedures and provide voters with confidence that our elections will remain accessible, efficient, and secure. The right to vote should never be taken for granted, and we must always strive to improve the processes that establish the foundation of our democracy."

"Florida's leaders have answered the call to ensure that our elections process remains secure and credible," said **Senator Dennis Baxley**. When it comes to the integrity of our free and fair elections, our state did not

wait until something went wrong. Instead we were proactive in our responsibility to ensure that Florida voters are confident that their vote is being counted. Thank you, Governor DeSantis, for your leadership and for helping us make Florida a place where it is easy to vote and very hard to cheat."

"This legislative session, we set out to improve and strengthen the integrity of elections," said **Representative Blaise Ingoglia**. "We set out to ensure safe, secure and trusted measures for voting, and we prevailed. I thank Governor DeSantis for his vote of confidence to carry such landmark legislation that will restore confidence in the most sacred right we have as Americans."

Senate Bill 90 strengthens existing voter ID laws, bans ballot harvesting, prohibits unsolicited mass mailing of ballots, increases election transparency, and prohibits private money from administering elections. While Florida already requires identification to vote, Senate Bill 90 will require additional identification information when changing any voter registration information, or requesting a vote by mail ballot, preventing fraud and securing the voter rolls.

The proposal strikes a reasonable balance for families and those in elder care facilities while simultaneously banning ballot harvesting by political operatives. Under this law, a person may not handle more than two ballots other than those of immediate family members. There is an exemption for ballots collected during supervised voting at assisted living facilities and nursing homes to make sure no undue burden is caused for Florida's most vulnerable.

The proposal bans the mass mailing of ballots, ensuring that vote-by-mail ballots are only sent to the individuals that requested them, and only if requested for each election cycle they intend to vote by mail. The bill also increases election transparency, allowing each political party and candidate guaranteed access to observe signature matching reviews by the canvassing board, and allows for appointed watchers on their behalf.

The bill bolsters reporting, requiring that every county have access to live voter turnout data, updated hourly by Supervisors of Elections (SOEs). SOEs will also be required to post, beginning at 7 p.m. on Election Day, the number of vote-by-mail ballots that have been received and the number of vote-by-mail ballots that remain uncounted. This reporting will be updated at least every hour.

Finally, the bill will prohibit private money from administering elections by prohibiting our Election Supervisors from accepting donations or grants to fund any aspect of election administration or operations.

Attorney General Moody Issues 2021 Hurricane Preparedness Guide

TALLAHASSEE, Fla.—Attorney General Ashley Moody today released the 2021

Hurricane Preparedness Guide in advance of this year's Atlantic Hurricane Season that begins June 1. The Florida Attorney General's Hurricane Preparedness Guide is a resource that provides current information about major storm events, how to prepare homes for a hurricane strike and avoiding scams in the aftermath of destruction. Following a [record-breaking season](#) last year, with 30 named storms, Attorney General Moody is encouraging Floridians to make preparations now and to have a plan in place.

Attorney General Ashley Moody said, "Preparing for hurricanes and dealing with the aftermath of a major storm is an unfortunate reality of living in Florida. If you are new to our great state, or need to update your family's plan, the 2021 Hurricane Preparedness Guide is a great resource of information. The guide includes hurricane safety tips, as well as information about how to avoid being swindled after a storm. The safety of your family, pets and property depends on preparations you make now—before disaster strikes."

The [National Oceanic and Atmospheric](#)

[Administration](#) is predicting the 2021 Atlantic Hurricane Season to be active with 13 to 20 named storms developing—with six to 10 of those storms becoming hurricanes. Beginning with the 2021 season, [NOAA's Climate Prediction Center](#) will use 1991-2020 as the new 30-year period of record, with the average number of storms per season increasing to 14 named storms and seven hurricanes. Last year's record-breaking season saw 30 named storms, 13 of which were hurricanes with six becoming major hurricanes.

The 2021 Hurricane Preparedness Guide provides Floridians with information on tropical storms and hurricanes, how to prepare for incoming storms, making a household emergency plan and tips for avoiding scams after the storm.

Below are some important hurricane preparedness tips from the guide: Know evacuation routes and shelter locations;

- Stock up on enough food, water and emergency supplies for three to seven days;
- Verify that storm-related products are hurricane-proof or impact-proof before purchasing;
- After the storm, be wary of contractors who solicit door-to-door, quote extremely low prices for repairs, demand large upfront payments with no date to return to do work, offer to perform repairs at a discount with leftover supplies from another job; and

- Research recovery charities before giving. As solicitations increase following a disaster, so do charity scams designed to profit off the goodwill of others.

- Price gouging is one of the most common consumer complaints reported during hurricane season. Florida's price gouging laws are designed to protect consumers from becoming victims before or after a disaster. Throughout a declared state of emergency, it is unlawful to sell essential commodities for an amount that grossly exceeds the average price for that commodity during the 30 days before the declaration.

During a declared state of emergency, the Florida Attorney General's Office activates the state's price gouging hotline to receive reports of excessive price increases. The Attorney General's Rapid Response Team also works with businesses and consumers in real time to stop potentially unlawful price increases to ensure Floridians can afford essential storm-related commodities when needed most. Consumers should plan ahead to prepare for a storm and stay

mindful of essential products and prices.

Along with the start of hurricane season, June 2021 also marks the two-year anniversary of Attorney General Moody launching [the NO SCAM reporting app](#), available for iPhone and Android devices in both English and Spanish. The No Scam app offers a user-friendly alternative for Floridians who suspect price gouging and want to report instances during a declared state of emergency.

Today's outdoor power equipment is increasingly easier to use, more efficient and cleaner—and powered in a variety of ways, including battery/electric, hybrids, propane and solar, as well as gasoline and diesel. Even robotic, interconnected and remote-controlled technology has entered the power equipment market.

A utility vehicle can be maneuverable and is smaller than a car, helping transport people and supplies quickly in an emergency.

Get ready in advance. Before a disaster or storm strikes is the best time to buy outdoor power equipment. You never know when the electricity might go out or when a storm might arise.

**Know your needs.** Determine what might

need to be cleaned up or tidied before severe weather arrives. Decide what equipment is needed to keep people and property safe before and after a disaster or power outage.

**Do research.** Outdoor power equipment has changed a lot from what you might remember from years past. The industry is rapidly innovating with equipment becoming faster, lighter, more efficient, more ergonomic and cleaner. Get their recommendations from dealers and store personnel who are well versed in equipment.

**Buy what fits your needs.** Each equipment type and power source has different maintenance and care requirements. Equipment is sized for different levels of need, so it's important to buy what works for your unique situation.

**Think ahead and purchase accessories.** Buy outdoor-rated extension cords for generators and consider getting an approved cover for your generator for rainy weather. Buy and install a carbon monoxide detector if purchasing a generator. Plan now where the generator will be set up (never in a home or garage and always away from your home and any air intake) and determine how to secure it if necessary. Identify safety equipment needed such as chaps, eye protection or hearing protection. Gasoline-powered outdoor power equipment uses E10 or less fuel and most manufacturers recommend adding a fuel stabilizer.

**Purchase appropriate fuel and charge batteries just ahead of a storm.** Use only an approved fuel container for gasoline and have an extra set of batteries on hand.

**Review manufacturer's directions and maintain your equipment.** Always follow

all safety and usage recommendations made by the manufacturer. Save a digital copy of the owner's manual on your computer if possible, so it can easily be consulted in the future. Set calendar reminders for regular maintenance.
