## Emergency Care to Police Injured K-9s

**Governor Ron DeSantis Signs Legislation to Provide Emergency Care to Police K-9s Injured in Line of Duty**

**ST. AUGUSTINE, Fla.** – Today, Governor Ron DeSantis joined members of the Florida Legislature and Florida's law enforcement community to support law enforcement canines injured in the line of duty by signing Senate Bill 388.

"Law enforcement K-9s are often the first to put their lives on the line as they work to apprehend dangerous or armed suspects in high-intensity situations," **said Governor Ron DeSantis**. "From responding to fires to finding missing persons to detecting narcotics or explosives, law enforcement dogs use their unique abilities to rescue victims and detect danger. I'm proud to sign this legislation today to ensure they quickly receive the care needed to recover when injured in the line of duty."

"I applaud Governor DeSantis and the Legislature on this bill that will help protect our K-9 partners," **said Florida**

**Department of Law Enforcement Commissioner Rick Swearingen**. "These dogs are a great asset to Florida law enforcement and the communities we serve and enhancing the ability for them to get critical care in the line of duty is important."

"People often forget that canine officers are an integral part of our law enforcement family," **said Senator Tom Wright**. "We must do everything in our power to protect these animals and make sure they are cared for in the same way as any other officer. I want to thank Governor DeSantis and my colleagues in the Legislature for supporting this bill unanimously throughout the process. We will maintain our steadfast commitment to support all law enforcement officers in Florida."

"I would like to thank Senator Wright for allowing me to run this good bill with him and for the support of Attorney General Moody and you, Governor DeSantis, for signing this important legislation," **said Representative Sam Killebrew**. "As many

of you know, I'm a big advocate for animals as well as law enforcement. Canines often risk their lives to protect others and are hurt in the line of duty; this bill will allow EMT personnel to provide emergency medical care and transport them to a nearby veterinary clinic. Simply, it takes a proactive approach to saving the lives of these officers."

Senate Bill 388 strengthens Florida's commitment to protecting our law enforcement, including canine members of the force. When a law enforcement canine is injured while safeguarding our communities, this bill authorizes emergency service vehicles, such as ambulances, to transport police canines to a veterinary clinic to ensure they quickly get the care needed to recover if there is no individual requiring medical attention or transport at that time. The bill also allows emergency medical technicians (EMTs) and paramedics to provide emergency medical care to an injured police canine at the scene of an emergency or while the canine is being transported.

The result is that, in a close race, 49% of those States voters are disenfranchised immediately.

That means that, often the 'loser' ends up as the winner.

What I see as a major issue, which is never discussed in the media, is the fact that a candidate can make whatever promises they want, just to get elected, and then, once in office, do the exact opposite.

If you run on 'Women's Rights' shouldn't you have to vote that way in Washington?

Same for the Second Amendment and Immigration Control.

Which brings us back to the original question – "Does 'democracy' have a place within a Republic?"

Isn't it a fact that perhaps half of the voters in the USA are against Legal Abortions and against Illegal Immigration?

The other half is for 'Women's Rights' and for Refugees?

So, what choices are there for the typical voter?

Vote for one issue and against the other?

As I See It, we need more 'democracy' and

less 'Executive Orders', regardless of which 'dictator' is in office.

We need to restore, not just the right to vote, but the power to enforce the will of the people.



Dear friends,  
In continuation of last month's column, we will be bringing you some more highlights of the 2021 Legislative Session. Last month was our budget update, and this month will be a highlight of legislation that was sponsored and passed by your Senator of the 12<sup>th</sup> District. Overall, we passed thirteen bills, either as stand-alone bills or added to a

larger policy package. Our priority legislation was SB 90, relating to Election Administration was passed through both chambers and signed by Governor DeSantis shortly after Session ended. This bill addresses a number of issues related to election administration and vote-by-mail. One provision in SB 90 addresses ballot harvesting so that no person may possess a ballot other than his or her own, those of immediate family members and two other



designated individuals. We have tightened up the security around drop boxes. Our bill requires that they only be used during early voting hours, and that they must be monitored, in person, at all times by staff or volunteers of our Supervisor of Elections. Also, the bill expands the timeframe for canvassing vote-by-mail ballots, providing that one vote-by-mail request is good for all elections through the next regularly scheduled general election. Current law states that one request is good for all elections through the next two general elections. This change is necessary to provide voters with more flexibility to decide which method of voting they want to utilize, instead of being locked in for two

cycles. Another priority bill for us this year was HB 282, Moments of Silence in Public Schools. This legislation requires that every classroom in K-12 schools begin their day with a moment of silence. In a noisy, busy world, just think of the impact that one moment of silence might have for all of us. We want to give our young students this chance to pause and reflect, and maybe even say a prayer. Thank you to the rabbis who brought me this idea and for all the hard work they did in helping us get this passed in Florida.

One that hit home for me, personally, was the passage of SB 272, which establishes a Rare Disease Advisory Council within our state. As the father of a daughter with a rare disease, I know how hard it can be to find the resources and support needed to deal with these issues. Rare diseases are defined as any disease with less than 200,000 cases nationwide. We hope that this council will be the springboard for research and ideas for families who may be struggling with rare diseases.

Finally, SB 280 requires school districts to provide basic training in first aid, including CPR, for all students in grade 9 and grade 11. Additionally, it encourages school districts to provide basic training in first aid, including CPR, for all students beginning in grade 6 and every two years thereafter to specify such instruction for students in grade 6 and grade 8. This is common sense legislation that will help save lives and we are very happy to have been able to work this through the process.

It's honor to serve you in the Florida Senate and work on important issues like these. Thank you for sending me on your behalf.

## Shifted The Axis Of The Earth

**Climate Change Likely Shifted The Axis Of The Earth, According To A New Study**

(NAPSI)—Global warming that caused glacial melting is likely the cause of a shift in the movement of the Earth's poles in the 1990s, according to a new study in Geophysical Research Letters, AGU's journal for high-impact, short-format reports with immediate implications spanning all Earth and space sciences.

Melting glaciers redistributed enough water to cause the direction of polar wander to turn, and accelerate, eastward, according to the new research.

"The faster ice melting under global warming was the most likely cause," said Shanshan Deng, a researcher at the University of the Chinese Academy of Sciences.

Summer is officially here in Florida! And that means rising temperatures and heavy humidity. It also means potentially dangerous conditions for pets and children.

The number of child hot car deaths for 2020 was 25. So far in 2021, four deaths have been reported. On average, 38 children under the age of 15 die each year from heatstroke after being left in

a vehicle. On a warm day, temperatures inside a vehicle can rise rapidly to dangerous levels. On an 85-degree day, for example, the temperature inside a car with the windows opened slightly can reach 104 degrees within 10 minutes. After 30 minutes, the temperature will reach 120 degrees. Hundreds of pets are left unattended in vehicles yearly. Pets left inside a hot car may suffer irreversible organ damage or in some cases, die. The Lady Lake Police Department encourages all drivers to never leave a pet or child in an unattended vehicle. Even for "a few minutes" to run inside a store quickly could be deadly for children and pets.

The North and South Poles aren't static, unchanging spots. The axis Earth spins around keeps moving.

The Earth spins around an axis kind of like a top, explains Vincent Humphrey, a climate scientist at the University of Zurich. If the weight of the top moves, the spinning top starts to lean and wobble. The same thing happens to the Earth as weight shifts from one area to another.

Changes in polar drift can occur for a number of reasons, including changes in water on land from melting glaciers and groundwater pumping.

### Changing The Length Of Your Days

The change to the Earth's axis isn't large enough that it would affect daily life, Humphrey added. It could change the length of day we experience, he said, but only by milliseconds.

While the melting glaciers were the main driver of polar drift in the 1990s, "the groundwater contribution is also an important one," Humphrey said. The

analysis revealed large changes in water mass in California, Texas, China and India—all areas that pump large amounts of groundwater for agricultural use.

### Backward In Time

Researchers discovered a way to rewind modern pole tracking analysis to learn why the Earth's poles shifted in the mid-1990s. The new research calculates the total land water loss in the 1990s.

"The findings offer a clue for studying past climate-driven polar motion," explained Suxia Liu, a hydrologist at the University of the Chinese Academy of Sciences.

### Water Loss And Polar Drift

Using data on glacier loss and estimations of groundwater pumping, Liu and her colleagues calculated how the water stored on land changed. They found that the contributions of water loss from the polar regions was the main driver of polar drift.

"I think it brings an interesting piece of evidence to this question," said Humphrey. "It tells you how strong this mass change is—it's so big that it can change the axis of the Earth."

### What It Means

Liu said the research has larger implications for understanding land water storage earlier in the 20th century. Researchers have 176 years of data on polar drift. By using some of the methods in this study, it could be possible to estimate how much land water was lost in past years.



### CS/SB 628 — Urban Agriculture

CS/SB 628 exempts propelled equipment used on a farm or used to transport farm products for the purpose of urban agriculture from the requirement that that farm equipment be stored, maintained, or repaired within the boundaries of the owner's farm and be located at least 50 feet away from a public road. The bill does not exempt nonresidential farm buildings, fences, or signs located on lands used for urban agriculture from the Florida Building Code or local governmental regulations.

The bill defines "urban agriculture" and provides applicability.

The bill authorizes the Department of Agriculture and Consumer Services (Department) to approve five urban agricultural pilot project programs in municipalities throughout the state. The bill sets forth requirements by which the Department may approve such projects, outlines eligibility and application requirements, and provides project length periods. The bill requires that municipalities submit a report to the Department outlining outcome and impact of their pilot projects by a specified date. The Department is then required to submit a report on the outcomes and impacts of the pilot projects to the President of the Senate and the Speaker of the House of Representatives.

The bill expressly preserves local governmental authority to regulate urban agriculture under certain circumstances.

If approved by the Governor, these provisions take effect July 1, 2021.

### Governor DeSantis Wins Major Victory to Protect Florida's Cruise Industry

**TALLAHASSEE, Fla.** — Today, the federal district court in Tampa delivered a major victory for Governor Ron DeSantis against the Centers for Disease Control and Prevention (CDC) and its obstructionist No Sail Orders that have flatlined Florida's cruise industry for over a year. Ruling in favor of Florida's Motion for Preliminary Injunction, Judge Stephen Merryday concluded the CDC's restrictions are likely unconstitutional and overstepping their

legal authority. The Cruise Industry will soon be permitted to set sail again thanks to the lawsuit brought by Governor DeSantis and Attorney General Moody. The state fought on behalf of the cruise industry in Florida to secure the ability to resume operations without overly burdensome requirements that discriminate against children, leave most of the ships sitting in port, and disregard the freedom of Floridians to make decisions for their families.

Beginning July 18, the CDC's orders will become mere "guidance," and cruise ships will hit the open waters once again free from the CDC. As Florida continues to thrive while open for business, the return of the cruise industry marks an important milestone in the fight for freedom.

"The CDC has been wrong all along, and they knew it," said **Governor Ron DeSantis**. "The CDC and the Biden Administration concocted a plan to sink the cruise industry, hiding behind bureaucratic delay and lawsuits. Today, we are securing this victory for Florida families, for the cruise industry, and for every state that wants to preserve its rights in the face of unprecedented federal overreach."

Included in the ruling, the Middle District Court of Florida found that:

- The CDC cannot discriminately keep children and families from cruising;
- Neither the CDC, nor any federal agency, can require a vaccine passport; and
- The CDC must create an actual framework for businesses to resume operations, rather than forcing them to conduct burdensome and bureaucratic tests without any standard by which to be measured.

In its ruling, the court says "Never has CDC (or a predecessor) detained a vessel for more than fifteen months; never has CDC implemented a widespread or industry-wide detention of a fleet of vessels in American waters; never has CDC condition pratique as extensively and burdensomely as the conditional sailing order; and never has CDC imposed restrictions that have summarily dismissed the effectiveness of state regulation and halted for an extended time an entire multi-billion dollar industry nationwide. **In a word, never has CDC implemented measures as extensive, disabling and exclusive as those under review in this action.**"

Judge Merryday also cites a previous ruling stating, "When an agency claims to discover in a long-extant statute an unheralded power to regulate 'a significant portion of the American economy,' we typically greet its announcement with a measure of skepticism."

## Support System For Veterans



### A Critical Support System For Veterans

(NAPSI)—There are certain aspects of the COVID-19 pandemic that many Americans may not have thought about. For example, one area that saw a sharp decline was volunteerism—placing heavy burdens on nonprofit organizations that rely on the compassion of their volunteer forces.

According to a recent research survey by Fidelity Charitable, a nonprofit organization created by Fidelity Investments, two-thirds of all U.S. volunteers had either decreased volunteer hours or stopped volunteering altogether because of the pandemic.

#### Volunteer to Help Veterans

One nonprofit feeling the effects is DAV (Disabled American Veterans) and its Transportation Network, which has helped get veterans to and from medical appointments since 1987, when the government-run system was shut down. The nationwide DAV Transportation Network provides no-cost rides to veterans who need help getting to their Department of Veterans Affairs (VA) medical centers and clinics. Prior to 2020, volunteer drivers spent more than one million hours and logged over 20 million miles, providing more than 600,000 rides for veterans each year.

"We've seen a major decline over the past year in volunteer support across all of our programs," said John Kleindienst, Director of Voluntary Services at DAV. "For our aging veteran population, getting to and from critical care appointments is a growing concern and without volunteers, many veterans have no way to access their health care or get other much needed support."

Ramping up volunteerism for the DAV Transportation Network is critical as the pandemic restrictions lift, as it is anticipated that higher than average numbers of veterans will return to the VA both for routine appointments and for care that was delayed over the past year.

“While safety has been the key priority, we have to think toward the next phase and be prepared to meet this increased demand for transportation,” Kleindienst added. “We know the pandemic has hurt a lot of veterans and they might not get the care they earned without our dedicated volunteers. We need the help.”

VolunteerMatch's survey, “The Impact of COVID-19 on Volunteering” found many in the nonprofit sector are rethinking volunteer engagement strategies to accommodate the current environment. While this strategy works for some sectors, it can be challenging for others.

Nonprofits, such as DAV, are hopeful that there is light at the end of the pandemic tunnel as vaccines are made widely available, restrictions are lifted and communities can safely get back to volunteering.

### What To Know About Mold And Mildew

(NAPSI)—If you're like a lot of homeowners, your domicile is in danger from an insidious, invisible

growth—mold—and you don't even know it. That's because for many people, mold conjures up images of smelly, green and black growth that can cause serious respiratory issues. It is often found in a home after an intrusive water event, such as a flood or a severe rainstorm. The reality is, just about every home has mold, though it only becomes a concern when there are moist building materials and you begin to notice visible mold growth and can smell it.

### Why To Fight Mold

Mold and water damage can have a negative effect on your and your family's health, as well as on the safety and structure of your home. People with allergies to mold may experience sneezing, runny nose, red eyes, rash and upper respiratory problems.

Homes in areas where there's a potential for flooding, tornadoes, or hurricanes are especially at risk. Mold typically grows in damp places such as basements and crawlspaces. Apart from floods, the four major causes of mold and water damage in residences are: leaks in the building envelope (that is, around window frames, roof); unattended plumbing leaks; high humidity levels (particularly from unvented or improperly vented indoor moisture sources, such as kitchens, bathrooms, and clothes dryers); and condensation on cool surfaces (on kitchen and bathroom surfaces, on window frames, in basements).

### How To Fight Mold

The good news is there are steps you can take to identify and remove mold, and prevent its re-occurrence by keeping the water out of the house. AIHA (formerly American Industrial Hygiene Association),

the organization for scientists and professionals committed to preserving and ensuring occupational and environmental health and safety (OEHS) in the workplace and community, created free resources for consumers including: “[Facts About Mold: A Consumer Focus](#),” a downloadable guide to the problems of mold growth and what you can do to prevent it; and a brief video, “[What is mold? Whos affected?](#)” a quick guide to the dangers of mold in your home.

### Who Can Fight Mold

If mold damage is severe, it may be time to seek the help of an OEHS professional or Certified Industrial Hygienist with extensive mold investigation and remediation experience. 



primary tool for such schemes. The COVID-19 pandemic is no exception.

Since news of the virus first broke, the U.S. Securities and Exchange Commission has suspended trading by several dozen issuers for potentially misleading COVID-19-related claims, many involving microcap securities.

### Microcaps Explained

Microcap securities are low-priced securities issued by small companies with low market capitalization. While these securities can represent real businesses, bad actors have a history of engaging in price manipulation and other fraud in the microcap sector. However, even in the absence of fraud, microcap securities can present higher risks than larger companies. Microcap companies may not file reports with the SEC, making it difficult for

investors to get facts about the company's management, products, services, and finances. Additionally, microcap securities have historically been more volatile and often less liquid than stock of larger companies—all reasons to invest with extreme care and only with money you can afford to lose.

Microcap securities are often the subject of pump-and-dump schemes, which involve touting stocks, products and other investments with the promise of huge gains and returns. However, as the price peaks, scammers sell their shares and pocket profits, resulting in the artificially inflated stock price dropping, leaving remaining investors with losses or worthless stock.

### What to Watch For

To help protect your assets, stay alert to warning signs of potential microcap investment scams:

Unsolicited calls, e-mails or text messages touting investments;

Increased promotion of a microcap company or its stock, often focusing on a stock's upside, with little to no support or mention of downside risk;

Unverifiable or questionable claims regarding partnerships, joint ventures or financing agreements;

Unconfirmable information about a public company, including evidence of its business activities;

Abrupt or frequent changes to business model, issuer name or ticker symbol, giving the appearance of a connection to the latest news; and

Recent reorganization or recapitalization of the company, such as through a reverse merger or association with companies currently or previously classified as a shell company, with no or limited operations or assets.

While the existence of these warning signs does not automatically mean an investment is a scam, be cautious. Hints or promises of high returns, with little or no risk, are also warning signs of fraud. Every investment carries some degree of risk, and

the potential for greater returns almost always comes with greater risk.

### Fight Fraud

To avoid fraud, follow these three tips:

1. Never rely solely on unsolicited information promoting a stock. Use Financial Industry Regulatory Authority (FINRA) BrokerCheck® to verify registration status and information on investment professionals and investment firms.

2. Check the SEC's EDGAR database to find out if the company files with the SEC.

3. Be extremely wary of buying investment products or taking investment advice from unlicensed professionals.

If you hear exaggerated or misleading claims, or suspect you or someone you know has been subjected to a scam, report your concerns to FINRA, the SEC and state securities regulator.

Florida Sheriffs**

“Because of the Florida Sheriffs, we have countless programs and initiatives throughout our state contributing to a stronger and safer environment for all Floridians. Thank you, to all our great Sheriffs, past and present, for your service and commitment to our state and the citizens who live here.”

Florida Sheriffs Association President Bobby Schultz said, “Much like the great State of Florida, the Office of Sheriff has grown and evolved over the last 200 years. Today, sheriffs work tirelessly every day to serve and protect our communities. Thank you General Moody, Governor DeSantis and the Florida Cabinet for honoring this historic anniversary.”

In 1821, Florida Military Commissioner Governor Andrew Jackson first established the Florida Office of the Sheriff by appointing Sheriffs to Florida's first two counties. Jackson appointed Henri Piere as Sheriff of Escambia County and James Hannan as Sheriff of St. John's County. In 1885, the state of Florida authorized the Office of the Sheriff in the Florida Constitution. Over the next 100 years, Florida established 67 counties throughout the state, each including a Sheriff's office.

Throughout the past two centuries, Florida Sheriffs have created numerous initiatives to better our state and the communities they serve, including:

- The Florida Department of Law Enforcement;

**Florida Fights Back Against Fentanyl  
Traffickers: Brother and Sister Drug  
Trafficking Duo Convicted for Selling  
Fentanyl**

TALLAHASSEE, Fla.—Attorney General Ashley Moody's Office of Statewide Prosecution secured convictions against a sibling drug trafficking duo. The defendants faced charges for selling and distributing heroin and fentanyl throughout

Central Florida. The convictions come following an investigation into Hector Mojica Phipps' drug trafficking operation involving his sister, Dilcia Mojica Phipps, serving as a proxy while Hector was out of town. Fentanyl is a highly lethal opioid and is increasing in the drug supply throughout Florida—exacerbating the opioid crisis. Nearly 21 people in Florida die each day from opioid abuse.

Attorney General Ashley Moody said, “This sibling drug trafficking team sold heroin and fentanyl, two key drugs at the heart of the nation's opioid crisis—disgraceful. Thankfully, my Statewide Prosecutors, working with the Metropolitan Bureau of Investigation, dismantled their operation, and these poison pushers will harm Floridians no more. Let this serve as a message to any potential fentanyl traffickers: We will find you, we will arrest you and you will serve time for your crimes.”

According to an investigation by the Metropolitan Bureau of Investigation, Hector Mojica Phipps sold and distributed kilos of heroin and fentanyl throughout Central Florida. After making initial contact with Hector through an undercover agent, MBI conducted a wiretap investigation in order to dismantle Hector's trafficking organization and uncover the source of narcotics being distributed. From the wiretap, agents intercepted calls between Hector Mojica Phipps and his source of supply in Mexico—Lorenzo Corral Martinez, a fugitive co-defendant. In the calls, Martinez arranged for Hector Mojica Phipps to receive, by a courier, three

kilograms of heroin.

The investigation also revealed that Hector's sister, Dilcia, trafficked fentanyl for the operation in his absence. MBI first began investigating Dilcia and Hector Mojica Phipps in 2018 when Dilcia completed a drug deal in Orlando for Hector while he was in New York. Following Hector and Dilcia's arrests, the pair's other siblings, Luis Mojica Phipps and Yajaira Mojica Phipps, proceeded to continue the drug trafficking operation. Authorities subsequently arrested Luis and Yajaira for trafficking a kilo of heroin. Luis and Yajaira's cases are still pending.

In 2018, officials arrested Hector and Dilcia Mojica Phipps. On June 3, an Orange County jury convicted Dilcia Mojica Phipps following a two-day trial. The jury convicted Dilcia Mojica Phipps of three felony charges, including trafficking fentanyl, conspiracy to traffic heroin—each first-degree felonies; and the unlawful use of a two-way communications device to facilitate the commission of a felony—a third-degree felony. Today, an Orange County jury convicted Hector Mojica Phipps of nine felony charges, including trafficking heroin, trafficking fentanyl, conspiracy to traffic heroin—each first-degree felonies; possession of a firearm in the commission of a felony—a second-degree felony; and the unlawful use of a two-way communications device to facilitate the commission of a felony—a third-degree felony.


