# Governor DeSantis Holds Roundtable

## Governor Ron DeSantis Holds Roundtable to Support the Cuban People

**MIAMI** – Governor Ron DeSantis was joined by Cuban-American leaders and elected officials in Miami for a roundtable supporting the Cuban people who are protesting the regime's tyrannical grip on the island.

Governor DeSantis called on the Biden Administration to take a strong stance against the oppressive, communist regime that has been using violence against its own people to crush dissent for more than six decades.

**Governor DeSantis said,** “We stand with the people of Cuba. For far too long, a tyrannical communist regime has oppressed its people and used its power to silence any dissidents. Now, the Cuban people are making their voices heard to demand freedom and an end to this dictatorship.

“Still, while the Cuban people are showing tremendous courage, the Biden Administration is showing cowardice. The Biden Administration has been weak in its statements, blaming COVID-19, and not mentioning socialism or communism. While the president and his spokespeople issue empty rhetoric, the federal government is inexplicably lifting sanctions in Venezuela. Right now, the Cuban regime is taking the measure of Washington.

“The people of Cuba are rebelling against a dictatorial government, not seeking minor policy changes that would merely be akin to rearranging deck chairs on the Titanic.”

## AS I SEE IT

Quote:-*"Today, 10.2 million undocumented immigrants are living and working in communities across the United States"*

A contributor on a local website asked *"How does the United States of America benefit from granting 'Naturalization/Citizenship' to foreigners? For whatever reason, almost all of the respondents ranted on about the many contributions made over the years by 'Immigrants'.*

For example- *"We are all immigrants!"*  
- *"Immigrants help grow the economy by filling labor needs, purchasing goods and paying taxes. When more people work, productivity increases."*

- *"As an increasing number of Americans retire in coming years, immigrants will help fill labor demand and maintain the social safety net."*

- *"Putting undocumented immigrants on a pathway to citizenship would increase U.S. GDP by up to \$1.7 trillion over the next decade, raise wages for all Americans, and create hundreds of thousands of new jobs, advancing the country's economic recovery."*

It's interesting to me that these letter-writers, who appear to be educated, intelligent and/or knowledgeable are unable to read/comprehend a simple question!

The question asked (above) was about 'Citizenship' NOT 'Immigration'.

There is a difference, isn't there?

For example, a citizen can't be deported.

But you can renounce your U.S. citizenship or, if you run for public office in a foreign country, or commit an act of treason against the United States, you might be in trouble.

I think I read somewhere that Adolph Hitler was born in Austria, emigrated to Germany, then became 'Naturalized!' So, they couldn't send him back to where he came from even if they wanted to.

The way I understand it, if you have only a green card, you can be deported for a serious crime. (Felon?)

A quote on so-called 'Green Cards' - *"U.S. Immigration law assumes that a person admitted to the United States as a (legal) immigrant will live in the United States permanently. Remaining outside the United States for more than 12 months may result in a loss of lawful permanent resident status"*.

Are they 'foreigners'?  
Quote- *"Foreigner" is one of those words where it is acceptable, but, in some cases, it might have a racist connotation and sometimes it's considered inappropriate. If the person has been living in the country for a long time (e.g. years) it may be considered rude and inappropriate to call them a foreigner."*

But others say, *"Foreigner just means the person is a citizen of a different country than the one in which they are now. If someone who is in fact a foreigner takes offense at being called such, well, that's their problem."*

One supporter of 'Naturalization' wrote

*"Offering citizenship to undocumented immigrants who are essential workers would boost the GDP by a cumulative total of \$989 billion over 10 years and create 203,200 new jobs."*

This column has been 'As I See It' for many years, but, in this case, I don't see it all.

If illegal 'immigrants' are good for America and Americans, as their supporters claim, then they (and their supporters) should apply for legal entry according to law.

But, the fact that they made criminal entry into the USA, a felony under Federal Law, disqualifies them from any kind of legal status doesn't it?

As I See It, the original question remains, 'Foreigners' can come live in the USA legally, under long-established rules, laws and procedures.

'Naturalization/Citizenship' is in no way connected to the 'legal' immigration process. That comes after 5 years residency doesn't it.

All of those jobs, businesses and alleged 'prosperity' which they credit to immigrants can and is accomplished without citizenship isn't it?

So, the question remains *"What is the benefit to America and Americans of giving away their American birthright to people who haven't earned it?"*

"America For Americans!"

The rest of us should be grateful just to be here!



**Back to School Safety**

The Villages Elementary School of Lady Lake will re-open and welcome schoolchildren on August 10, 2021. The Lady

Lake Police Dept. would like to remind all drivers to remain alert and use extra caution around school buses and school zones. The penalties for failure to stop for a school bus in Florida is a minimum of \$200 and if there's a second offense committed in 5 years, the license will be suspended for up to 1 year. Some tips for motorists to remember when driving near and around schools, school zones and school buses:

- Pay extra attention to the lowered speed

- limits in school zones
  - Watch and obey signals from traffic control officers assisting motorists and pedestrians around school zones
  - Load and unload children in designated loading/unloading areas
  - Stop and yield to pedestrians crossing in a crosswalk
  - NEVER pass a school bus from behind if it is stopped to load or unload children. Stop far enough back (at least 10 feet) to allow children space to safely enter and exit the bus.
  - Be extra cautious around bicyclists as children tend to be unpredictable and turn without looking or signaling
  - Put away the phone, don't get distracted, and be extra vigilant.
- Lady Lake Police officers will be patrolling the school zones and bus stop areas in the Town of Lady Lake to enforce compliance with the rules of the road and to ensure the safety of the children.

# WASHINGTON (AP)

Attorney General Merrick Garland on Monday formally prohibited federal prosecutors from seizing the records of journalists in leak investigations, with limited exceptions, reversing years of department policy.

The new policy largely codifies the commitment Garland made in June, when he said the Justice Department would abandon the practice of seizing reporters' records as part of efforts to uncover confidential sources. It aims to resolve a politically thorny issue that has long vexed Justice Department prosecutors trying to weigh the media's First Amendment rights against the government's desire to protect classified information.

"The United States has, of course, an important national interest in protecting national security information against unauthorized disclosure," Garland wrote in his memo. "But a balancing test may fail to properly weight the important national interest in protecting journalists from compelled disclosure of information revealing their sources, sources they need to apprise the American people of the workings of their government."


The memo makes clear that federal prosecutors can, in some cases, obtain journalists' records. Those exceptions include if the reporters are suspected of working for agents of a foreign power or terrorist organizations, if they are under

investigation for unrelated activities or if they obtained their information through criminal methods like breaking and entering. There are also exceptions for situations with imminent risks, like kidnappings or crimes against children.

Garland was moved to act following an outcry over revelations that the department during the Trump administration had obtained records belonging to journalists at The Washington Post, CNN and The New York Times as part of the investigation into who had disclosed government secrets related to the Russia investigation and other national security matters.

Others whose records were obtained were Democratic members of Congress and aides and former White House counsel Don McGahn.

## Non-white/White Neighborhoods



**Across The U.S., Non-white Neighborhoods Are Hotter Than White Ones**

(NAPSI)—Nationwide, in both major cities and small towns, neighborhoods with more Black, Hispanic and Asian residents experience hotter temperatures during summer heatwaves than nearby white residents, regardless of a neighborhood's

income.

These racial disparities exist because non-white neighborhoods tend to be more densely built up with buildings and pavement that trap heat, and have fewer trees to cool the landscape, according to the nationwide study in the AGU journal Earth's Future, which publishes interdisciplinary research on the past, present and future of the planet and its inhabitants.

The trend held up even when wealth was taken out of the picture. When residents had a similar income, non-white neighborhoods still faced significantly higher temperatures than white ones in 71% of the counties.

"Urban climate is different from temperatures outside the city," explained the study's co-author Susanne Benz, an environmental scientist who conducted this research at the University of California, San Diego and is now at Dalhousie University. "Inside the city, temperatures are affected by the buildings surrounding you and by the surface of the streets." Dark pavement absorbs sunlight and releases the heat at night, while trees and other vegetation cool an area through transpiration, when they release water vapor through pores in the leaves.

### High Temperatures Can Be Deadly

Heatwaves cause over 700 deaths a year in the United States. When heat and humidity are so high that a body can no longer cool itself through perspiration, heat stroke can set in, rapidly causing brain and organ damage. People who are older, have certain

chronic health conditions or are physically exerting themselves are most at risk. A few degrees difference can mean life or death.

Using data from NASA and the Census Bureau, Benz and co-author Jennifer Burney, an Earth scientist at the University of California, San Diego, found that in 76% of counties with more than 10 census tracts, poorer neighborhoods were notably hotter than wealthier ones, primarily due to physical differences—more pavement and people and fewer trees. Areas with a larger percentage of people of color or where people had less education also experienced higher temperatures.

Benz and Burney saw the same patterns playing out in less developed areas as in urban ones. "It turns out that even your tiny towns have the same disparities," Benz said, "and this was something that really shocked me."

"The findings are really quite staggering," said Jeremy Hoffman, a climate scientist and chief scientist at the Science Museum of Virginia, who was not involved in the research. "These disparities exist across virtually every built environment in the country. Money doesn't grow on trees, but it is certainly concentrated underneath them across the U.S."

**Treating "Untreatable"**

**Treating "Untreatable" Cancers - Functional Profiling Comes of Age**

Cancers arise from cells that have learned certain tricks to enhance their survival. In so doing they outlive their normal counterparts. These transformed cells interact directly with their micro-environment. Cancer cells "talk" to each other and to all the surrounding immune cells, blood vessels and structural elements using chemical signals such as growth factors and metabolic byproducts. Blood vessels, immune cells and connective tissues all participate and promote the cancer process.

Each human cancer reflects all of its genes, both mutated and normal, acting together to create what we recognize as a malignant tumor. But gene changes are only the starting point and not the final product of

**How To Beat Urban Heat**

There are solutions. Hoffman suggests planting trees at parks, bus stops and along pedestrian thoroughfares and providing incentives for green or white reflective roofs to cool buildings. These initiatives could dovetail with urban agriculture programs, solar panel installation, workforce development and other programs to more holistically address racial inequality.

The new analysis provides information for policymakers and establishes a way to evaluate the success of policies designed to address urban heat. Now that officials can recognize and measure urban heat disparities, they can try to fix them.

cancer development. The practice of just analyzing genes is incapable of capturing the complexity of human tumor biology. Only Functional analyses can interrogate each patient's tumor in real time to provide insights that can inform drug selection and treatment decisions.

Because each cancer patient is unique and very different from one person to the next, drugs that work for one person may not for another, even with exactly the same diagnosis. Standard trial-and-error approaches cannot meet each patient's needs.

### Who Developed the Idea

The pioneer behind this is Los Angeles-based oncologist [Dr. Robert Nagourney](#), author of "Outliving Cancer" and known as the father of precision cancer medicine. His testing of cancer cells against potential drugs offers patients the opportunity to take charge of their cancers and the treatments most likely to work.

[Dr. Nagourney](#) recognized the short comings of modern trial and error cancer

medicine and decided to do something about it. Over the past two decades he has amassed data on over 10,000 patients, providing individualized therapies that have been shown to double response rates and improve survival. While major centers continue to offer gene profiles that examine DNA mutations hoping to find a "magic bullet," those result have been extremely disappointing with a minority of patient's revealing actionable findings.

The Nagourney Institute receives samples from all over the world. If you think functional profiling would be good for you, you can arrange to have your sample collected and shipped overnight to the laboratory. The Institute will even assist you with a specimen transportation kit and specific handling instructions.

## Volunteers Wanted

### A Critical Support System For Veterans

(NAPSI)—There are certain aspects of the COVID-19 pandemic that many

Americans may not have thought about. For example, one area that saw a sharp decline was volunteerism—placing heavy burdens on nonprofit organizations that rely on the compassion of their volunteer forces.

According to a recent research survey by Fidelity Charitable, a nonprofit organization created by Fidelity Investments, two-thirds of all U.S. volunteers had either decreased volunteer hours or stopped volunteering altogether because of the pandemic.

### Volunteer to Help Veterans

One nonprofit feeling the effects is DAV (Disabled American Veterans) and its Transportation Network, which has helped get veterans to and from medical appointments since 1987, when the government-run system was shut down. The nationwide DAV Transportation Network provides no-cost rides to veterans who need help getting to their Department of Veterans Affairs (VA) medical centers and clinics. Prior to 2020, volunteer drivers spent more than one million hours and logged over 20 million miles, providing more than 600,000 rides for veterans each year.

"We've seen a major decline over the past year in volunteer support across all of our programs," said John Kleindienst, Director of Voluntary Services at DAV. "For our aging veteran population, getting to and from critical care appointments is a growing concern and without volunteers, many veterans have no way to access their health care or get other much needed support."

Ramping up volunteerism for the DAV Transportation Network is critical as the pandemic restrictions lift, as it is anticipated that higher than average numbers of veterans will return to the VA both for routine appointments and for care that was delayed over the past year.

"While safety has been the key priority, we have to think toward the next phase and be prepared to meet this increased demand for transportation," Kleindienst added. "We know the pandemic has hurt a lot of veterans and they might not get the care they earned without our dedicated volunteers. We need



the help."

VolunteerMatch's survey, "The Impact of COVID-19 on Volunteering" found many in the nonprofit sector are rethinking volunteer engagement strategies to accommodate the current environment. While this strategy works for some sectors, it can be challenging for others.

Nonprofits, such as DAV, are hopeful that there is light at the end of the pandemic tunnel as vaccines are made widely available, restrictions are lifted and communities can safely get back to volunteering.

"We know there are many passionate and dedicated volunteers who are ready to step up and support our nation's veterans and with added safety measures in place we're beginning to see more people coming out to help. We can only hope it will be enough to keep pace with those veterans in need," added Kleindienst.



These funds help accomplish that important work by incentivizing great educators with proven track records of success to come help our most vulnerable students in our most vulnerable schools succeed.”

· The funds provided through UniSIG will be used to support school improvement initiatives in Florida's lowest performing five percent of schools. Teachers who teach at these low performing schools and have earned highly effective or effective ratings can receive up to \$15,000.

### Governor DeSantis Coordinating State Resources to Surfside Building Collapse

**TALLAHASSEE, Fla.** – Governor Ron DeSantis, Lt. Governor Jeanette Nuñez, Chief Financial Officer Jimmy Patronis, Florida Division of Emergency Management (FDEM) Director Kevin Guthrie, Surfside Mayor Charles Burkett and Miami-Dade County Mayor Daniella Levine Cava are at the Surfside Building Collapse site to receive a briefing of the situation, tour site damage and coordinate state resources.

Early this morning, the State Watch Office received a report regarding the collapse of the Champlain Towers South building in Surfside. Local fire rescue teams immediately responded and began search and rescue efforts.

Governor DeSantis hosted a press conference on the site to provide an update about the disaster and ongoing state response efforts. Remarks from Governor DeSantis and FDEM Director Kevin Guthrie are available.

State response efforts include: FDEM has deployed State Emergency

Response Team personnel to assist response teams.

FDEM Mental Health Coordinator is standing by to deploy as needed and has begun organizing mental health resources across partner agencies. The Division is also coordinating with the Florida Crisis Response Team to provide group crisis intervention to survivors.

The Florida Department of Economic Opportunity (DEO) has activated the Business Damage Assessment Survey to gather information and ensure proper resources are available for response and recovery for the Surfside Community. The survey can be taken at FloridaDisaster.biz/BusinessDamageAssessments by selecting the “Surfside Condo Collapse”. For additional assistance, please call 850-815-4925.

The American Red Cross is providing temporary lodging for displaced individuals and has opened a “Safe and Well” event for the collapse. The “Safe and Well” event is available.

DEO is working with AirBnB to coordinate housing assistance for displaced individuals.

VISIT FLORIDA held a call with AirBnB and VRBO this morning. AirBnB reported that none of their rentals in the building were occupied last night. VRBO reported that they did not have any listings in the building.

The Florida Department of Transportation is coordinating with Miami-Dade County to fulfill resource requests that will assist with scene security and redirection of traffic.

Displaced residents can utilize the Florida Housing and Finance Corporation rental





**Attorney General Moody Highlights App for Reporting Price Gouging in English and Spanish**

TALLAHASSEE, Fla.—In the midst of the 2021 Atlantic Hurricane

Season, Attorney General Ashley Moody traveled to Osceola County to highlight the No Scam Price Gouging Reporting App that is available in both English and Spanish. At a news conference hosted by the Osceola County Sheriff's Office, Attorney General Moody highlighted the first-of-its-kind app that allows consumers to report allegations of price gouging during a declared state of emergency in real time directly to the Attorney General's Office. The app allows users to attach pictures and copies of receipts directly from smartphones when reporting suspected price gouging.

Attorney General Ashley Moody said, "The No Scam app has helped thousands of consumers report outrageous price increases during declared states of emergency, in English and Spanish. As this year's hurricane season is already underway, I am encouraging all Floridians to download this free app to be ready to help us fight price gouging."

In June 2019, Attorney General Moody's office launched the No Scam Price Gouging Reporting App. Since then, the app has been downloaded by more than 21,000

consumers and has assisted consumer protection investigators in the Attorney General's Office with more than 2,200 reports of suspected price gouging. The app also helps increase awareness about Florida's price gouging statute.

The app permits users in real time to: Send pictures of prices on signs, online posts and products;

- Capture and report receipts and email confirmations;
- Write narratives of interactions with sellers and prices observed of essential commodities;
- Report prices of identical products offered by different sellers in the same vicinity; and
- Capture any additional supporting documentation.

For tips on how to better report price gouging, read the Attorney General's [Tips for Avoiding Price Gouging and Gathering Gouging Evidence](#).

Under Florida's price gouging statute, it is unlawful during a declared state of emergency to sell, lease, offer to sell, or offer for lease essential commodities, dwelling units, or self-storage facilities for an amount that grossly exceeds the average price for that commodity during the 30 days before the declaration of the state of emergency, unless the seller can justify the pricing by showing increased costs or changed market

conditions resulting in increased costs.

The Attorney General's No Scam Price Gouging Reporting App can be downloaded for free through Apple and Android stores by searching No Scam.

In addition to being used to report price gouging during states of emergency related to hurricanes, No Scam has been continually updated for use during other states of emergency—most notably the health state of emergency declared last year for the COVID-19 pandemic. **Attorney General Moody Sues Google for Antitrust Violations Over App Store**

TALLAHASSEE, Fla.—Attorney General Ashley Moody is suing Google for illegally and unfairly maintaining a monopoly on the app store for Android devices. Google allegedly uses exclusionary conduct relating to the Google Play Store for Android mobile devices and Google Billing. This antitrust lawsuit is the newest legal action against the tech giant, claiming anticompetitive, illegal and unfair

business practices. The suit accuses Google of using its dominance to unfairly restrict competition with the Google Play Store, harming consumers by limiting choice and driving up app prices. Attorney General Moody joins a coalition of 37 attorneys general in filing the lawsuit.

Attorney General Ashley Moody said, "Time and time again, we have seen Google use its power in the tech industry to unscrupulously exploit the marketplace. Google's manipulation of app distribution on Android devices forces consumers into using Google's services to purchase apps—resulting in a 30% commission charge on in-app payments.

"The tech giant's monopoly on Android app purchases significantly hinders other in-app payment processors from entering the marketplace, leaving consumers with no other options when seeking to download apps. We will not allow Google to continue to monopolize an entire sector—eliminating competition and harming consumers."

According to the lawsuit, Google's exclusionary conduct substantially shuts out competing app distribution channels. Google also requires app developers, who offer apps through the Google Play Store, to use Google Billing as a middleman. This arrangement ties a payment processing system to an app distribution channel and forces app consumers to pay Google's commission on in-app purchases that are distributed via the Google Play Store. This commission reaches up to 30% and is much higher than the commission consumers would pay if they had the ability to choose one of Google's competitors instead.

The lawsuit alleges that Google works to discourage or prevent competition, violating federal and state antitrust laws. Google previously promised app developers and device manufacturers that it would keep Android open source, allowing developers to create compatible apps and distribute them without unnecessary restrictions. The lawsuit argues Google did not keep that promise.

By promising to keep Android open, Google successfully enticed OEMs—mobile device manufacturers such as Samsung—and MNOs—mobile network operators such as Verizon—to adopt Android and forgo competing with Google's Play Store. Once Google obtained the critical mass of Android OS adoption, the tech giant moved to close the Android OS ecosystem—and the relevant Android App Distribution Market—to any effective competition by requiring OEMs and MNOs to enter into various contractual restraints. These restraints disincentivize and restrict OEMs and MNOs from competing, or fostering competition, in the relevant market.

This lawsuit is one of many actions taken against Google by the Florida Attorney General's Office. In September 2019, Attorney General Moody and a bipartisan coalition of attorneys general [launched an investigation](#) into Google's business practices.

Following the investigation in October 2020, Attorney General Moody, along with the U.S. Department of Justice and 10 other state attorneys general, [filed a civil antitrust lawsuit](#) to prevent Google from unlawfully maintaining monopolies through anticompetitive and exclusionary practices in the search and search advertising markets.

In March, Attorney General Moody [filed a lawsuit against Google](#) for multiple violations of federal and state antitrust and consumer protection laws in connection with its role in the multitrillion-dollar online-display advertising industry.

In addition to Attorney General Moody, the attorneys general of the following jurisdictions joined the lawsuit: Alaska, Arkansas, Arizona, California, Colorado, Connecticut, Delaware, the District of Columbia, Idaho, Indiana, Iowa, Kentucky, Maryland, Massachusetts, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Oklahoma, Oregon, Rhode Island, South Dakota, Tennessee, Utah, Vermont, Virginia, Washington and West Virginia.

vaccines are provided by the federal government at no cost to recipients.

**6. Can you get a vaccine from your primary care doctor?** Your primary care doctor may have COVID-19 vaccines available in their office. 
## Internet for People of Cuba
