These pictures seem to solve the question "were the unauthorized cameras in Lady Lake"? The answer is yes the pictures show proof of it. The next questions is who did the installation's, Flock Security did! who where they surveilling, for what reason were they surveilling, did the Lady Lake Town Council know about it? The answer is no the Lady Lake Town Council did not know about it!

There seems to be a lot of confusion about the camera's and how they got authorized to be installed. They were not authorized by the Lake County Commission. I first heard about these cameras by a resident in Lady Lake. They said they have seen them all over. I probe and looked around for more sources of information. I started asking questions. I ran into many dead ends. Most

residents did not know what they were for or who put them there.

I found out the reason I could not get any questions answered is because it started in Leesburg. None of the locals knew what was going on. I have been told Lake County Sheriff authorized the installation of these traffic camera's as a pilot program to help fight crime in the area. Makes policing sense but they needed permits and approval from Lake County Commissioners. The Lake County Commissioners did not know about the method of the Crime fighting program and was very unhappy. The camera's were ordered to be taken down. The poles that held them are still in place. Is there an effort to put them back.

The Lady Lake Town Council was not made aware of the project. As I see it's an infringement on residents privacy. The cameras have been taken down in Lady Lake but were up through most of August. I am sure Lady Lake Town Council will be reacting to this act of anti privacy.

## AS I SEE IT

This column is about 'government' not 'politics'.

Is this the BIRTH OF DICTATORSHIP in the Good Old USA?

Apparently any President, Governor or Mayor can issue an Executive Order which cancels, voids and over-rides the law. This goes all the way back to George Washington and every President since.

A recent example was the outgoing President, closing the border to Mexico, then the incoming President reversing that ban. And, after an invasion of over a million South Americans, he can change his mind again.

All this without any input or control by our elected representatives.

In fact, the Federal Register Act specifies that such orders need not be published if they had "no general applicability and legal effect.", but it doesn't say who makes that decision.

An executive order is supposed to limit the President to managing the Federal Government and should comply with laws passed by Congress and with the Constitution. But, of course, a President can fire any government employee who doesn't comply with his instructions, whether it's best for the country or not.

In theory, Congress could overturn an Executive Order. But any action they take would be vetoed by the President they are trying to control.

Then it would take a two-thirds vote of Congress to over-ride his veto – Not likely that either party would take on their own

President.

The U. S. Supreme Court could rule that an Executive Order is unconstitutional, but they seem to take a year or two to decide anything.

One Presidential Candidate said, of another, ""Executive orders sort of came about recently. Nobody ever heard of an executive order. Then all of a sudden he starts signing them like they're butter," That speaker then said "I want to do away with Executive Orders for the most part."

But eventually he signed about 55 per year and the person he was talking about signed only 35.

Regardless of which party, they're all politicians, so lying comes easy to them.

Florida is another example of a State Governor using his 'Executive Power' to bypass congress, and the voters.

For example, Florida lawmakers adjourned in March 2021 without finalizing a \$93.2 billion budget.

But the Governor used his 'emergency powers' and \$12 billion in federal COVID-19 assistance to trash their budget and make up his own version.

As mentioned, this is not a criticism of that Governors action. My question is "Does this practice, bypass, reduce, eliminate, avoid the concept of FREEDOM and DEMOCRACY valued so highly by all Americans?"

Why spend so much time and money on 'free' elections, when the decisions of our elected representatives can be canceled and ignored by a single 'dictator'?

It's a dangerous trend which threatens freedom in the USA.

AS I SEE IT, it's a mistake to say, "I support the person I voted for, no matter what."

Keep in mind that the other party will 'inherit' the dictatorship which you are creating.

A few weeks ago, the world watched the situation unfold in Afghanistan (thanks to Joe Biden's complete lack of competency) where we saw images of mothers throwing their children over barbed wire in hopes that some friendly troops might take them out of the country. We saw Afghan youths clinging to U.S. cargo planes as they took off, only to

come crashing back to the earth when they found they could hold on no longer. ### School's Open - Drive Carefully:

No matter where in Florida you may live, keeping our children and students safe is a community responsibility.

There are many guidelines put in place to ensure that our students arrive to and from school safely every single day such as designated crosswalks, School Crossing Guards or Community Service Aides, seat belt laws, and so on. But one law that is absolutely crucial and yet often gets ignored is, **"ALWAYS"** stopping behind a school bus.

Drivers need to remember that Florida law prohibits passing, in either direction, a school bus that is stopped with its "STOP" sign extended and flashing red lights activated on a two-way street or highway. If the highway is divided by a raised barrier or an unpaved median at least five feet wide you do not have to stop if you are moving in the opposite direction of the bus. Anyone caught passing a stopped school bus or speeding in a school zone can expect to get a costly fine – the Lady Lake Police Department simply will not tolerate violations that could harm a child. We also

take into account which side of the bus you chose when violating the law. While neither side is necessarily "safer," the amount of danger to kids sharply increases if you pass the bus on the right-hand side, as this is the side that the children use to step off of the bus, and therefore are more likely to be struck by your car.

- Drivers who pass a school bus on the right-hand side, will pay a minimum fine of **\$265.00**. A second offense within 5 years of this nature carries an additional **\$265 fine**, as well as the **suspension of your license for 180 days to one year**. There is a mandatory court hearing for both offenses.

- Drivers who pass a school bus on the left-hand side are no less culpable for their actions. You will pay a minimum fine of **\$165**. A second offense will add another \$165 to that total, along with license suspension of 90 days to 6 months.

You will also be required to attend and successfully complete a basic driver improvement course. Submission of successful completion proves to the state that you have reviewed and refreshed your knowledge of Florida traffic laws, including those dealing with school zones and school buses. Please reference Florida State Statute 316.172 and

<https://www.flhsmv.gov/safety-center/child-safety/school-bus-safety/> for further details.

Although any parent whose child takes the

bus to and from school has no doubt cautioned them about the dangers of traffic, we need to remember that children are still young and still learning. With all of the distractions and noises that are abundant on school busses, it's easy to imagine a child stepping off of the bus and not being able to hear oncoming traffic. We are the adults; it is our duty to abide by the laws put in place and give our children a safe environment in which to learn, play, and grow.

On behalf of the men and women of the Lady Lake Police Department, we wish everyone a productive and safe school year.

### They Saved A Baby's Life—Here's How You Could, Too

(NAPSI)—If your family is like most, you've spent months preparing for the joys and challenges that arise with the arrival of a new baby—and if your family is like many, you've discovered not everything can be planned.

### One Family's Story

Consider the case of the McKennas: In July 2020, at six months pregnant with her



second child, Erica McKenna and her husband Dan, received devastating news about their unborn daughter. Their baby was experiencing a condition called maternal alloimmunization. This condition can occur when a pregnant woman's blood contains certain antibodies that attack the red blood cells of the fetus. This can cause the baby to become dangerously anemic.

Doctors told Erica if this condition was not treated, her baby would die. To stabilize and save her child's life, Erica's baby received five blood transfusions in utero starting at 24 weeks.

Just two months later, at eight months pregnant, Erica experienced worrying symptoms requiring immediate action. Within hours, she was in the hospital where she underwent an emergency C-section. Following delivery, her infant daughter was rushed to the NICU where another three blood transfusions were needed.

Nearly a year later, Erica and Dan's

daughter, Annie, is a thriving baby with a smile for everyone.

"You would never know she went through all of that," said Erica. "We're extremely lucky. We're grateful for the people who donate blood and the amazing doctors who took care of us both."

### Arms Out For Annie

To give back, Erica and her family started Arms Out for Annie, a special blood donation campaign with a goal to recruit 100 donors to give blood in Annie's name before her first birthday on September 26.

"Annie's life was saved eight times," said Erica, referring to the eight transfusions her daughter received before and after birth. "She wouldn't be here without them. And I can't imagine our lives without her."

### What You Can Do

Currently, there is an emergency need for lifesaving blood donations. As the nation confronts a severe blood shortage, due to a rise in hospital demand for blood, the American Red Cross urges those who are healthy and able to donate now.

The Red Cross is distributing more blood products to hospitals across the country compared to the same time last year. Over

the past three months, the Red Cross sent 12% more blood products to hospitals each day for patients. Hospitals are responding to a higher number of traumas and emergency room visits and seeing patients who postponed medical care earlier in the COVID-19 pandemic.

All blood types are needed, particularly type O. With only about a day's supply of type O blood, there is an emergency need for type O donors. Type O is the most needed blood group by hospitals. In most cases, those who have received a COVID-19 vaccine can donate.

### How To Help

Healthy individuals are urged to schedule an appointment to give blood or platelets by using the Red Cross Blood Donor App, visiting [RedCrossBlood.org](https://www.redcrossblood.org) or calling 1-800-RED-CROSS.

only are these people coping with the death of their loved one, they may have lost the main breadwinner and be overwhelmed with the stress of paying for a funeral, paying their mortgage, or sending their children to college. But help may be at hand.

### Assistance Available

In May 2020, the Brave of Heart Fund was launched by the foundations of New York Life and Cigna, alongside charitable partner E4E Relief, to provide monetary grants that can help ease the financial and emotional burden of the families of front-line healthcare workers and volunteers nationwide who lost their lives to COVID-19.

### Reaching Eligible Families

The Fund's \$15,000 Phase 1 grants are available to certain spouses, domestic partners, parents, grandparents, children, and siblings of the deceased who are responsible for funeral expenses.

The Fund's Phase 2 grants of up to \$60,000 are available to certain family

members who were financially dependent on the healthcare worker's income for basic living expenses such as housing, utilities and childcare.

All grantees have access to emotional support and bereavement resources at no cost.

A recent Brave of Heart Fund grantee from Massachusetts reflected on the financial support provided, "The Brave of Heart Fund truly saved my life by providing me assistance after losing my husband. The financial grant I received helped me make payments on my car so I could continue getting to work. Through their assistance, I was also able to maintain payments so that I could stay in the home that my husband and I had lived in for years."

### How You Can Help

Anyone can help these families in need by sharing this information: The Fund will accept grant applications through December 31, 2021. Families of healthcare workers and volunteers nationwide—including doctors, nurses, technicians, orderlies, cafeteria workers, custodians, and others—who lost their lives working on the front lines of the healthcare industry during the COVID-19 pandemic may be eligible to apply.

## Alternative To Google Photos



### Picture This: A Free Alternative To Google Photos

(NAPSI)—If you're like most Americans, you have hundreds, perhaps thousands, of photos and videos stored on your phone, computer, tablet and so on. They bring back memories of happy times, loved ones, important occasions and beautiful places and you'd hate to lose them just because your computer dies or your phone gets lost. That's where cloud storage comes in. All cloud storage solutions on the market provide a basic set of services. That includes a specific amount of storage space, easy access to files and the ability to share files with other users.

### The Problem

One of the main differentiators among these products is the amount of free storage space they provide.

Google Photos, for instance, had long been loved for its unlimited free storage. Now, however, any photos you upload will eat into the 15GB of space on your Google account shared with your Gmail and Google Drive. And once that space is used up, you'll need to pay \$29.99 a year if you want to

upgrade to 200GB.

### Some Solutions

Fortunately for consumers, a variety of new cloud storage products have entered the market. Microsoft's OneDrive and Dropbox are familiar names and now there's a promising new product that might be the best free cloud storage provider you've never heard of.

Called TeraBox, it provides users with 1TB (1024GB) of free storage space permanently, with no catch. It's also fully compatible with Android, iOS, and desktop computers. And it can sync your files seamlessly across your devices.

1TB of free space is equivalent to carrying around a high-capacity hard drive on you at all times. That amount of space can store hundreds of thousands of photos, or thousands of high-quality videos.

### Cost Comparisons

Dropbox offers only 2GB of free space. To upgrade to 1TB, you'll need to pay \$9.99 per month. OneDrive fares only a bit better, offering 5GB of space free. A subscription fee of \$1.99 per month will buy you a mere 100GB of extra space. TeraBox may well be the only cloud storage solution to offer 1TB of space, free.

If you find that 1TB of free space isn't enough, you can upgrade to 2TB for \$2.99 per month. Google Drive also offers a 2TB subscription package, but at \$9.99 per month, roughly triple the rate.

### Size Matters

Another important consideration of cloud storage solutions is file size limitations. Users of TeraBox's free service can upload files as large as 4GB, while subscribers can upload files up to 20GB. TeraBox's sharing function has no limit on file size, so no matter how big a file, it can easily be shared with other users.

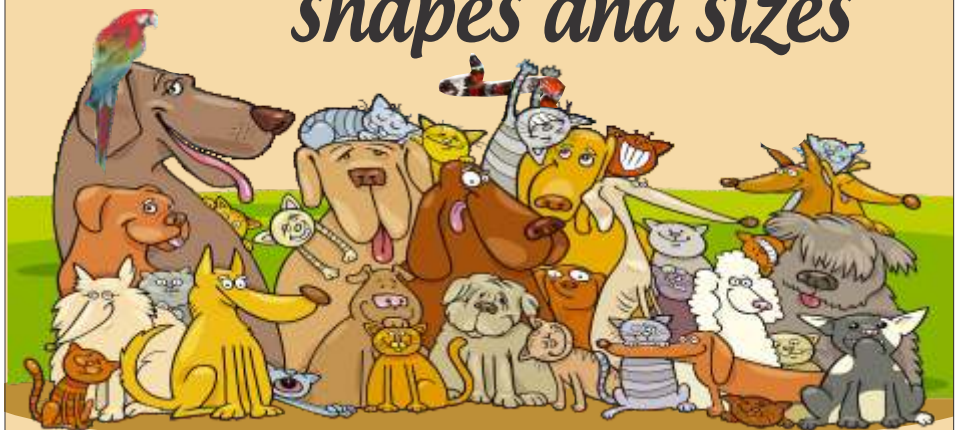

### Governor Ron DeSantis Announces New Monoclonal Antibody Site in Orlando

On August 16, 2021, in News Releases, by Staff

ORLANDO, Fla. –

Today, Governor Ron DeSantis announced that the State of Florida is setting up a new monoclonal antibody therapy treatment site in Orlando at Camping World Stadium. This location has the capacity to serve more than 300 patients per day and will be open from 9 a.m. to 7 p.m. daily.

“Early monoclonal antibody treatment keeps people out of the hospital and saves lives,” said Governor Ron DeSantis. “We look forward to continuing to open these sites throughout the state and hope awareness about the treatment continues to spread.”

To find locations to receive monoclonal antibody treatments around the entire state, please visit [floridahealthcovid19.gov](https://floridahealthcovid19.gov).

“The monoclonal antibody treatment can be a game changer if you get it early,” said Secretary of the Agency for Health Care Administration Simone Marstiller. “I have seen firsthand how effective this therapy can be at keeping people out of the hospital and speeding their recovery. Once again, Governor DeSantis has prioritized Florida’s seniors and has created a delivery

system for the monoclonal antibody treatment that will allow Florida’s most vulnerable citizens to receive the treatment without leaving their long-term care facility and keeping them at home and out of hospitals.”

“The Division is committed to increasing access to monoclonal antibody therapy statewide, in coordination with the Florida Department of Health,” said Florida Division of Emergency Management (FDEM) Director Kevin Guthrie. “We will continue to work with County Emergency Management offices to identify additional locations for this lifesaving treatment and ensure that Floridians have access to all potential treatments that can help them recover from COVID-19.”

“This is a lifesaving treatment that needs more attention,” said FDEM Chief Medical Officer Dr. Kenneth Scheppke. “Thank you to Governor DeSantis for his dedication to protecting Floridians through innovative solutions. By increasing access to monoclonal antibody therapy through mobile and stationary sites, we will continue the fight against COVID-19 in Florida and bring this treatment to the individuals who need it most. Monoclonal antibodies have been used in medicine for decades and have the ability to protect the human body from viruses.”

Monoclonal antibody treatments can be prescribed by health care providers to individuals 12 years of age and older who

have been diagnosed with COVID-19 or who have been exposed to someone with COVID-19 and are at high risk for severe illness and hospitalization. However, to support Governor DeSantis’ initiative, there is currently a standing order in Florida signed by the State Surgeon General that allows patients to receive this treatment without a prescription or referral if administered by an eligible health care provider. Such referrals are not required at any of the State of Florida monoclonal antibody treatment sites and treatments are available at no cost to patients.

The antibodies help the immune system recognize and respond effectively to the virus. According to [the treatment guidelines](#), they should be administered as soon as possible after diagnosis. By providing access to these treatments at these new sites, Governor DeSantis is alleviating demand on hospital resources and further making sure that Floridians have access to all potential treatments that can help them recover from COVID-19.

Governor DeSantis and the Florida Department of Health continue to encourage Floridians to receive the COVID-19 vaccine.

After the Governor’s staff dispelled the misleading narrative and exposed the partisan agenda of the Associated Press, the publication sent a letter to Governor DeSantis on August 20, criticizing him for his staff’s efforts to correct the record.

Today, Governor DeSantis responded to that letter, not only defending his staff, but once again calling on the Associated Press and corporate outlets to stop creating conspiracy theories, publishing clickbait headlines and circulating partisan political narratives, at the expense of readers.

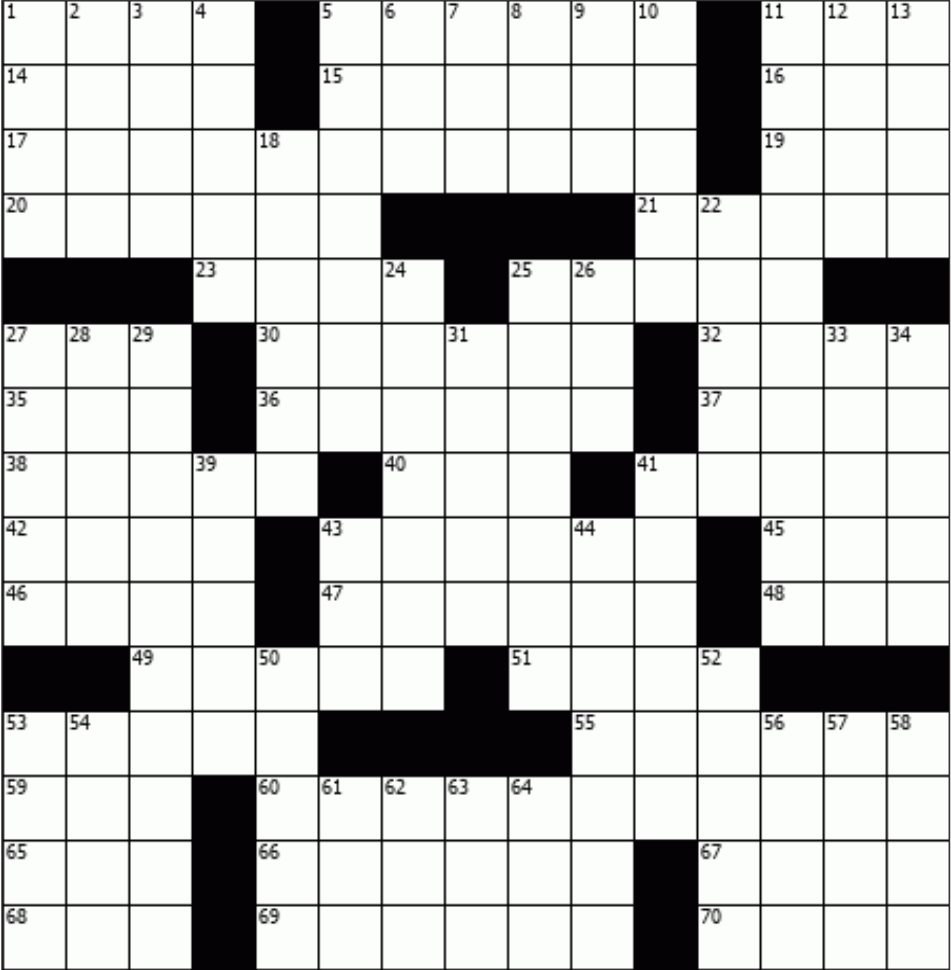

## Whatever Happened To...



### Whatever Happened To Prince John?

(NAPSI)—You may think it's a legend out of ancient times, but in little more than living memory there was a royal prince—who vanished (at least as far as the press and public were concerned).

#### The Story of the Missing Prince

Even an ardent Anglophile and

enthusiastic follower of the British Royal Family might be surprised to hear a story about the little-known prince and the hushed rumors and speculation that surrounded his death for many years.

The fifth son and youngest of six, Prince John (Queen Elizabeth's uncle) was born in 1905. His parents were King George V and Queen Mary. At the time of his birth, his father was heir apparent to the reigning monarch, King Edward VII. In 1910, the Prince of Wales succeeded to the throne and Prince John became fifth in the line of succession to the British throne.

But a childhood illness would play a hand in the fate of the young prince and his story would become something of a well-hidden family secret.

At the tender age of four, Prince John was discovered to have epilepsy, and as his condition worsened, he was sent to live out of the public eye at Sandringham House to be cared for by his governess. His mother gathered local children to befriend the prince, but he was otherwise hidden from the public from early childhood. The young prince died of a severe seizure in 1919 at Sandringham and was buried at nearby St. Mary Magdalene Church. His illness was only disclosed after his death.

### Did The Royals Try To Hide An "Upsetting" Secret...

Royal historians who have since delved into the sad story of Prince John have speculated that the Royal Family tried to hide the Prince away, and this was a great display of inhumanity.

His governess wrote that the family didn't want to let John be with his brothers and

sisters because his frequent attacks "upset them so much." Prince Edward, who was 11 years older than his brother and had barely known Prince John, callously stated in a letter to his mother that he saw this death as "little more than a regrettable nuisance." He later apologized to her for being "cold hearted and unsympathetic."

### ...Or Were They Just Protecting The Family?

Some accounts, however, are very much to the contrary. They state he was a full-fledged member of the family, making frequent public appearances until after his 11th birthday, when his condition became untenable.

#### You Decide

## ATTORNEY GENERAL MOODY



### Attorney General Moody Activates Price Gouging Hotline in Preparation for Tropical Depression Fred

TALLAHASSEE, Fla.—Attorney General Ashley Moody today

activated Florida's Price Gouging Hotline as Tropical Depression Fred approaches the state. The activation follows Governor Ron DeSantis's [state of emergency declaration](#) covering Bay, Calhoun, Citrus, Dixie, Escambia, Franklin, Gadsden, Gilchrist, Gulf, Holmes, Jackson, Jefferson, Lafayette, Leon, Levy, Liberty, Manatee, Okaloosa, Santa Rosa, Taylor, Wakulla, Walton and Washington counties.

Floridians can now report instances of extreme price increases on essential commodities needed to prepare for the storm. Florida's price gouging law only applies to commodities and services essential to preparing for, or recovering from, a storm within the areas of a declared state of emergency.

Attorney General Ashley Moody said, "With Tropical Depression Fred approaching our shores, I'm urging all Floridians to be prepared. I've activated the state's price gouging hotline to accept reports of extreme price increases of essential goods in areas covered by the declared state of emergency. Help us

protect consumers—if you suspect price gouging, report it to my office using the free No Scam reporting app, or calling 1(866) 9NO-SCAM."

During a storm-related declared state of emergency, state law prohibits excessive increases in the price of essential commodities, such as food, water, hotel rooms, ice, gasoline, lumber and equipment, needed as a direct result of the event.

Anyone who suspects price gouging can report it to the Florida Attorney General's Office by using the No Scam app, visiting [MyFloridaLegal.com](#) or calling 1(866) 9NO-SCAM. The Attorney General's No Scam app can be downloaded for free on Apple and Android devices through the app store by searching No Scam.

Violators of the price gouging statute are subject to civil penalties of \$1,000 per violation and up to a total of \$25,000 for multiple violations committed in a single 24-hour period. In addition to the civil penalties for price gouging, state law criminalizes the sale of goods and services

to the public without possession of a business tax receipt.

### Three Arrested for Abuse and Neglect Resulting in Third-Degree Burns

TALLAHASSEE, Fla.—Attorney General Ashley Moody's Medicaid Fraud Control Unit, with the assistance of the Orange County Sheriff's Office and Groveland Police Department, today announced the arrests of three Metro Orlando registered nurses for aggravated abuse and neglect of a disabled adult. Christina Hison, Linda Moore and Christopher Rodriguez Lozada are accused of causing third-degree burns to a disabled adult.

Attorney General Ashley Moody said, "This trio was trusted to provide care to a patient suffering from a serious health condition. Instead of acting in the best interest of the patient, they disobeyed hospital policy and established medical procedure. Because of their actions, the patient suffered a new set of medical issues requiring multiple surgeries. Thanks to the work of my Medicaid Fraud Control Unit and local law enforcement, these caregivers will be held accountable for their neglect and abuse. We will not tolerate abuse of our seniors in Florida."

According to the investigation, Hison,

Moore and Rodriguez Lozada worked as registered nurses for Select Specialty Hospital Orlando North, a long-term care hospital in Orlando. In September 2019, the three provided care to a disabled adult suffering from hypothermia. Against hospital policy and established medical procedure, Hison, Moore and Rodriguez Lozada applied ice bags filled with hot water—allegedly from a coffee maker with a hot water dispenser—to the disabled adult's body in an attempt to counter the patient's hypothermia. The disabled adult was then left alone for at least two hours before another employee discovered that the victim sustained several third-degree burns. As a result, the patient required transportation to Orlando Regional Medical Center to undergo several skin-graft surgeries.

Hison, Moore, and Rodriguez Lozada each face one count of aggravated abuse of a disabled adult, a first-degree felony; and neglect of a disabled adult, a second-degree felony. If convicted, each face up to 45 years in prison and up to \$20,000 in fines. The Office of the State Attorney for the Ninth Circuit will prosecute the case.

The Florida Attorney General's Medicaid Fraud Control Unit investigates and prosecutes providers that intentionally defraud the state's Medicaid program through fraudulent billing practices. Medicaid fraud essentially steals from Florida's taxpayers. From January 2019 to the present, Attorney General Moody's MFCU has obtained more than \$74 million in settlements and judgments.
