### STATE OF FLORIDA OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 22-01 (Executive Order of Suspension)

WHEREAS, Article IV, Section 7(a) of the Florida Constitution provides that the Governor may suspend from office any county officer for commission of a felony; and

WHEREAS, Oren Miller is presently serving as a County Commissioner for Sumter County, Florida, District 5, having been elected in 2020 to serve a four-year term; and

WHEREAS, on December 14, 2021, Oren Miller was charged by Information with the felony charge of perjury in an official proceeding, in violation of section 837.02(1), Florida Statutes; and

WHEREAS, a violation of section 837.02(1), Florida Statutes, constitutes a felony in the third degree; and

WHEREAS, it is in the best interests of the residents of Sumter County, and the citizens of the State of Florida, that Oren Miller be immediately suspended from the public office that he now holds, upon the grounds set forth in this executive order.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, pursuant to Article IV, Section 7(a), find as follows:

- Oren Miller is, and at all times material hereto was, County Commissioner, District 5, Sumter County, Florida.
- The office of County Commissioner, District 5, Sumter County, Florida, is within the purview of the suspension

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, pursuant to Article IV, Section 7(a), find as follows:

The Delta variant, has been controlled, to some extent by vaccines, but it's the OMICRON Variant, which is much less deadly, which has taken over.

Remdesivir is the first drug approved by the FDA for adults and pediatric patients at least 12 years of age in the hospital. Remdesivir, also known as Veklury®, is in a class of treatments called antivirals. It works by stopping SARS-CoV-2 from spreading in the body.

Actemra (tocilizumab): Is a mAb authorized for emergency use for the treatment of some patients in the hospital with COVID-19.

Actemra is a medication for multiple inflammatory diseases, including rheumatoid arthritis, and has shown in studies that it may be effective in treating COVID-19.

Other drugs and treatments, such as mAbs are used to slow or reduce the virus' growth and spread in the body, as well as to enhance breathing and help with other symptoms.

How can any of us stay safe?

You could move to HAITI – no cases reported there!

Dear Friends,  
What a great country we live in! Only in America, could a hard-working young man who started out mowing the lawn and washing cars at a funeral home, eventually become the principle and grow that business in to a thriving company with over 100 employees. That young man is now your State Senator and what a blessing and privilege it is to be

able to serve you in Tallahassee.

First, a quick update on the redistricting process. As of this writing, the Senate and Congressional maps are just about complete and we expect to hold a vote on the final maps very soon. It was the priority of the Senate to get these done early so that we can focus on other needs of the state. Florida's citizens should be pleased with the final product as this open process followed a strict procedure and was done

fairly and constitutionally.

Also, excited to inform you of some legislation that we have been working on for some time and has recently been filed for consideration. SB 1820, the "Health Care Ethics and Liberty Protection Act" is a bill that would protect doctors and health care providers from being forced to participate in or pay for any health care service that violates their conscience. There are those on the left that believe that health care providers should not be able to refuse to perform or pay for things like abortions and gender reassignment procedures, even if these things are inconsistent with sincerely held religious beliefs. Despite the fact that these procedures do more harm than good and can

be very damaging to individuals, we should all at least be able to agree that no one should be forced to participate in something that violates their conscience. This bill would reinforce that right and make it very clear that this will not be tolerated in the State of Florida.

On the front of the fight for Life, Senator Kelli Stargel and Rep. Erin Grall have just filed SB 146/HB 5, which would ban all abortions after 15 weeks. A future column will go in to more detail about this bill, as it is brand new and will need some closer analysis, but we believe this bill is a huge step forward in protecting innocent life. Leadership in both chambers, as well as the Governor, have signaled their intent to pass meaningful pro-life legislation this Session and we believe this is the best chance we have had in a number of years to finally get it done.

Thank you for taking the time to read this legislative update and for engaging in your government. It is an honor to serve the people of Senate District 12.

plate. You expose the image you want on it. Then you apply lacquer to the p[late] and the lacquer sticks to the image of the exposed plate. You then put it on the press. This is where the name offset comes in. The press has a maze of rollers some distributing alumni water solution which goes on the plate as the press runs. the alqueline wet the plate and the lacquer repel's the water so the ink takes it's place. As the press run the image transfers to a rubber blanket and the rubber blanket transfers it to the paper, (Offset printing).

The Production manger said I have never heard of such a thing. I said well it works because I have done it. The Production manager went back to the owner and reported offset printing will never work in his pressroom.

They chose an experimental method called letterflex where you have a plastic plate instead of lead which had to be etched by lasers. The employees making the plates were getting burned and harm by the process, so they had to do something. They soon sold it to Scripts Howard, I had some friends telling me about the changes I was long gone. Hollywood SunTattler was in between the Ft. Lauderdale News and the Miami Herald, they could not expand, so they had very little growth. It was a little late to recover from the losses. They are no longer there. What a shame for the decision of one man who could not make the change a great newspaper went of existence.

### and New Traffic Patterns on U.S. 27/441

As road construction continues along U.S. Hwy 27/441, the Lady Lake Police Department would like to remind all motorists to be aware of the changing traffic patterns. There will be more pattern changes as the widening project continues so it important that all motorists pay attention when traveling through the construction zone. A traffic pattern can be as simple as a shift in a lane that you are traveling on or a detour onto a new roadway like in recent months.

Most local motorists are already aware of the new traffic pattern on U.S. Hwy 27/441 near Fennell Blvd. This pattern will prevent southbound motorists from accessing the bridge. Southbound motorists will need to travel to the right of the bridge on a newly constructed roadway.

The southbound side of the bridge is in the process of being removed.

Please be aware of the "No left turn" signs when traveling southbound near Rolling Acres Rd, Old Vineyard Rd, Fennell Blvd, and Water Oak Blvd. FDOT has put these signs out for the safety of all motorists. You will have to find an alternate route. Be patient and find a safe alternate route. You may have to drive further south and find an intersection to turn around. You can use CR 466 to do so as there is a traffic signal which makes it a safer option. We realize that it is an inconvenience but here is the reality of impatient motorists. The police department responded and worked 17 traffic crashes in the construction zone in the first 6 days of the pattern change. These crashes can be minimized if motorists are paying attention and making the right decision to obey all posted signage. Do not attempt to cross in front of traffic that has the green signal. You will cause a traffic crash. You will be cited and found at fault. You will be dealing with your insurance carrier as the responsible party for property damage and any personal injury.

So please pay attention, remain alert, and make the proper decision when driving to avoid a traffic crash. Why would you want to risk your safety and the safety of others to save a few minutes?

### Attorney General Moody Releases 2022 Online Safety Toolkit to Help Protect Children from Human Traffickers

TALLAHASSEE, Fla.—Attorney General Ashley Moody today released the 2022 Online Safety Toolkit, consisting of red flags, risk factors and statistics relating to human trafficking recruitment via the internet. The [2020 Federal Human Trafficking Report](#) shows that 83% of active sex trafficking cases involved online solicitation. More than half of the children in the United States have smartphones by the age of 11, [according to reports](#).

The 2022 Online Safety Toolkit is designed to help empower parents to teach their children about the dangers of human trafficking online and create effective online safety plans for safe internet use.

Attorney General Ashley Moody said, “It’s important that as parents we take steps to protect our children from online predators. To help with this daunting task, I am releasing my 2022 Online Safety Toolkit during Human Trafficking Prevention Month. I hope this comprehensive resource guide will better equip parents to protect children from human traffickers, or anyone else trying to use social media to harm them.”

Orange County Sheriff John Mina said, “At the Orange County Sheriff’s Office, we are committed to the mission of eradicating Human Trafficking in Central Florida and across the nation. It’s extremely important for parents – and all of us – to recognize the signs of human trafficking, and report anything suspicious to law enforcement.”

Osceola County Sheriff Marcos Lopez

said, “Power comes from information and we need all parents armed with the power to combat human trafficking. The Attorney General’s Online Toolkit is a great way to get informed about the signs of human trafficking and ways to prevent your children from being victims. The information is available in English and Spanish. Check it out so you can help us keep your children safe.”

Metropolitan Bureau of Investigation Director Ron Stucker said, “Human trafficking is a crime that seeks out and exploits the vulnerabilities of victims in our communities. The collaboration of law enforcement, prosecutors, social services and families is essential in bringing hope to

**CONSUMER ALERT:** Beware of COVID-19 Test Scams as Omicron Cases Increase Nationwide  
TALLAHASSEE, Fla.—Attorney General Ashley Moody today

issued a Consumer Alert warning Floridians about new and reemerging COVID-19 test scams as Omicron variant cases increase nationwide. With more and more people seeking tests, scammers may be exploiting this demand to steal personal, financial or medical information. There are recent reports in Florida and nationwide of potential fake COVID-19 testing sites, imposter health care workers at legitimate sites and at-home testing scams. Attorney General Moody is asking Floridians to remain cautious when requesting a COVID-19 test—both at a testing site and at home.

Attorney General Ashley Moody said, “As we have seen throughout the pandemic, scammers change tactics as news and situations change. With the recent rise in the number of people seeking COVID-19 tests comes an increased risk that scammers will try to take advantage of the demand. Please take precautions to protect your personal information when seeking a test—whether at a legitimate site or when purchasing an at-home test.”

Long lines at in-person testing sites have caused many Floridians to seek the convenience of at-home COVID-19 tests and testing services. Before purchasing one of these tests or providing personal information to companies offering at-home testing services, particularly online, follow these steps to verify the legitimacy of the product:

- Only purchase products from a well-established, legitimate store or website;
- Search online for the brand name of the test and any complaints;
- Beware of private companies that offer free or reduced cost at-home testing services, particularly if those companies require private information to make an appointment; and
- Watch out for private companies that require personal information to sign up for an at-home testing service but will not guarantee an appointment time.

In addition to at-home test scams, there have been recent [reports of suspicious COVID-19 testing sites popping up in Illinois](#). The sites appear legitimate but are designed to steal personal information from unsuspecting test seekers. Signs of illegitimate, pop-up testing sites include:

- Having no affiliation with local medical providers or government entities;
  - Not delivering test results;
  - Workers seeming uninformed about the testing process; and
  - Volunteers that are unmasked or not following current [Center for Disease Control and Prevention point-of-care guidelines](#) and the [Occupational Safety and Health Administrations standards](#) during interactions with patients.
- Last week in Sarasota, [law enforcement received reports of suspicious individuals impersonating health care workers](#) at a legitimate testing site asking test seekers to provide personal, financial and medical information. Below are questions to ask to help spot a testing-site imposter:

- Are they dressed the same as the other health care workers on site?
- Are they interacting with test seekers within the established test-site area?
- Can they accurately and correctly answer questions without seeming nervous or confused?
- Do they pressure test seekers for personal or financial information?
- Are health care guidelines and standards being followed?

The U.S. Food and Drug Administration reviews and authorizes the use of products to prevent or treat COVID-19, including vaccines, tests, drugs and non-vaccine biological products, medical products and devices and more. Unfortunately, some bad actors may sell unproven or illegal products to profit off the pandemic. Not only are these products ineffective, but they could endanger consumers. FDA's website

provides an updated list of fraudulent products and warning letters of firms who have been reported for selling these fake products.

Anyone who suspects a COVID-19 test-related scam should report it to local law enforcement, or to the Florida Attorney General's Office by calling 1(866) 9NO-S C A M or visiting [MyFloridaLegal.com](#).

[The 100 Percent Club](#) is a campaign recognizing Florida businesses that pledge to train 100% of employees on how to spot and report suspected human trafficking safely and effectively.

Attorney General Ashley Moody said, “Human traffickers are constantly looking for new angles and tactics to exploit victims and advance their illicit trade. We too must update and improve how we target and stop traffickers. I am proud to join our dedicated partners today to launch a new training initiative designed to dramatically increase the number of Floridians equipped to spot and report suspicious activity in Florida. We also are launching a new statewide tip line and providing quick-reference alert cards to Floridians to assist us in this essential fight.”

Lieutenant Governor Jeanette Nuñez said, “Governor DeSantis and I stand strong in our opposition to human trafficking in our state. As a member of the Statewide Council on Human Trafficking, a former state legislator, and now as Lieutenant Governor, I have embraced each role as an opportunity to listen to victims, advocate for their needs, build partnerships, and develop policies and initiatives—all to protect Floridians and to end this horrible scourge. Through our collective efforts, we will one day be able to say that Florida has put an end to human trafficking.”

Representative Toby Overdorf said, “I am proud to be part of the DSO supporting the Statewide Human Trafficking Council. The training and awareness provided by the council is paramount to changing the tide in the fight against Human Trafficking in Florida.”

Florida Alliance to End Human Trafficking Chair Ellyn Bogdanoff said, “Even though human trafficking is a global issue, it is taking place in many of our communities. By increasing our training efforts, we hope that when citizens see something suspicious, they will call the

hotline and report it.”

Through the program, quick reference resource cards will be provided to trainees to help them effectively report suspicious activities. This could lead to thousands, or hundreds of thousands, of Floridians knowing how to appropriately handle a suspected human trafficking situation. When companies equip employees with the proper tools and training, employees become the eyes and ears throughout the state to spot suspicious activities.

The first members of Attorney General Moody's 100 Percent Club are PGT Innovations, one of the largest private-sector employers in Sarasota County, and Landstar Systems, Inc., one of the largest trucking companies in Florida. Both companies have committed to anti-trafficking training and these partnerships bring Florida one step closer to all Commercial Driver License holders being equipped with proper human trafficking prevention training.

Since increased awareness and education is a vital tool for prevention, Attorney General Moody and the Florida Alliance to End Human Trafficking will be partnering with the Florida Restaurant and Lodging Association, as well as other Florida businesses, to set a goal of 100,000 individuals completing our human trafficking course in 2022.

Working with the Florida Department of Law Enforcement, Attorney General Moody's office created a statewide tip line that will be directly monitored by FDLE for calls of suspected human trafficking. The tip line is 1(800) 342-0820. Alert cards, like the ones shown above, will be spread across the state and provide simple steps on how to report human trafficking using the designated number.

**Viruses tend to spread more quickly in winter months.** As the temperature drops, people tend to spend more time inside. Crowded indoor spaces are perfect places for COVID and other viruses to spread, even sometimes among people who are fully vaccinated. In addition to masking in public indoor spaces, make sure you get a booster on the CDC-recommended schedule.

**Limiting the spread of COVID-19 through boosters can help control the pandemic.** The more a virus spreads, the more likely it is to mutate, increasing the chances of the development of more contagious and dangerous variants. As more people get COVID-19 vaccines and boosters, the spread of the virus will be limited, reducing the chance of new variants emerging. Fully vaccinated people continue

Stop the Wrongs to Our Kids and Employees (W.O.K.E.) Act, a legislative proposal that will give businesses, employees, children and families tools to fight back against woke indoctrination. This [CRT] is not what we need to be teaching in our schools. I want to continue to keep my kids in public school, but their educators need to teach them the basics."

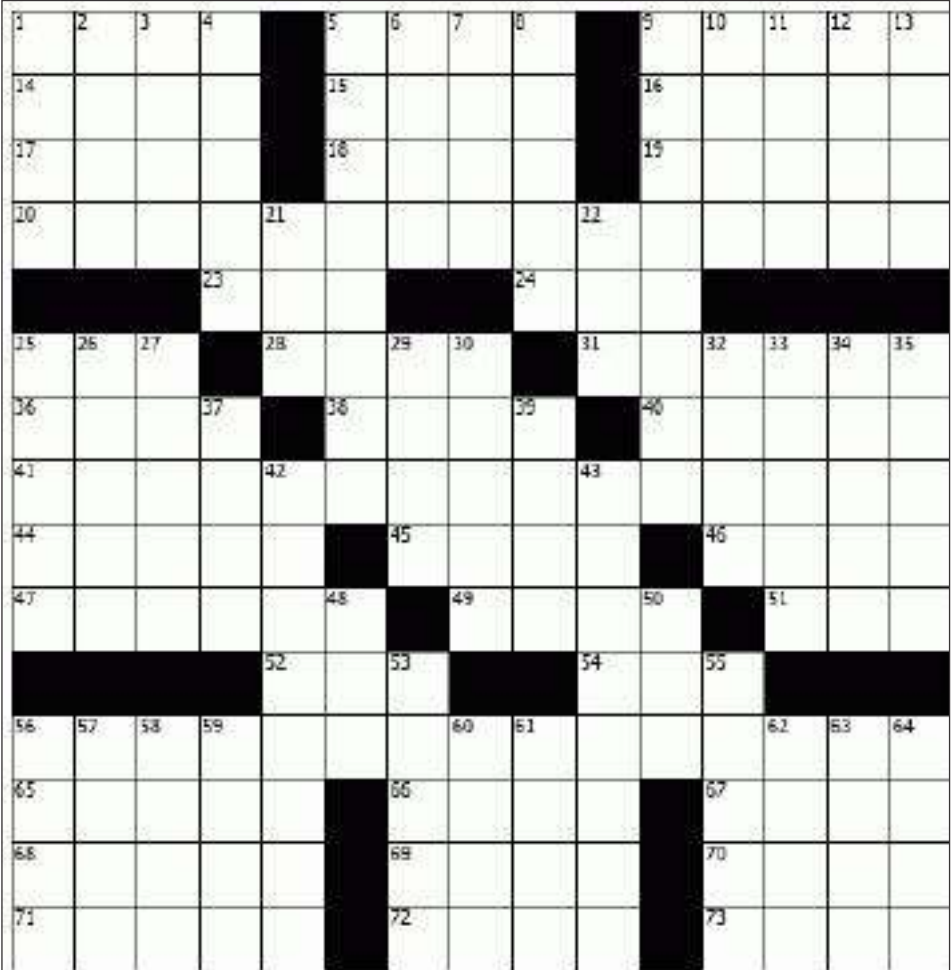

to be protected against severe illness, hospitalization, and premature death. Boosters provide extra protection from cases that can lead to wider spread of the virus and the development of future variants. The best way to control COVID-19 and prevent variants is for more vaccinated people to get boosters.

**Boosters are easy to get and available to all vaccinated people age 12 or older.** Just

as with the vaccines, booster shots are available at no cost to anyone living in the U.S. People who got Pfizer or Moderna vaccines should get a booster five months after the initial doses. Anyone vaccinated with the Johnson & Johnson vaccine should get a booster two months after initial vaccination. Vaccinated adults 18 years and older may choose any available vaccine as a booster, regardless of the type or brand of vaccine received previously; only the Pfizer vaccine is available as a booster for those ages 12 to 17.

Boosters are safe and easy to get and are a great first step to a healthy 2022. For more

victims and justice to traffickers.”

Attorney General Moody's 2022 Online Safety Toolkit contains pages of educational material aggregated from federal, state and local public agencies, as well as private organizations, including the U.S. Department of Justice, the National Center for Missing and Exploited Children, Florida law enforcement and technology companies.

A few tips from the toolkit include:

- Discuss internet safety and develop an online safety plan;
- Adjust privacy settings and use parental controls;
- Be alert to potential signs of abuse; and
- Teach children about body safety and boundaries.

In August 2021, Attorney General Moody released a guide on how to enable parental controls on commonly-used devices, as well as tips to safeguard children's online activity.
