A bill to be entitled

An act relating to independent special amending s. 189.0311, F.S.; dissolving independent special districts; authorizing the reestablishment of certain independent special districts; providing an effective date.

Be It Enacted by the Legislature of the State of Florida Section 1. Section 189.0311, Florida Statutes, is amended to read: 189.0311 Independent special districts; charter requirements.—

(1) Notwithstanding any general law, special act, or ordinance of a local government to the contrary, any independent special district charter enacted after September 30, 1989, shall contain the information required by s. 189.031(3). Recognizing that the exclusive charter for a community development district is the

statutory charter contained in ss. 190.006-190.041, community development districts established after July 1, 1980, pursuant to the provisions of chapter 190 shall be deemed in compliance with this requirement.

(2) Notwithstanding s. 189.072(2), any independent special district established by a special act prior to the date of ratification of the Florida Constitution on November 5, 1968, and which was not reestablished, re-ratified, or otherwise reconstituted by a special act or general law after November 5, 1968, is dissolved effective June 1, 2023. An independent special district affected by this subsection may be reestablished on or after June 1, 2023, pursuant to the requirements and limitations of this chapter.

Section 2. This act shall take effect July 1, 2022.



Dear Friends,
This column will be the second in a series that we plan to write, providing an overview of the 2022 Legislative Session. Last month, we brought some information to you regarding Florida's budget and what the Legislature did with your money. This month, we will highlight two education policy bills that we passed this year

HB 1557, Parental Rights in Education by Senator Baxley and Representative Harding. By now, many of you are familiar with this bill as it received national attention and is part of broader conversation regarding parental rights going all the way back to last year. Given the slanderous moniker "Don't Say Gay Bill" by left wing media outlets, this bill expands on the Parental Rights bill passed in 2021. Let us be clear, this bill says nothing about not being able to say "gay" in schools. We are not prohibiting casual conversations. What we are saying is that children in K-3 schools do not need to be indoctrinated with gender theory instructional material and their parents left in the dark about it. HB 1557 will empower parents and families by prohibiting school districts from adopting policies that require employees to withhold information from a parent regarding their child, unless necessary to protect the child when the school suspects abuse or neglect. Additionally, this bill ensures age-appropriate curriculum by prohibiting teacher-led classroom instruction on gender identity or sexual orientation in the primary grade levels (K-3) and Improves transparency between schools and parents by requiring school boards to notify parents if there is a change in their child's services related to mental, emotional, or physical health and wellbeing. The enforcement arm of this bill authorizes a parent to request the Commissioner of Education to appoint a special magistrate to investigate unresolved parental complaints and recommend resolutions to the State Board of Education within 30 days. Further, it establishes a process whereby parents can bring action against a school district that violates the provisions of the bill that seek resolutions for unresolved concerns.

HB 7, Individual Freedoms by Senator Diaz and Representative Avila. This bill protects individual freedoms and prevents discrimination in public schools and the workplace while supporting factual, educational discussions and materials for our students. The bill identifies several principles of individual freedom to guide instruction and curriculum, such as: No individual is inherently racist, sexist, or oppressive, whether consciously or unconsciously, solely by virtue of his or her race or sex. No race is inherently superior to another race. No individual should be discriminated against or receive adverse treatment solely or partly on the basis of race, color, national origin, religion,

disability or sex. Accordingly, the bill requires that instruction, instructional materials, and professional development in public schools be consistent with principles of individual freedom.

Thank you for the honor of letting me serve you in the Florida Senate. There is no higher calling than serving others.

students from the elementary, middle and high school levels.

Jacen Bartenfelder, a third grader at Watergrass Elementary, was the Water Matters elementary level recipient with his project “Removing Phosphates From Water.” His project looked at the effects of different filtration materials and how they impacted the number of phosphates found in a water sample. The inspiration for his project came after concern about runoff polluting the lake behind his home. This experiment was designed to learn about ways to protect his local bodies of water.

Sebastian Davis, a seventh grader at Pasco Middle School, was the Water Matters junior level recipient with his project “Stopping Thirst One Drop at a Time.” The project aimed to find the best method for removing mineral components from sea water. Davis observed multiple methods to determine the most effective and efficient way to cleanse sea water. His goal was to find the best way to purify salt water to increase freshwater supply.

Muhammad Shahraj, a twelfth grader at Cypress Creek High School, received the Water Matters award for the high school level. His project involved using White-Rot fungi to degrade metal pollutants in different water environment conditions. Shahraj observed the potential of the fungi in his experiment to understand how the heavy metals would break down in larger bodies of water.

Leesburg Man Arrested

Leesburg Man Arrested On Child Pornography Charges

On April 7, detectives with the Lake County sheriff’s Criminal Intelligence Unit executed a search warrant at the residence of 7448 Harbor View Drive in Leesburg regarding suspected child pornography being contained on the premises. Detectives located multiple electronic and digital media storage devices that were collected as evidence. On-scene forensic analysis was conducted on some of the devices, which revealed numerous images of the sexual performance of children ranging from infants to teenagers.

The suspect in this case, Keith Alan Wilkins (D.O.B. of 9/03/1960), was taken into custody and charged initially with 11 counts of possession of images depicting the sexual performance by a child and possession or promotion of certain images of child pornography. Further forensic review of the evidence collected from the home is being conducted, which will likely result in additional charges.

Wilkins has been employed as a facilities maintenance supervisor responsible for inspecting maintenance work conducted at daycare facilities throughout the state.

Wilkins was transported to the Lake

County Detention Center and was booked in with a \$55,000 bond.

Heatstroke Awareness for a Family Safe Summer

With summer upon us, it is important to prepare for the heat that Florida sun provides to us. The state of Florida has the

second highest total number of heat related vehicle deaths of children with 99 based on statistics from 1998-2021. More than half of vehicular heatstroke cases were because an adult forgot about a child, according to NoHeatstroke.org. Additionally, every year pets suffer and die when their guardians make the mistake of leaving them unattended in a parked vehicle to "run in for just a minute" at the local store. The Lady Lake Police Department is committed to informing and educating parents and pet owners on the dangers of leaving children and pets unattended in a vehicle and taking precautions to help prevent these tragic situations.

Leaving a child or a pet in a hot car even for a short period of time can be dangerous, even if parked in a shade or with the windows cracked. A vehicle's glass transparency allows for the sun's rays to heat up the inside essentially creating a vacuum of heat. Within minutes a car that was just being cooled can experience a spike in temperature. On a sunny day, when temperatures are 80 degrees outside, the

inside temperature of a vehicle can rise to 99 degrees in 10 minutes and soar up to 114 degrees in 30 minutes. At 90 degrees outside, the inside temperature of a vehicle can rise to 109 degrees in 10 minutes and soar up to 124 degrees in 30 minutes.

A child's body temperature can rise up to five times faster than an adult. When a core body temperature of 107 degrees Fahrenheit is reached, internal organs begin to shut down leading to death.

Dogs and cats can't sweat like humans, so they pant to lower their body temperature. If they're inside a car, recycling very hot air, panting gives no relief, and heat stroke can happen quickly.

I encourage you to take these safety precautions to help avoid these preventable tragedies:

Make it routine to open the back door of your car every time you park.

Set an alarm on your cell phone or computer calendar as a reminder to drop your child off at childcare. Make the alarm sound different from other alert tones.

Keep a stuffed animal in the child's car seat. Place it on the front passenger seat as a reminder when the child is in the back seat.

Ask your babysitter or childcare provider to call you if your child hasn't arrived as scheduled.

If you are driving a child, put something you need in the back seat so you will need to open the back door. Items may include a cellphone, handbag, employee badges, or any other item you would need at your destination.

What to do if you find a pet confined to a

vehicle:

Take the vehicle's make, model, color, and license plate number and notify your local Animal Control or Police Department.

Once removed from the vehicle, provide water to drink and if possible, immerse in cool water for up to two minutes to gradually lower the body temperature.

Watch for signs and symptoms of heatstroke such as restlessness, thick saliva, heavy panting, glazed eyes, dark tongue, rapid heartbeat, difficulty breathing, dizziness, seizure, and lack of coordination. If a dog shows any of these symptoms remove it from the heat and transport to a veterinarian immediately.

Practice safety awareness and follow these precautions this summer season with your children and your pets to prevent a vehicle heat-related tragedy from happening to your family. Stay safe out there during our hot and humid summer!

Attorney General Moody and Congressman Posey Announce Legislation to Give States the Ability to Enforce Immigration

Laws When DHS Won't

TALLAHASSEE, Fla.—Frustrated by the border crisis and the federal government's refusal to enforce its own laws, Attorney General Ashley Moody and Congressman Bill Posey today announced legislative efforts to give states more authority to combat illegal immigration. The congressional legislation, H.R. 7413, would allow state officials to demand the secretary of the Department of Homeland Security enforce federal immigration law in certain circumstances. DHS will then have the option to either enforce the law or deputize state officials to carry out the federal immigration duties.

The bill comes just days after President Joe Biden announced the termination of [Title 42](#), a pandemic-era rule that allows border agents to quickly expel migrants attempting to enter the U.S. who traveled from a country where a communicable disease is present. DHS estimates that there might already be [25,000](#) migrants waiting in shelters just south of the border for Title 42

to come to an end. There are also projections that customs and border patrol agents could see up to 18,000 migrants a day after the removal of the policy.

Attorney General Ashley Moody said, "In less than a year and a half, the Biden administration has obliterated our southwest border and it's about to get even worse as the president prepares to end Title 42. We can no longer trust this administration to enforce the law. It is time for swift action to protect the American people. That is why, Representative Posey and I are taking this matter to Congress and asking the legislative branch to let the states protect our citizens by enforcing public-safety immigration laws when Biden won't."

Congressman Bill Posey said, "Maintaining operational control over our nation's borders is critical to our security and our ability to stop human traffickers, drug smugglers and other violent criminals and terrorists who mean to do our communities harm. When the federal government abdicates its role in protecting our nation's borders and refuses to enforce immigration laws allowing millions of people to illegally cross into our country states should have authority to protect their citizens."

Under H.R. 7413, the Immigration and Enforcement Partnership Act of 2022, if a state attorney general finds that DHS is not adequately fulfilling the non-discretionary duties under title II of the Immigration and Nationality Act, the attorney general may

request in writing that the DHS secretary do so. Such duties include the arrest, detention and removal of criminal and arriving aliens. No later than 30 days after receiving a request, the secretary shall either ensure that the duties are adequately fulfilled by officers and employees of the DHS, or authorize state officials to enforce federal immigration law. If the secretary does not comply, the attorney general may file a civil action to enforce these requirements. The bill also requires the courts to expedite proceedings on such action to the greatest extent practicable.

U.S. Customs and Border Protection encounters with illegal migrants at the southwest border totaled more than 2 million since February 2021, with deportations down [70%](#) last year. Attorney General Moody and Congressman Posey are concerned that the federal government's seeming disinterest with enforcing immigration laws will exacerbate the opioid crisis and leave the door open for unmitigated drug and human trafficking.

It costs Florida more than \$100 million a year just to incarcerate illegal immigrants who commit crimes in the state. The cost to public safety is harder to calculate as the nation struggles with a deadly opioid crisis claiming 21 lives a day in Florida. The crisis is being exacerbated by fentanyl, a synthetic opioid 100 times stronger than morphine. According to CBP, since Biden took office, the amount of fentanyl seized at the border is enough to kill every man, woman and child in the nation more than seven times over.

According to recent reports, fentanyl is the number one killer of adults aged [18-45](#). The [Center for Disease Control and](#)

[Prevention](#) projects that nearly 70,000 people nationwide have died from fentanyl overdose in the most recently recorded 12-month period. With Mexico being the number one source of fentanyl [imports](#) into the U.S., it is important that states be able to enforce the law when the federal government does not.

Attorney General Moody and Congressman Posey are also fighting to end human trafficking in Florida. The southwest border is a gateway for human smugglers to bring trafficking victims into the nation. Due to the chaos at the border, many are sneaking by enforcement officials. A former border patrol chief [estimates](#) more than 400,000 migrants evaded agents and crossed the border last year. The risk of being trafficked is higher with noncitizens who pay to be smuggled into the country. [U.S. Immigration and Customs Enforcement](#) officials state that dangerous human smuggling circumstances are encountered every day at the southwest border.

[CBP](#) reports arrests of individuals with criminal convictions increased more than 340% in the last fiscal year. There was an 450% increase of those previously convicted of illegal drug possession and trafficking, a 585% increase of illegal immigrants previously arrested for trafficking, and a 212% increase of those arrested for sexual offenses.

In [January](#), Attorney General Moody traveled to the southwest border in Texas to receive briefings from law enforcement officials about the dramatic overrun of the border brought on by President Biden's

Governor Ron DeSantis Signs Bill to Protect the Lives of Florida's Most Vulnerable

KISSIMMEE, Fla. — Today, Governor Ron DeSantis was joined by pro-life advocates and

community leaders to sign HB 5, the Reducing Fetal and Infant Mortality Act, to protect the lives of Florida's most vulnerable by prohibiting all abortions after 15 weeks of gestation. HB 5 represent the most significant protections for life in Florida's modern history. Read more on what they are saying below.

"Life is precious and children are a God-given gift," said **Lieutenant Governor Jeanette Nuñez**. "That is why House Bill 5 is so important, as it provides added protections for the unborn child. Governor DeSantis and I remain steadfast in our commitment to defending the sanctity of innocent human life and protecting the unborn."

"Every abortion kills a special and unique human being who deserves protection under the laws of this state and the chance to grow up in a loving family," said **Senate President Wilton Simpson**. "As an adopted child in a family that took in foster children, it has always been important to me that our state do everything we can to promote adoption as an alternative to abortion. Floridians can be proud that we

live in a state that not only protects innocent, unborn life, but also supports children and parents. I commend Governor DeSantis for making strong pro-life, pro-child, and pro-family legislation the centerpiece of his administration."

"With Governor DeSantis' signature on our bill that respects and protects life before and after birth, we are well on our way to saving thousands of babies — and it doesn't stop there," said **House Speaker Chris Sprowls**. "Through provisions in our bill, we will continue to support babies and new moms to ensure they have the best opportunities to be healthy and safe for years to come. I could not be more proud of the tenacity, courage and resilience displayed by Representatives Grall and Persons-Mulicka in their fight for this bill and the lives of Florida's next generation."

"In the half century since the Roe v. Wade decision, science has shown us that an unborn baby rapidly develops the functions and form of a child long before viability. "When Hope was 10 and a half weeks gestation, her birth mother had an abortion at an abortion facility and she left that day believing she had had an abortion, but God had spared Hope's life," said **Terri Kellogg, Hope's mother Pro-Life Advocate**. "At 5 1/2 months, her birth mother felt movement and at that point she chose life and adoption. She didn't know anything was wrong with her baby until she delivered two months early. When I look at Hope and I see her scar, I am reminded of how God

sparred her. I am thankful for my daughter, and I am thankful for her birth mother who chose life when given a second chance. My heart is full to be here with all of you who have done so much to stand for life."

"No one wanted my daughter, her father said it's not mine, my parents wanted nothing to do with the pregnancy, my mother even took me for the abortion but when I got there, I didn't do it," said **Kelly Therrien, Pro-Life Advocate**. "I had nothing, I had nobody but I did it. My daughter will be 3 1/2 on the 17th. I was pro-choice but when you get in that spot and it is you personally, it messes with your mind and I am against it now, because I wouldn't have her. People say she was a mistake but no, she was a surprise. Thank you Governor for signing this."

"Being a single mother has not been easy, but I have the good fortune to be where I am now," said **Agency for Health Care Administration Secretary Simone Marsteller**. "When I was in college, I fell pregnant at 19. I went to a physician and was handed a referral for abortion without any counseling. I decided to keep my baby and when she was born, yelling and screaming, she was put on my chest and immediately fell silent, that is when I knew I had done the right thing. It takes courage for any woman who finds herself at a crossroads and has to make the toughest decision of their life. I hope hearing my story will encourage someone out there to make a choice and choose life, do not believe the narrative that a baby will ruin your life and that abortion is the right choice, you WILL be fine and all WILL be well."





Cotija cheese
Chopped cilantro
Pickled jalapeno

Lime wedges

In large bowl, combine soy sauce, lime juice, 2 tablespoon Mazola® Corn Oil, minced garlic, chili powder, cumin and oregano. Remove steak from freezer and slice thinly across the grain. 

reckless immigration policies. Attorney General Moody joined attorneys general from across the nation for the security briefing.

Congressman Posey has been to the border and seen firsthand how open and dangerous it has been allowed to become. Congressman Posey has been a strong advocate in Congress for securing the borders and maintaining operational control over them, as well as fighting human trafficking, targeting fentanyl and other illegal drugs, deporting criminal aliens and rooting out fraud in our immigration system.

Attorney General Moody Brings Multistate Action Against Biden's Unlawful Federal Immigration Policies

TALLAHASSEE, Fla.—Attorney General Ashley Moody is bringing a multistate action against President Joe Biden for fail-ing to enforce federal immigration law. The attorneys general of Alabama and Georgia joined Attorney General Moody in a complaint for declaratory and injunctive relief, arguing that the president is failing to perform the duties required by Con-gress by continuing to operate under unlawful immigration enforcement priorities. Under these priorities, the Biden admin-istration is refusing to detain and deport criminals in the country illegally—directly contrary to federal law.

The immigration enforcement priorities are also contrary to precedent set by presidents of both political parties. As Obama administration Solicitor General Donald Verrilli recognized, “Congress has told the Department of Homeland Security that it has to prioritize the removal of criminal aliens.”

Attorney General Ashley Moody said, “The Biden administration's refusal to deport criminals here illegally after they complete their sentences makes us all less safe. Biden's lax immigration policies are exacerbating the opioid crisis, facilitating human trafficking and further jeopardizing overall public safety. As Attorney General, I will continue fighting these unlaw-ful immigration policies until the president is forced to do his job and secure the southwest border.”

The immigration priorities, as is nearly every immigration policy from the Biden administration, are designed to weaken border security. Through multiple acts of legislation, Congress instructed the executive branch to arrest, detain and remove criminal aliens due to concerns that those who are not detained continue to engage in crime and fail to appear for removal proceedings.

The complaint filed by Attorney General Moody states: “The Biden Administration seeks to 'dispense with' these acts of Congress. It claims the discretion to decide...which aliens should be arrested, detained and removed, even if its policy preferences directly conflict with the clear

commands of Congress. And it has used the claimed discretion to allow illegal immi-grants guilty of drug trafficking, burglary and other serious crimes to return to our communities upon release from state custody rather than arresting and removing them as federal law requires.”

Thus, Florida argues that Biden's new immigration priorities are contrary to law because, as the Supreme Court has held, immigration officials “must arrest those aliens guilty of a predicate offense.”

The policy is also arbitrary and capricious. The Biden administration displayed no awareness that the memo changes a longstanding position of the federal government, nor does the memo consider the substantial costs imposed on the states by ignoring the law.

States bear many of the consequences of unlawful immigration. According to the complaint, “Plaintiffs spend more than \$100 million per year incarcerating illegal immigrants who commit crimes within their borders. They will spend more be-cause of the criminals the Biden administration is releasing instead of arresting, detaining and removing...especially given the high recidivism rates among released prisoners. Plaintiffs will also expend more resources on the supervised release of aliens.”

The complaint asks the court to hold the immigration priorities unlawful, issue permanent injunctive relief prohibiting the Biden administration from enforcing the policy and compel the Department of Homeland Security to comply with the law.

The states of Alabama and Georgia are joining Florida in the action that is filed in the United States District Court in the Northern District of Alabama.

skills as well," he said.

Up a Creek Robotics was established in 2004 and partners with the St. Vrain School District. Curd, a tech industry engineer, has been a team mentor since 2014. The team has won numerous regional competitions dating back to 2015 and has earned several invitations to compete at the international meet in Houston, Texas. It also took first place in the global skills competition last year against more than 1,500 teams.

"Some students from our club have gone on to work at local robotics firms, and about 90% of them pick a career in STEM (Science, Technology, Engineering and Math) fields, such as mechanical engineering or aerospace," Curd said.

Gracious and Professional

An important element of the *FIRST* culture is being gracious and professional. The organization rewards teams that help each other advance. Unlike combat robot competitions, the focus of *FIRST* robotics challenges is not to destroy your competitor's robot, but to perform the challenges as best you can. The teams want to win, but against opponents who are also at their best.

"Teams are paired with each other in alliances to play games better or faster than their opponents," explained Kate Pilotte, senior manager, kit of parts at *FIRST*. "The ultimate goal for many teams is to be on the alliance that wins the championship."

Coping with COVID

In March 2020, due to the spread of COVID-19, *FIRST* competitions around the world were canceled. Pilotte said that teams had to pivot their goals. They used what they learned in *FIRST* to make personal protective equipment, ventilators, robots that delivered groceries to seniors, and much more. "In the end," she added, "they found innovative ways to put their talents to the test and are emerging from the pandemic



arguably more resilient."

The Competition

Every January, the *FIRST* Robotics Competition launches a new challenge in which teams of high school students build industrial-sized robots to play a difficult field game. Sometimes robots have to climb, build, stack, or throw objects, grab things and move them, or fit components together.

"The technology that goes into these robots is crazy," Curd said. "Almost every year we are using state-of-the-art vision systems—tracking targets on the field and shooting at them. There's a lot of complex software algorithmic work going on here that is impressive for these high school students."

Every team builds its robot on a control platform named roboRIO from National Instruments, which is driven by powerful Zynq-7000 adaptive computing chips from [AMD-Xilinx](#) that have the processing capacity to handle complex AI algorithms in real time. "The Zynq device can operate at different voltages, interfaces and protocols. It offers a great deal of flexibility that supports different types of input and output paths to and from the NI box," Curd said.

AMD-Xilinx has sponsored the Up a Creek team for many years. "Sponsoring

FIRST gives us an opportunity to help students get exposed to the idea of pursuing careers in technology and does a lot of other good for the community as well," said Dan Gibbons, vice president of software programmability and compute acceleration at AMD-Xilinx.

Inspiring Ideas

"There are students from *FIRST* who designed and manufactured a special wheelchair for a kid in their community. In Turkey, one team built a robot to help save a puppy," Pilotte said. "It is truly inspiring to see what these kids can do."

In the Atlanta suburb of College Park, juniors Alex Van Aacken, Heather Frisch, and Lily Pamphile have been involved in [Woodward Academics](#) *FIRST* robotics program for three years and now are program leads. Van Aacken contributes to the team as a mechanical designer and helps build the robots. Pamphile is head of

programming, and Frisch leads electrical engineering.

In March, the team completed its first competition in three years and made it to the quarterfinals.

"The Columbus competition included an interesting game involving lots of balls flying around," Van Aacken said. "We focused our robot on getting good at ball shooting from far away. There were some problems that plagued us along the way, but we're really proud of how far we got. We haven't advanced this far as a team since 2018."

"Our main issue at the competition stemmed from the electrical board," Frisch explained. "We had some new electrical components that had connection problems and we had a firewall issue. It was definitely a struggle, but we got a lot of advice from our *FIRST* mentors and we talked to other teams to help us solve the problems."

Last year, the Woodward Academy robotics team was able to meet in person on a hybrid schedule and participated in competitions online. "We basically built half of an FTC field in our lab and then we ran a match, trying to score as many points as possible," Pamphile explained. "From there, we uploaded our scores and videos to the *FIRST* website, and that's how we were ranked."

Finding Community

"*FIRST* is not all about robotics. It's not always about kids with the best programming ability. It's also about kids looking for a community," said Tim Hipp, the team's lead faculty mentor. "*FIRST* is the reason many of these students come to school." [More information: <https://xlnx.com/38xmjdg>.]
