The elected president demands 'blind loyalty' from, not only the population, but also from other elected leaders and government employees, either of whom gets fired if they have an opinion different from the leader.

Eventually, it gets worse. In Florida right now the governor is attacking a private business, not because they did anything illegal or immoral, but for the simple reason



Dear Friends,  
This is Part II of our report on the 2022 Legislative Session. As of this writing, we have already worked through one Special Session addressing congressional redistricting and independent special districts (Disney, Reed Creek). Both of these have been highly publicized already, so we won't spend much time on those, except to tell you two things:

First, the congressional maps that we passed are fair and constitutional, and we fully expect that it will be upheld by the higher court. The Fair Districts Act, while (possibly) well intended, sends the wrong message about how we should operate as a society. Drawing a district to favor a population, based on the color of their skin, is moving us further away from the dream of Dr. King where we judge men not by the color of their skin, but by the content of their character. Second, in regards to the Disney and the Special Districts Bill, the robust authority granted to the Reedy Creek Improvement District stretches well beyond those for other cities and counties. It was time for the legislature to conduct an extensive review of the powers and authorities of special districts through the lens of today's environment. As elected officials, it is our duty to represent the best interest of Floridians, not boardrooms in California.

Back to our report on the 2022 Regular Session. We have two bills that we want to highlight this month that we're sure you've seen already, but they were the two that we were the most excited about.

The first, HB 1557 - Parental Rights in Education Act, was a bill that your Senator carried through to final passage. This bill strengthens the Parents' Bill of Rights Act, safeguarding the rights and responsibilities of parents to decide how best to raise their children and remain informed about their child's education. Further, it prohibits teacher-led classroom instruction on sexual orientation or gender identity in primary grades (K-3), and specifies that instruction in other grades must be age appropriate and consistent with state standards. Kids at that age don't need indoctrination, they need to be taught skills that can help to make them life-long learners. This shouldn't be controversial. We want to thank Governor Ron DeSantis and President Wilton Simpson for their unwavering support of this legislation.

The second bill sponsored by Senator Stargel, was HB 5 - Reducing Fetal and Infant Mortality. HB 5 prohibits abortions after 15 weeks of gestation. The bill clarifies the term "gestation" to provide a more commonly understood and medically accepted measurement of development. State government must do all we can to protect the lives of innocent children and provide support and educational information for parents. Destroying

innocent life as an answer to unplanned pregnancies is not who we want to be as a people, and Florida is committed to being the voice for those who cannot yet speak for themselves.  
Thank you for the honor of letting me serve you in the Florida Senate. It is truly a pleasure to represent hometown America in our state capitol.

## Hurricane Preparedness 2022

Hurricane Season is upon us in Florida. The 2022 Atlantic hurricane season runs June 1 through November 30, 2022. The

NOAA forecasters predict a 65% chance of an above-normal season. National Oceanic and Atmospheric Administration's Atlantic hurricane season forecast calls for 14 to 21 named storms, with six to 10 becoming hurricanes. The time to prepare for the hurricane season is when you have time and are not under pressure. The Lady Lake Police Department would like to encourage all residents to begin preparations for this anticipated busy hurricane season now, before the season gets into full swing. Some things to consider during your preparations should include,

- Formulate an evacuation plan and an alternate plan
- The CDC recommends you get a COVID-19 vaccine as soon as you can. COVID-19 vaccines help protect you from getting sick or severely ill with COVID-19 and may also help protect people around you

while in shelters or during evacuation.

- Keep a first aid kit and check that it is stocked
- Plan on at least one gallon of drinking water per person, per day (at least 3-5 days)
- Stock supplies of non-perishable food items like peanut butter, cereal, granola bars and dried fruit for at least 3-5 days
- Have at least a 7 day supply of medications
- Flashlight
- Extra Batteries and portable chargers
- Personal hygiene items
- Waterproof container with cash and important documents
- Make sure that cats and dogs are wearing collars and identification tags that are up to date
- Put your cellphone number on your pet's tag (or a relative/friend's number in case you need to evacuate)
- check in advance to find out about pet-friendly shelters and special needs shelters if required

Additionally, help your neighbors. Many people, especially senior citizens, rely on the assistance of neighbors before and after a hurricane. Help your neighbors collect supplies they will need before the storm or assist them with securing their residences. Assist them with evacuation if needed or ordered to do so. Check on them after the storm when it is clear and safe.

With proper preparations and planning ahead you may remain safe in an emergency.

Dear Mr. Loury:

Thank you for contacting the Office of Governor DeSantis regarding the Northern Turnpike Extension project. Your correspondence was forwarded to Florida's Turnpike Enterprise, part of the Florida Department of Transportation (FDOT), for review and a response. We appreciate you reaching out with your concerns.

Currently, the project is in the planning phase and is following the FDOT's Alternative Corridor Evaluation (ACE) process and the Project Development and Environment (PD&E) process, both of which evaluate and compare corridor alternatives. While all options are still in consideration, four initial alternative corridors have been developed. The PD&E study will also evaluate a No-Build option as well as potential Transportation Systems Management and Operations (TSM&O) improvements. Alternatives will be evaluated on environmental factors, as well as their ability to enhance regional connectivity, address regional congestion and safety, accommodate increased travel demand, and improve hurricane evacuation.

Starting at Florida's Turnpike Mainline and the I-75 interchange, the planning level analysis used to develop the initial corridors considered minimizing impacts to the natural environment and communities while also considering previous studies and reports within the study area. The NTE is being studied to enhance regional connectivity and is not the only project

being proposed to meet that end. As you indicated, the department is also preparing an Interstate Master Plan to evaluate potential short and long-term improvements to the I-75 corridor. For study purposes, the I-75 corridor has been divided into two study areas. Information about the project is available on the project websites at [cfroads.com/project/443623-1](http://cfroads.com/project/443623-1) (southern study) or [cfroads.com/project/443624-1](http://cfroads.com/project/443624-1) (northern study).

The department will follow all requirements of the PD&E process and will continue to work in partnership with local governments, environmental and community organizations, and the public to consider innovative concepts to combine right-of-way acquisition with the acquisition of lands or easements to

facilitate environmental mitigation or ecosystem, wildlife habitat, or water quality protection or restoration. Additional analysis will be used to refine corridors during the ACE and PD&E phases that will avoid and minimize impacts to communities and environmentally sensitive features to the extent possible.

## FROM THE DESK OF GOVERNOR DESANTIS



### DeSantis Protects Floridians from Protests Outside Their Homes

TALLAHASSEE, Fla. — Today, Governor Ron DeSantis signed HB 1571, which prohibits picketing and protesting outside of a person's place of residence.

"Sending unruly mobs to private residences, like we have seen with the angry crowds in front of the homes of Supreme Court justices, is inappropriate," said Governor Ron DeSantis. "This bill will provide protection to those living in residential communities and I am glad to sign it into law."

Once this law takes effect, law enforcement officers will provide a warning to any person picketing or protesting outside of a dwelling and will make arrests for residential picketing only if the person does not peaceably disperse after the warning. Residential picketing will be punishable as a second-degree misdemeanor.

### Governor DeSantis Approves Historic \$100 Million for Cancer Care and Research at NCI Facilities

MIAMI — Today, Governor Ron DeSantis and First Lady Casey DeSantis announced the approval of \$100 million for cancer research and care in the Fiscal Year 2022-

2023 Budget, a \$37 million increase over the current budget. Last year, the First Lady held a roundtable to announce the Governor's proposal of this historic funding for Florida's top cancer centers to continue providing world-class care to cancer patients.

"Cancer remains a leading cause of death in Florida, and we will continue to support those fighting this deadly disease," said Governor Ron DeSantis. "With this funding, cancer centers will continue their cutting-edge research and provide high quality care to patients. Our family is grateful for the care that the First Lady received during her cancer treatment this past year, and we want to make quality care available for all Floridians."

"I am incredibly proud to see this record funding secured for cancer patients, their families, and the facilities that serve them," said First Lady Casey DeSantis. "Early detection is a game changer in the cancer fight. I encourage anyone reading this to be proactive about your health — it might just save your life."

"As a physician, my patients with cancer were the most courageous, and showed optimism in the face of their difficult battle," said State Surgeon General Dr. Joseph Ladapo. "This funding is a wonderful thing. The research will identify places of discovery to make change. These discoveries are going to be how we prevent and treat cancer around the world."

"I used to run marathons and do triathlons, but in 2011 my doctors found that I had stage 4 kidney cancer, which spread to my lungs," said Raquel E. Kauffer, Kidney Cancer Survivor. "I went through many harsh tests and treatments with horrible side effects, but I wasn't going to let cancer take my life. Thankfully I had a great support system, and thanks to Sylvester giving me the help I needed, I am here. I want to thank the Governor and Legislature for your commitment to cancer research."

"My daughter Bella battled an aggressive childhood cancer valiantly for 6 years, walking, running, and jumping when doctors never thought possible," said Raymond Rodriguez-Torres, Bella's Father and Chairman, Live Like Bella® Childhood Cancer Foundation Board of Directors. "With support from around the world we founded Live Like Bella to assist families affected by childhood cancer. Since then, \$26 million has been made possible through our foundation for pediatric cancer research in Florida. This brings hope for children and families. Today we know that Bella smiles from heaven, and we remain charged until we know that childhood cancer no longer threatens our kids."

Cancer has been the second leading cause of death in Florida since 2014, which is why the Florida Consortium of National Cancer Institute (NCI) Centers Program was created. The \$100 million for this program is nearly a 60% increase from previous years, and will go to Moffitt Cancer Center, the University of Miami Sylvester Comprehensive Cancer Center, and the University of Florida Health Cancer Center.

Florida's three NCI-designated and NCI-

seeking centers provide world-class care to residents in different regions of our state. These centers use this funding for enhanced research projects and care to support their patients.

Florida is dedicated to supporting every individual in this fight. The state also provides funding for initiatives that support pediatric cancer research and grants for cancer research at centers that are not NCI designated.





**ATTORNEY GENERAL MOODY**



Florida is now experiencing an influx of new synthetic drugs—some even more powerful than fentanyl.

This week, I filed an emergency rule to outlaw eight synthetic opioids

known as nitazenes, adding these dangerous drugs to the state's Schedule I controlled substances list. This means possessing or selling them in Florida is now a felony, punishable by time in prison.

I hope this sends a strong message to drug dealers, that we will not allow them to poison Floridians.

While we do not know yet exactly how prevalent nitazenes have become in the illicit drug market, we do know that Florida law enforcement has identified more than 260 cases involving these substances since 2020—including more than 80 so far this year.

Nitazenes have also been linked to at least 15 deaths in our state. The scariest thing about these drugs is that users often have no idea they are taking them.

Like fentanyl, nitazenes are being mixed with other, more common drugs and sold to unsuspecting users—often with deadly

consequences.

It was vital that we took swift, decisive action to outlaw these dangerous substances, before they could become a larger part of the illicit drug supply and increase overdoses in Florida.

**Attorney General Moody Calls on U.S. Attorney General Garland to Enforce Federal Law Prohibiting Efforts to Intimidate Supreme Court Justices**

TALLAHASSEE, Fla.—Attorney General Ashley Moody is calling on United States Attorney General Merrick Garland to enforce federal law against attempts to intimidate U.S. Supreme Court Justices by protesting outside the Justices' homes. Along with 24 other Attorneys General, Attorney General Moody is demanding the U.S. Attorney General take action to safeguard and ensure the integrity of the rule of law.

Attorney General Ashley Moody said, "The integrity of our courts is paramount to a free and democratic society. Any attempt

to threaten or intimidate United States Supreme Court Justices so they change their votes should be thoroughly investigated by the Department of Justice—not just for the safety of judges and their families, but for the independence of our nation's entire judicial system."

In a letter to Attorney General Garland, the state Attorneys General write: "Following last week's leak of a draft opinion in *Dobbs v. Jackson Women's Health Organization*, pro-abortion activists have begun protesting not just outside the Supreme Court, but outside the Justices' homes, in the hope of pressuring the Justices to change their votes. As a former federal judge and the current head of the Department of Justice, you must surely appreciate the unique risks to both judges and the rule of law when judges are targeted at their homes. That is why Congress has long barred 'picket[ing] or parad[ing]' near a judge's home 'with the intent of interfering with, obstructing, or impeding the administration of justice.' We the undersigned Attorneys General act daily to uphold the rule of law. These remarkable recent events provide you an opportunity to do the same."

The Attorneys General also noted in the letter that Attorney General Garland was not previously shy in using his authority to address a "threat" of parents voicing their opinions to school boards. Yet, when U.S. Supreme Court Justices and the Justices' families are being harassed at home, Attorney General Garland has remained

silent.

The letter states: "You were quick to respond to the purported 'threat' of parents speaking out at local school board meetings (though the basis for your threat assessment was shaky to say the least). Here, in the face of escalating extremism directed at the judicial branch, you have an obvious role to play. Congress recognized that pressuring judges to change their votes by protesting outside their homes directly threatens the rule of law. You profess to share those concerns, having unequivocally stated that attacking a courthouse 'to prevent judges from actually deciding cases' plainly constitutes 'domestic extremism, domestic terrorism.' You can and should act accordingly by faithfully executing federal law to prevent protestors from attempting to intimidate the Justices of the Supreme Court, both to protect the Justices and to safeguard the rule of law."

The following Attorneys General joined Attorney General Moody in signing on to the letter: Alabama, Alaska, Arizona, Arkansas, Georgia, Idaho, Indiana, Kansas, Kentucky, Louisiana, Mississippi, Missouri, Montana, Nebraska, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia and Wyoming.

**Attorney General Moody Urges Biden Administration to Stop Attack on the First Amendment**

TALLAHASSEE, Fla.—Attorney General Ashley Moody is calling on U.S. Department of Homeland Security Secretary Alejandro Mayorkas to terminate the creation of a disinformation board that attacks Americans' First Amendment rights. Along with 18 other attorneys general, Attorney General Moody argues that the proposed Disinformation Governance Board will hurt the constitutional freedom to speak freely, debate and disagree with the government—freedoms that state attorneys general are responsible for defending.

Attorney General Ashley Moody said, "President Biden is attempting to confuse and distort legitimate criticism and the perspective of American citizens. This authoritarian maneuver could be straight out of the novel 1984 and should frighten Americans of all political persuasions."

The attorneys general argue that this government watchdog agency would abridge a citizen's right to express their opinions and disagree with the government, furthering self-censorship rather than protecting freedom of speech. The board's creation is also an example of federal overreach. There is no statutory authority to support its inception—particularly as the public's elected representatives debate the issue of disinformation in Congress.

The letter states that "the Disinformation Governance Board, by its very existence, and almost certainly by design, threatens to 'enforce silence' when Americans wish to express views disfavored by the Administration. It is therefore already chilling free speech and impeding the political process in...every...State. This is unconstitutional, illegal and un-American. Unless you turn back now and disband this Orwellian Disinformation Governance Board immediately, the undersigned will have no choice but to consider judicial remedies to protect the rights of their citizens."

# All Electric Farm Equipment

When you read things like this it is obvious the "all electric" is not well thought out.

questions regarding being forced to purchase electric farm equipment.

Some operation are "partnership farm" with John Deere. They use the larger farm operations as demonstration projects for promotion and development of new equipment. the farmer recently received a phone call from his John Deere representative, and they want the farm to go to electric tractors and combines in 2023. He currently has 5 diesel combines that cost \$900,000 each that are traded in every 3 years. Also, over 10 really BIG tractors. JD wants him to go all electric soon.

He said: "Ok, I have some questions. How do I charge these combines when they are 3 counties away from the shop in the middle of a cornfield, in the middle of nowhere?" "How do I run them 24 hours a day for 10 or 12 days straight when the harvest is ready, and the weather is coming in?" "How do I get a 50,000+ lb. combine that takes up the width of an entire road back to the shop 20 miles away when the battery goes dead?"

There was dead silence on the other end of the phone.

When the corn is ready to harvest, it has to have the proper sugar and moisture content. If it is too wet, it has to be put in giant dryers that burn natural or propane gas, and lots of it. Harvest time is critical because if it

degrades in sugar content or quality, it can drop the value of his crop by half a million dollars or more. It is analyzed at time of sale. It is standard procedure to run these machines 10 to 12 days straight, 24 hours a day at peak harvest time. When they need fuel, a tanker truck delivers it, and the machines keep going. John Deere's only answer is "we're working on it." They are being pushed by the lefty Dems in the government to force these electric machines on the American farmer. These people are out of control. They are messing with the production of food crops that feed people and livestock... all in the name of their "green dream."

s. Boosters provide extra protection. Like seatbelts prevent injuries in accidents, vaccines are highly effective at preventing hospitalization and death from COVID, but

they don't work if you don't use them. Vaccination is the best way to slow the spread of COVID and prevent hospitalizations and deaths. COVID vaccines are available to anyone age 5 and older in the United States.

**Wear a mask.** After vaccines, wearing a mask is one of the most effective ways to help reduce the spread of COVID. The Centers for Disease Control and Prevention (CDC) recommends wearing a mask in public indoor spaces, especially in areas where community transmission is high. A mask should fit closely on the face, covering the nose and mouth, without any gaps along the edges or around the nose. Masks are still required on most methods of public transportation.

**Keep your distance.** If you are not up to date on COVID vaccines, stay at least six feet away from other people, especially if you are at higher risk of getting very sick with COVID. In areas where community levels are high, it is best to avoid crowded places where it is difficult to stay distanced from others who may not be vaccinated. When spending time with people who don't live with you, outdoors is the safer choice. Holding gatherings outdoors decreases the chance of COVID exposure.

Layering these proven prevention strategies in line with your personal health risk and current community levels of COVID transmission, is the best way to prevent severe illness, hospitalization, and death. Don't throw away that umbrella, keep wearing a seatbelt, and stay current on

COVID vaccines even when cases are lower in your community.

believe a relationship exists between vaping and serious respiratory impacts, such as those from COVID-19. While a network of solutions is required to overcome this epidemic, there are actions people can each take today.

Families play a critical role in influencing a child's decision-making. Parents and guardians can help keep their kids healthy by having thoughtful, factual conversations about the dangers of vaping. For assistance getting started, parents and guardians can turn to no-cost digital tools from [Be Vape Free](#)—a nationwide initiative, built around the evidence-based CATCH My Breath program, that provides standards-aligned e-cigarette prevention resources for educators teaching grades 5-12 and families. [Be Vape Free](#) was created in partnership with the CVS Health Foundation, CATCH Global Foundation, and Discovery Education.

The parent toolkit is designed to give parents, guardians, educators, and community members the opportunity to learn more about the vaping epidemic, gauge a child's risk of trying e-cigarettes and find the best strategy to talk to kids about the dangers of e-cigarettes. Chock-full of facts

and research, these resources have just about everything families need to empower students to live a healthy life. With the toolkit, families can answer key questions related to vaping including:

- What is vaping?
- Why do teens vape?
- What do vapes look like?
- What are in vapes?
- What are the effects of vaping?
- What are signs of vaping?

With this informational foundation, parents and guardians can connect with their kids to initiate conversations about the dangers of e-cigarettes based on facts. Together—one conversation, one day, and one student at a time—we can end the vaping epidemic by arming young people with the tools they need to make healthy, smart decisions, and impart lessons that last a lifetime.

# Big Tobacco/Microplastics Problem



(NAPSI)—It's likely you see one of the most common sources of plastic pollution everyday—on the ground, in parking lots, in gutters or at the beach—cigarette butts. This is not trash but toxic garbage and plastic pollution poisoning marine life and humans.

Since cigarette filters are made of plastic, they can take years to decompose, leaving behind toxic microplastics that pollute our environment—and could make their way inside of us. In fact, every smoked cigarette filter contains 15,000 strands of microplastic fibers. Though often invisible to the human eye, microplastics are nearly everywhere—polluting the food we eat, the water we drink, and even the air we breathe.

So, what exactly are microplastics? Microplastics are tiny pieces of plastic measuring less than 5 millimeters long, or about the size of a sesame seed or smaller.

Due to their tiny size, microplastics are nearly impossible to remove from our food and water sources. As a result, they can cause great harm not only to our environment, but

also to our health. It might come as a surprise to learn that Americans ingest an estimated tens of thousands of microplastic particles a year.

Adding to the problem, cigarette butts are the most littered item on Earth. They're also the most discarded item found on California beaches and waterways.

“Though microplastics are small, the microplastic fibers produced from smoked cigarette filters can cause massive damage to our environment and our bodies. Microplastics pollute our oceans and leach into our soil, and as a result, can harm our wildlife, our food sources, and consequently our health. Putting an end to tobacco product waste isn't just best practice but a necessity for the health of our environment and our communities,” said Eben Schwartz, Marine Debris Program Manager at the California Coastal Commission.

The tobacco industry is a top global plastic polluter, producing six trillion cigarettes every single year. More than 4.5 trillion cigarette butts are dumped into the environment globally, each year, and the microplastic remnants can make their way into our communities, our food, and ultimately our own bodies. Microplastics have been found in apples, pears, lettuce, broccoli and carrots, as well as in seafood commonly consumed by humans.

Holding the tobacco industry accountable starts with exposing their lies and unmasking the damage they've caused.


## This Year's Winners
