COVID Decrease

Ocala, Fla. — New COVID-19 cases in Marion County decreased during the past week, according to the Florida Department of Health's most recent summary, released Friday. The community's positivity rate also declined.

According to the state's report, Marion County recorded the following for the week of Oct. 14–20:

- New cases: 136. That was down from 174 cases in the state's previous report, released on Oct. 7. The number of new cases has steadily decreased since the July 15 report, when the community peaked at 1,199 new cases.
- The county's cumulative case total as of Sept. Oct. 20: 100,090.
- Latest positivity rate: 5.9%. That decreased from 8.3% in the state's Oct. 7 report and is the lowest rate since 3.5% reported on April 22.
- Statewide positivity rate: 7.1%. That remained the same as the state's Oct. 7 summary.
- Vaccines: 25. That decreased from 33 vaccines noted in the state's Oct. 7 report.
- Overall ratio of county residents 6 months or older who have been vaccinated: 61%.

Unreported at-home tests performed in Marion County are not included in the state's summary.

As of Oct. 20, the U.S. Centers for Disease Control and Prevention rated Marion County's community transmission

risk as low.

The Department of Health in Marion County encourages our community's residents to help reduce the spread of the virus as much as possible. Please stay home if you feel sick and use good personal hygiene practices, more importantly washing your hands frequently. DOH-Marion also reminds residents that vaccines may help reduce serious illness and hospitalizations from COVID-19.

From COVID-19 cases reported during the week of Oct. 14–20, Marion saw:

- An average of 19.4 new cases per day
- 35.6 cases per 100,000 residents
- 5.9% positivity rate
- A total of 25 people vaccinated

During the week of Sept. 30–Oct. 6, covered in the state's last report, Marion County recorded:

- An average of 24.9 new cases per day
- 45.6 cases per 100,000 residents
- 8.3% positivity rate
- A total of 33 people vaccinated

For the reporting period of Sept. 16–22, Marion County noted:

- An average of 40.4 new cases per day
- 74.1 cases per 100,000 residents
- 9.4% positivity rate
- A total of 49 people vaccinated

For the week of Sept. 2–8, Marion saw:

- An average of 72.4 new cases per day
- 132.8 cases per 100,000 residents
- 11.5% positivity rate
- A total of 50 people vaccinated

Governor Ron DeSantis Issues Updates on Hurricane Ian Recovery

TALLAHASSEE, Fla. — Today, Governor Ron DeSantis visited Sanibel Island to hand deliver \$1,000 recognition payments to first responders in areas impacted by Hurricane Ian. These recognition payment checks were mailed prior to Hurricane Ian making landfall but were unable to be delivered to impacted areas following the storm. The Governor

delivered checks to first responders employed by the Sanibel Fire & Rescue District, the Captiva Island Fire Control District, and the Upper Captiva Fire Protection & Rescue Service District.

First Lady Casey DeSantis announced new mental health resiliency tools in response to Hurricane Ian. The Florida Department of Children and Families (DCF) launched the Family Support Line,

AS I SEE IT

CLIMATE CHANGE-Fact or Fiction?
Will it ever end?

Is it even real?

As I See It, most people accept that our Planet Earth has changed several times over its millions of years of existence. But, for some reason, many intelligent, educated people insist that those changes have stopped and that the weather we have now is the same as it's always been, and it will continue, unchanged for ever. The years 2016 and 2020 are the warmest years on record.

Several Paleoclimate studies show that current warming is occurring roughly 10 times faster than the average rate of warming after any ice age.

Also Carbon Dioxide from human activities is increasing about 250 times faster than it did from natural sources after the last Ice Age.

Cut down an old tree. The tree rings clearly show that there are substantial variations in rainfall year-to-year. Sometimes year-after-year.

World-wide, water levels have risen substantially. Scuba diving in the Mediterranean will show you whole cities which are now thirty feet under water. Even in the USA, many areas in the mountains have lost the snow coverage which has been there all our lives, but is now

disappearing.

The mighty Colorado River is drying up. The list goes on and on.

Green Chicken Enchilada Cauliflower Casserole



Ingredients

20 oz frozen cauliflower florets (about 4 cups)
4 oz cream cheese, softened
2 cups cooked chicken, shredded
1/2 cup [Salsa Verde](#)
1/2 teaspoon kosher salt
1/8 teaspoon ground black pepper
1 cup shredded sharp cheddar cheese
1/4 cup sour cream
1 tablespoon chopped fresh cilantro (optional)

Instructions

- Put your cauliflower in a microwave safe dish and cook for 10-12 minutes or until fork tender.
- Add the cream cheese and microwave for another 30 seconds. Stir.
- Add the chicken, salsa verde, salt, pepper,

cheddar cheese, sour cream, and cilantro. Stir.

- Bake in a preheated oven at 375 degrees (F) in an ovenproof casserole dish for 20 minutes.
- OR you could microwave on high for 10 minutes.
- Serve hot.

Unified Command I Am Ashamed Established

UNIFIED COMMAND ESTABLISHED TO MONITOR ASTOR FLOODING

The Lake County Sheriff's Office, Lake County Fire/Rescue, and the Lake County Office of Emergency Management have established a unified command in Astor to monitor and manage the flood situation along the St. Johns River that has come about as a result of Hurricane Ian.

Areas of the community that are adjacent to the river are currently being assessed. At this point, the most impacted areas are as follows:

-Claire Street, and adjoining roads

-Alligator Road, Possum Road, and the roads to the north of these

In addition, the following boat ramps are closed due to flooding and unsafe conditions:

-Butler Street Boat Ramp

-Pearl Street Boat Ramp

-Lake George Boat Ramp

Several of the roads in these areas are under water, with more flooding likely in the coming days; therefore, these areas are closed to non-residents. Residents who must travel in these areas are asked to maintain minimal speeds to avoid forcing more water into the yards and homes of other residents.

People are also being asked to stay off the water in the Astor area to avoid pushing more water into the aforementioned areas.

The situation will continue to be monitored and further updates will be provided as they become available.

Aquaculture Caucus

WASHINGTON, D.C. — Today, Reps. Kat Cammack (R-FL-03), Ed Case (D-HI-01), Jimmy Panetta (D-CA-20), and Steven Palazzo (R-MS-04) announced the establishment of the Aquaculture Caucus, for which the four representatives will serve as inaugural co-chairs.

The caucus will serve as a resource and forum to educate and share the potential for growing sustainable, innovative domestic aquaculture. It will also provide policy updates and share initiatives in Congress that support U.S. aquaculture and work to make it more competitive at the global level.

"Aquaculture should be one of the United States' priorities as we grow our focus on food security. In Florida, we've seen the benefits of aquaculture firsthand, breeding, raising, and harvesting shellfish, fish, and aquatic plants in our waters. We've demonstrated that it's possible to provide healthy, fresh food that's produced sustainably at home to support our growing population," said **Congresswoman Cammack**. "The Aquaculture Caucus shares our enthusiasm for pushing these industries and their innovations forward while growing our infrastructure and market domestically."

"Aquaculture has always held great

promise to help us achieve our broader goals of creating sustainable food systems and responsibly managing our marine resources," said **Congressman Case**. "Congress should focus more directly on how best to mold federal policy to realize the full potential of American aquaculture. Our new Aquaculture Caucus will provide that focus as we clarify often confusing and contradicting regulatory schemes while ensuring that we protect our marine environment."

"Since first introducing the Advancing the Quality and Understanding of American Aquaculture Act (AQUAA) in 2018, the conversation on expanding our nation's aquaculture industry has only grown," said **Congressman Palazzo**. I'm proud to be a part of the new Aquaculture Caucus and look forward to the conversations and ideas this caucus moves forward."

"It is reported that we import well over three-quarters of the seafood that we consume in the United States. Aquaculture can play an important role in reducing our reliance on other countries for fish and increase our consumption as well as our domestic production of sustainable seafood," said **Congressman Panetta**. "The bipartisan Congressional Aquaculture Caucus will work to create policies to support not just a sustainable source of food that can create jobs, but also ensure that it's economically feasible and environmentally friendly."

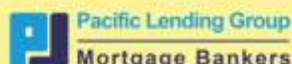

Genetically Modified Mosquitoes

NIH Used a Box of Genetically Modified Mosquitoes to Vaccinate Study Patients

(RightWing.org) – The National Institutes of Health (NIH) continue to find themselves surrounded by controversy. For instance, several lawmakers and scientists have accused the agency of funding dangerous gain-of-function research overseas — in China, to be exact. Likewise, a recent news report revealed the NIH funded a study that used a box of genetically-altered mosquitoes in an attempt to vaccinate study patients.

On August 24, Science Translational

Medicine a research study involving a genetically-altered parasite engineered to create a vaccine to protect humans from malaria. Particularly concerning is the fact that is the deadliest species of its class that spreads malaria in humans through animal or insect bites or stings.

Study participants literally place their forearms over a cardboard box containing hundreds of mosquitoes infected with the altered Plasmodium falciparum. The containers had a wire mesh top that allowed the insects to bite but prevented them from escaping. One of the participants NPR the researchers “literally [used] a Chinese food

takeout container.” Scientists hope one day to release infected mosquitoes to vaccinate unwitting and unwilling humans against the ravages of malaria. However, full vaccination requires multiple bites, and so far, the efficacy rate of this particular vaccine is far less than necessary to protect the population. It calls to question. What other vaccines could be unleashed on our population without us knowing it's happening?

Watch the Weather Wait to Water



During the summer months of June, July, August and September, yards need no more than ½ to ¾ inch of water every 2 to 3 days. If your lawn has received enough water from rainfall, turn off your irrigation system, and turn it back on when needed.

Follow these tips when you "watch the weather, wait to water":

- Water only when your yard needs it
- The simplest way to determine if your yard needs water is to look for these visual clues:
- Grass blades are folded in half lengthwise on at least one-third of your yard.
- Grass blades appear blue-gray.
- Grass blades do not spring back, leaving footprints on the lawn for several minutes after walking on it.
- Check the forecast
- If your yard is showing signs that it needs

- water, check your local forecast to see if rain is on the way.
- Use a rain gauge to determine how much rain your yard has received.
 - Check your rain sensor
 - If you have a rain sensor, make sure that it is working properly.
 - Take full advantage of the rain
 - Make sure gutter downspouts are directed into landscaped areas or lawn.
 - Install a [rain barrel](#) to capture excess rainwater.

Governor Ron DeSantis Announces Emergency Repairs to Sanibel Causeway Completed More Than a Week Ahead of Schedule

TALLAHASSEE, Fla. — Today, Governor Ron DeSantis announced that emergency repairs to the Sanibel Causeway have been completed in 15 days, more than a week ahead of schedule. As of this morning, access to Sanibel Island has been restored for residents, reconnecting Sanibel Island to the mainland. To watch the Governor's full remarks, click here.

"The work that has been done to restore vehicle access to Sanibel Island has been historic," said Governor Ron DeSantis. "Cutting through bureaucratic red tape and delivering on our promise to get Sanibel Island up and running has been a top priority. By restoring access over the causeway, repair crews, first responders, emergency vehicles, business owners and residents will be better able to expedite recovery from this storm."

"I am grateful for our dedicated team members who quite literally built a road in the Gulf in 15 days," said FDOT Secretary Jared W. Perdue, P.E. "While the bridges were largely undamaged by the storm, portions of the causeway which connect bridge structures together were washed

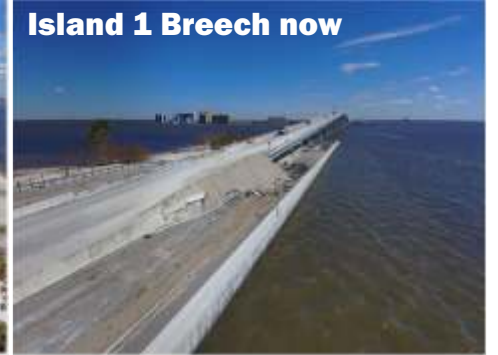
away by Hurricane Ian, leaving the bridges unconnected to the mainland or the island. A project like this, under normal circumstances, could take months. However, FDOT, along with our law enforcement partners at the Florida Highway Patrol, Lee County and Florida Department of Emergency Management made use of strategic and innovative techniques to rebuild the causeways quickly. Under Governor DeSantis' leadership, and thanks to the hard work of hundreds of FDOT employees and contractors, we were able to relink Sanibel Island to the mainland."

On October 4, Governor DeSantis directed FDOT to prioritize repairs to the Sanibel Causeway with an estimated completion date by the end of October. On October 11, the Governor announced that due to steady progress on repairs to the causeway, a one-time convoy of more than 350 vehicles for utility restoration would be able to safely cross the bridge onto Sanibel Island.

Damage from Hurricane Ian prevented vehicles from being able to cross the 3-mile-long bridge, delaying the delivery of needed services and supplies to the hard-hit Sanibel community. Crews worked around the clock to restore drivable access for the over 6,000 residents of Sanibel Island. With the completion of the temporary emergency repairs to the Sanibel Causeway, FDOT will now work with Lee County on plans for

permanent repairs on the causeway.

FDOT, in partnership with Lee County, has completed emergency repairs to several other damaged bridges in the Lee County area, including repairs to the Pine Island Bridge in less than three days in addition to Big Carlos Pass, Big Hickory, Little Carlos Pass, and New Pass Bridges.

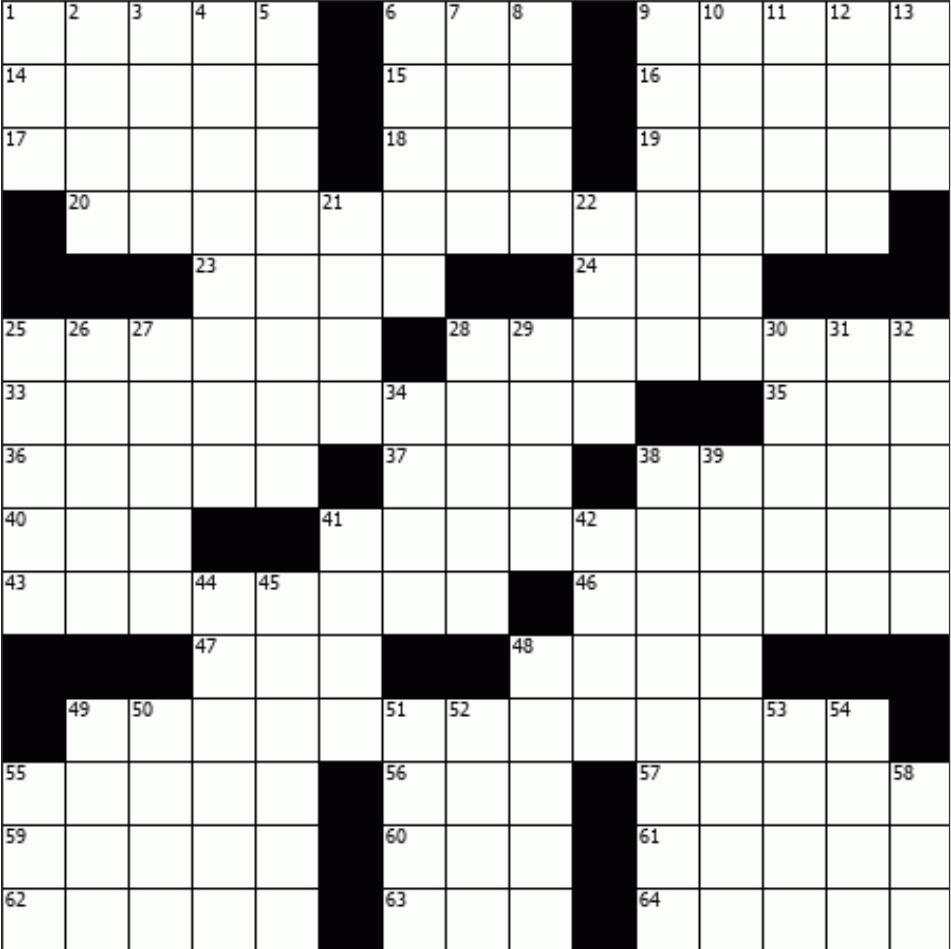

Generous Floridians and people across the country are contributing to the recovery efforts and we are so grateful for their support, but I want to remind those who want to give to watch out for charity scams and do some research before donating."

Attorney General Moody is issuing the following tips to Floridians looking to give:

- Research a charity before donating. Search the organization's name with the word 'scam'. Use [CharityNavigator.org](https://www.charitynavigator.org) for further vetting;
- When donating, use a credit card for extra protection;
- Avoid aggressive solicitors and urgent deadlines;
- Pay close attention to email addresses and website URLs—fraudulent sites will have slight changes from the legitimate sites;
- Keep records of all donations and transactions; and
- Do not click on any suspicious links in emails or text messages soliciting money or financial information, even if it seems like it is for a good cause.

Scammers may also target charitable organizations, especially after a disaster. A scammer could attack an organization's cybersecurity systems in hopes of stealing donors' identity or financial information, or may create an imposter organization that poaches donors from the true charity.

Florida charitable organizations can help prevent charity fraud by:

- Investing in trusted cybersecurity systems and providing cybersecurity training for all employees;
- Reviewing payment processing systems to double-check that it follows industry standards; and
- Keeping all software up to date.

Rain Barrels



Rain barrels are one component of this water-efficient landscape.

A How-to for Installing a Rain Barrel Benefits

Supplement irrigation and save money over time

Reduce stormwater runoff which can lead to reduced levels of pesticides and fertilizers in our water

Help reduce the amount of water that may settle around the foundation of your home

Uses for Collected Water

Connect to a soaker hose (with the pressure-reducing washer removed)

Fill a watering can and hand-water plants, flower beds and gardens

Keep your compost bin moist

Rinse off gardening tools

How Do I Get Started?

Step 1. Start With a Drum

Many people make rain barrels out of inexpensive 50-gallon food-grade drums that were used to carry juices, olives, pickles, etc. Stay away from ones that were used to carry harsh chemicals. Often you can find barrels for around \$10 from drum and barrel suppliers.

Be sure to get a heavy-grade plastic container that won't let in light — clear or translucent barrels can speed the growth of algae, which can clog pipes.

Rinse the inside of the barrel with a mixture of 1/8 cup of bleach and 5 gallons of water to wash away food or juice remnants.

Step 2. Chose a Location and Install a Hose Spigot

Some subdivisions have guidelines affecting size, location and appearance, so check with your homeowners association before installing a rain barrel.

Decide where to place the barrel — many people put them under a downspout for easy attachment. Also consider the distance to your plants, gardens and flower beds. If you

don't have gutters, put the barrel under a valley in the roof that sheds a lot of water, and put a screen over the open barrel.

To install a 3/4" hose spigot, drill a 15/16" hole for the spigot threading just a few inches from the bottom of the barrel. This will provide a few inches of clearance for attaching a hose or filling a watering can and will allow for debris to settle below the outlet to reduce clogging.

Step 3. Build a Platform

Concrete cinder blocks provide a strong, stable and level platform for your rain barrel. If you use more than one layer of blocks, stack them in a crisscross pattern so they won't tip over.

Step 4. Connect Downspout to Barrel

Position the barrel at its set height and measure where you need to cut or disconnect your downspout. Often you can disassemble the downspout at the gutter by taking out screws or drilling out rivets. If you do have to cut it off, use a fine-toothed hacksaw blade or tin snips.

A flexible downspout extender makes an easy transition from the downspout to your barrel lid and eliminates the need for exact measurement because it bends and stretches to the length you need.

Step 5. Cut Barrel Opening and Add Screen

Place the downspout connection in the barrel. If your barrel comes with a lid, or if it has a sealed top, you will need to cut a hole in it. Use a window screen or wire mesh to keep out debris and insects, and clean the tank periodically to remove any settling. Leaf debris, bird droppings and chemicals from roof material won't likely be harmful to plants.

It's important to keep your rain barrel independent from existing house piping or sprinkler system piping to prevent a cross-connection to your potable water.

You may want to connect an overflow pipe or link multiple barrels together. An overflow pipe will carry excess water that would normally overflow the barrel to another part of the yard or into another rain barrel. This is a great way to reduce water around the foundation of your house during rain.

A typical 1/2-inch rainfall will fill a 50- to 55- gallon barrel. Figure about a half gallon of water per square foot of roof area during a 1-inch rainfall. A 2,000-square-foot roof can collect about 1,000 gallons of water (accounting for about 20% loss from evaporation, runoff and splash).

This study also reveals some interesting generational differences with regards to acceptance of new authentication options such as biometrics. Compared to members of the Baby Boomer generation, millennials and respondents in generations X and Z, are more than twice as likely to be comfortable adopting biometrics. The younger respondents were, the more willing they would be to implement facial recognition to protect their accounts; almost double the number of 18-to-24-year-olds indicated a willingness to use the technology compared to Baby Boomers.

Big On Biometrics

Despite these differences, people as a whole seem receptive to using biometric authentication. Over half, regardless of age bracket, said they'd replace passwords with biometrics for activities such as ecommerce, online banking and social media. Almost half of respondents said they'd also do so for online government services. Additionally, across all age brackets, the majority of users said the ability to sign up for a new service with their biometric identity made them more likely to use that service.

So what's it going to take to get everyone to do away with outdated passwords and get on board with biometrics? Public education goes a long way; it's important to ensure that every generation understands the benefits and protections around this kind of data, especially as biometric security becomes more and more commonplace. In many cases, biometric data is deleted within milliseconds after being used. Even in cases where it's stored, images are broken down into bits so small that hackers wouldn't be able to make a composite image to access personal information. And, of course, commercial services can't use your biometrics without consent.

While there aren't many issues that can prompt agreement over generational divides, it's pretty clear that passwords are a universal source of frustration. It's hoped as data indicates, those frustrations will subside as biometric authentication becomes a more popular and convenient option.

Commit To Password Hygiene Or Resign To Getting Hacked

(NAPSI)—Passwords—they're so ubiquitous, yet are the source of so many online hacks due to poor password hygiene. According to a recent Aware poll, more than 50 percent of people choose to use the same

password across multiple accounts, which means that if a hacker has a password to one account, they can likely access several of that person's accounts. In fact, almost 70 percent of people remember passwords by picking those that are easy-to-use, or writing them down on a stray piece of paper.

Currently, there are billions of passwords available on the Dark Web, all aggregated through various attack methods, from malware and phishing to brute force. Passwords are highly prone to being weak, stolen, or lost—which brings up the question: Why don't people adopt more sophisticated techniques?

What is Password Hygiene?

Password hygiene is the practice of ensuring passwords are strong (hard to guess) and not prone to theft or loss. Best password hygiene practices include choosing unique passwords for each account, routinely changing passwords and never storing them somewhere obvious. But with people's attention spans and patience so often stretched, does anyone really do this?

Alternatives to Traditional Passwords?

Nearly 67 percent of Aware survey respondents know people who have been victims of account hacks. Unfortunately, the likelihood of those hacks will only continue to grow as cybercriminals get smarter and their methods become more agile. With all the problems around passwords, what are some more sophisticated approaches that could supplement or replace them?

1.Use two-factor authentication: Two-factor authentication requires an additional step before the user logs into the account. It typically is a one-time password via text, phone or email to ensure that only the account owner can gain access. Many websites do let users override two-factor authentication for trusted devices, so be sure not to do this, no matter how convenient it may seem.

2.Leverage a password manager: Password managers help users generate strong passwords and store them all in one encrypted place, alleviating the burden of remembering individual passwords for every account. In fact, you need to remember only one password in order to access that password manager.

Password managers can be a great organizational tool but aren't foolproof; if someone gains access to the password manager account, they have access to all the passwords stored within, which could be disastrous. Additionally, should a password manager company experience a data breach, all of its customers would be in danger.

3.Implement “passphrases” instead of passwords: Many organizations have begun locking sensitive data behind passphrases, not passwords. Instead of a password constructed by letters, numbers and symbols, some organizations require users to type out a whole phrase or sentence to access sensitive data. Again, this isn't a foolproof method, as sentences and phrases can also be guessed, but the length and strength of that passcode definitely supersede that of a password, making it more difficult to guess.

4.Biometrics: Biometric authentication

methods are considered the strongest means of authenticating people because they rely on something that can't be stolen or guessed at: their face, voice, fingerprints or iris. In addition to its superior security, biometric authentication is highly convenient, and the widespread presence of cameras on computers and smartphones makes it very easy to implement. The Aware survey also found that most consumers would choose to replace passwords with biometrics for most online services, including shopping and banking.?

It's never been more important for users to adopt good password hygiene in both their personal and their work lives. Between those efforts and the growing implementation of biometric security, it's possible to reduce the incidence of cybercrime.

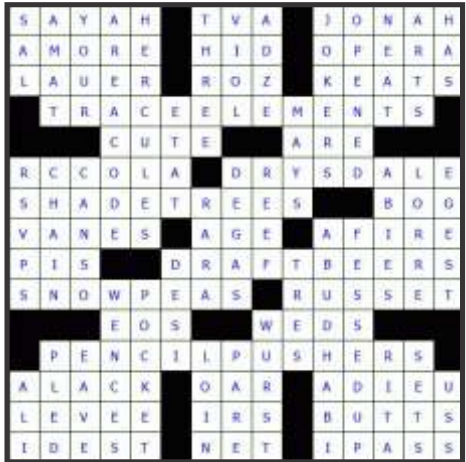
