that were the pride of a booming city. It takes readers to another time and another world that is distant but familiar.

Steel City by William J. Miller Jr. takes readers to the cauldron of Pittsburgh, Pennsylvania in the late nineteenth century. The steel business has made the city the industrial capital of not just the country but the world. And through the eyes of Jamie Dalton, readers witness the titanic events of that city in that age:

- The Johnstown Flood that killed over 2,000 people, the country's greatest natural disaster of the century.

- The Homestead Steel Strike of 1892, in which Henry Clay Frick sent an army of Pinkertons to break the back of the labor movement.

- An anarchist's assassination attempt on Frick's life in revenge for Homestead.

- The fight to the death between Frick and Andrew Carnegie for control of the country's predominant steel company.

- The inside story of what is still the largest corporate buyout of all time.

At the time, Pittsburgh's technological innovations and wealth creation made it the Silicon Valley of its day. It was first in steel, food processing, and electricity, and the leaders of those industries—Carnegie, Frick, Heinz, and Westinghouse—are names we still know today.

The author, William J. Miller Jr., grew up in Pittsburgh and was always fascinated by the living connections to its storied past: the Carnegie Library and Museum, the Carnegie Institute of Technology, and, in his own neighborhood, the Frick mansion, where Henry Frick's daughter, Helen, still lived. Miller has spent his entire career in journalistic enterprises as reporter, publisher, blogger, and Time Inc. consumer marketing veteran.

In this historical novel, Jamie, his father Richard, his mother Eleanor, and Pittsburgh society high and low navigate the social and economic issues of the late nineteenth century that still resonate today: corporate vs. individual responsibility, labor relations, suffrage, income inequality, substance abuse, media ethics. Steel City portrays the rich panoply of that era.

Jamie, a recent Yale graduate and son of a corporate lawyer, must decide whether to accede to his father's wishes and pursue a career in law or the steel business, or follow his own instincts and become a newspaperman. The Johnstown Flood confirms his choice to be a journalist, and Jamie goes on to cover Pittsburgh's business titans, labor strikes and assassination

## Letter to The Governor



We are now at about the halfway point of the 60-day Legislative Session in Tallahassee. We are reminded of how blessed we are to be living in this great state and it is an honor to be able to serve you

committee and is headed to the floor. This bill establishes universal school choice across the State of Florida. This bill puts parents in the driver's seat regarding their child's education, provides parents and students with the full array of educational opportunities, and allows every student in Florida to receive an education in a setting fit to their own individual needs. Through this legislation, families of students who fall below 185% of the federal poverty level (FPL) will be prioritized, with a second priority for households with income below 400% of FPL, to receive an empowerment account to take education dollars earmarked for their child and choose among a variety of options to customize their child's k-12 education.

As the fentanyl crisis continues to threaten millions of Floridians each day, it is critical that the legislature take a proactive approach to ensure that we limit the negative impact of synthetic drugs that are flooding into our state through the southern border. Recently, SB 736 was heard in the Senate Committee on Criminal Justice where it passed with unanimous committee support. Senate Bill 736 adds nitazenes, synthetic opioids similar to fentanyl, to the list of Schedule 1 controlled substances. This legislation ensures that our law enforcement agencies across the state have the necessary tools to cease the distribution of nitazenes and hold those accountable who are distributing this poison in our communities.



in the Florida Senate. Thanks to you, Florida continues to thrive economically and we are seeing hundreds of people moving here every day. While we are excited that they have chosen Florida to work and raise a family, it does present us with many challenges as we address the explosion of growth. comfortable talking to her about my mental health."

Talking about mental health with primary care providers is something doctors and nurse practitioners want more people to do. According to the GeneSight Mental Health Monitor national survey from Myriad Genetics, more than 83 percent of primary care providers (PCPs) wish more of their patients would tell them about their mental health concerns.

Yet, more than half of surveyed clinicians don't think patients are aware that PCPs and nurse practitioners are fully trained to diagnose and treat mental health conditions.

"It would be great if patients knew that they could bring up their mental health concerns to me," said Long. "But it is also my responsibility to complete depression and anxiety screening with them."

Regular mental health screenings at primary care appointments are a good first step in addressing patients' mental health, bridging the communication gap, and accurately diagnosing those suffering with mental health conditions. However, diagnosis is just the beginning of what is often an uphill battle to find the appropriate medication and dosage to alleviate patients' symptoms.

One tool that may help providers is the GeneSight test, which is a genetic test that determines how your genes may affect medication outcomes. Providers get a report about which medications to treat depression, anxiety, ADHD, and other mental health conditions may require dose adjustments, be less likely to work, or have an increased risk of side effects based on a patient's DNA.

Long uses the GeneSight test to help

reduce the medication trial-and-error process. After seeing that a prior depression medication didn't work for Beth, Long ordered the GeneSight test and used the information to decide how to change Beth's prescription. Today, Beth says she "feels so much better" and more like herself.

letting hackers in and personal data out. "While most people won't give security in the smart home a second thought, you really should," says Nelson. # Your Kidney Health



## Have More Healthy Moments: Get Tested and Follow Your Kidney Health

(NAPSI)—Kidney disease is often referred to as a "silent disease" because there are usually no symptoms during its early stages. In fact, as many as 90% of Americans who have chronic kidney disease (CKD) don't know they have the disease until it is advanced.

CKD is estimated to affect more than 1 in 7 adults in the United States. The good news is the earlier you find out you have kidney disease, the sooner you can take steps to protect your kidneys from further damage. By getting tested for CKD and following your kidney health, you may help keep your kidneys healthier for longer and give yourself more healthy moments.

### Know Your Risk

Even if you feel healthy and have no symptoms, ask your doctor about getting tested for kidney disease. If you are over 60 or have any risk factors for kidney disease—such as diabetes, high blood pressure, heart disease, a history of acute kidney injury or a family history of CKD—you may be at increased risk.

Early diagnosis gives you and your health care team time to develop a plan to slow kidney disease progression. The plan can also reduce your risk for other health problems, such as heart attack and stroke. Damage from kidney disease usually cannot be reversed, but treatment can help prevent further kidney damage and allow you to live a full life.

### Schedule Your Test

Testing for CKD involves two quick tests. A blood test checks how well your kidneys are filtering your blood. A urine test checks for protein in your urine, which is a sign of

kidney damage. Contact your doctor's office—or a community health center if you don't have a regular doctor—to schedule your kidney tests and find out how your kidneys are doing. You may be nervous about getting your kidneys tested but finding and treating kidney disease early gives you the best chance of staying healthier longer.

### Follow Your Kidney Health

Keep your appointments even if you feel well. Your doctor may repeat testing each year, or more often if needed, and use the changes in your results to plan the next steps for your care. If your kidney function is stable, your care team may recommend you continue doing what you're doing. If your kidney function seems to be getting worse, the team may suggest lifestyle or medicine changes.

Be proactive! Keep your kidneys healthy by following a kidney-healthy lifestyle.

- Manage your blood pressure and blood glucose levels.
- Talk with your doctor or pharmacist before taking nonsteroidal anti-inflammatory drugs, such as ibuprofen (e.g., Advil) or naproxen (e.g., Aleve).
- Be active for at least 30 minutes each day.
- Aim for 7 to 8 hours or more of sleep each night.
- Quit smoking.
- Consult a registered dietitian to build a meal plan you can stick to.

If financial or resource challenges make it hard for you to follow your care plan—including getting to medical appointments, paying for medicines, or buying healthy food—ask your care team for help.

"For people with kidney disease, working with a health care team is key to an early diagnosis and to staying on top of their kidney health," said National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK) Director Dr. Griffin P. Rodgers. "As we continue to research new ways to prevent and treat kidney disease, there are steps people can take today to improve and maintain the health of their kidneys—and enjoy more healthy moments."

## Eye Disease Can Affect More Than Your Sight

(NAPSI)—Eye disease affects more than your ability to see the world clearly. People with impaired vision face an increased risk of falls, fractures, injuries, depression, anxiety, cognitive deficits and social isolation. One of the best ways to protect yourself against vision loss from eye disease is to get regular eye exams.

Ophthalmologists—physicians who specialize in medical and surgical eye care—have more tools than ever before to diagnose eye diseases earlier, and to treat them better. But these advances cannot help people whose disease is undiagnosed, or who are unaware of the seriousness of their disease.

That's why the American Academy of Ophthalmology recommends all adults receive a comprehensive eye exam by age 40, and every year or two after age 65.

Here's how low vision can affect nearly every aspect of your life:

**1. Depression and social isolation.** Being unable to drive, read, enjoy hobbies or see loved ones' faces is frightening and can lead some people to withdraw from life, leaving them feeling helpless or lonely. One study found that after being diagnosed with a vision-threatening eye disease, a person's chance of experiencing depression triples.

**2. Dementia.** Several studies suggest a connection between eye disease and dementia. While the cause is unclear, it's possible some eye diseases interfere with the brain's sensory pathways. Early diagnosis and treatment are the best way to prevent vision loss.

**3. Injuries from falls.** People with decreased vision are more likely to misstep and fall. Every year, about 3 million older Americans are treated for injuries from falls, according to the Centers for Disease Control and Prevention. Many of these falls are caused by low vision. Luckily there are some changes around the house people can make, such as grouping furniture together and increasing lighting. Seeing an ophthalmologist regularly and making sure your glasses are updated with your latest prescription are important safety precautions as well.

**April is Distracted Driving Awareness Month: Distracted Driving is Dangerous.**

Anything that takes your attention away from driving can be a distraction. There is no doubt that the improvement of technology in today's society has greatly benefited our society as a whole. But, sending a text message, talking on a cell phone or using a navigation system creates hazardous road conditions. These and any other distractions, such as tending to kids or passengers in the back seat, eating, watching an event outside of the vehicle, interacting with passengers, unsecured pets, putting on makeup or grooming, adjusting radio or climate controls, checking your GPS app or daydreaming. These distractions can endanger you, your passengers, and others on the road.

There are three main types of distraction:

- Visual-taking your eyes off the road,
- Manual-taking your hands off the wheel
- Cognitive-taking your mind off driving.

Texting while driving has been proven dangerous beyond dispute due to the fact that it requires all three distractions at once to complete. Taking one's eyes off the road for the average 5-6 second text, is enough to travel the length of a football field at 55 MPH. A lot can happen during that distance

that creates a hazardous condition on the roadway.

According to the CDC related to 2019 statistics, over 3100 people were killed and an estimated 424,000 were injured in crashes involving distracted driving. About 1 in 5 of the people who died in crashes were not in vehicles. They were walking, riding their bicycles, or outside of their vehicle.

Young adult and teen drivers are the most at risk for distracted driving. In 2019, 9 percent of distracted drivers involved in fatal crashed were aged 15-20. It is important for parents to speak to their teen drivers about the risks of driving while distracted. Remind them that driving requires their full attention. This must also be done by setting the example for them. A parent/guardian who drives while distracted will likely not be taken seriously by their young driver. ["Governor Ron DeSantis Leads Alliance of 18 States to Fight Against Bidens ESG Financial Fraud"](#)

TALLAHASSEE, Fla. — Today, Governor Ron DeSantis and the governors of Alabama,

Alaska, Arkansas, Georgia, Idaho, Iowa, Mississippi, Missouri, Montana, Nebraska, New Hampshire, North Dakota, Oklahoma, South Dakota, Tennessee, Utah, West Virginia, and Wyoming formed an alliance to push back against President Biden's environmental, social, corporate governance (ESG) agenda that is destabilizing the American economy and the global financial system. Earlier this month, Congress took action to pass legislation which would keep politics out of Americans' retirement funds; however, President Biden has promised to veto this measure to further his progressive agenda. In a joint statement proposed by Florida, these states committed to lead state-level efforts to protect individuals from the ESG movement that threatens the vitality of the American economy and Americans' economic freedom, such as removing all state pension funds and state-controlled investments from firms that follow the ESG model of 'politics before fiduciary duty.'

"At my direction, Florida has led the way in combatting the pernicious effects of the ESG regime by directing our state pension fund managers to reject ESG and instead focus on obtaining the highest return on investment for Florida's taxpayers and retirees," said **Governor Ron DeSantis**. "At the time I said we would spearhead an

initiative to join with other like-minded states to send an even louder message to the financial industry that the American people have rejected ESG at the ballot box, and ideologues cannot and should not circumnavigate the will of the people. Today, we have delivered on that promise. Florida has emerged as America's economic engine, with an unemployment rate consistently lower than the nation's and the highest rate of business formations of any other state. We will not stand idly by as the stability of our country's economy is threatened by woke executives who put their political agenda ahead of their clients' finances."

Last month, Governor DeSantis announced legislation to protect Floridians from ESG. This legislation will safeguard Floridians' economic liberty by:

- Prohibiting big banks, trusts, and other financial institutions from discriminating against customers for their religious, political, or social beliefs — including their support for securing the border, owning a firearm, and increasing our energy independence.
- Prohibiting the financial sector from considering so called "Social Credit Scores" in banking and lending practices that aim to prevent Floridians from obtaining loans, lines of credit, and bank accounts.
- Prohibiting banks that engage in corporate activism from holding government funds as a Qualified Public Depository (QPD).
- Prohibiting the use of ESG in all investment decisions at the state and local level, ensuring that fund managers only consider financial factors that maximize the highest rate of return.

▪ Prohibiting all state and local entities, including direct support organizations, from considering, giving preference to, or requesting information about ESG as part of the procurement and contracting process.

▪ Prohibiting the use of ESG factors by state and local governments when issuing bonds, including a contract prohibition on rating agencies whose ESG ratings negatively impact the issuer's bond ratings.

▪ Directing the Attorney General and Commissioner of Financial Regulation to enforce these provisions to the fullest extent of the law.

This proposed legislation builds upon Governor DeSantis' actions taken at the August 2022 meeting of the Florida Cabinet where he and the Trustees of the State Board of Administration (SBA) passed a resolution that specifies that investment decisions "must be based only on pecuniary factors [which] do not include the consideration of the furtherance of social, political, or ideological interests" and stipulates that the SBA "may not sacrifice investment return or take on additional investment risk to promote any non-pecuniary factors" when making investments or proxy votes.





E, Fla.—Attorney General Ashley Moody, the Metropolitan Bureau of Investigation, the U.S. Drug Enforcement Administration and the U.S. Postal Inspection Service today announced the dismantling of a massive drug trafficking ring—arresting 35 suspects and seizing millions of dollars' worth of drugs. These defendants made up one of the largest cocaine trafficking rings in Florida history, transporting drugs from Puerto Rico to sell in Florida. The defendants also trafficked illicit fentanyl and are responsible for violent crimes, including torture.

Attorney General Ashley Moody said, “This massive drug-trafficking organization moved millions of dollars' worth of cocaine from Puerto Rico into the United States. They used torture to intimidate and maintain a stranglehold on the market, and supplied Central Florida with so much cocaine that the price of the illicit substance in that area actually dropped. I am proud of my Statewide Prosecutors for working with Florida and federal law enforcement to dismantle this dangerous drug-trafficking ring and ensure these suspects face justice.”

The joint investigation by MBI, DEA and USPIS seized more than 339 kilograms of cocaine, 71 grams of fentanyl and 152 grams of heroin—a seizure worth more than \$8 million. The investigation also uncovered that the traffickers tortured

people who crossed the group, and on one occasion burned a man with an iron.

The defendants are charged with racketeering, conspiracy to commit racketeering, traffic in and conspiracy to be trafficking in cocaine and fentanyl—all first-degree felonies.

Attorney General Moody's Office of Statewide Prosecution and the U.S. Attorney's Office in Puerto Rico will prosecute all 35 defendants.

### TAX-SEASON SCAMS SERIES: Tax Identity Theft

TALLAHASSEE, Fla.—Attorney General Ashley Moody is continuing the 2023 Tax-Season Scams Series with a warning for Floridians about Tax Identity Theft. In 2021, the Federal Trade Commission received 1.2 million reports of identity theft, and the FTC reports that the tax-filing season is the most common time for identity theft.

Attorney General Ashley Moody said, “Identity thieves love tax season and as we continue our series warning about common tax-related scams, I want filers to be extra cautious and take proactive steps to guard their personal information.”

Securing personal information, both online and offline, is one of the best ways to guard against tax identity theft. Physical documents containing sensitive information should be shredded before being thrown away into the trash. If a personal shredder is not available, communities often host local shredding days. Utilizing multi-factor authentication, as well as incorporating strong passwords, can spoil an online scammer's plan of obtaining personal information.

Attorney General Moody recommends these tips to avoid tax identity theft:

- File taxes early so a scammer can't file using stolen information;

- Apply for an [Electronic Filing PIN number with the Internal Revenue Service](#) for increased safety;
- Never use the same passwords across multiple websites or applications;
- Limit the number of companies that receive personal information;
- Avoid filing taxes in public;
- Take sensitive outgoing mail to a post office location rather than placing in a home mailbox; and
- Protect an electronic device with firewalls and anti-virus software, and keep up to date with security patches and updates.

Anyone who falls victim to tax identity theft should complete IRS Form 14039, Identity Theft Affidavit, at [IRS.gov](#) and attach it to the year's tax return. Taxpayers should also check credit reports regularly to ensure that there are no fraudulent accounts opened with stolen information.


*Scams at a Glance: Travel Traps* highlights some common travel scams:

- **Vacation-Rental Fraud:** Fake postings offering vacation-rental properties created by scammers who take the victim's money, leaving the traveler without accommodations;
- **Taxi or Ride-Sharing Scams:** Unlicensed or unmetered drivers that operate out of airports or major tourist destinations, charging undisclosed or flat-rate fees that are more expensive than real-metered fares;
- **Fake-Ticket Scams:** Scammers create fake websites, ads or physical tickets to trick visitors into buying worthless entrance passes;
- **Vehicle-Rental Scams:** Damaged sports-rental equipment or vehicles such as jet skis, scooters and boats are rented to tourists and the owner claims the renter damaged the vehicle; and
- **Credit-Card Skimming:** The illegal copying of the magnetic strip of a credit or ATM card—often occurring when a credit card is taken out of sight, or by placing illicit skimming machines on card readers or terminals.
