## Simple Eye Exam Could Save Your Life



Six Ways a Simple Eye Exam Could Save Your Life

(NAPSI)—It may come as a surprise to

some, but an ophthalmologist can help you keep an eye on your overall health. In fact, an ophthalmologist—a physician who specializes in medical and surgical eye care—may be the first to detect if you're at risk for a heart attack, stroke or other life-threatening conditions. That's because subtle, early damage to tiny blood vessels in the eyes can provide important clues about what is happening in the small blood vessels of the brain and heart.

The American Academy of Ophthalmology recommends all adults receive a comprehensive eye exam by age 40, and every year or two after age 65.

Surprising medical conditions that can be detected in a routine eye exam:

1. **Cancer.** This includes not only

eye-related skin cancers on the eyelid or the surface of the eye, but also cancers in other parts of the body. Leukemia, lymphoma, and breast cancer can all be detected in the eye.

2. **Diabetes.** Diabetes is a leading cause of vision loss in the United States, but signs of diabetes can also appear in the eye before vision is affected. When a person with diabetes has high blood sugar levels, it can affect the blood vessels in the eye. That's how an ophthalmologist might diagnose diabetes before other symptoms appear.

3. **Heart disease.** During a routine eye exam, ophthalmologists use a special imaging tool to examine the retina, the light-sensitive tissue at the back of the eye. If the blood supply to the retina is reduced or blocked, this could be an early symptom of heart disease.

4. **High blood pressure.** One in three American adults has high blood pressure, which can lead to heart disease if left untreated. Unusually shaped blood vessels or bleeding in the back of the eye can signal high blood pressure.

5. **High cholesterol.** Another common health condition that can lead to serious health issues is high cholesterol. A yellow or blue ring around the cornea can be a symptom, as can deposits in the blood vessels of the retina.

6. **Stroke.** An ophthalmologist can also spot plaque deposits in the arteries of the eye. If these pieces of plaque reach the brain, they can cause a stroke. Several eye symptoms are linked to stroke, such as loss of side vision, sudden blind spots, blurry vision, double vision, or sensitivity to light. People experiencing these symptoms should seek immediate medical attention.

**Can't Afford an Eye Exam? EyeCare America® Can Help.**

Individuals age 65 or older who are concerned about their risk of eye disease and/or the cost of an eye exam, may be eligible for a medical eye exam, often at no out-of-pocket cost, through the American Academy of Ophthalmology's EyeCare America® program. This public service program matches volunteer ophthalmologists with eligible patients in need of eye care across the United States. Identify and establish a personal teaching philosophy.

Use data and analytics to design curricula, see what's working and what isn't, and discover ways to improve students' academic experiences.

Form early and strong relationships with colleagues.

Nurse educators must also possess and master soft skills such as communication, collaboration, partnership, management, leadership, and advocacy to mold capable

Dear Friends,  
Our work in Tallahassee for 2023 has been completed. It feels good to be back in hometown America with friends, family, and the people of Senate District 13!

Our goal over the next few columns is to report on some of the key pieces of legislation that we passed in 2023, as well as provide a quick snapshot of the budget that we passed. Please note, as of this writing, the Governor still has time to sign or veto pieces of the budget as well as some policy items that we may mention in this first column. However, we do feel confident that those that we do highlight are not in danger of getting the red pen.

Our 2023 balanced budget (Yes, a balanced budget, we do not spend money we do not have!) addresses key needs in communities across our state, enhances our state's thriving economy, and provides Floridians with critical tax relief as we all deal with the crippling inflationary policies from the Federal Government. The general appropriations act is \$117 billion in total allocations. This includes nearly \$11 billion in total reserves, which serves as our state's rainy day fund. As usual, our two highest areas of funding are health and human services and education at \$47.3 billion and \$27.9 billion, respectively. \$2.7 billion will be returned to taxpayers via various forms of outlets.

This year's budget appropriates an historic \$711 million for a affordable housing through SB 102, the Live Local Act. This legislation and the appropriated funds signify the Legislature's commitment to providing high-quality, attainable workforce housing that allows Floridians to live in the communities they serve.

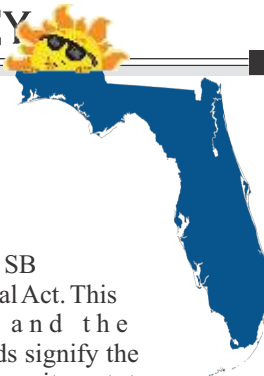
Additionally, \$850 million is allocated for the expansion of Florida's Iconic Wildlife Corridor, which, through an additional \$200 million appropriation for the expansion of the SUNTRAIL system, will be accessible for locals and visitors to experience all that Florida's heartland has to offer.

In K-12 education, parents and students can expect to see expanded school choice opportunities, increased FEFP funding, and improved school safety. This funding will increase base per-student allocations by over 12% and ensure that educational funding in Florida follows the student, expanding opportunities for all students. The budget also allocates \$675.8 million to fund workforce development, teacher apprenticeship programs, and career and technical education for Florida school districts, empowering students to attain high-paying careers immediately after

graduating high school if they decide college is not the path for them. Continuing our commitment to attract the very best teachers to the State of Florida, the budget provides an additional \$252 million to increase teacher pay.

Thank you for sending us to Tallahassee to fight for you and your families. It is an honor to serve you as President Pro Tempore of the Florida Senate.

They help their students address the health issues of diverse patient populations such as individuals from foreign countries who do not speak English and need an interpreter, low-income persons who can't afford necessary procedures, and people in rural communities without access to high-quality care.

## FROM THE DESK OF CONGRESSWOMAN KAT CAMMACK



**Reps. Cammack, Soto, Jackson, Perez Introduce Rural Internet Improvement Act Of 2023**

WASHINGTON, D.C. — Today, Congresswoman Kat

Cammack (R-FL-03), Congressman Darren Soto (D-FL-09), Congressman Ronny Jackson (R-TX-13), and Congresswoman Marie Gluesenkamp Perez (D-WA-03) introduced the Rural Internet Improvement Act of 2023.

The Rural Internet Improvement Act eliminates duplicative broadband programs

at the U.S. Department of Agriculture (USDA) by merging and codifying the popular Rural e-Connectivity Pilot Program (ReConnect) with USDA's broadband loan and grant program. ReConnect builds upon past successes of these programs by enhancing the participation of all types of providers.

Reliable high-speed broadband services are necessary for America's rural communities, providing opportunities for telehealth, education, and economic development. There are more than 14.5 million Americans who still lack access to both fixed and mobile broadband, according to the FCC's most recent Broadband Deployment Report.

"North Central Florida's rural communities deserve reliable, affordable, and high-speed internet access for daily activities, including education, telehealth, business, and more. It's important to continue our critical work to ensure ReConnect works for our rural communities, and I'm pleased to join with my bipartisan colleagues in connecting more people to the internet for our increasingly digital world," said Rep. Kat Cammack.

"Access to reliable high-speed broadband services is no longer a luxury, but a necessity, especially for our rural communities. The Rural Internet Improvement Act seeks to bridge the digital divide by streamlining USDA broadband authorities, focusing on truly unserved communities, and ensuring program accountability and transparency. By providing support and enhancing participation of all types of providers, we can connect more Americans to the opportunities for advancements in healthcare, education, and economic development that broadband services offer," said Rep. Darren Soto.

"I live in rural America, and I get my internet from a radio tower. Struggling to access the internet is part of everyday life for me and my community. This bipartisan bill brings us closer to ending the digital divide and making sure people can access the internet no matter where they live," said Rep. Gluesenkamp Perez.

"We applaud Reps. Cammack, Soto, Gluesenkamp Perez, and Jackson on the introduction of the Rural Internet Improvement Act of 2023, legislation focused on helping broadband reach more

homes. This bill would guide funding for network expansion to areas where at least 90 percent of households lack access to broadband and encourage reliance on network builders that have experience constructing and operating broadband networks," said NCTA, the Internet & Television Association. "In addition, this legislation would replace existing programs with a revised ReConnect program that would enhance participation and results so more communities can be connected to broadband even faster. Altogether, these are improvements that should be adopted as part of the Farm Bill. Deploying affordable high-speed broadband to all Americans is a key priority for the cable industry, and we look forward to working with members on passage of this legislation."

# Know the Signs of Stroke



Acting in Time Can Save a Life

**Call 911 immediately if you think you or someone around you is having a stroke.**

(NAPSI)—You work hard to help keep yourself and your loved ones healthy. To help, the National Institute of Neurological Disorders and Stroke (NINDS) reminds everyone that stroke is a leading cause of death and disability in the United States. About 800,000 people in the country have a stroke each year. The good news is, when treated quickly, survival is possible and damage can be greatly reduced. That's why understanding your risk for stroke, knowing signs of stroke, and acting in time are critical and can make all the difference for you or someone you care for. If you have a greater chance of stroke, there are also steps you can take now to help prevent one.

## What is Stroke?

There are two major types of stroke. One, called a hemorrhagic stroke, occurs when a brain blood vessel breaks and blood escapes into or around the brain. The other, called an ischemic stroke, or "brain attack," occurs when blood flow to the brain is interrupted. When this happens, brain cells stop getting the oxygen and nutrients they need.

## Risk Factors for Stroke

## Signs of Stroke

- The symptoms of stroke usually happen quickly and include one or more of the following:
- Sudden NUMBNESS or weakness of face, arm, or leg, especially on one side of the body
- Sudden CONFUSION, trouble speaking, or understanding speech
- Sudden TROUBLE SEEING in one or both eyes
- Sudden TROUBLE WALKING, dizziness, or loss of balance or coordination

- Sudden SEVERE HEADACHE with no known cause

## Act in Time: Call 911 Right Away

Stroke is a medical emergency. If you believe you are having a stroke—or if you think someone you know is having a stroke—call 911 immediately. Do not wait for the symptoms to improve or worsen. Making the decision to call for medical help right away can save a life or mean avoiding a lifelong disability.

## Ways to Help Prevent Stroke

You can help prevent stroke by making healthy choices and controlling any health problems you may have.

Manage any health problems you may have, especially high blood pressure, but also diabetes, high cholesterol, and obesity to lower your risk for stroke.

Eat a healthy diet with plenty of fresh fruits and vegetables.

Exercise regularly—about 30 minutes a day, 5 days a week.

Avoid drinking too much alcohol.

### New Study Estimates YouTube's Impact on U.S. Economy and Culture

(NAPSI)—The next time you enjoy watching something on YouTube, you may care to consider there's a lot more to the service than fun and learning. It's an important part of our economy, too.

#### Study Shows

For example, Oxford Economics—a global advisory firm—published a study assessing the impact of YouTube creators on the United States' economy, culture, and society. The report found that in 2022, YouTube's creator ecosystem contributed more than \$35 billion to the U.S. gross domestic product and supported over 390,000 full-time equivalent jobs.

In the U.S., the number of YouTube channels with 1 million subscribers increased by more than 15% year over year between 2021 and 2022. The number of YouTube channels making \$100K or more in revenue also went up by 5%.

#### A Big Help For Small Business

The report also provides insight into how YouTube creators and users, parents and teachers feel about the platform's impact on American life.

Small businesses are also figuring out how to turn YouTube subscribers into opportunities. Oxford Economics' research found that 78% of small businesses that use YouTube agreed it's essential to their business growth.

"YouTube leveled the playing field between us and big box stores because it puts our business in front of customers who may not otherwise find us," said Steve Andrianos, who runs [Hercules Candy](#) with his family in Syracuse, NY.

Others are leveraging platforms such as YouTube to launch new, rewarding careers. Nisha Vora of San Diego, CA left her career as an attorney at a top law firm to pursue her passion for vegan cooking. Her YouTube channel—[Rainbow Plant Life](#)—has over 1 million subscribers.

"Online success doesn't just mean having a viral video or 15 minutes of fame anymore," said Vora. "People are waking up to the realization that you can build lasting careers and successful businesses by leveraging platforms like YouTube."

#### Parents And Teachers Approve

The report also shows that parents and teachers find value in YouTube. According to the study, 85% of U.S. parents who use YouTube agree that it provides quality content for their children's learning and entertainment. Additionally, 73% of teachers who use the system agree that it helps students learn.

[Governor Ron DeSantis Announces Florida has Lowest Unemployment Rate Amongst the 10 Largest States in the Nation and Experienced Record Tourism in First Quarter of 2023](#)

*Florida's unemployment rate remains at a near record low 2.6 percent for the 4<sup>th</sup> consecutive month. Florida also saw the largest volume of visitors ever recorded in a single quarter between January and March of this year.*

**TALLAHASSEE, Fla.** — Today, Governor Ron DeSantis announced that Florida has the lowest unemployment rate among the top 10 largest states in the nation at 2.6 percent, as Floridians see continued economic stability spurred on in part by the thriving tourism industry. Between January and March of 2023, Florida saw a record 37.9 million visitors, the largest volume of visitors ever recorded in a single quarter. In April 2023, Florida's unemployment rate was 2.6 percent for the fourth consecutive month, which is 0.8 percentage points lower than the national rate of 3.4 percent. Florida's statewide unemployment rate has remained lower than the national rate for 30 consecutive months since November 2020.

In April 2023, the labor force was 10,960,000, an increase of 5.8 percent since February 2020. Between April 2022 and April 2023, Florida's total private sector

employment grew by 336,200 jobs (4.1 percent), which is faster than the national private sector job growth rate of 2.7 percent during the same time period. In April 2023, with the exception of October 2022, Florida employers have added jobs for 35 months since May 2020. Florida's over-the-year private sector job growth rate has exceeded the nation's growth rate for 25 consecutive months since April 2021.

"Through strong economic policy and strategic investments, Florida is outperforming the nation and providing more opportunity for its citizens, resulting in more than 200,000 new business formations this year alone and an unemployment rate near an all-time low," said **Governor Ron DeSantis**. "In Florida, we are combatting negative national economic headwinds by promoting policies that support Florida businesses and families and attract record numbers of tourists every day."

"Florida's low unemployment rate of 2.6 percent – the lowest among the top 10 largest states in the nation – is a testament to Governor DeSantis' bold leadership," said **Meredith Ivey, Acting Secretary of the Florida Department of Economic Opportunity (DEO)**. "Governor DeSantis' Freedom First policies are helping Florida businesses continue to create jobs and Floridians feel confident in the meaningful job opportunities available to them, ensuring the economic prosperity of the great state of Florida and its residents."

"The Q1 estimates show that 2023 is on track to continue Florida's outstanding performance in welcoming visitors," said

**Dana Young, VISIT FLORIDA President and CEO**. "Each quarter shows that Florida is the most sought-after destination for visitors and we are excited to continue our efforts in welcoming more throughout the year. VISIT FLORIDA is proud of the work we have done with our partners in sharing Florida's sunshine with the world and we thank Governor DeSantis for his unwavering support of our organization and the tourism industry."

Florida's strong economy and freedom first policies continue to draw record numbers of visitors that support Florida's businesses. Florida welcomed 37.9 million total visitors between January and March 2023, according to VISIT FLORIDA estimates. This is the largest volume of visitors ever recorded for a single quarter. A record high of approximately 34.6 million domestic visitors traveled to Florida in Q1 2023, continuing the trend of domestic visitation growth for an eighth consecutive quarter. Florida welcomed 1.8 million overseas travelers in Q1 2023, an increase of 36 percent from Q1 2022. This marks the closest that overseas visitation has come to full recovery since the onset of the pandemic. Total enplanements at 19 Florida airports rose 11.8 percent in Q1 2023 from Q1 2022, reaching 27.6 million visitors.

Florida's labor force grew over-the-year by 2.3 percent (+248,000), faster than the national labor force growth rate of 1.7 percent. In April 2023, Florida's labor force grew by 0.3 percent (+38,000), while the national labor force declined by less than 0.1 percent over the month. In April 2023, total private employment increased by 18,200 (+0.2 percent), growth on par with the national rate of change.

In April 2023, the professional and business services sector gained the most

jobs among all major industries, adding 10,900 jobs (+0.7 percent) from the previous month, followed by education and health services with 7,100 jobs (+0.5 percent) and financial activities with the addition of 2,700 jobs (+0.4 percent).

Data from the month of April continues to indicate there are many job opportunities available for Floridians throughout the state, with more than 464,000 jobs posted online. Floridians in search of work and new job opportunities are encouraged to turn to the [CareerSource Florida network](#) for help. Floridians can find guidance on how to register with [Employ Florida](#) and search listings of available local job openings. Career seekers also can improve their employability by perfecting resume writing and interviewing skills, establishing career goals and pursuing customized career training. These services are provided at no cost to job seekers.

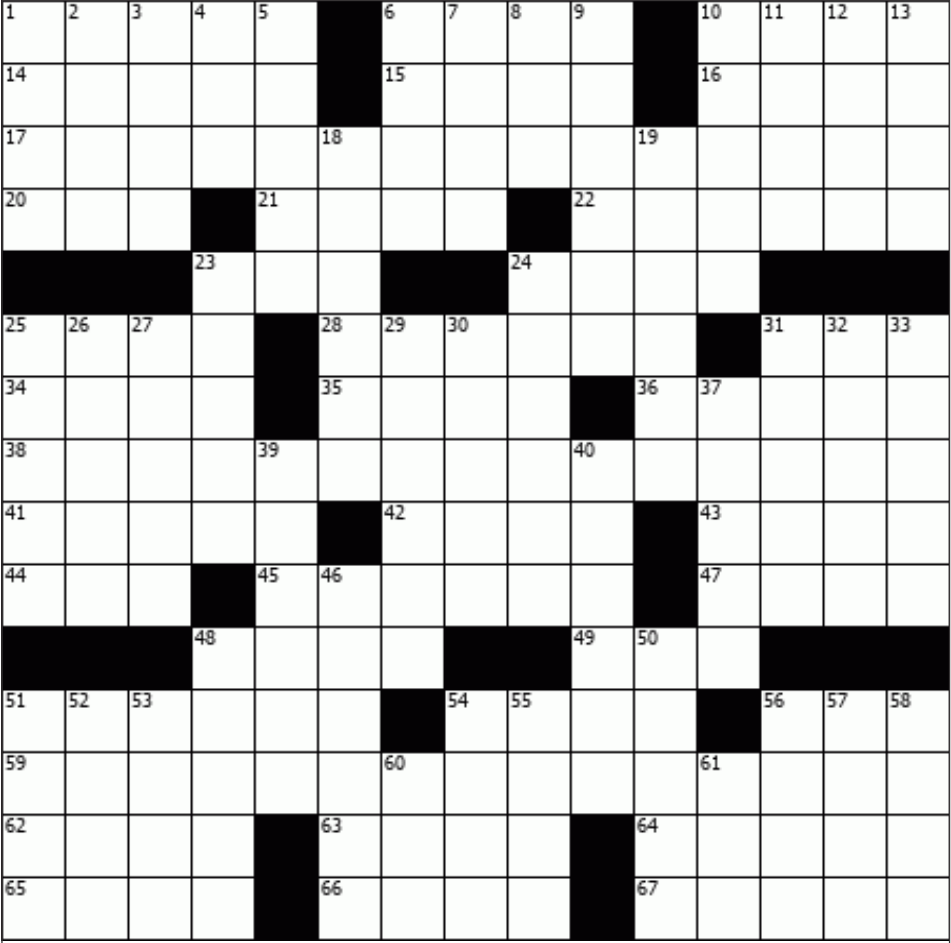

- Ingredients**
- 4 cups (32 ounces) marinara sauce
  - 2 cups (16 ounces) ricotta cheese
  - 2 garlic cloves, minced
  - 1 tablespoon lemon zest
  - 1 teaspoon oregano
  - ¼ teaspoon red pepper flakes
  - ¾ teaspoon sea salt, more for the pasta water
  - Freshly ground black pepper
  - 1 pound ziti pasta
  - Extra-virgin olive oil, for drizzling
  - 1 pound fresh spinach
  - 1½ cups smoked mozzarella cheese
  - ¼ cup grated pecorino or Parmesan cheese

- Instructions**
- Preheat the oven to 425°F. Spread ½ cup marinara in the bottom of a 9x13-inch baking dish.
- In a medium bowl, combine the ricotta cheese, garlic, lemon zest, oregano, red pepper flakes, ½ teaspoon salt, and several grinds of fresh pepper.
- In a large pot of salted boiling water,

- cook the pasta according to package directions until al dente. Drain.
- Return the pot back to the stove. Over low heat, drizzle the bottom of the pot with a little olive oil and add the spinach. Toss and sauté 1 to 2 minutes until just wilted, working in batches if necessary. Turn off the heat, remove the spinach from the pot, and gently squeeze out some of the excess water. Coarsely chop it and set aside.
- Add the pasta back to the pot along with the remaining marinara, most of the chopped spinach, ¼ teaspoon sea salt, and more fresh pepper and toss until combined.
- Add half the pasta to the baking dish, top with dollops of the ricotta, the remaining spinach, and scoop the remaining pasta on top. Top with the mozzarella and pecorino cheese. Drizzle with olive oil and bake until the cheese is browned, 16 to 22 minutes.
- Garnish with fresh basil or parsley and serve hot.

In recognition of National Police Week and Mental Health Awareness Month, Attorney General Ashley Moody is highlighting available resources for Florida law enforcement officers. Statistics show, in previous years, that law enforcement officers are more likely to die by suicide than in the line of duty. According to [BlueHelp.org](https://www.bluehelp.org), the national law enforcement suicide rate increased in 2022—however, Florida's rate decreased. In an effort to further protect Florida's officers, Attorney General Moody is encouraging any first responder struggling with mental health issues to seek help.

**Attorney General Ashley Moody** said, "We received some encouraging news this National Police Week and Mental Health Awareness Month. The suicide rate among Florida law enforcement officers declined last year. I want to thank all the mental health experts in Florida who focus efforts on helping our first responders who struggle with the mental health issues brought on because of their service to others. I also encourage anyone struggling to seek help. There are caring professionals available 24/7 who want to help."

**Crisis Center of Tampa Bay President & CEO Clara Reynolds** said, "The Crisis Center of Tampa Bay would not be able to support the community to the extent that it does without partnering with local law enforcement agencies. We are so

appreciative of their support of the victims of assault they bring to our door, the interventions they provide when someone is contemplating taking their life, and the numerous other ways they step in to keep us all safe. Thank you for choosing this very vital but difficult work each and every day."

Law enforcement officers face challenging work daily that can take a serious toll on mental health. The [Blue H.E.L.P.](https://www.bluehelp.org) program seeks to bring awareness to suicide and mental health issues law enforcement officers face. The program, created by Karen Soloman and Jeffrey McGill, offers mental health education, advocates for law enforcement officers and their families and recognizes those lost to mental health causes.

Attorney General Moody wants all law enforcement officers struggling with mental health issues to know that help is available. There are caring people available 24/7 who understand the struggles and challenges that often accompany protecting the public from danger and violence.

The Crisis Center of Tampa Bay is a nonprofit organization developed in 1972 to offer comprehensive services to people in the Tampa Bay community through collaboration and partnerships. With more than 10 different programs that offer a wide range of services and resources to all individuals, the Crisis Center of Tampa Bay is determined to ensure no one in the Tampa Bay community has to face a crisis alone.

Since taking office, Attorney General Moody continues to take action to support Florida law enforcement officer mental health, including:

- **Urging Congress to pass the Public Safety Officer Support Act of 2022:** Last year, Attorney General Moody, joined by 52 other attorneys general, urged Congress to pass the Public Safety

Officer Support Act of 2022. The legislation addresses gaps in support for public safety officers who suffer from PTSD associated with the high-risk nature of their jobs..

- **Presented a Back the Blue Award to an Officer for Supporting Mental Health Awareness:** Attorney General Moody presented a Back the Blue Award to a Tallahassee Police Department officer who co-wrote a book with information on mental health awareness and treatment strategies for first responders. Officer Sean Wyman co-authored *Going Beyond the Call: Mental Health Fitness for Public Safety Professionals*. The book focuses on social-emotional trauma, stress impacts and communication strategies to reduce the number of suicides within the public safety industry.

- **Recognizing CCTB's Law Enforcement Suicide Help Line:** Attorney General Moody presented a Florida Cabinet [resolution](#) recognizing National Suicide Prevention Month in Florida in September 2019. Attorney General Moody then visited CCTB to recognize the then-pilot program called "First to Respond, Last to Ask For Help." At the time, the program served officers in Hillsborough County with a help line to call for immediate, confidential support. Now, the help line is extended statewide—any officer in the state needing assistance can call 1(866) 4FL-HERO.

**ATTORNEY GENERAL MOODY  
URGES CONGRESS TO PASS  
BIPARTISAN BILL TO FIGHT  
PREVALENCE OF DEADLY  
XYLAZINE**

Attorney General Ashley Moody today urged congressional leadership to pass the Combating Illicit Xylazine Act (H.R.1839/S.993). This bill would provide critical measures to combat the widespread illicit use and trafficking of xylazine and help prevent xylazine-related deaths. Attorney General Moody's call on Congress follows a surge in overdose deaths nationwide related to xylazine, a potent veterinary medication that is being widely mixed with illicit drugs, such as fentanyl, and is easily obtainable online. Over the past few months, multiple federal agencies, including the U.S. Drug Enforcement Administration, have issued public alerts about the dangers of xylazine.

**Attorney General Ashley Moody** said, "Xylazine burst onto the illicit substances scene this year exacerbating the worst overdose crisis we have ever seen. This flesh-eating zombie drug is being combined with extremely deadly fentanyl and for months we have been fighting to educate the public about its dangers. I urge all members of Congress to support the important Combating Illicit Xylazine Act."

Xylazine is only approved by the U.S. Food and Drug Administration as a veterinary medicine used to sedate and relieve pain in large animals. In humans, xylazine is known to depress breathing and heart rate, lower blood pressure, and cause unconsciousness, necrosis and even death. Xylazine is not an opioid; thus, existing medications like naloxone are not effective in reversing the drug's effects even if used with opioids.

According to DEA, a dramatic increase in xylazine-related overdose deaths across the U.S. occurred between 2020 and 2021, with an increase of 1,127% in the Southern region, 750% in the Western region, 516% in the Mideast region and 103% in the Northeast region. Additionally, in 2022, approximately 23% of fentanyl powder and 7% of fentanyl pills seized by the DEA contained xylazine.

In a letter to congressional leaders today, Attorney General Moody urged lawmakers to pass the Combating Illicit Xylazine Act. The bill federally schedules the dangerous drug and allows DEA to track manufacturing and sales of xylazine to ensure it is not diverted, among other measures.

In addition to Attorney General Moody, the attorneys general of the following states and territories signed the letter: Alabama, Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, District of Columbia, Georgia, Hawaii, Illinois, Indiana, Kentucky, Louisiana, Maryland, Michigan, Minnesota, Missouri, Nevada, New Hampshire, New Mexico, New York, North Carolina, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin.

Before Title 42 expires at midnight, the Biden administration must explain to a federal judge why a new immigration policy does not violate a court order obtained by Attorney General Ashley Moody earlier this year. The judge's order compelling a response follows two legal actions by Attorney General Moody during the past 24 hours.

was confirmed this week through an [email](#) by an official at the U.S. Department of Justice. The Biden administration's new policy is in direct conflict with a ruling earlier this year obtained by Attorney General Moody in federal court. In the [ruling](#), United States District Court Judge T. Kent Wetherell held that Biden's federal immigration policies are illegal and must change. It now appears the only thing the Biden administration is willing to change about the policy is the name—not the unlawful approach that will allow more than [700,000](#) immigrants to flood the country.

Judge Wetherell's order requiring expedited response states: “If the allegations in the complaint and motion are true, then it appears that DHS is preparing to flout the Court's order in *Florida v. United States* by implementing a new 'parole' policy that, based on the DHS spokesperson's description of the policy, sounds virtually identical to the Parole+ATD policy the Court vacated in *Florida*.”

**Attorney General Ashley Moody** said, “The gall of Biden to thumb his nose at a federal court order and proceed with an unlawful plan to allow what amounts to an invasion at our Southwest Border is not only unprecedented, it is dangerous. We have blown the whistle on Biden every step along his path to illegally dismantle our nation’s border security system—and even as the clock ticks down to the end of Title 42, we are taking action to force this administration to follow the law, secure the border and protect the American people.”

Attorney General Moody is taking legal action to stop another unlawful policy by the U.S. Department of Homeland Security. The new DHS policy requires the release of inadmissible immigrants without deportation proceedings. In the wake of a court order prohibiting policies like this, and

In a [legal action](#) filed in the U.S. District Court Northern District of Florida, Attorney General Moody argues that DHS's new policy is not in accordance with law, exceeds the agency's authority, is arbitrary and capricious as well as fails to meet notice and comment requirements. Attorney General Moody is filing this new complaint to postpone the effective date of the unlawful new policy, preliminarily enjoin it and ultimately vacate any new parole policy.

The complaint states, “On May 9, 2023—approximately two months after the Court vacated the March Parole + ATD Policy—the media began reporting that Border Patrol planned to restart the mass release of migrants at the Southwest Border upon the expiration of the Title 42 order on May 11, 2023. On May 10, a DHS spokesperson told the media that DHS plans

to employ the 'targeted use of parole [to] allow Border Patrol to focus its resources most effectively [on] quickly processing and removing individuals who do not have a legal basis to remain in the country.' In short, rather than seek a stay of the Court's judgment in good faith, DHS plans to continue its game of whack-a-mole with Florida and with this Court by promulgating yet another unlawful policy."

Attorney General Moody also filed an [emergency motion for a temporary restraining order](#) in the same court. Florida seeks the restraining order to prevent DHS from implementing the new parole policy or otherwise using parole as a tool of operational convenience.

The motion states: “Florida seeks a temporary restraining order to preserve the status quo until the parties can brief motions for a preliminary injunction or to postpone the effective date of the new policy. The Biden Administration's behavior, if left unchecked, makes a mockery of our system of justice and our Constitution.”

On March 8, after a year and a half of litigation, Judge Wetherell ruled that Biden effectively turned the U.S. Southwest Border into “little more than a speedbump” and vacated the Biden administration’s catch-and-release policy.

This case gained national attention over the damning evidence Attorney General Moody uncovered concerning the Biden administration's deliberate efforts to weaken border security. Attorney General Moody filed the case in September 2021. During the course of discovery and litigation, Florida forced the federal government to provide or disclose the following:

- A [deposition](#) of U.S. Border Patrol Chief Raul Ortiz showing the Biden administration purposely reduced detention capacity of the U.S. Immigration and Customs Enforcement and narrowed removal pathways. Ortiz claimed these changes left Border Patrol with no other choice but to release hundreds of thousands of immigrants into the interior. Ortiz also agreed that Biden's

policies caused the unprecedented surge at the border.

- A [memo](#) outlining the federal government's plan in the event immigrants overrun the border when Title 42 expires—the mass release of migrants into the United States.

### [Testimony](#)

- and deposition of ICE Executive Associate Director for Enforcement and Removal Operations Corey Price confirming the Biden administration knew its immigration priorities would cut enforcement in half and still implemented them. Price also confirmed that ICE is removing more than seven times fewer inadmissible immigrants than in 2012, booking in roughly half the number of immigrants than the previous administration.
