# Operation: Poison Control

## Lake Sheriff's Undercover Detectives Charge 21 in Operation: Poison Control

The Lake County Sheriff's Special Investigations Bureau, in conjunction with the City County Investigation Bureau, recently concluded a six-month investigation dubbed *Operation: Poison Control*. The goal of the operation was to target mid- to high-level drug traffickers distributing fentanyl throughout Lake County.

As the investigation progressed, detectives encountered an assortment of illegal narcotics being distributed throughout Lake County. As a result of the operation, undercover detectives were able to successfully purchase trafficking amounts of fentanyl, as well as trafficking amounts of methamphetamine, cocaine, and MDMA from multiple drug traffickers throughout the county. Undercover detectives were able to obtain arrest warrants for 21 individuals, for a total of 50 charges.

It should be noted that some information obtained for this investigation was developed through information received from the public. In addition, the investigation was a joint effort between several law enforcement agencies, to include the Florida Department of Law Enforcement, the Drug Enforcement Administration, and the Leesburg, Eustis, Mt. Dora, and Clermont Police Departments. Such support from our citizens and inter-agency cooperation is what makes these investigations successful.

As a result of the operation, arrest warrants were issued for 21 subjects. A warrant round-up was conducted last week; 15 are in custody at the time of this release, and 6 are still wanted.

If you have any information concerning the whereabouts of these six individuals, you are encouraged to call the Sheriff's Office or Central Florida CRIMELINE at 1-800-423-TIPS, where you can remain anonymous and possibly be eligible for a cash reward.

# Operation Safe Kids

## Florida Sheriffs Task Force Announce Successful Completion of Operation Safe Kids in Lake County

**Lake County, Fla. (September 12, 2023)**

—Today, the Florida Sheriffs Association (FSA) Task Force released the results of Operation Safe Kids, a strategic initiative in 42 Florida counties that called attention to traffic safety in and around schools to ensure that children had a safe return to school from Summer Break. During the Task Force Operation Safe Kids, Florida's sheriffs issued 7,218 warnings and 5,171 traffic citations, dedicated 5,900 hours during the enforcement period, delivered 5,520 educational messages and posted 80,674 social media messages throughout the state.

"Safeguarding Florida's future through youth-focused programs and services is a key objective for law enforcement statewide. This goal has been achieved today by identifying and monitoring high-risk areas, issuing warnings and citations, and educating the public on the importance of school zone safety," said **FSA President and Nassau County Sheriff Bill Leeper**. "The implementation of this program highlights Florida sheriffs' strong commitment to upholding the security of families and local communities in our state."

Dear Friends,  
We sincerely hope that all of you made it safely through Hurricane Idalia. As we near the end of hurricane season, we have officially made it to the beginning of committee meetings, which started on October 9<sup>th</sup>. As a reminder, The committees that I have been assigned to are Agriculture, Appropriations, Appropriations Committee on Criminal and Civil Justice, Appropriations Committee on Health and Human Services, Children, Families, and Elder Affairs, Community Affairs, Military and Veterans Affairs, Space, and Domestic Security, and Rules.

To better prepare for the upcoming legislative session, the Lake County Legislative Delegation held their annual legislative delegation meeting on August 22<sup>nd</sup>. This annual public meeting is an opportunity for citizens, elected officials, cities and local governments, and other civic organizations to address the delegation before the start of the next legislative session. This meeting was inspiring and fruitful. It is always encouraging to see the community come together to express their ideas and to take an active part in their government. Since Senate District 13 covers all of Lake County and West Orange County, we will also be attending the Orange County Legislative Delegation meeting on November 29<sup>th</sup> for further insight into the concerns and needs of our constituents.

On another note, we have begun the implementation of one of the many important pieces of legislation that was passed during the 2023 Legislative Session – House Bill 1: Education. In a show of good faith, incorporating recommendations from the Florida Association of District School

Superintendent s, led by former Senator Bill Montford, this bill took the first step towards reducing onerous and excessive regulations on public schools with several immediate revisions to Florida's Education Code. For example, the bill reduces hurdles to a 5-year temporary teacher certificate for anyone with a bachelor's degree and for those with three years of effective or highly effective service. The bill repeals the requirement that a student take one online course in order to graduate from high school, which is not currently required in private schools. The bill also offers districts flexibility in facility costs for new construction, and offers student transportation flexibility to improve efficiency, while maintaining student safety. To reduce additional regulation on public schools, the next step in implementing HB 1 is for the State Board of Education to review the entirety of the Florida Early Learning-20 Education Code for potential repeals and revisions to be considered during the 2024 Legislative Session. HB 1 requires the Board to consider input from teachers, superintendents, administrators, school boards, public and private postsecondary institutions, home educators, and other entities, and that process is ongoing.

Thank you for taking the time to read this letter. We hope that it will encourage you to attend your local legislative delegation meeting as well as shed some light on an important legislative priority that the Florida Legislature will continue to focus on during the next session.

## FAIRTax

**FAIRtax**  
SIMPLE • EFFICIENT • VISIBLE

I've often heard people say that the FAIRtax is unfair to the poor and the wealthy won't pay their fair share. That is NOT true. I've also heard that it is unfair that the wealthy get the same prebate as everyone else. Again, NOT true. Let's also remember that the "net" tax rate differs greatly from your "effective" tax rate (the rate you actually pay).

Let's look at a billionaire under the FAIRtax and assume he is married with no children. If he spends \$10,000,000 he is paying \$2,300,000 in taxes and gets a prebate of \$4,697 then his effective tax rate as a percentage of spending is 22.95 percent.

Now let's look at a middle-income married couple with no children under the FAIRtax. If they spend \$50,000 they pay \$6,803 net of their prebate for an effective rate of 13.6 percent. The effective rate increases as spending increases, but never exceeds 23 percent.

In contrast, if the same couple earns \$50,000 in wages today under the current

income tax system, they pay \$4,093 in income taxes and \$3,825 in payroll taxes for a total of \$7,918 or 15.8 percent. That's a tax burden 14.1 percent higher than under the FAIRtax. In addition, their employer pays another \$3,825 in payroll taxes. Most economists agree that the employer payroll tax is actually borne by the employees in the form of lower wages. Looking at it this way, this couple is paying \$11,743 (23.5 percent) in taxes today which does not include the hidden taxes they pay every time they purchase an item.

Finally, let's look at a low-income couple that spends at the poverty level under the FAIRtax. # A Look Into the Eye



## Help Kids See Their Way To A Good Education

(NAPSI)—If any of the approximately 74 million schoolchildren in the U.S. is someone you care about, here's something you may want to look into: According to the National Institutes of Health (NIH), visual health can have a great influence on students' academic performance. Visual disorders, the NIH says, are one of the best predictors of educational success.

### A Look Into The Eye

The eye is literally an extension of the brain. It is estimated that more than 60% of the brain has some duties associated with vision input, the American Optometric Association points out. Because of this, any condition that hampers vision or the processing of vision may result in learning problems. When diagnosed and treated early, however, most individuals have a better chance of learning efficiently.

That's one reason the U.S. Preventative Services Task Force recommends children between the ages of 3 and 5 get vision

screening to reveal problems that may lead to blindness without early treatment.

So, many students, teachers, and parents may be glad to learn about an improved way to test children's vision.

### Seeing Vision Problems Clearly

A handheld, portable device called the Welch Allyn Spot Vision Screener by Baxter has been designed to help quickly and easily detect the risk factors of amblyopia and other vision issues in children as young as six months, all done from a non-invasive, three-foot distance. A bright touchscreen displays instant results, indicating whether measurements are in range or a complete eye exam is recommended.

The machine objectively measures refractive errors and alignment between the eyes, which helps identify six risk factors of amblyopia. Select photo screening devices can examine both eyes at once and can take only a few seconds to perform the screening.

Results are easy to interpret and can be shared with family and other eye care specialists. It can easily be used in pediatric offices, schools and community vision screenings. The American Academy of Pediatrics and American Association for Pediatric Ophthalmology and Strabismus recommend the use of photo screening instruments in young children.

### The Effectiveness of Photo Screening

A study performed by researchers at Virginia Commonwealth University found that photo screening correctly identified more students in need of a comprehensive eye exam than an ordinary screening could. The study also showed that instrument-based screening is time efficient and can be performed in a quarter of the time of visual acuity screening.

### One Family's Story

The Malpass family, based in Washington

State, includes two active boys, Miles, 12, and Parker, 8, who love to play all sorts of sports and are avid readers. When Miles complained that he could not see well out of his right eye, their parents had both boys looked at with a Spot Vision Screener. It was discovered that each boy's eyes were slightly different sizes, causing a refractive error in the bad eye. The brain prefers to use the dominant eye, which made the vision worse in the non-dominant eye. An ordinary eye chart test at school had failed to catch the problem. Fortunately, it was correctable and both boys now wear glasses and see well at school and on the playing fields and ski slopes.

### Be Informed

Find out what disasters or emergency situations may occur where you live, work and go to school; how officials will contact you during a disaster; and how you will get important information, such as evacuation orders.

The increase in large disaster responses also means that more people need help across the country. As a part of this, the Red Cross is calling for new volunteers to help grow its disaster workforce—90% comprised of trained volunteers—to deliver shelter, food, health and mental health support, and one-on-one recovery assistance. ### Weather Affects the National Blood Supply

Blood and platelet donations that go uncollected due to climate-related events, such as hurricanes, wildfires and extreme heat, can put further strain on the national blood supply. As extreme weather events are worsening, the Red Cross—which provides about 40% of the nation's blood supply—is seeing that translate into more blood drive cancellations. In 2022, over 1,300 blood drives were canceled due to weather—about 23% higher than the average of the prior nine years.

## Global Spotlight: Brazil

### Brazil: Deforestation of Amazon reduce by more than 30 Percent

For years, the Amazon rainforest was cut down. The concern: the unique ecosystem could collapse. The deforestation in Brazil is a huge environmental problem. But the election of Lula da Silva as president gave hope. He announced that he would end the deforestation of the Amazon. In fact, the first steps followed a few days after taking office. The encouraging result: in comparison to the previous year, deforestation was reduced by more than a third.

The BBC reports first successes in the fight against rainforest deforestation. Compared to the first half of the previous year, deforestation was reduced by 33.6%. In June 2023, as much as 41% less forest was destroyed than the previous year. Brazilian Environment Minister Marina Silva attributes this to Lula's successful environmental policy.

### Lulas potential to reduce deforestation by 89 percent

Lula's goal of ending deforestation by 2030 is a major challenge. Under his predecessor, Jair Bolsonaro, deforestation took on alarming dimensions. The new conservation plan, which President Lula published at the beginning of June 2023, aims to achieve this goal. Among other things, it provides for the confiscation of half of all illegally used land within protected areas, as well as higher penalties for illegal logging.

Furthermore, the Brazilian president calls on other countries, especially the rich West, to contribute financially to saving the “green lungs of the earth” in order to combat the climate crisis globally.

A study confirms that Lula's plans actually have the potential to reduce deforestation in the Amazon by 89 percent. In any case, Lula will not have it easy: The left-wing president still faces a conservative majority in parliament.

### Under Bolsonaro, the Amazon shrank by more than twice the area of Vienna – per month

## Rep. Cammack Joins Colleagues To Support Florida's Request For Federal Fishery Disaster Declaration

GAINESVILLE, FL

Florida's fisheries, a significant contributor to Florida's economy. These small businesses need assistance to recover from this Major Hurricane.

On September 5, 2023, the State of Florida requested the U.S. Department of Commerce to declare a federal fishery resource disaster to support fishery businesses affected by Hurricane Idalia.

Rep. Cammack joined U.S. Senator Marco Rubio (R-FL) and colleagues in sending a letter to U.S. Department of Commerce Secretary Gina Raimondo supporting the State of Florida's request.

“Florida's iconic fisheries are foundational to the economy and way of life of many of the communities that have been devastated by Hurricane Idalia. A timely and robust response by the Department of Commerce, through the declaration of a fishery disaster in support of Florida's fishing industries, is required to help these communities recover.”

## To Rein in Biden, Look To Florida's Example

President [Joe Biden](#)'s regulatory assault on American families is easily the worst in American history.

It's driving up grocery prices, utility bills, and the cost of everyday life, leaving people paying a lot more while getting a lot less. If [Republicans](#) truly want to fight back, they should look to the states for

inspiration—especially our home state of Florida. The Sunshine State is rolling back red tape at a record pace, thanks in large part to a unique policy that empowers lawmakers to block new mandates. Republicans in [Congress](#) should rally around a similar law to stop President Biden's rule by administrative fiat.

Compare what's happening in D.C. to what's happening in Florida.

At the federal level, President Biden proposed and enacted new regulations costing a [staggering \\$201 billion](#) in his first year alone. That's more than three times the burden imposed by President [Barack Obama](#) over the same timespan, and 40 times that of President [Donald Trump](#).

In his second year in office, President Biden shows no signs of slowing down. He's dictating everything from the [cars we can drive](#) to the [lightbulbs we can buy](#). If anything, the president's spree of red tape is only going to grow, especially if Republicans retake Congress this November. He'll use what President Obama famously called his "pen and phone" in ways no chief executive ever has before.

Compare that with what's happening in Florida.

The Sunshine State proposed the lowest number of regulations in modern history last year, according to [new research from the Foundation for Government Accountability](#). It follows years of regulatory repeal and relief by governors and lawmakers alike.

This sustained progress puts Florida well ahead of its competition. California now has more than twice as many regulatory restrictions. New York has about 75% more, and Illinois 65% more. Even Texas has a larger regulatory burden than Florida.

The chasm between these states is set to grow even deeper. The overall number of regulatory restrictions is still falling in Florida; it's growing in nearly every other state.

Why is Florida cutting red tape so quickly and effectively? One of the biggest reasons is a [2010 law](#), passed over then-Gov. Charlie Crist's veto, that says the state legislature must approve all rules that cost \$1 million or more over five years. If lawmakers don't affirmatively approve such a regulation, it doesn't go into effect. This policy ensures that the people's representatives have a say on new mandates.

Unsurprisingly, lawmakers have stopped new mandates that would jack up costs on Florida families. That includes stopping a [proposed rule](#) this year from the agriculture commissioner to ban styrofoam in grocery stores, saving families from higher costs.

Florida's policy is the definition of common sense—but the federal government takes the opposite, and nonsensical, approach. President Biden can force Americans to pay hundreds of billions of dollars in higher regulatory costs because there's no real check on his administration's ability to propose new rules. Congress gets no say in the matter, even though the Constitution invests the House and the [Senate](#) with sole lawmaking power. Lawmakers are bystanders when they should be referees.

At the start of the current Congress, one of us (Rep. Cammack) [introduced](#) a federal version of Florida's law. It's called the REINS Act and it requires the House and Senate to vote on all federal regulations that impose at least \$100 million in costs annually. This policy would have given Congress the chance to stop a significant portion of President Biden's regulatory spree; it would have put [Democrats](#) in the tough spot of voting for mandates that make prices higher and life more painful for working families.

But the current REINS Act wouldn't

necessarily have stopped all the president's use and abuse of the federal bureaucracy. Like Obama before him, President Biden has also relied on executive orders and agency "guidance," including the [recent 25% boost to food stamp payments](#). This approach has the de facto effect of regulation absent formality, meaning Congress couldn't always vote to stop it.

We're therefore partnering to introduce an expanded version of the REINS Act to close this loophole. If this policy is enacted, Congress will be required to vote on essentially every major action coming out of the executive branch. By stopping new mandates like President Biden's, lawmakers could save Americans untold billions of dollars, and even help tame runaway inflation in the process. Most important, it will put citizens back in the position of holding accountable their duly elected representatives—not unelected bureaucrats.

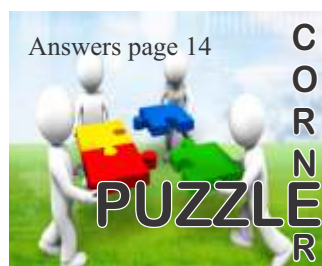
Florida proves this policy works. The state's economy is booming, with new residents moving here every 50 seconds and 1,800 new start-ups setting up shop every day. The state's light touch on red tape, driven by the governor's and lawmakers' willingness to stop costly new rules, is undoubtedly contributing to the [Sunshine State's ever-brightening outlook](#). Republicans in Congress should fight to bring that approach of accountability and affordability to Washington, D.C.

## Attorney General Moody Encourages Floridians To Remain Vigilant During National Preparedness Month

TALLAHASSEE, Fla.—This National

Preparedness Month, Attorney General Ashley Moody is urging Floridians to remain vigilant. National Preparedness Month raises awareness about the importance of preparing for disasters and emergencies that could happen at any time. September also marks the peak of hurricane season. Currently, there are multiple tropical systems in the Atlantic Ocean, including Hurricane Lee. Florida just endured the effects of Hurricane Idalia late last month and recovery efforts will be ongoing for the foreseeable future. To help Floridians solidify storm-readiness plans, Attorney General Moody is highlighting the 2023 Hurricane Preparedness Guide.

Attorney General Ashley Moody said, "In emergency situations, proper preparations can make all the difference. As we recognize National Preparedness Month, move through the peak of hurricane season, and see heavy storm activity in the Atlantic, I encourage all Floridians to take another look at our 2023 Hurricane Preparedness Guide to solidify storm preparations."

The Atlantic Hurricane season peaks between mid-August and mid-October. Hurricane Lee and Hurricane Margot are both strong storms currently moving through the Atlantic Ocean, and thankfully not forecasted to reach Florida. However, Floridians should still be prepared. On Aug. 30, Hurricane Idalia hit Florida's Big Bend region, and residents are still recovering from the storm that caused [billions of dollars](#) in damage.

Below is a graph from the National Oceanic and Atmospheric Administration showing hurricane and tropical storm activity from 1944 to 2020.

Preparedness tips provided in the guide include:

- Know evacuation routes and shelter locations;
- Stock up on enough food, water and emergency supplies for the entire household for at least seven days or more;
- Check that storm-related products are hurricane-proof or impact-proof before purchasing;
- Research recovery charities before donating;
- Beware of unsolicited contractors and extremely low or high prices for quotes; and
- Report price gouging during a state of emergency, including online or on the free No Scam app.

Floridians can stay informed about serious storm events using the Florida Division of Emergency Management's website, [FloridaDisaster.org](#). Floridians can monitor a storm's progression and the latest weather alerts using the NOAA's Hurricane Center by visiting [NHC.NOAA.gov](#).

In the event of an incoming tropical storm or hurricane, Floridians should look for further guidance from local officials and emergency managers.

## AG MOODY AND FLORIDA CRIME STOPPERS TEAM UP WITH FORMER HOST OF AMERICA'S MOST WANTED FOR STATEWIDE CRIME-FIGHTING INITIATIVE

TALLAHASSEE, Fla.—Attorney General Ashley Moody and the Florida Association of Crime Stoppers are teaming up with John Walsh from "America's Most Wanted" and "In Pursuit with John Walsh" to fight crime. At the Palm Beach County Sheriff's Office today, Attorney General Moody, Walsh and Crime Stoppers announced a new partnership to encourage Floridians to use \*\*TIPS, the state's anonymous crime tip reporting line. The crime-fighting trio are encouraging Floridians to be proactive in helping law enforcement solve cases by reporting information related to crimes. Over the past three years, PBCS received more than 2,000 tips from Crime Stoppers, with more than 400 tips leading to an arrest.

Attorney General Ashley Moody said, "John Walsh has been the relentless force behind America's Most Wanted and the National Center for Missing and Exploited Children—I am excited that he is helping us recruit Floridians to join our fight against crime. Through this new partnership with Florida Crime Stoppers, we will be spreading the word about \*\*TIPS and encouraging Floridians to anonymously report information to help law enforcement solve crimes."

John Walsh said, "I have dedicated my career to locating missing children and fighting crime. The \*\*TIPS tipline will give Florida law enforcement an advantage over criminals in hard-to-crack cases. Solving a case can be a miracle for a family and help make communities safer. I praise Attorney General Moody for her efforts in supporting law enforcement and encouraging Floridians to actively help officers stop crime."

President of the Florida Association of Crime Stoppers, Frank Brunner said, "Our statewide network of 27 Crime Stoppers chapters throughout Florida is excited about John Walsh joining our team of crime fighters. This new partnership, along with our current partner, the Attorney General's Office, will encourage public engagement and help increase awareness on how people can anonymously share their critical information and assist law enforcement with making our state a stronger, safer place."

Attorney General Moody, FACS and Walsh are releasing a video message for Floridians to assist law enforcement in making their communities safer. The informational video highlights the \*\*TIPS tipline—a number anyone in the state can call from a cell phone to reach the nearest Crime Stoppers office. Individuals can submit information on crimes and remain anonymous. If the tip leads to an arrest, the

caller may receive a cash reward.

Attorney General Moody and FACS first launched [\\*\\*TIPS](#) in October 2020. Before the tipline's creation, Floridians needed to look up the specific region's Crime Stoppers number to report a crime—there are 27 different offices each with separate phone numbers. Now, by simply dialing the six-key tipline on a cellphone, citizens are automatically rerouted to the nearest regional Crime Stoppers office.

In February 2022, [Crime Stoppers USA adopted the phone number](#) for nationwide use. Now, anyone in the United States can report crime anonymously with this easy-to-remember number and possibly collect a reward for tips that lead to an arrest.

In 2021, Attorney General Moody and FACS announced a [near-doubling](#) of award money for anonymous tips in murder cases that lead to an arrest. The increase takes the maximum allowable award amount from \$5,000 to \$9,500 for tips provided to FACS.

John Walsh is known internationally as a crime fighter, victims' advocate and host of "America's Most Wanted," the reality program that helped law enforcement capture fugitives. Walsh currently hosts "In Pursuit with John Walsh," and co-founded the National Center for Missing and Exploited Children that helped bring home more than 50 missing children. Over the past three [decades](#), through "America's Most Wanted, Walsh helped bring to justice more than 1,200 fugitives—including 17 people off of the FBI's Most Wanted list.

## AG MOODY UNCOVERS BIDEN'S SECRET PLAN FOR MASS-RELEASE QUOTAS FOR MIGRANTS STOPPED AT THE SW BORDER AMID IMMIGRATION SURGE

TALLAHASSEE, Fla.—Attorney General Ashley Moody continues to uncover evidence of the Biden administration's intentional destruction of the nation's border with Mexico. Recently-obtained U.S. Border Patrol emails outline new proposed "bookout targets" for field chiefs and deputies to "bring in-custody numbers to manageable levels."

U.S. Customs and Border Protection's Acting Deputy Chief emailed the new targets on Aug. 8, following a field leadership call to discuss "in-custody numbers." During the call, CBP leaders revealed that "the rate of daily encounters continues to surpass the daily permanent bookouts and the in-custody numbers

continue to rise."

Attorney General Ashley Moody said, "Biden and Mayorkas have become so brazen that they are now implementing mass-release quotas for immigrants surging into our country. As a federal judge already recognized, these releases are unlawful, yet the Biden administration is ordering Border Patrol to release even more immigrants into the interior. This latest email is further proof of the disastrous cycle created by Biden's intentional destruction of our border with Mexico. Biden cuts resources, opens the border, and then releases detainees while claiming there is not enough detention capacity to prevent the unprecedented flood of migrants entering the country because of his terrible policies. With every passing day it is becoming more obvious that the border crisis is being intentionally orchestrated by the Biden administration. We will continue to do everything in our power to push back and let the American people know of Biden's devious plan."

While the email Attorney General Moody obtained from CBP references new "daily bookout targets," the actual release quotas were redacted for unexplained reasons.

According to reports, CBP is currently detaining nearly 20,000 migrants with agents [reporting nearly 6,000](#) new encounters daily.

Since President Biden took office:

- [More than 6 million](#)
- migrants have surged across the border;
- [More than 50,000](#)
- pounds of fentanyl has been seized, enough to kill the U.S. population more than 35 times over; and
- [259 people](#)
- on the terrorist watch list have been identified, including 146 so far in fiscal year 2023.

With the current surge and mass-release policies in place, states as far north as New York and Massachusetts are feeling the effects. [Massachusetts is under a state of emergency](#) while struggling to house an influx of illegal immigrants.

Florida beat the Biden administration in federal court earlier this year, obtaining a ruling that called the current border "[little more than a speed bump](#)," a ruling affirming what Attorney General Moody has been saying for years, that Biden's immigration policies are unlawful.

Last month, [a federal trial](#) in Texas began, challenging Biden's Humanitarian Parole Policy allowing 30,000 immigrants from select countries automatic access into the U.S. every month. Florida is a party to the case.

### Governor DeSantis Hosts Discussion About COVID Boosters with State Surgeon General and Health Experts

**TALLAHASSEE, Fla.** — Governor Ron DeSantis held a discussion with State Surgeon General Dr. Joseph Ladapo and public health experts about the recently federally approved COVID-19 mRNA boosters. “Once again, the federal government is failing Americans by refusing to be honest about the risks and not providing sufficient clinical evidence when it comes to these COVID-19 mRNA shots, especially with how widespread immunity is now,” **said State Surgeon General Dr. Joseph Ladapo**. “In Florida, we will always use common sense and protect the rights and

liberties of Floridians, including the right to accurate information.”

Today's announcement builds on actions taken by the DeSantis administration to push back on the FDA and CDC's rushed approval and mandates of COVID vaccines since 2020, even when the evidence doesn't line up

Amazon has been badly affected in recent years. When Lula first moved into the presidential palace in 2003, he launched an ambitious program to save the rainforest. He and his successor Dilma Rousseff, who like Lula comes from Brazil's leftist Workers' Party, succeeded in reducing deforestation by 80 percent to a historic low. But when Bolsonaro came to power in 2019, Brazil did an about-face on environmental policy.

Bolsonaro readily awarded concessions to allow corporations to clear rainforest for soy and palm oil farming, as well as cattle ranching and mining. Illegally cleared areas were legalized by Bolsonaro, and forest fires were fought only half-heartedly. Clearing jumped by 70 percent under his government.

**For the first time, the Amazon emits**

**more CO2 than it can absorb**

Under Bolsonaro, the Amazon's climate balance had turned around: For the first time, it emits more CO2 than it can absorb. This was shown in a study by researchers from the French National Institute for Agronomic Research. The scientists mainly analysed satellite data documenting the plant biomass in the rainforest and its deforestation. The result: the Amazon basin released about 16.6 billion tons of CO2 into the environment, but only absorbed about 13.9 tons. This 2.7 billion ton difference is roughly Austria's consumption for 35 years.

**Without well-maintained Amazon rainforest, the whole ecosystem could topple over**

Currently, the Amazon has a perfectly functioning water cycle: regions inland actually have too little rainfall for a tropical rainforest. But the trees suck the groundwater upwards, it evaporates and

rains down again over the huge forest area. This cycle could be permanently disrupted by further deforestation. The rainforest would slowly die, turning into savannah and changing the climate around the world.

This process would release as much CO2 as the entire world consumes in seven years. The unique ecosystem that is home to 10 percent of all species would be irretrievably lost, and with it the CO2-binding effect of the rainforest. Scientists assume that this tipping point is reached at a deforestation rate of 20 to 25 percent. Currently, we are at 18 percent.

**Deforestation in Brazil: Raids after taking office**

Within days of taking office, Lula's government took action, conducting checks in the rainforest against illegal logging. As Reuters reports, controls were carried out in areas all within the Cachoeira Seca indigenous reserve, where deforestation is strictly prohibited.

While deforestation is decreasing, the number of fires continues to increase, satellite monitoring shows. Whether due to natural causes or arson cannot be determined.

Even with the proper use of filters, your home's heating and cooling system gets really dirty through normal, everyday use, just as surfaces in your home get dusty over time.

All sorts of contaminants and air pollutants—bacteria, pet dander, dust, skin cells, mold, tobacco smoke, even chemicals—get pulled into an HVAC system and recirculate through the home several times a day, building up in the system.

Worse, rodents and insects can chew their way into the ductwork to travel throughout your home, build nests and leave droppings.

Telltale signs include chewed materials, unpleasant smells, and bacteria contaminating the air you breathe.

All this can contribute to poor indoor air quality and major health issues, especially for those with respiratory conditions, autoimmune disorders, asthma, or allergies. The EPA says poor indoor air increases your risk of pneumonia and causes irritated eyes, nose, and throat, headaches, dizziness, and fatigue.

In addition, when the system is clean, it doesn't have to work as hard so it lasts longer and uses less energy, lowering electric bills

### A Second Issue

Getting your ducts cleaned, however, can mean another problem: Scams. The HVAC system cleaning industry is plagued with fraudulent “duct cleaners” who cause more harm than good by agitating rather than removing dust, debris, and pollutants or who charge for unneeded add-on services.
