nerve in me. I have been paying into this for my retirement benefits, not a welfare fund...Not to pay illegal immigrants that came in to this country by breaking the law or people who just don't want to work!

This is NOT a benefit. It is OUR money, paid out of our earned income! We all contribute to Social Security, and our employers did too! It totaled 15% of our income before taxes. If you averaged \$30K per year over your working life, that's close to \$180,000 invested in Social Security. Calculate the future value of your monthly investment in social security (\$375/month, including both you and your employers' contributions) at a meager 1% interest rate compounded monthly, after 40 years of working you'd have more than \$1.3+ million

dollars saved. This is our personal investment. Upon retirement, if you took out only 3% per year, you'd receive \$39,318 per year, or \$3,277 per month. That's three times more than today's average Social Security benefit! according to the Social Security Administration. (Google it). Your retirement fund would last more than 33 years until you're 98 if you retire at age 65.

I can only imagine how much better most average-income people could live in retirement if our government had not used our funds for things they think are more important. Instead, the Government pulled off a bigger Ponzi scheme than Bernie Madoff ever did. They took our money and used it elsewhere. They did not have a

### Lake County Detectives Make Arrest in Connection with Recovered Missing Juvenile

On September 7, 2023, the Lake County Sheriff's Office received a report of a missing female juvenile, Aliyah Duncan, who has since been recovered. After the initial report was completed by deputies, extensive search efforts were performed. Detectives proceeded to interview multiple family members and people known to the missing juvenile. The interviews consisted of detectives meeting with the juvenile's boyfriend, Damion Anderson, and his grandmother, Debbie Myers, with whom he resides.

Detectives interviewed both Anderson and Myers nearly twelve times over the course of three weeks. During that time, both parties provided little information, as they were adamant about having no knowledge of the juvenile's whereabouts. Anderson and Myers were made aware of the multiple resources being utilized to locate the juvenile. In addition, they were both informed of the criminal charges they could face if they had knowledge of the juvenile's location and chose to withhold that information from law enforcement. Myers response to that was that she believed the extensive search was becoming "ridiculous" and that whoever is responsible for assisting the juvenile should be charged.

In addition to multiple interviews, detectives completed a total of four search warrants for different social media accounts, six subpoenas for location services, and eight exigent after-hour information requests. Detectives also coordinated with multiple FBI agents, US Marshalls, neighboring sheriff's offices, local law enforcement agencies, and the Florida Department of Law Enforcement, who all assisted with the search efforts in some capacity. At the conclusion of utilizing multiple different investigative strategies and extensive resources, the juvenile was ultimately located at the residence of Myers

and Anderson, where she was staying during the entirety of the time, she was reported missing.

An arrest warrant for Anderson and Myers was issued, charging them both with interference with child custody, providing false information to law enforcement, and contributing to the delinquency of a minor. They have both been arrested as a result of the arrest warrants.

### Five Arrested in Undercover Sting Operation: Nightcrawler

Detectives assigned to the Lake County Sheriff's Cyber Crimes Unit recently concluded a 4-day operation targeting subjects online attempting to meet children for sexual activity. The investigation, dubbed *Operation: Nightcrawler*, was conducted October 4-7 and resulted in five arrests for various sex-related crimes.

After unknowingly talking online with an undercover detective, the subjects traveled to a predetermined location with the intent to have sex with a child. All suspects were taken into custody upon arrival. This operation would not have been possible without the cooperation and support from the Florida Department of Law Enforcement, as well as the Clermont, Tavares, Eustis, Leesburg, Mount Dora, and Altamonte Springs Police Departments.

## Florida State Senate

We are in our second month of committee meetings and only two months away from the official start of the 2024 Legislative Session, which begins on January 9<sup>th</sup>, 2024. We have been busy in Tallahassee preparing for this exciting day. We will share with you some important highlights that have recently taken place at the Capitol.

The Senate Republican Caucus selected Senator Ben Albritton (R-Wauchula) as Senate President-Designate to lead the chamber through the 2024-2026 term. Senator Albritton was nominated by Senators Ed Hooper (R-Clearwater) and Jim Boyd (R-Bradenton) and was elected by a unanimous vote of his Republican Colleagues. In his speech, delivered after his election, the newly named President-Designate Albritton highlighted his roots in Florida's Heartland, his love for his wife and family, his support for Florida agriculture, and his vision of what Florida's future can be. Looking toward his tenure as Senate President, President-Designate Albritton displayed his excitement to work with his fellow Senators and our colleagues across the Rotunda, led by Speaker-Designate Daniel Perez, as they look to meet the challenges of our time and deliver results for Floridians in every corner of the state.

Senate President Kathleen Passidomo (R-Naples) and Speaker Paul Renner (R-Palm Coast), joined by members of the Florida Senate and Florida House of Representatives, held a joint press conference condemning the atrocities committed by Hamas and showing Florida's strong support for the people of Israel. During the press conference, President Passidomo and Speaker Renner issued a joint proclamation on behalf of their respective chambers that officially supports

Israel's right to defend itself, condemns the barbaric attacks by Hamas, and demands the immediate end to any direct or indirect financial support directed to Hamas, Hezbollah, and Iran. A copy of this proclamation will be presented to the President of the United States, each member of the Florida delegation to the United States Congress, and the Ambassador of the State of Israel to the United States. Florida has made it clear that we stand proudly with our brothers and sisters in Israel, we recognize their right to exist as a sovereign state, and we support their right to defend themselves from any and all threats.

The Florida Department of Children and Families appeared before the Senate Committee on Children, Families, and Elder Affairs, chaired by Senator Ileana Garcia (R-Miami), to provide a presentation on the new Office of Community Services. The Office of Community Services includes a variety of programs focused on care, prevention, and concentrated services to result in positive long-term outcomes for Florida's most vulnerable children, adults and families. Initiatives include prevention measures relating specifically to human trafficking, domestic violence, continuing care, and homelessness. Through these critical programs Florida continues the effort to increase vital services to support and protect our most vulnerable populations across the state.

Thank you for taking the time to read this letter. As always, it is an honor to be your Senator and we look forward to continue serving our constituents in Lake and West Orange County.

## FAIRTax



Senior citizens as a group fair better under the FAIRtax than under the current income tax.

Although some erroneously believe they pay no taxes if living on Social Security alone, they are still paying the hidden corporate income tax and employer payroll tax imbedded in everything they buy. Under the FAIRtax, those hidden costs are removed. Plus, senior, like ever other citizen or legal resident will receive the prebate at the beginning of each month for taxes paid on the cost of necessities. Since once an item is taxed it is not taxable again, all purchases of used goods are rendered tax free. If a senior wishes to continue working, they are freed from the regressive payroll taxes on their earnings under the FAIRtax and there is no income tax on their Social Security. The income tax imposed on investment income and pension benefits or IRA withdrawals is repealed. An income tax deduction from most pension funds, IRAs and 401(k) was taken for contributions to most of these plans. All beneficiaries and owners of these

plans expected to pay income tax on them upon withdrawal, but are not required to do so under the FAIRtax. Plus any interest on savings you may have acquired is no longer subject to taxation. Seniors have a dramatically higher home ownership rate than other age groups but those who wish to sell their homes face capital gains tax under the current system. Senior also have the comforting knowledge that if they wish to pass their estate on to their heirs, that the heirs will not have to sell all or part of that estate in order to pay the inheritance tax. There is no capital gains tax or inheritance tax under the FAIRtax. The FAIRtax makes the economy much more dynamic and prosperous. Consequently, federal revenues grow which makes it less likely that federal budget pressures require Medicare and Social Security benefit cuts. And, since the FAIRtax requires a certain percentage of all revenues collected to be distributed between these two programs, Medicare and Social Security will be much more stable for years to come. ## Fighting Housing Shortage

Los Angeles implemented a new tax on luxurious real estate to finance affordable housing and combat homelessness

Los Angeles implemented a so-called "mansion tax". At a rate of 4% for real estate purchases between 5 and 10 million dollars and 5.5 percent for properties over ten million dollars. All in all, the tax is expected to bring in about 670 million dollars of revenue. The money is mend to finance affordable housing and thus preventing

people from becoming homeless.

The tax, officially known as "Measure ULA" was agreed upon by the state legislator after a referendum in November 2022 as close to 60% of voters cast their ballot in favour of the proposed law. Los Angeles being the city with the highest number of homeless people in the country, it's little wonder that such a tax comes to fruition. California in general is also known as the second most expensive state when it comes to real estate, only being topped by Hawaii.

Under the new tax, a millionaire selling a house worth 5 million dollars would have to pay 200 thousand dollars to the government. To put the necessity of action in the city of LA into perspective, the recent crises have made the number of homeless people

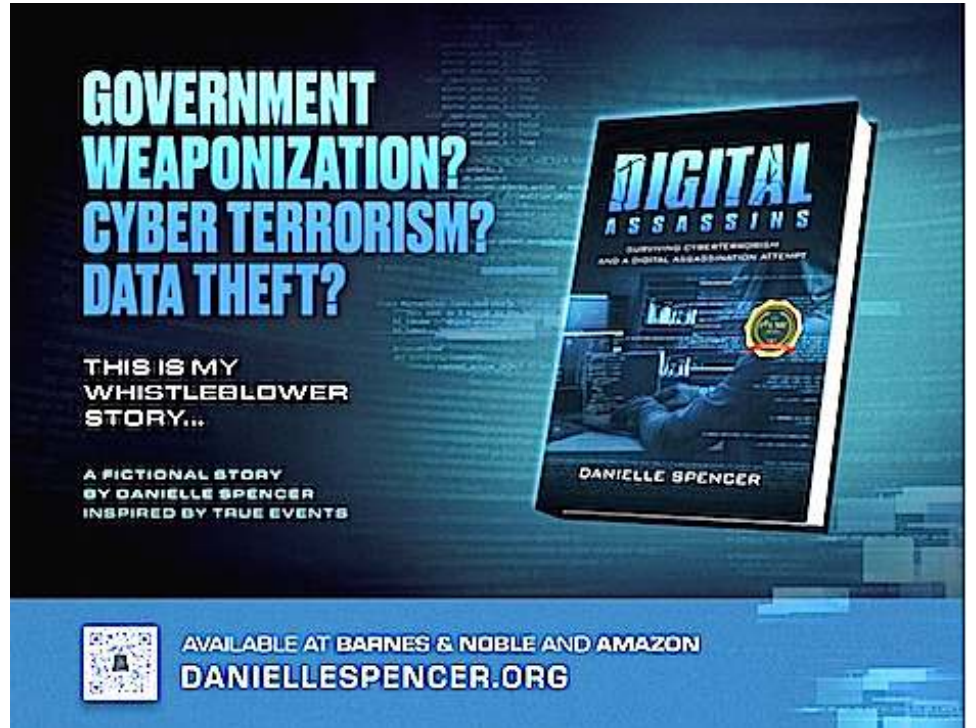
skyrocket to around 42,000 people in February 2022. In 2016 the number was closer to [28,000 people](#) without a home according to an article published in the New York Times.

Other estimates by the "US department of housing and urban development" put the number of homeless people in the LA at a staggering 65.111 people.

Rep. Cammack Joins Colleagues To Support Florida's Request For Federal Fishery Disaster Declaration

GAINESVILLE, FL — Hurricane Idalia severely impacted

Florida's fisheries, a significant contributor to Florida's economy. These small businesses need assistance to recover from this Major Hurricane.

On September 5, 2023, the State of Florida requested the U.S. Department of Commerce to declare a federal fishery resource disaster to support fishery businesses affected by Hurricane Idalia.

Rep. Cammack joined U.S. Senator Marco Rubio (R-FL) and colleagues in sending a letter to U.S. Department of Commerce Secretary Gina Raimondo supporting the State of Florida's request.

“Florida's iconic fisheries are foundational to the economy and way of life of many of the communities that have been devastated by Hurricane Idalia. A timely and robust response by the Department of Commerce, through the declaration of a fishery disaster in support of Florida's fishing industries, is required to help these communities recover.”

To Rein in Biden, Look To Florida's Example

President Joe Biden's regulatory assault on American families is easily the worst in American history.

It's driving up grocery prices, utility bills, and the cost of everyday life, leaving people paying a lot more while getting a lot less. If Republicans truly want to fight back, they should look to the states for

inspiration—especially our home state of Florida. The Sunshine State is rolling back red tape at a record pace, thanks in large part to a unique policy that empowers lawmakers to block new mandates. Republicans in Congress should rally around a similar law to stop President Biden's rule by administrative fiat.

Compare what's happening in D.C. to what's happening in Florida.

At the federal level, President Biden proposed and enacted new regulations costing a staggering \$201 billion in his first year alone. That's more than three times the burden imposed by President Barack Obama over the same timespan, and 40 times that of President Donald Trump.

In his second year in office, President Biden shows no signs of slowing down. He's dictating everything from the cars we can drive to the lightbulbs we can buy. If anything, the president's spree of red tape is only going to grow, especially if Republicans retake Congress this November. He'll use what President Obama famously called his "pen and phone" in ways no chief executive ever has before.

Compare that with what's happening in Florida.

The Sunshine State proposed the lowest number of regulations in modern history last year, according to new research from the Foundation for Government Accountability. It follows years of regulatory repeal and relief by governors and lawmakers alike.

This sustained progress puts Florida well ahead of its competition. California now has more than twice as many regulatory restrictions. New York has about 75% more, and Illinois 65% more. Even Texas has a larger regulatory burden than Florida.

The chasm between these states is set to grow even deeper. The overall number of regulatory restrictions is still falling in Florida; it's growing in nearly every other state.

Why is Florida cutting red tape so quickly and effectively? One of the biggest reasons is a 2010 law, passed over then-Gov. Charlie Crist's veto, that says the state legislature must approve all rules that cost \$1 million or more over five years. If lawmakers don't affirmatively approve such a regulation, it doesn't go into effect. This policy ensures that the people's representatives have a say on new mandates.

Unsurprisingly, lawmakers have stopped new mandates that would jack up costs on Florida families. That includes stopping a proposed rule this year from the agriculture commissioner to ban styrofoam in grocery stores, saving families from higher costs.

Florida's policy is the definition of common sense—but the federal government takes the opposite, and nonsensical, approach. President Biden can force Americans to pay hundreds of billions of dollars in higher regulatory costs because there's no real check on his administration's ability to propose new rules. Congress gets no say in the matter, even though the Constitution invests the House and the Senate with sole lawmaking power. Lawmakers are bystanders when they should be referees.

At the start of the current Congress, one of us (Rep. Cammack) introduced a federal version of Florida's law. It's called the REINS Act and it requires the House and Senate to vote on all federal regulations that impose at least \$100 million in costs annually. This policy would have given Congress the chance to stop a significant portion of President Biden's regulatory spree; it would have put Democrats in the tough spot of voting for mandates that make prices higher and life more painful for working families.

But the current REINS Act wouldn't

necessarily have stopped all the president's use and abuse of the federal bureaucracy. Like Obama before him, President Biden has also relied on executive orders and agency "guidance," including the recent 25% boost to food stamp payments. This approach has the de facto effect of regulation absent formality, meaning Congress couldn't always vote to stop it.

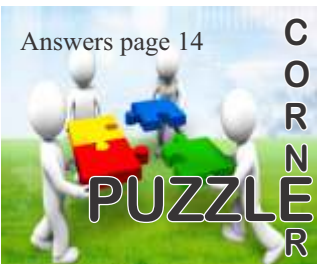
We're therefore partnering to introduce an expanded version of the REINS Act to close this loophole. If this policy is enacted, Congress will be required to vote on essentially every major action coming out of the executive branch. By stopping new mandates like President Biden's, lawmakers could save Americans untold billions of dollars, and even help tame runaway inflation in the process. Most important, it will put citizens back in the position of holding accountable their duly elected representatives—not unelected bureaucrats.

Florida proves this policy works. The state's economy is booming, with new residents moving here every 50 seconds and 1,800 new start-ups setting up shop every day. The state's light touch on red tape, driven by the governor's and lawmakers' willingness to stop costly new rules, is undoubtedly contributing to the Sunshine State's ever-brightening outlook. Republicans in Congress should fight to bring that approach of accountability and affordability to Washington, D.C.

## Attorney General Moody Encourages Floridians To Remain Vigilant During National Preparedness Month

TALLAHASSEE, Fla.—This National

Preparedness Month, Attorney General Ashley Moody is urging Floridians to remain vigilant. National Preparedness Month raises awareness about the importance of preparing for disasters and emergencies that could happen at any time. September also marks the peak of hurricane season. Currently, there are multiple tropical systems in the Atlantic Ocean, including Hurricane Lee. Florida just endured the effects of Hurricane Idalia late last month and recovery efforts will be ongoing for the foreseeable future. To help Floridians solidify storm-readiness plans, Attorney General Moody is highlighting the 2023 Hurricane Preparedness Guide.

Attorney General Ashley Moody said, "In emergency situations, proper preparations can make all the difference. As we recognize National Preparedness Month, move through the peak of hurricane season, and see heavy storm activity in the Atlantic, I encourage all Floridians to take another look at our 2023 Hurricane Preparedness Guide to solidify storm preparations."

The Atlantic Hurricane season peaks between mid-August and mid-October. Hurricane Lee and Hurricane Margot are both strong storms currently moving through the Atlantic Ocean, and thankfully not forecasted to reach Florida. However, Floridians should still be prepared. On Aug. 30, Hurricane Idalia hit Florida's Big Bend region, and residents are still recovering from the storm that caused [billions of dollars](#) in damage.

Below is a graph from the National Oceanic and Atmospheric Administration showing hurricane and tropical storm activity from 1944 to 2020.

Preparedness tips provided in the guide include:

- Know evacuation routes and shelter locations;
- Stock up on enough food, water and emergency supplies for the entire household for at least seven days or more;
- Check that storm-related products are hurricane-proof or impact-proof before purchasing;
- Research recovery charities before donating;
- Beware of unsolicited contractors and extremely low or high prices for quotes; and
- Report price gouging during a state of emergency, including online or on the free No Scam app.

Floridians can stay informed about serious storm events using the Florida Division of Emergency Management's website, [FloridaDisaster.org](#). Floridians can monitor a storm's progression and the latest weather alerts using the NOAA's Hurricane Center by visiting [NHC.NOAA.gov](#).

In the event of an incoming tropical storm or hurricane, Floridians should look for further guidance from local officials and emergency managers.

## AG MOODY AND FLORIDA CRIME STOPPERS TEAM UP WITH FORMER HOST OF AMERICA'S MOST WANTED FOR STATEWIDE CRIME-FIGHTING INITIATIVE

TALLAHASSEE, Fla.—Attorney General Ashley Moody and the Florida Association of Crime Stoppers are teaming up with John Walsh from "America's Most Wanted" and "In Pursuit with John Walsh" to fight crime. At the Palm Beach County Sheriff's Office today, Attorney General Moody, Walsh and Crime Stoppers announced a new partnership to encourage Floridians to use \*\*TIPS, the state's anonymous crime tip reporting line. The crime-fighting trio are encouraging Floridians to be proactive in helping law enforcement solve cases by reporting information related to crimes. Over the past three years, PBCS received more than 2,000 tips from Crime Stoppers, with more than 400 tips leading to an arrest.

Attorney General Ashley Moody said, "John Walsh has been the relentless force behind America's Most Wanted and the National Center for Missing and Exploited Children—I am excited that he is helping us recruit Floridians to join our fight against crime. Through this new partnership with Florida Crime Stoppers, we will be spreading the word about \*\*TIPS and encouraging Floridians to anonymously report information to help law enforcement solve crimes."

John Walsh said, "I have dedicated my career to locating missing children and fighting crime. The \*\*TIPS tipline will give Florida law enforcement an advantage over criminals in hard-to-crack cases. Solving a case can be a miracle for a family and help make communities safer. I praise Attorney General Moody for her efforts in supporting law enforcement and encouraging Floridians to actively help officers stop crime."

President of the Florida Association of Crime Stoppers, Frank Brunner said, "Our statewide network of 27 Crime Stoppers chapters throughout Florida is excited about John Walsh joining our team of crime fighters. This new partnership, along with our current partner, the Attorney General's Office, will encourage public engagement and help increase awareness on how people can anonymously share their critical information and assist law enforcement with making our state a stronger, safer place."

Attorney General Moody, FACS and Walsh are releasing a video message for Floridians to assist law enforcement in making their communities safer. The informational video highlights the \*\*TIPS tipline—a number anyone in the state can call from a cell phone to reach the nearest Crime Stoppers office. Individuals can submit information on crimes and remain anonymous. If the tip leads to an arrest, the

caller may receive a cash reward.

Attorney General Moody and FACS first launched [\\*\\*TIPS](#) in October 2020. Before the tipline's creation, Floridians needed to look up the specific region's Crime Stoppers number to report a crime—there are 27 different offices each with separate phone numbers. Now, by simply dialing the six-key tipline on a cellphone, citizens are automatically rerouted to the nearest regional Crime Stoppers office.

In February 2022, [Crime Stoppers USA](#) adopted the phone number for nationwide use. Now, anyone in the United States can report crime anonymously with this easy-to-remember number and possibly collect a reward for tips that lead to an arrest.

In 2021, Attorney General Moody and FACS announced a [near-doubling](#) of award money for anonymous tips in murder cases that lead to an arrest. The increase takes the maximum allowable award amount from \$5,000 to \$9,500 for tips provided to FACS.

John Walsh is known internationally as a crime fighter, victims' advocate and host of "America's Most Wanted," the reality program that helped law enforcement capture fugitives. Walsh currently hosts "In Pursuit with John Walsh," and co-founded the National Center for Missing and Exploited Children that helped bring home more than 50 missing children. Over the past three [decades](#), through "America's Most Wanted, Walsh helped bring to justice more than 1,200 fugitives—including 17 people off of the FBI's Most Wanted list.

## AG MOODY UNCOVERS BIDEN'S SECRET PLAN FOR MASS-RELEASE QUOTAS FOR MIGRANTS STOPPED AT THE SW BORDER AMID IMMIGRATION SURGE

TALLAHASSEE, Fla.—Attorney General Ashley Moody continues to uncover evidence of the Biden administration's intentional destruction of the nation's border with Mexico. Recently-obtained U.S. Border Patrol emails outline new proposed "bookout targets" for field chiefs and deputies to "bring in-custody numbers to manageable levels."

U.S. Customs and Border Protection's Acting Deputy Chief emailed the new targets on Aug. 8, following a field leadership call to discuss "in-custody numbers." During the call, CBP leaders revealed that "the rate of daily encounters continues to surpass the daily permanent bookouts and the in-custody numbers

continue to rise."

Attorney General Ashley Moody said, "Biden and Mayorkas have become so brazen that they are now implementing mass-release quotas for immigrants surging into our country. As a federal judge already recognized, these releases are unlawful, yet the Biden administration is ordering Border Patrol to release even more immigrants into the interior. This latest email is further proof of the disastrous cycle created by Biden's intentional destruction of our border with Mexico. Biden cuts resources, opens the border, and then releases detainees while claiming there is not enough detention capacity to prevent the unprecedented flood of migrants entering the country because of his terrible policies. With every passing day it is becoming more obvious that the border crisis is being intentionally orchestrated by the Biden administration. We will continue to do everything in our power to push back and let the American people know of Biden's devious plan."

While the email Attorney General Moody obtained from CBP references new "daily bookout targets," the actual release quotas were redacted for unexplained reasons.

According to reports, CBP is currently detaining nearly 20,000 migrants with agents [reporting nearly 6,000](#) new encounters daily.

Since President Biden took office:

- [More than 6 million](#)
- migrants have surged across the border;
- [More than 50,000](#)
- pounds of fentanyl has been seized, enough to kill the U.S. population more than 35 times over; and
- [259 people](#)
- on the terrorist watch list have been identified, including 146 so far in fiscal year 2023.

With the current surge and mass-release policies in place, states as far north as New York and Massachusetts are feeling the effects. [Massachusetts is under a state of emergency](#) while struggling to house an influx of illegal immigrants.

Florida beat the Biden administration in federal court earlier this year, obtaining a ruling that called the current border "[little more than a speed bump](#)," a ruling affirming what Attorney General Moody has been saying for years, that Biden's immigration policies are unlawful.

Last month, [a federal trial](#) in Texas began, challenging Biden's Humanitarian Parole Policy allowing 30,000 immigrants from select countries automatic access into the U.S. every month. Florida is a party to the case.

### Governor DeSantis Hosts Discussion About COVID Boosters with State Surgeon General and Health Experts

**TALLAHASSEE, Fla.** — Governor Ron DeSantis held a discussion with State Surgeon General Dr. Joseph Ladapo and public health experts about the recently federally approved COVID-19 mRNA boosters. While there, the Surgeon General announced new COVID-19 booster guidance advising against the use of COVID boosters for individuals under the age of 65. This recommendation was based on the fact that the newly FDA approved COVID boosters lack a human clinical trial and evidence of benefit or efficacy. The federal government has spent more than \$30 billion on COVID-19 vaccines, including boosters, which have shown little to no benefit to prevent COVID-19 infection.

“I will not stand by and let the FDA and CDC use healthy Floridians as guinea pigs for new booster shots that have not been proven to be safe or effective,” **said Governor Ron DeSantis.** “Once again, Florida is the first state in the nation to stand up and provide guidance based on truth, not Washington edicts.”

“Once again, the federal government is failing Americans by refusing to be honest about the risks and not providing sufficient

clinical evidence when it comes to these COVID-19 mRNA shots, especially with how widespread immunity is now,” **said State Surgeon General Dr. Joseph Ladapo.** “In Florida, we will always use common sense and protect the rights and liberties of Floridians, including the right to accurate information.”

Today's announcement builds on actions taken by the DeSantis administration to push back on the FDA and CDC's rushed approval and mandates of COVID vaccines since 2020, even when the evidence doesn't line up

## The Fight Against Polio



(NAPSI)—When it comes to combating polio, there's good news, bad news and better news.

**The good news** is that efforts to eradicate the dreaded disease have been going on for decades. Back in the disease's peak years in the 1940s and 50s, it affected between 13,000 and 20,000 people in the United States each year, many of them children. Thousands died. Many others were permanently paralyzed. Then Jonas Salk and Albert Sabin developed vaccines and the number of cases dropped. As of August 30, 2023, only seven cases of “wild polio virus” (two in Pakistan, five in Afghanistan) have been detected in 2023.

**The bad news** is that even one case of

polio is one too many, and while cases of polio have fallen over 99% worldwide since 1988, a variant of the polio virus is causing outbreaks and consuming critical resources needed to stop the transmission of wild poliovirus. What's more, the COVID-19 pandemic disrupted efforts to combat vaccine-preventable diseases, including polio.

**The better news** is we know how to eradicate polio. Vaccines are highly effective, and the more people who are vaccinated, the less the virus can spread.

### What's Being Done

The Global Polio Eradication Initiative developed tailored strategies to end polio. It offers multi-vaccine campaigns with polio and other vaccines, and increased environmental surveillance sites to quickly detect the virus.

Also, Rotary and its partners are using a new vaccine, nOPV2, to address outbreaks of the variant poliovirus. Millions of doses have been administered.

### Who Is Helping

Polio eradication is the flagship priority of Rotary, a global humanitarian organization with more than a million members around the world. These men and women are business, professional, and community leaders with a shared commitment to making the world a better place.

The organization had the audacity to take on a global effort to protect children everywhere from disability and death due to polio and the tenacity to finish the job and keep its promise to children everywhere.

### What You Can Do

You can be part of the effort to end polio in four ways:

1. **Donate** to the End Polio Now Campaign. Donations will be matched 2:1, up to U.S. \$50 million by the Bill & Melinda Gates Foundation.

2. **Contact** government leaders and encourage them to prioritize financial and political support for polio eradication.

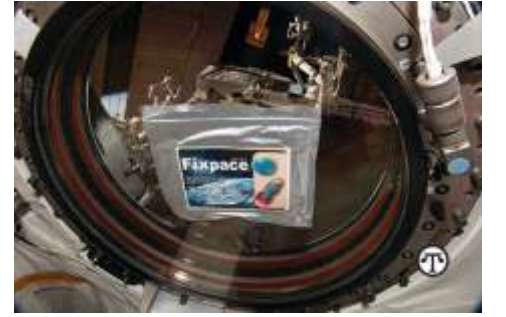

## Give Thanks With A Traditional Meal

### Apple Cider Brined Turkey

#### INGREDIENTS FOR THE BRINE

2 qt. apple cider  
6 c. water  
1 c. kosher salt  
1/4 c. packed brown sugar  
4 cinnamon sticks  
3 sprigs fresh rosemary  
1 orange, quartered  
1 tsp. whole cloves  
1 tsp. whole peppercorns  
1 (8-lb.) whole turkey, giblets removed

#### FOR ROASTING

1 red onion, cut into large wedges  
1 apple, quartered  
1 head garlic, halved  
Kosher salt  
Freshly ground black pepper  
6 tbsp. butter, melted

#### INSTRUCTIONS

The night before you plan to cook your turkey, make brine. In a large pot over medium heat, bring all of the brine ingredients except turkey to a boil and let boil until sugar and salt are dissolved. Remove from heat and let cool to room temperature.

Place turkey in a brine bag or in a stock pot big enough to hold your turkey and pour brine over turkey, making sure it's completely covered. Refrigerate overnight. Preheat oven to 400°. Remove turkey from



brine and pat dry with paper towels. Stuff cavity with red onion, apple, and garlic. Season bird all over with salt and pepper and brush with melted butter. Tie legs together with kitchen twine.

Place turkey on a roasting rack over a large roasting pan. Roast until golden and thickest part of thigh reads 165°, 1 hour 30 minutes to 2 hours.

Let cool 15 minutes before slicing.

kosher salt and freshly cracked black pepper to taste

#### INSTRUCTIONS

Peel and dice potatoes, making sure all are in about 1 inch cubes.

Place in a large pot and cover with water. Bring to a boil over medium-high heat and then reduce heat to medium low to maintain a rolling boil. Cook until potatoes are fork tender and you can easily pierce them with a fork when touched.

Remove the potatoes from the heat and drain off the water. Place the diced potatoes through a ricer and then place back into the warm pot. Alternatively, if you don't have a ricer, mash the potatoes with a masher and place back into the warm pot

Add the cream, butter, Parmesan, mascarpone and garlic and stir to incorporate. Season with salt and pepper and fold in the chopped chives before serving.
