Lady Lake Unveils 'Children's Choice' Pyramid Park Playground

LADY LAKE – Lady Lake's Pyramid Park will soon receive an exciting makeover with the addition of new playground equipment.

Earlier this year, the Lady Lake Parks and Recreation Department outreached to area children to gather their input in choosing between two new playground options. Through votes taken at The Villages Elementary of Lady Lake, the Lady Lake Library and via the Town's Facebook page, a majority of children opted for Design Option 1.

The chosen playground structure, in vibrant red, blue and yellow hues, includes several slides, a spinner, a rope climber, and various decks and platforms. It is

specifically geared toward kids aged 5-12 with a focus on safety.

With approval from the Town Commission, and at a cost of approximately \$270,000, the playground will be paid for through impact fees. The structure will be built by BCI Burke, a company based in Fond Du Lac, Wisconsin.

The new structure will replace aging equipment that was removed earlier this year and will complement existing equipment that children have come to love.

When the installation begins, the entire playground area will be closed for two weeks to ensure the safety of our community. Residents will be notified via Facebook, the Town website, and signage.

“Dog Gone It: This is Even Better Than Stretching

What sets pandiculation apart is its motor sensory component. The process entails contracting muscles, lengthening them, and finally relaxing them, thereby stimulating a feedback loop among nerves, the spinal cord, and the brain. These movements, collectively known as the Magnificent 7, encompass all activities and profoundly impact independence and quality of life as we age.

Here's an example of pandiculation intertwined with a foundational movement pattern. If you're experiencing pain or have any medical concerns, please refrain from attempting this exercise:

- Stand upright.
- Hinge at the hips and reach forward, extending your arms as if pushing against a wall.
- Hold for 10 seconds.
- Release the position and stand tall, extending your spine and hips, and reaching toward the floor with your arms.
- Hold for 10 seconds, then release.
- Stand naturally and relax for 10 seconds.

Pandiculation can be applied to all muscles and joints; just be creative and remember the three steps: contract, lengthen, and relax, within the framework of the Magnificent 7.

Take a cue from our furry companions and incorporate pandiculation into your routine after periods of inactivity. Consider this: when was the last time your dog or cat suffered from a sore back or pulled hamstring? Pandiculation might just be the “purrrfect” addition to your health and wellness regimen.”

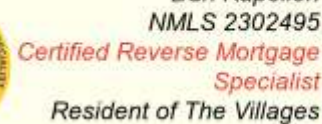

In the last few days, Governor DeSantis signed the following education bills into law:

HB 931 establishes a statewide school chaplain program,

which:

- Authorizes school districts and charter schools to allow volunteer chaplains to be on school campuses and provide additional counseling support to students.
- Chaplains will be assigned by the district school board or charter school governing board.
- A student may only receive support offered by school chaplains with written parental consent.

HB 1317 authorizes districts to allow civic and patriotic organizations to visit schools to encourage student participation and involvement. These organizations include:

- Big Brothers Big Sisters of America
- The Boy Scouts of America
- The Boys & Girls Clubs of America
- The Civil Air Patrol
- Future Farmers of America
- The Girl Scouts of the United States of America
- Little League Baseball
- The Marine Corps League
- The Navy Seal Cadet Corps

S B 1 2 6 4 ,
which does the
following:

- Adds to existing Communist history standards with instruction on the history of Communism in the United States and the tactics of Communist movements.
- Authorizes the newly-established Institute for Freedom in the Americas at Miami Dade College to promote the importance of economic and individual freedoms as a means to advance human progress—specifically in Latin America and the Caribbean.
- This institute will partner with the Adam Smith Center for Economic Freedom at Florida International University.
- Enables the Florida Department of State, in collaboration with the Florida Department of Education, to recommend to the Legislature the creation of a Florida-based museum on the history of Communism.
- Prepares students to withstand indoctrination on Communism at colleges and universities.

* Most Americans believe we don't have enough freedom but over 50% of the elite and 70% of the politically involved elite say we have too much freedom.

- * 70% of the elite trust government to do the right thing and believe we would all be better off if they were in charge of making decisions for the rest of us. What does the elite 1% control?
- * Most of the important positions in the current and prior administrations.
- * Most think tanks - both conservative

and liberal ones.

- * Most policy groups in D.C.

What is it that the elite 1% don't want?

- * The other 99% to control how much federal taxes they pay.
- * To lose the I.R.S. as a way to intimidate and control the other 99%.
- * To lose the ability to reward their friends and punish their enemies using the tax code.
- * To lose the ability to use the tax code to coerce people into acting against their own best interests in order to achieve an outcome that is beneficial to them. The elite 1% in D.C. is ignoring the one real solution that allows us to remain citizens and not subjects the FAIRtax.

- * eliminates income tax and payroll taxes
- * eliminates the I.R.S.
- * eliminates tax lobbyists selling tax benefits to special interest groups
- * eliminates any federal tax on spending

Cammack, Magaziner, Malliotakis, Panetta Alleviating Barriers For Caregivers Act (ABC Act)

WASHINGTON, D.C. — Today, Congresswoman Kat Cammack (R-FL-03), Congressman Seth Magaziner (D-RI-02), Congresswoman Nicole Malliotakis (R-NY-11), and Congressman Jimmy Panetta (D-CA-19) introduced the Alleviating Barriers for Caregivers Act (ABC Act).

The ABC Act would help reduce red tape for family caregivers at the Centers for Medicare and Medicaid Services (CMS) and Social Security Administration (SSA) by requiring the agencies to review the eligibility determination and application processes, procedures, forms, and communications of Medicare, Medicaid, Social Security programs, and the Children's Health Insurance Program (CHIP) to reduce administrative challenges for caregivers. It requires a report on the findings and remedy plan back to Congress within a year of the bill's enactment to streamline the policies and procedures.

"America's family caregivers work around-the-clock to provide essential care for their loved ones, and over half—56 percent—act as advocates on behalf of their family members. The last thing these caregivers need is more red tape that distracts from their support for those in their care," **said Rep. Kat Cammack**. "I'm honored to introduce this bipartisan and bicameral ABC Act with my colleagues to lower the burden around the important medical decisions caregivers must make every day. Together we can support the 48 million caregivers that make up a critical part of our health care landscape in the U.S."

"Family caregivers work around the clock

to support their loved ones—often balancing their jobs and family responsibilities at the same time—and Congress must do our part to make their lives easier," **said Rep. Seth Magaziner**. "That's why I'm proud to co-lead the ABC Act, a bicameral, bipartisan bill that will cut through bureaucratic red tape to provide caregivers with the support they deserve."

"There are over 48 million family caregivers in the United States who provide essential services so their loved ones can continue to lead an independent lifestyle," **said Rep. Nicole Malliotakis**. "I'm proud to join a bipartisan and bicameral group in introducing the ABC Act to streamline policies and alleviate administrative barriers so our caregivers can spend less time on stressful paperwork, and more time caring for patients in need."

"Family caregivers face daily and numerous challenges when it comes to their many important responsibilities to help provide for the health and wellbeing of care recipients," **said Rep. Jimmy Panetta**. "By streamlining the overly burdensome and bureaucratic process, the bipartisan bicameral Alleviating Barriers for Caregivers Act would allow family caregivers to focus more on people rather than paperwork. This legislation would help ensure that the federal government is a partner, not an obstacle, for the over 48 million family caregivers around the country."

"Family caregivers are the backbone of our nation's long-term care system, and they are overwhelmed managing their loved one's care," **said Executive Vice President and Chief Advocacy and Engagement Officer Nancy LeaMond**. "The Alleviating Barriers for Caregivers Act could help reduce the stress family caregivers experience by making it easier to navigate resources, eligibility, benefits, and health systems when providing care. AARP thanks

Representatives Cammack, Magaziner, Malliotakis, and Panetta for their dedication to family caregivers and urges Congress to swiftly pass this important bipartisan, bicameral legislation."

The bill's Senate companion, S. 3109, was introduced by Senators Shelley Moore Capito (R-WV) and Ed Markey (D-MA).

The bill has been endorsed by dozens of organizations, including AARP, the ALS Association, the Alzheimer's Association, the American Heart Association, Autism Speaks, the Family Caregiver Alliance, the Home Care Association of America, the National Alliance for Caregiving, and many more.

Rep. Cammack Joins Rep. Donalds In Bipartisan Initiative To Protect Big Cypress National Preserve From Destructive Biden Admin. Meddling

WASHINGTON, D.C. — Rep. Cammack joined Rep. Byron Donalds (FL-19) in a bipartisan letter alongside Representatives Mario Díaz-Balart, Scott Franklin, and 14 additional colleagues from across the Sunshine State in demanding that the Biden administration does not proceed with any proposed wilderness designation at Big Cypress National Preserve.

Federally-designated wilderness areas are defined as areas "where the earth and its community of life are untrammelled by man, where man himself is a visitor and does not remain." Any wilderness designation of Big Cypress by Biden administration officials would not only restrict the free movement of the local Miccosukee and Seminole Tribes, but it would supercharge the spread of invasive species, destroy local small businesses, and restrict wildfire response capabilities.

"Big Cypress National Preserve is an iconic fixture of our Southwest Florida community that must be protected from debilitating federal overreach," said Rep. Donalds (R-FL). "I proudly stand with my constituents, local stakeholders, and environmental officials from across the Sunshine State in demanding that the Biden administration does not proceed with any wilderness

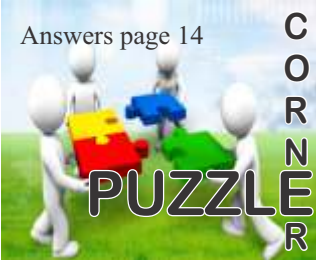
designation of the preserve. It is imperative that we block this disastrous and completely unnecessary potential action by out-of-touch bureaucrats in Washington."

"As we approach the 50th Anniversary of the Big Cypress National Preserve, it is crucial to continue protecting this outstanding natural and sacred land for future generations," said Rep. Díaz-Balart (R-FL). "As the first-ever National Preserve in the National Park Service, this land stands as one of the most ecologically diverse areas of our country. Any proposed wilderness designation by the Biden Administration would pose significant threats to the sacred cultural sites of the Miccosukee Tribe and Seminole Tribe, and way of life enjoyed by the Tribes, constituents and tourists who visit America's first Preserve for camping, fishing, and hunting. As the Member of Congress representing a majority of the Preserve, I remain steadfast in my commitment to safeguarding its future."

"In Florida, we know no one is better at preserving our state's natural beauty than the locals who have lived with and alongside the land for generations," said Rep. Franklin (R-FL). "If the Biden Administration finalizes this determination, it will be in vehement opposition to the will of our state's agencies, Tribal Nations and the affected counties in my district. I thank my Florida colleagues for joining the effort to stop this overreach from the federal government."

"I'm glad to join Rep. Donalds and my Florida colleagues in opposing a wilderness designation for Big Cypress National Preserve," said Rep. Cammack (R-FL). "The wilderness designation will restrict access for the Seminole and Miccosukee tribes which rely on this area for cultural, ceremonial, and burial significance, along with hunters and fishermen who work to manage invasive species..."

This week was a long one—and it's still not over! The House will

be in session through tomorrow to consider several important pieces of legislation. I spoke about what's been happening today on the House Floor in a Facebook Live here.

It was a busy week in the Energy & Commerce Committee as we reviewed several pieces of legislation that deal with protecting you and your privacy online. I also introduced a bipartisan piece of legislation called the Alleviating Barriers for Caregivers Act (ABC Act). ATTORNEY GENERAL MOODY FILES CRIMINAL CHARGES AGAINST VIOLENT RETAIL THIEVES

TALLAHASSEE, Fla.—Attorney General Ashley Moody is filing criminal charges against two violent organized retail thieves. Raheem Davis Jr. and co-defendant

Vayshoun Harris are facing charges for multiple robberies at Home Depot stores across five different counties that involved physical violence against store employees.

Attorney General Ashley Moody said, "These two criminals committed multiple robberies at Home Depot stores across five counties, violently assaulting employees in the process. In one incident, a defendant even pepper sprayed a cashier in the face. We do not stand for organized retail theft in this state, especially theft that involves violence—I proudly stood with Gov. DeSantis recently as he signed a new law strengthening our statutes against crimes just like these. We will continue to hold these thieves accountable."

According to the investigation, Davis and Harris traveled to various Home Depots throughout the state, filled up shopping carts and tried to check out in the store's outdoor garden center. The defendants then tried to pay for merchandise, more than \$1,000 each time, with counterfeit bills. When the clerks realized the counterfeit money, Davis entered the store employee-only area and pushed buttons on the register screen in an attempt to open the cash drawer. Davis assaulted store employees who tried to resist. In one incident, Davis pepper sprayed a clerk in the face. Harris served as a lookout or took the cart full of stolen merchandise to the duo's vehicle while Davis struggled with store employees.

ATTORNEY GENERAL MOODY LEADS MULTISTATE LEGAL ACTION DEMANDING THE EPA RESCIND "ENVIRONMENTAL JUSTICE" INITIATIVES HARMING STATES

TALLAHASSEE, Fla.—Attorney General Ashley Moody today led a 23-state coalition in filing a legal action demanding that Biden's Environmental Protection Agency modify its Title VI regulations. These regulations—known as "disparate impact" regulations—are what the EPA is using to advance much of its race conscious "environmental justice" initiatives.

Attorney General Ashley Moody said, "The EPA should be focusing on enforcing the environmental laws passed by Congress, not so called 'environmental justice,' which is a euphemism for Biden's extreme agenda. His radical exploitation of Title VI, if followed, would force states to unconstitutionally discriminate against their own citizens. The EPA should grant our Petition and revise its Title VI regulations."

Title VI of the Civil Rights Act of 1964 was established to prevent any person in the United States from being excluded from any program receiving federal funding on the grounds of race, color or national origin. Since Biden has taken office, "the EPA has taken unprecedented steps to use the EPA's Title VI regulations to advance what it calls 'environmental justice'...In practice, 'environmental justice' asks the States to engage in racial engineering in deciding whether to, for example, issue environmental permits, rather than relying on the effect on the environment and other appropriate factors."

In a Petition for Rulemaking, Attorney General Moody and the coalition go on to state that the U.S. Supreme Court has

indicated that the EPA's regulations are unlawful: "Although Sandoval did not directly address the validity of Title VI disparate impact regulations, the Court expressed significant skepticism on the validity of those regulations. The Court explained that the regulations were "in considerable tension with the rule...that forbids only intentional discrimination." Additionally, the attorneys general claim that "other scholars have even suggested that the EPA's regulations violate the Equal Protection Clause". Notably, in 2020, the Trump administration proposed a revision to the Department of Justice's similar Title VI regulations to remove disparate impact provisions. The Biden administration withdrew the proposal shortly after taking office.

The attorneys general conclude by stating: "By imposing disparate impact liability where it is not called for by statute, the EPA's regulations gravely depart from the original understanding of Title VI and compel States to unconstitutionally discriminate against their citizens by incorporating disparate-impact liability. EPA should grant this Petition and revise its Title VI regulations to be consistent with Title VI and the Equal Protection Clause."

Attorney General Moody is joined on the petition by the attorneys general of Alabama, Arkansas, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Mississippi, Missouri, Montana, Nebraska, North Dakota, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, and Wyoming.

ATTORNEY GENERAL MOODY ADDRESSES LAW ENFORCEMENT OFFICERS AT STATE CAPITOL DURING 2024 TORCH RUN

TALLAHASSEE, Fla.—Attorney General Ashley Moody today addressed law enforcement officers and Special Olympics athletes at the Florida Capitol during the 2024 Law Enforcement Torch Run, benefiting Special Olympics Florida. State and local law enforcement officers participated in a two-mile run this morning in Tallahassee up to the Capitol. The Law Enforcement Torch Run is the largest annual public relations and fundraising event for Special Olympics Florida, with thousands of law enforcement officers and Special Olympics athletes running hundreds of miles throughout the state.

Attorney General Ashley Moody said, "Law enforcement officers are always giving back to the community, and the 2024 Law Enforcement Torch Run is just another example of their commitment to serving others. Stroke Prevention Tips for Black Men

- Know your blood pressure numbers. Blood pressure is measured using two numbers. The first number, your systolic blood pressure, measures the pressure in your arteries when your heart beats. The

Governor Ron DeSantis Announces More Than 200 Americans Have Been Rescued by the State of Florida from Haiti

TALLAHASSEE, Fla.— Governor Ron DeSantis announced that the number of Americans rescued from political turmoil in Haiti by the State of Florida **now exceeds 200 individuals**. Since the Florida Division of Emergency Management's first state coordinated rescue flight on March 20, a total of **220 Americans** have been successfully evacuated from Haiti to Florida. The evacuations have been executed by the Florida Division of

Emergency Management (the Division). “When Floridians and other Americans are in need, the State of Florida acts,” said **Governor Ron DeSantis**. “I'm pleased to announce that we've been able to successfully rescue more than 200 Floridians and other Americans from Haiti. Even when the federal government fails to act, Florida will always step up.”

“Being able to support our residents in this time of crisis is because of Governor DeSantis' leadership and the collaboration between our state agencies and private and nonprofit partners,” said **Division Executive Director Kevin Guthrie**. “I am proud of the State Emergency Response Team for working around the clock to coordinate these emergency flights and get Floridians home safely.”

Of the Americans the Division has evacuated from Haiti, 95 percent are Floridians. Upon return to Florida, evacuees have immediate access to a multi-agency resource center, and then the Division gets them all the way back to their doorstep. The evacuations are provided at no cost to those who are rescued. To date, the resource center has dispensed more than 350 resources to residents returning home from Haiti, including:

- Meals and water
 - Lodging
 - Transportation home from the airport
 - Basic health and medical screenings
 - Care supplies for infants, toddlers, seniors, and pets
 - A family reunification center
 - Hope navigators, mental health counselors, and therapy dogs
 - A children's activity center
 - Phones, SIM cards, and charging stations
 - ID replacements through a mobile Florida License on Wheels (FLOW) center
- In addition to ensuring Floridians are returned all the way to their homes, the Division also provided the U.S. Department of State with Florida's completed Haiti Assistance forms, so other Americans could be connected with a federally coordinated flight home.

- second number, your diastolic blood pressure, measures the pressure in your arteries when your heart rests between beats. If the measurement reads 120 systolic and 80 diastolic, you would say, "120 over 80," or write, "120/80 mm Hg."
- Normal Blood Pressure for Most Adults - Less than 120/80 mm Hg
 - High Blood Pressure - 130 or higher/80 or higher mm Hg
 - Stay informed. Discuss high blood pressure with your healthcare provider. Talk to your healthcare provider about your risks and ways to manage your blood pressure to help prevent stroke and dementia.
 - Take your medications. Your healthcare provider may recommend taking medicine daily to prevent stroke and heart attack, especially if you have high blood pressure.
 - Quit smoking or using tobacco. Smoking harms nearly every organ in the body, including the heart. Any amount of smoking damages the heart and blood vessels.
 - Manage your cholesterol levels. Reducing your cholesterol will lower your risk of developing a wide variety of serious health issues, including stroke and heart disease.
 - Eat healthy foods and exercise. Choose plenty of fresh fruits and vegetables. Get about 30 minutes of moderate to intense exercise, such as brisk walking or bicycling, every day. Following a healthy

eating plan and keeping physically active will significantly lower your risk for heart disease, high blood pressure, and other chronic and debilitating health problems.

- Manage your diabetes. Having diabetes or pre-diabetes puts you at increased risk of stroke and heart disease. You can lower your risk by keeping your blood glucose (also called blood sugar), blood pressure, and blood cholesterol close to the recommended target numbers provided by your healthcare provider.
- Get enough sleep. Getting a good night's sleep is important for good heart and brain health. Adults should aim for an average of 7 to 9 hours, and babies and kids need more depending on their age.
- Start early. Preventing stroke and heart disease is more effective if started in midlife. Studies also find that controlling blood pressure may reduce the risk of dementia.

These simple and effective lifestyle changes can reduce your chance of all types of stroke, heart disease, and dementia later in life. Taking charge of your health now can help avoid unnecessary risks and keep blood pressure under control.

No Bake Brownie Bites

Ingredients

- 1/2 cup pecans
- 1 cup pitted dates
- 1/4 cup warm water
- 1 tsp flaxseed, (optional)
- 1/4 cup unsweetened cocoa powder
- 1/8 tsp salt
- 1 1/2 cups ground almonds

Instructions

- Whirl pecans in a food process--or until finely chopped (but not ground). Scrape into a shallow dish and set aside.
- Combine dates with water and flaxseeds in

food processor. Whirl until it starts to form a paste, about 20 sec. Whirl in cocoa powder and salt until combined. Add ground almonds and pulse until a dough forms.

• Scrape mixture into a bowl. Roll 1 tbsp portions into balls, then coat with chopped pecans.
